References are made to (i) the announcements of Alliance International Education Leasing Holdings Limited (formerly known as International Alliance Financial Leasing Co., Ltd.) (the “**Company**”) dated 22 December 2022 and 4 January 2023 in relation to the Proposed Change of Company Name; (ii) the circular of the Company dated 27 January 2023 (the “**Circular**”) regarding the extraordinary general meeting of the Company held on 14 February 2023 (the “**EGM**”); (iii) the announcement of the Company dated 14 February 2023 in relation to the poll results of the EGM; and (iv) the announcement of the Company in relation to, among others, the Change of Company Name (the “**Announcement**”). Unless otherwise defined, capitalised terms used herein shall have the same meanings as those defined in the Circular and the Announcement.

## **COMPLETION OF REGISTRATION OF CHANGE OF NAME IN HONG KONG**

As stated in the Announcement, subsequent to the approval of the Shareholders by passing a special resolution in relation to the Proposed Change of Company Name at the EGM and the Registrar of Companies in the Cayman Islands approving the Proposed Change of Company Name by way of the issue of the certificate of incorporation on change of name, the English name of the Company has been changed from “International Alliance Financial Leasing Co., Ltd.” to “Alliance International Education Leasing Holdings Limited” and “友聯國際教育租賃控股有限公司” has been adopted as the dual foreign name in Chinese of the Company in place of “国际友联融资租赁有限公司”.

The Board is pleased to announce that the Certificate of Registration of Alteration of Name of Registered Non-Hong Kong Company was issued by the Registrar of Companies in Hong Kong on 10 March 2023 confirming the registration of the new English and Chinese name of the Company in Hong Kong under Part 16 of the Companies Ordinance (Chapter 622 of the Laws of Hong Kong).

### **CHANGE OF STOCK SHORT NAME**

Following the Change of Company Name, the English stock short name of the Company will be changed from “IA FIN LEASING” to “ALLI INTL ED LE” and the Chinese Stock Short name will be changed from “友聯租賃” to “友聯國際教育租賃” for trading in the Shares on the Stock Exchange, with effect from 9:00 a.m. on 22 March 2023. The stock code of the Company on the Stock Exchange remains as “1563”.

New share certificates will be issued in the new name of the Company, following the change of the new stock short name.
