The Board hereby announces that on March 21, 2023, the Company entered into the Factoring Agreement with the Factoring Bank, pursuant to which, (i) the Factoring Bank has agreed to provide the Company with recourse factoring services of approximately RMB105,332,451.30 from the execution date of the Factoring Agreement, and the Company has agreed to transfer of the undue sums from the Lease Receivables I (i.e. RMB48,935,333), the Lease Receivables II (i.e. RMB57,551,700), the Lease Receivables III (i.e. RMB10,673,958), the Lease Receivables IV (i.e. RMB7,717,041) and the Lease Receivables V (i.e. RMB5,362,979) to the Factoring Bank for obtaining the facility of approximately RMB105,332,451.30 (the "Funds") from the Factoring Bank; and (ii) the Funds shall be repayable by the Company to the Factoring Bank by February 19, 2026 pursuant to the terms and conditions of the Factoring Agreement.

## THE FACTORING AGREEMENT

The principal terms of the Factoring Agreement are summarized as follows:
