DISCLOSEABLE TRANSACTION PROVISION OF FINANCIAL ASSISTANCE

PROVISION OF FINANCIAL ASSISTANCE

The Board is pleased to announce that on 29 March 2023, the New Loan Agreement was entered into between HK Finance (PL) as the lender and Customer H, Customer I and Customer J, collectively as the Borrowers. Pursuant to the New Loan Agreement, HK Finance (PL) has agreed to grant the New Loan to the Borrowers for a principal amount of HK\$25,600,000.

Prior to the entering into the New Loan Agreement, HK Finance (PL), as the lender, has entered into the Previous Loan Agreements to grant the Previous Loans to the Borrowers for the aggregate principal amount of HK\$8,000,000.

LISTING RULES IMPLICATIONS

The grant of New Loan and the Previous Loans requires aggregation under Rule 14.22 of the Listing Rules. As certain applicable percentage ratios under Rule 14.07 of the Listing Rules in respect of the New Loan and the Previous Loans granted to the Borrowers in aggregate exceed 5% but are less than 25%, the grant of the New Loan constitutes a discloseable transaction for the Company under Chapter 14 of the Listing Rules.

PROVISION OF FINANCIAL ASSISTANCE

The Board is pleased to announce that on 29 March 2023, the New Loan Agreement was entered into between HK Finance (PL) as the lender and Customer H, Customer I and Customer J, collectively as the Borrowers. Pursuant to the New Loan Agreement, HK Finance (PL) has agreed to grant the New Loan to the Borrowers for a principal amount of HK\$25,600,000.

Prior to the entering into the New Loan Agreement, HK Finance (PL), as the lender, has entered into the Previous Loan Agreements to grant the Previous Loans to the Borrowers for the aggregate principal amount of HK\$8,000,000.

Further details of the Previous Loan Agreements for the Borrowers have been set out in the Company's announcement dated 2 March 2023. Summarised below are the principal terms of the New Loan Agreement.

THE NEW LOAN AGREEMENT

Date of Agreement	:	29 March 2023
Lender	:	HK Finance (PL)
Borrowers	:	Customer H, Customer I and Customer J
Principal	:	HK\$25,600,000
Interest rate	:	1.1% per month (equivalent to 13.2% per annum)
Term	:	12 months commencing from the drawdown date
Security	:	A mortgage in respect of a residential property located at Hereford Road, Kowloon, Hong Kong, with valuation conducted by an independent property valuer with the amount of approximately HK\$57,000,000 as at 21 February 2023
Repayment	:	the Borrowers will repay the interest on a monthly basis with a principal sum to be repaid at the maturity

INFORMATION ON THE CREDIT RISK RELATING TO THE NEW LOAN

The proceeds of the New Loan are partially utilised for the full settlement of both the Previous Loans and the other mortgage loan previously granted by other financial institute to the Borrowers. The making of the New Loan is collateralised. The collateral provided by the Borrowers for the New Loan is sufficient based on the value of the mortgaged property for the New Loan determined by an independent valuer.

The advance in respect of the New Loan is also made on the basis of the Group's credit assessments with reference to the facts that (i) the collateral provided by the Borrowers is at the prime site in Hong Kong; (ii) the Borrowers are repeated customers with no default record; (iii) the personal net wealth of Customer I and Customer J proves the Borrowers' repayment ability; (iv) repayment records of the Previous Loans are satisfactory; and (v) the terms of the advances are relatively short. After taking into account the factors as disclosed above in assessing the risks of the relevant advance, the Group considers that the risks involved in the advance to the Borrowers are manageable.

FUNDING OF THE NEW LOAN

The Group will finance the New Loan with the Group's general working capital.

INFORMATION ON THE BORROWERS

Customer H is a company incorporated in Hong Kong engaging in the business of property investment holdings, and is directly and ultimately owned by Customer I and Customer J, being individuals who are merchants and are closely connected to each other. The Borrowers are repeated customers and were approached by the Group through its network. To the best of the knowledge, information and belief of the Directors having made all reasonable enquiry, the Borrowers are Independent Third Parties and not connected with the Group.

INFORMATION ON THE GROUP AND THE LENDER

The Company is an investment holding company. The Group is principally engaged in money lending business in Hong Kong under the Money Lenders Ordinance. HK Finance (PL), as the lender, is an indirect wholly-owned subsidiary of the Company.

REASONS FOR ENTERING INTO THE NEW LOAN AGREEMENT

Taking into account the principal business activities of the Group, the grant of the New Loan to the Borrowers is in the ordinary and usual course of business of the Group.

The terms of the New Loan Agreement were negotiated on an arm's length basis between HK Finance (PL) and the Borrowers. The Directors consider that the grant of the New Loan is a financial assistance provided by the Group within the meaning of the Listing Rules. The Directors are of the view that the terms of the New Loan Agreement were entered into on normal commercial terms based on the Group's credit policy. Taking into account the satisfactory financial background of the Borrowers and that a stable revenue and cashflow stream from the interest income is expected, the Directors consider that the terms of the New Loan Agreement are fair and reasonable and the entering into of the New Loan Agreement is in the interests of the Company and its Shareholders as a whole.
