UNAUDITED OPERATING FIGURES FOR FEBRUARY 2023

The board of directors (the “**Board**”) of Sanxun Holdings Group Limited (the “**Company**”) wishes to provide the shareholders of the Company and potential investors with a sales update containing certain operating data of the Group for the two months ended 28 February 2023. For the two months ended 28 February 2023, the aggregate contracted sales of the Company, its subsidiaries and associated companies (the “**Group**”) was approximately RMB306 million, the aggregate contracted gross floor area was 44,707 sq.m. and the average selling price was approximately RMB6,837.9 per sq.m..
