#### **TERMS OF REFERENCE**

#### **1. CONSTITUTION**

1.1 The remuneration committee (the “Remuneration Committee”) of Chuanglian Holdings Limited (the “Company”) was formed pursuant to the board resolution passed on 9 September 2005 by the board (the “Board”) of directors (the “Director(s)”) of the Company.

1.2 This set of terms of reference of the Remuneration Committee was revised and adopted by the Board on 31 March 2023.

#### **2. FUNCTIONS AND OBJECTIVES**

The Remuneration Committee is responsible for reviewing the remuneration policies and making recommendation to the Board on the remuneration package of Directors and senior management.

#### **3. MEMBERSHIP**

3.1 The members of the Remuneration Committee (the “Member(s)”) shall be appointed by the Board from amongst the Directors of the Company and shall consist of not less than three members.

3.2 The majority of the Members shall be independent non-executive Directors and the chairman of the Remuneration Committee (the “Chairman”) must be an independent non-executive Director.

3.3 The appointment of Members may be revoked, or additional Members may be appointed by resolutions passed by the Board.

#### **4. MEETINGS**

4.1 The company secretary of the Company or such other person appointed by the Remuneration Committee shall be the secretary of the Remuneration Committee.

- 4.2 A quorum of the Remuneration Committee shall be any two Members.
- 4.3 Notice of any meetings has to be given at least 7 days prior to any such meeting being held, unless all Members unanimously waive such notice. Irrespective of the length of notice being given, a member attending the meeting shall be deemed waiver of the requisite length of notice of the meeting by the member. Notice of any adjourned meetings is not required if adjournment is for less than 7 days.
- 4.4 Meetings may be held in person, by telephone or video conference. Members may participate in a meeting by means of a conference telephone or similar communications equipment by means of which all persons participating in the meeting are capable of hearing each other.
- 4.5 Resolutions of the Remuneration Committee at any meetings shall be passed by a majority of votes of the Members present.
- 4.6 A resolution in writing signed by all Members shall be as valid and effectual as if it had been passed at a meeting of the Remuneration Committee duly convened and held.
- 4.7 Minutes of meetings of the Remuneration Committee shall record in sufficient detail the matters considered by the Remuneration Committee and decisions reached, including any concerns raised by Directors or dissenting views expressed.
- 4.8 Full minutes of Remuneration committee meetings should be kept by the secretary of the Remuneration Committee. Draft and final versions of minutes of the Remuneration committee meetings shall be sent to all Members for their comment and records respectively, in both cases within a reasonable time after the meeting. Such minutes of meeting shall be opened for the Board's inspection at any reasonable time on reasonable notice.
- 4.9 At the invitation of the Remuneration Committee, the chairman of the Board and/or managing Director, external advisers and other persons may attend the meetings.
- 4.10 Only Members are entitled to vote at the meetings.
- 4.11 The Chairman in consultation with the secretary, shall decide the frequency and timing of its meetings. There shall be as many meetings as the Remuneration Committee's duties and responsibilities require.
- 4.12 The Remuneration Committee shall meet no less than one meeting a year.

## 5. AUTHORITY

- 5.1 The Remuneration Committee shall consult the chairman of the Board and/or managing Director in respect of their proposals relating to the remuneration of other executive Directors and senior management.
- 5.2 The Remuneration Committee shall have the right to require the Company's management to furnish any remuneration related information it requires from senior management of the Company for the purposes of performing its duties.
- 5.3 A Member may, through the company secretary of the Company, seek professional advice in appropriate circumstances at the Company's expense to perform his/her duties as a Member to the Company within its terms of reference.
- 5.4 The Remuneration Committee shall be provided with sufficient resources to perform its duties.

## 6. DUTIES & RESPONSIBILITIES

The Remuneration Committee shall have the following duties and responsibilities:

- 6.1 to make recommendations to the Board on the Company's policy and structure for all Directors' and senior management remuneration and on the establishment of a formal and transparent procedure for developing remuneration policy;
- 6.2 in regard to 6.1 above and 6.7 below, it is the responsibility of the Board to determine which individual or individuals constitute senior management. Senior management may include directors of subsidiaries; head of divisions, departments or other operating units within the Company and its subsidiaries (collectively, the "Group") as, in the opinion of the Board, is appropriate.
- 6.3 to review and approve the management's remuneration proposals with reference to the Board's corporate goals and objectives;
- 6.4 to make recommendations to the board on the remuneration packages of individual executive Directors and senior management, including benefits in kind, pension rights and compensation payments, including any compensation payable for loss or termination of their office or appointment;
- 6.5 to make recommendations to the Board on the remuneration of non-executive Directors;

- 6.6 to consider salaries paid by comparable companies, time commitment and responsibilities and employment conditions elsewhere in the Group;
- 6.7 to review and approve compensation payable to executive Directors and senior management for any loss or termination of office or appointment to ensure that it is consistent with contractual terms and is otherwise fair and not excessive for the Company;
- 6.8 to review and approve compensation arrangements relating to dismissal or removal of Directors for misconduct to ensure that they are consistent with contractual terms and are otherwise reasonable and appropriate;
- 6.9 to ensure that no Director or any of his associates is involved in deciding his own remuneration; and
- 6.10 to review and/or approve matters relating to share schemes under Chapter 17 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited

## 7. REPORTING PROCEDURES

- 7.1 The minutes of meetings and written resolutions of the Remuneration Committee shall be circulated to the Board.
- 7.2 The Remuneration Committee shall report to the Board after each meeting.

## 8. PUBLICATION OF THE TERMS OF REFERENCE

The terms of reference will be posted on the websites of The Stock Exchange of Hong Kong Limited and the Company.
