**(1) CONNECTED TRANSACTION IN RELATION
TO ENTERING INTO THE SUBLEASE AGREEMENT; AND
(2) CHANGE OF PRINCIPAL PLACE OF BUSINESS IN HONG KONG**

THE SUBLEASE AGREEMENT

The Board hereby announces that on 31 March 2023, Central China Properties (as sublessor) and the Company (as sublessee) entered into the Sublease Agreement, pursuant to which, Central China Properties agreed to sublet the Subleased Portion to the Company for a period commencing from 1 April 2023 to 30 March 2026 (both days inclusive).

IMPLICATIONS UNDER THE LISTING RULES

As at the date of this announcement, Central China Properties was an indirect wholly-owned subsidiary of CCRE, which was in turn indirectly owned as to approximately 41.88% by Mr. Wu Po Sum, who is the father of Ms. Wu Wallis (alias Li Hua) (a non-executive Director). Hence, Central China Properties is a connected person of the Company under the Listing Rules. Accordingly, the Sublease Agreement and the transactions contemplated thereunder constitute a connected transaction of the Company under Chapter 14A of the Listing Rules.

As the highest of all of the applicable percentage ratios in respect of the Sublease Agreement is more than 0.1% but less than 5%, the transactions contemplated under the Sublease Agreement are only subject to reporting and announcement requirements but exempt from the independent Shareholders' approval under Chapter 14A of the Listing Rules.

CHANGE OF PRINCIPAL PLACE OF BUSINESS IN HONG KONG

The principal place of business of the Company in Hong Kong will be changed to Unit No. 7708A on Level 77 of International Commerce Centre, 1 Austin Road West, Kowloon, Hong Kong with effect from 1 April 2023.

THE SUBLEASE AGREEMENT

The principal terms of the Sublease Agreement are set out below:

REASONS FOR AND BENEFITS OF ENTERING INTO THE SUBLEASE AGREEMENT

The Company intends to sublease the Subleased Portion from Central China Properties as one of the Group's office premises, taking into account of the favourable location, size and floor level of the Subleased Portion.

The terms of the Sublease Agreement (including the rent) were determined after arm's length negotiations between the parties, with reference to the actual rental, air-conditioning and management charges and other fees and charges charged by the landlord of the Head Lease pursuant to the terms of the Head Lease without any mark-up (being about 20% of the size of the Head-lease Premises). The rental being charged by the landlord of the Head Lease to Central China Properties was determined by reference to the prevailing market rental of comparable office premises in the vicinity of the Head-lease Premises.

The Directors (including the independent non-executive Directors) consider that the Sublease Agreement has been entered into on normal commercial terms and in the ordinary and usual course of business of the Company, and that the terms of the Sublease Agreement are fair and reasonable and are in the interests of the Company and the Shareholders as a whole.

INFORMATION OF THE PARTIES

The Company was incorporated as an exempted company with limited liability in Bermuda, the Shares of which are listed on the Stock Exchange. It is an investment holding company with subsidiaries principally engaged in the prefabricated construction work, decoration and landscaping services, granting licenses, consulting services and sales of equipment in the PRC.

Central China Properties is a company incorporated in Hong Kong with limited liability. It is an investment holding company. As at the date of this announcement, Central China Properties was an indirect wholly-owned subsidiary of CCRE, which was in turn indirectly owned as to approximately 41.88% by Mr. Wu Po Sum, who is the father of Ms. Wu Wallis (alias Li Hua) (a non-executive Director).

IMPLICATIONS UNDER THE LISTING RULES

As at the date of this announcement, Central China Properties was an indirect wholly-owned subsidiary of CCRE, which was in turn indirectly owned as to approximately 41.88% by Mr. Wu Po Sum, who is the father of Ms. Wu Wallis (alias Li Hua) (a non-executive Director). Hence, Central China Properties is a connected person of the Company under the Listing Rules. Accordingly, the Sublease Agreement and the transactions contemplated thereunder constitute a connected transaction of the Company under Chapter 14A of the Listing Rules.

In accordance with HKFRS 16 “Leases”, the Group will recognize the value of the right-of-use assets in its balance sheet in connection with the Sublease Agreement, and this transaction will be regarded as an acquisition of assets by the Group pursuant to the Listing Rules.

As the highest of all of the applicable percentage ratios in respect of the Sublease Agreement is more than 0.1% but less than 5%, the transactions contemplated under the Sublease Agreement are only subject to reporting and announcement requirements but exempt from the independent Shareholders’ approval under Chapter 14A of the Listing Rules.

To the best of the Directors’ knowledge and belief after having made all reasonable enquiries, other than Ms. Wu Wallis (alias Li Hua) (a non-executive Director) who is the daughter of Mr. Wu Po Sum (who indirectly holds approximately 41.88% of the shareholding of CCRE, which in turn indirectly holds the entire issued share capital of Central China Properties), none of the Directors has a material interest in the Sublease Agreement and the transactions contemplated thereunder. Other than Ms. Wu Wallis (alias Li Hua), who had abstained from voting on the relevant Board resolution approving the Sublease Agreement and the transactions contemplated thereunder for good corporate governance purpose, none of the other Directors was required to abstain from voting on the relevant Board resolution.

CHANGE OF PRINCIPAL PLACE OF BUSINESS IN HONG KONG

The principal place of business of the Company in Hong Kong will be changed to Unit No. 7708A on Level 77 of International Commerce Centre, 1 Austin Road West, Kowloon, Hong Kong with effect from 1 April 2023.
