 - In light of the ongoing COVID-19 pandemic, the Company is adopting special arrangements in respect of the meeting (details of which are set out in the circular of the Company dated 4 April 2023 ("Circular")). In particular, other than the minimum number of persons legally required to form a quorate meeting, together with a limited number of other attendees to ensure the proper conduct of the Meeting, other shareholders, proxies or corporate representatives will not be able to attend the meeting in person. Any person who attempts to do so will be excluded and will not be permitted entry to the venue of the meeting.
