- 5. This form of proxy must be signed by you or your attorney duly authorised in writing or, in the case of a corporation, must be either under its common seal or under the hand of an officer or attorney duly authorised in writing.

In the case of joint holders, the vote of the senior who tenders a vote, whether in person or by proxy, will be accepted to the exclusion of the votes of the other joint holder(s), and for this purpose seniority will be determined by the order in which the names stand in the Register of Members of the Company.
- 7. To be valid, this form of proxy, together with any power of attorney (if any) or other authority (if any) under which it is signed or a notarised copy thereof, must be deposited at the Company's Hong Kong branch share registrar (the "Share Registrar"), Tricor Tengis Limited at 17/F, Far East Finance Centre, 16 Harcourt Road, Hong Kong, or via the designated URL (https://spot-emeeting.tricor.hk) by using the username and password provided on the notification letter sent by the Company on 6 April 2023 as soon as possible and in any event not later than 11:00 a.m. on Wednesday, 26 April 2023 or not less than 48 hours before the time appointed for holding any adjourned meeting.

8. A proxy need not be a member of the Company but must attend the SGM in person to represent you.

- 9. Completion and delivery of this form of proxy will not preclude you from attending and voting at the SGM if you so wish and in such event, this form of proxy shall be deemed to be revoked.

## PERSONAL INFORMATION COLLECTION STATEMENT

- iv. You and your appointed proxy have the right to request access to and/or correction of the respective Personal Data in accordance with the provisions of the PDPO. Any such request for access to and/or correction of the Personal Data should be in writing and sent by post to the Share Registrar, Tricor Tengis Limited at 17/F, Far East Finance Centre, 16 Harcourt Road, Hong Kong.
