EXPANSION OUTSIDE HENAN

For the three months ended 31 March 2023, the Group had three newly contracted project in provinces other than Henan, with newly contracted GFA of 329,100 sq. m..

As of 31 March 2023, the Group had 28 projects under management in provinces other than Henan with an aggregate GFA of 2,950,642 sq. m., accounting for 9.1% of the total GFA of the Group's projects under management. These projects cover seven provinces or autonomous region outside Henan, including Anhui, Shanxi, Shaanxi, Hebei, Xinjiang, Hainan and Inner Mongolia.

CONTRACTED SALES OF PROJECTS UNDER MANAGEMENT
