UNAUDITED OPERATING STATISTICS FOR MARCH 2023

The board of directors (the “**Board**”) of Zhongliang Holdings Group Company Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) is pleased to announce certain unaudited operating statistics of the Group for March 2023 as follows:

- From January to March 2023, the Group’s aggregated contracted sales (including contracted sales by joint ventures and associates) and contracted gross floor area (“**GFA**”) amounted to approximately RMB11.43 billion and 1,156,000 square metres (“**sq.m.**”), respectively. The Group’s contracted average selling price from January to March 2023 was approximately RMB9,900/sq.m.
- In March 2023, the Group’s contracted sales (including contracted sales by joint ventures and associates) amounted to approximately RMB3.75 billion with contracted GFA of approximately 369,000 sq.m. The Group’s contracted average selling price in March 2023 was approximately RMB10,200/sq.m.

The above-mentioned sales data is unaudited and is based on preliminary internal information of the Group, which may differ from figures to be disclosed in the audited or unaudited consolidated financial statements to be published by the Company on an annual or half-yearly basis due to various uncertainties during the process of collating such sales information. As such, the above data is provided for investors’ reference only.
