If any proxy other than the chairman of the Meeting of the Company is preferred, strike out the words "the chairman of the Meeting or" and insert the name and email address of the proxy desired in the spaces provided. The proxy need not be a member of the Company but must attend the Meeting in person to represent you. ANY ALTERATION MADE TO THIS FORM OF PROXY MUST BE INITIALLED BY THE PERSON WHO SIGNS IT.
- 4. IMPORTANT: IF YOU WISH TO VOTE FOR A RESOLUTION, PUT A TICK IN THE BOX MARKED "FOR". IF YOU WISH TO VOTE AGAINST A RESOLUTION, PUT A TICK IN THE BOX MARKED "AGAINST". Failure to do so will entitle your proxy to vote or abstain as he/she thinks fit. Your proxy will be also entitled to vote at his/her discretion on any resolution properly put to the Meeting other than those referred to in the notice convening the Meeting.
- 5. This form of proxy must be signed by you or your attorney duly authorised in writing or, in the case of a corporation, must be either under its common seal or under the hand of an officer duly authorised in writing.
- 6. The form of proxy despatched with the Circular for use at the extraordinary general meeting held on 22 March 2023 (the "EGM") will remain valid for the Meeting if you do not intend to change your vote. However, should you intend to lodge a revised form of proxy, you are requested to complete and return this form of proxy in accordance with the instructions printed hereon and return this form of proxy to the branch share registrar of the Company in Hong Kong, Tricor Investor Services Limited, at 17/F., Far East Finance Centre, 16 Harcourt Road, Hong Kong as soon as possible and in any event not less than (48) hours before the time appointed for holding the Meeting, i.e. Wednesday, 3 May 2023 at 11:00 a.m. (Hong Kong time), or any adjournment thereof. After lodging the revised form of proxy as aforesaid, if completed correctly, the form of proxy despatched with the Circular for use at the EGM previously lodged will be superseded and become invalid.
- 7. In the case of joint holders, the vote of the senior who tenders a vote, whether in person or by proxy, will be accepted to the exclusion of the vote(s) of the other joint holder(s), and for this purpose, seniority will be determined by the order in which the names stand in the register of members.
- 8. To be valid, this form of proxy, together with any power of attorney or other authority (if any) under which it is signed, or a notarially certified copy thereof must be deposited at the Company's branch share registrar in Hong Kong, Tricor Investor Services Limited at 17/F, Far East Finance Centre, 16 Harcourt Road, Hong Kong not less than 48 hours before the time appointed for the holding of the Meeting or any adjournment thereof, and in default the instrument appointing a proxy shall not be treated as valid.
- 9. Completion and delivery of the form of proxy will not preclude you from attending and voting at the Meeting should you so wish and, in such event, the instrument appointing a proxy shall be deemed to be revoked if you vote in person at the Meeting.

PERSONAL INFORMATION COLLECTION STATEMENT
