## Election of Means of Receipt of Corporate Communications

To make your election, please complete the enclosed reply form (the “**Reply Form**”) and return it by post or by hand to the Company’s branch share registrar and transfer office in Hong Kong, Tricor Abacus Limited (the “**Hong Kong Branch Share Registrar**”), at 17/F, Far East Finance Centre, 16 Harcourt Road, Hong Kong **on or before May 22, 2023**. If you return the Reply Form by post in Hong Kong, you may use the mailing label in the Reply Form and no postage stamp will be necessary. Otherwise, please affix an appropriate stamp on the envelope.

**If we do not receive the completed Reply Form or receive a response indicating objection from you by May 22, 2023, or until you inform us by reasonable notice in writing or by email ([giordano-ecom@hk.tricorglobal.com](mailto:giordano-ecom@hk.tricorglobal.com)) otherwise, you will be deemed to have consented to receiving all future Corporate Communications by electronic means through the Company’s website in lieu of the printed form. A notification of the publication of Corporate Communications on the Company’s website will be sent to you by post at your address appearing in the register of members of the Company maintained by the Hong Kong Branch Share Registrar.**

If you choose to receive Corporate Communications by electronic means and have specified your email address in the enclosed Reply Form, we will send you an email notification of the publication of the relevant Corporate Communications on the Company’s website on the day that each Corporate Communication is sent to the Company’s shareholders. If no email address is provided, we will send notification of the publication of Corporate Communications on the Company’s website to such shareholders by post.

Even if you have made your election, you are entitled to change your means of receipt of Corporate Communications at any time by giving reasonable notice in writing or by email ([giordano-ecom@hk.tricorglobal.com](mailto:giordano-ecom@hk.tricorglobal.com)) to the Hong Kong Branch Share Registrar. If you have chosen electronic means (or are deemed to have chosen or consented to choosing electronic means), and, for any reason, have difficulty in receiving or gaining access to the Corporate Communications, we will promptly, upon request, send a printed version to you free of charge.

The printed version of Corporate Communications will be available from the Company or the Hong Kong Branch Share Registrar on request.
