- 2. To re-elect Mrs. Pan Zhang Xin Marita as an executive Director.
- 3. To re-elect Ms. Xu Jin as an executive Director.
- 4. To re-elect Mr. Qian Ting as an executive Director.
- 5. To re-elect Mr. Xiong Ming Hua as an independent non-executive Director.
- 6. To authorize the Board to fix the remuneration of the Directors.
