INTRODUCTION

The purpose of this circular is to provide the Shareholders with information regarding, among other things, (1) the grant of the Repurchase Mandate; (2) the grant of the Issue Mandate; (3) the extension of the Issue Mandate by the addition of the number of Shares repurchased

pursuant to the Repurchase Mandate; (4) the re-election of Directors; (5) the appointment of independent non-executive Director; and (6) the adoption of the Amended and Restated Memorandum and Articles of Association, and to give the Shareholders the notice of the AGM.

REPURCHASE MANDATE

At the last annual general meeting of the Company held on 19 May 2022, a general mandate was granted to the Directors to exercise the power of the Company to repurchase Shares. Such mandate will lapse at the conclusion of the AGM. An ordinary resolution will be proposed at the AGM to grant the Repurchase Mandate to the Directors to repurchase Shares not exceeding 10% of the aggregate nominal amount of the issued share capital of the Company as at the date of passing the resolution approving the Repurchase Mandate at the AGM. An explanatory statement as required under the Listing Rules to provide further information of the Repurchase Mandate is set out in Appendix I to this circular.

ISSUE MANDATE AND EXTENSION OF THE ISSUE MANDATE

At the AGM, an ordinary resolution will be proposed that the Directors be given the Issue Mandate in order to ensure flexibility to the Directors to issue new Shares. As at the Latest Practicable Date, a total of 588,835,343 Shares were in issue. Subject to the passing of the proposed ordinary resolution approving the Issue Mandate and on the basis that there is no further change to the issued share capital of the Company from the Latest Practicable Date and up to the date of the AGM, the exercise of the Issue Mandate in full would result in issuing up to a maximum of 117,767,068 Shares, representing 20% of the total number of Shares in issue as at the date of passing of the resolution in relation to the Issue Mandate at the AGM (assuming no Share is issued between the Latest Practicable Date and the date of the AGM). In addition, an ordinary resolution will also be proposed to extend the Issue Mandate by adding to it the number of such Shares repurchased under the Repurchase Mandate.

RE-ELECTION OF DIRECTORS

In accordance with Article 112 of the Articles of Association, Ms. Leelalertsuphakun Wanee, being executive Director, and Dr. Chan Yau Ching, Bob ("**Dr. Chan**") and Dr. Tsim Wah Keung, Karl ("**Dr. Tsim**"), both being independent non-executive Directors, will retire and, being eligible, will offer themselves for re-election at the AGM.

Pursuant to the code provision set out in paragraph B.2.3 of Appendix 14 of the Listing Rules, it is recommended that serving more than nine years could be relevant to the determination of a non-executive director's independence. Any further appointment of independent non-executive Director serving more than nine years should be subject to a separate resolution to be approved by the Shareholders.

Dr. Chan and Dr. Tsim are independent non-executive Directors serving the Company since 2002 and 2004 respectively. The Board believes that Dr. Chan and Dr. Tsim are considered as independent and continue to be independent because they have the required elements, character,

integrity and experience to continue fulfilling the role of an independent non-executive Director by taking into account the factors set out in Rule 3.13 of the Listing Rules. Notwithstanding that Dr. Chan and Dr. Tsim have served on the Board for more than nine years, the nomination committee and the Board are of the view that this does not and would not affect the exercise of their independent judgement as they have been providing objective views and independent opinions to the Company over the years. Dr. Chan and Dr. Tsim have not engaged in the daily or executive management of the Group nor in any relationships or circumstances which would interfere with the exercise of their independent judgement. In addition, the Company have received from each of Dr. Chan and Dr. Tsim a confirmation of independence pursuant to Rule 3.13 of the Listing Rules.

Taking into consideration of Dr. Chan's and Dr. Tsim's independent scope of work and valuable contributions given to the Company in the past years, the Board considers Dr. Chan and Dr. Tsim are able to provide independent, balanced and objective views to the Company's affairs and continue to independently fulfill their role as an independent non-executive Director despite the fact that they have served the Company for more than nine years. The nomination committee also considers that Dr. Chan and Dr. Tsim could continue to contribute to the diversity of the Board with: (1) Dr. Chan's past experience as independent non-executive director in other listed companies; and (2) Dr. Chan's professional experience in the corporate development and financial management sector and Dr. Tsim's expertise in biological sciences. Accordingly, the Board and the nomination committee recommend them to be re-elected as independent non-executive Directors at the Annual General Meeting. A separate resolution will be proposed for each of Dr. Chan's and Dr. Tsim's re-elections.

The biographical details of these Directors are set out in Appendix II to this circular.

Pursuant to code provision B.2.4 of Appendix 14 of the Listing Rules, where all the independent non-executive directors of an issuer have served more than nine years on the board, the length of tenure of each existing independent non-executive director on a named basis should be disclosed, and the issuer should appoint a new independent non-executive director on the board at the forthcoming annual general meeting with effect from the financial year commencing on or after 1 January 2023. The Board wishes to inform the Shareholders that all the Company's independent non-executive Directors, i.e. Dr. Chan, Dr. Tsim and Mr. Lam Yat Cheong, were appointed on 14 January 2002, 20 September 2004 and 1 July 2004 respectively, have been serving as independent non-executive Directors for more than 21, 18 and 18 years respectively as at the Latest Practicable Date.

APPOINTMENT OF INDEPENDENT NON-EXECUTIVE DIRECTOR

Reference is made to the announcement of the Company dated 19 April 2023 in relation to the proposed appointment of independent non-executive Director.

After considering the recommendation of the nomination committee, the Board has proposed to appoint Ms. Cheang Yee Wah, Eva ("Ms. Cheang") as a candidate for the independent non-executive Director for the Shareholders' approval at the AGM. Subject to the approval by the Shareholders at the AGM, Ms Cheang's term of office will be effective from the conclusion of the AGM for a term of three years, and the Company will appoint her as a member of the audit committee.

Upon approval of the appointment of Ms. Cheang as an independent non-executive Director by the Shareholders, a letter of appointment will be entered into between the Company and Ms. Cheang for a period of three years commencing from the AGM, which can be terminated by either party giving to the other not less than two months' prior written notice. She is subject to retirement by rotation and re-election at the annual general meeting of the Company under the Company's Memorandum and Articles of Association. Ms. Cheang will be entitled to an annual remuneration of HK\$216,000 and bonus will not be paid. This is determined by the remuneration committee and the Board with reference to her duties and responsibilities within the Company and the prevailing market conditions, and will be subject to annual review by the remuneration committee and the Board. The remuneration of directors will also be disclosed by the Company in the annual report.

Ms. Cheang has confirmed that she meets the independence criteria set out in Rule 3.13 of the Listing Rules. After taking into account the confirmation of her independence to the Company under Rule 3.13 of the Listing Rules and her educational background, rich experiences in the past and professional knowledge, the Board proposed to appoint Ms. Cheang as the independent non-executive Director. Ms. Cheang has expertise in accounting and auditing and other work experience required to fulfill the role of independent non-executive Director.

The biographical details of Ms. Cheang are set out in Appendix II to this circular.

ADOPTION OF AMENDED AND RESTATED MEMORANDUM AND ARTICLES OF ASSOCIATION

Reference is made to the announcements of the Company dated 6 April 2022, 19 May 2022 and 17 April 2023 in relation to the adoption of the Amended and Restated Memorandum and Articles of Association.

The Company proposed to amend the existing Memorandum and Articles of Association to permit the Company to (i) hold hybrid general meetings and electronic general meetings; (ii) bring the existing Articles of Association to conform to the core standards of shareholder protection as provided in the amended Appendix 3 to the Listing Rules under the new listing regime for overseas issuers which took effect on 1 January 2022; and (iii) incorporate certain housekeeping amendments.

The proposed adoption of the Amended and Restated Memorandum and Articles of Association is subject to the approval of the Shareholders by way of a special resolution at the AGM and shall take effect upon the close of the AGM.

Full particulars of the proposed amendments to the existing Memorandum and Articles of Association brought about by the adoption of the Amended and Restated Memorandum and

Articles of Association (marked-up against the existing Memorandum and Articles of Association) are set out in Appendix III to this circular. The Chinese translation of the proposed Amended and Restated Memorandum and Articles of Association is for reference only. In case of any discrepancy or inconsistency between the English version and its Chinese translation, the English version shall prevail. EXPLANATORY STATEMENT ON THE REPURCHASE MANDATE

This Appendix serves as an explanatory statement as required under the Listing Rules, to provide further information to you for consideration of the Repurchase Mandate.

SHARE CAPITAL

As at the Latest Practicable Date, the Company had 588,835,343 Shares in issue or an issued share capital of HK\$29,441,767.15. Subject to the passing of the proposed ordinary resolution approving the Repurchase Mandate and on the basis that there is no further change to the issued share capital of the Company from the Latest Practicable Date to the date of the AGM, the exercise of the Repurchase Mandate in full would result in the Company repurchasing up to a maximum of 58,883,534 Shares, representing 10% of the total number of Shares in issue as at the date of passing of the relevant resolution at the AGM (assuming no Share is issued between the Latest Practicable Date and the date of the AGM).

REASONS FOR SHARES REPURCHASES

The Directors believe that it is in the best interests of the Company and the Shareholders for the Directors to have general authority from the Shareholders to enable the Company to repurchase Shares in the market. Such repurchases may, depending on market conditions and funding arrangements at the time, lead to an enhancement of the net asset value per Share and/or earnings per Share and/or dividend per Share and will only be made if the Directors believe that such repurchases will benefit the Company and the Shareholders.

FUNDING OF SHARE REPURCHASES

In repurchasing the Shares, the Company may only apply funds legally available for such purpose in accordance with its Articles of Association, the Listing Rules and the applicable laws of the Cayman Islands.

UNDERTAKING

Accordingly, a Shareholder, or a group of the Shareholders acting in concert (within the meaning under the Takeovers Code), depending on the level of increase of the Shareholders' interests, may obtain or consolidate control of the Company and become obliged to make a mandatory offer in accordance with Rules 26 and 32 of the Takeovers Code.

As at the Latest Practicable Date, to the best knowledge and belief of the Directors, the group of Shareholders acting in concert in the Company including Huby Technology Limited, the beneficial owners of Huby Technology Limited, namely, Ms. Lee Siu Fong and Ms. Leelalertsuphakun Wanee, Dr. Li Xiaoyi, High Knowledge Investments Limited, and the beneficial owner of High Knowledge Investments Limited, namely, Ms. Lue Shuk Ping, Vicky (collectively the "Concert Group") were interested in 180,923,651 Shares, representing approximately 30.73% of the existing issued share capital of the Company. In the event that the Directors exercise in full the power to repurchase Shares which is proposed to be granted pursuant to the Repurchase Mandate, the shareholdings of the Concert Group would be increased to approximately 34.14% of the issued share capital of the Company as reduced by the Shares repurchased pursuant to the Repurchase Mandate (taking no account of any Shares that may be issued upon exercise of share options that may be granted under the share option schemes of the Company adopted on 26 June 2002, 10 May 2012 and 19 May 2022 or any other scheme as may be adopted by the Company). Accordingly, the exercise of the Repurchase Mandate in full would give rise to an obligation to make a general offer to Shareholders under Rules 26 and 32 of the Takeovers Code by the Concert Group.

The Directors have no present intention to exercise the Repurchase Mandate to the extent that would give rise to an obligation to make a general offer to Shareholders under Rules 26 and 32 of the Takeovers Code by any Shareholders.

In the event that the Repurchase Mandate is exercised in full, the number of Shares held by the public would not fall below 25% of the total number of Shares in issue. In any event, the Directors will not make share repurchase on the Stock Exchange if such repurchase would result in the requirements under Rule 8.08 of the Listing Rules not being complied with.

SHARES REPURCHASES MADE BY THE COMPANY

The Company did not repurchase of Shares (whether on the Stock Exchange or otherwise) in the six months preceding the Latest Practicable Date.

Ms. Leelalertsuphakun Wanee (李燁妮女士)

Executive Director and Managing Director, Chief Marketing & Sales Officer, member of remuneration committee and member of management committee, aged 69

Ms. Leelalertsuphakun Wanee ("Ms. Leelalertsuphakun") joined the Group in April 1997. In September 2003, Ms. Leelalertsuphakun was appointed the Chief Marketing and Sales Officer and is responsible for the Group's sales and marketing activities. Ms. Leelalertsuphakun is the sister of Ms. Lee Siu Fong and Dr. Li Xiaoyi, an executive Director and a non-executive Director respectively. Ms. Leelalertsuphakun has entered into a service contract with the Company on 14 January 2002 under which she has been appointed to act as an executive Director on a continuous basis until terminated by either party by giving to the other party not less than three months' notice in writing.

In accordance with the supplemental agreement dated 20 December 2021, Ms. Lee is also entitled to annual bonus and retirement benefits as listed below:

The instrument appointing a proxy shall be in writing under the hand of the appointer or of his/her attorney duly authorised in writing or, if the appointer is a corporation, either under its seal or under the hand of an officer, attorney or other person authorised to sign the same.
- 4. In the case of a joint holding, any one of such persons may vote at the AGM, either in person or by proxy; but if more than one joint holders are present at the AGM in person or by proxy, the said person whose name stands first on the register of members of the Company in respect of the relevant joint holding shall alone be entitled to vote in respect thereof.
- 5. To be valid, a proxy form in the prescribed form together with the power of attorney or other authority (if any) under which it is signed, or a notarially certified copy of such power or authority, must be lodged with the branch share registrar of the Company in Hong Kong at 17M Floor, Hopewell Centre, 183 Queen's Road East, Wanchai, Hong Kong not later than 48 hours before the time fixed for holding the AGM.
- 6. If a "black" rainstorm warning signal or a tropical cyclone warning signal number 8 or above is in force in Hong Kong at any time between 8:00 a.m. and 11:00 a.m. on Wednesday, 17 May 2023, an announcement will be made in such event to notify the Shareholders of any alternative date for the AGM.
- 7. The circular of the Company dated 21 April 2023 and the accompanying proxy form have been sent to the shareholders of the Company together with the 2022 Annual Report of the Company.
