The notice to convene the 2023 First H Shareholders Class Meeting is set out on pages HCM-1 to HCM-3 of this circular.

The purpose of this circular is to provide you with information of the resolutions to be proposed at the AGM and 2023 First H Shareholder Class Meeting to enable you to make an informed decision on whether to vote for or against or abstain from voting at those resolutions. Such resolutions and details are set out in this Letter from the Board of Directors.

II. MATTERS TO BE RESOLVED AT THE AGM

1. Report of the Board of Directors for the year ended 31 December 2022

An ordinary resolution will be proposed at the AGM to approve the report of the Board of Directors for the year ended 31 December 2022, the full text of which is included in the 2022 annual report of the Company to be published on the websites of the Company and the Stock Exchange on 24 April 2023.

2. Report of the Board of Supervisors for the year ended 31 December 2022

- (C) the date on which the authority set out in the special resolution to be passed for the granting of the Issue Mandate is revoked or varied by a special resolution of the shareholders of the Company in a general meeting; and

APPENDIX I

This appendix serves as an explanatory statement, as required by the Listing Rules, to enable the Shareholders to make an informed decision on whether to vote for or against the grant of the Repurchase Mandate.

I. LISTING RULES RELATING TO THE REPURCHASE OF SECURITIES

However, the Directors do not intend to make any repurchases to such an extent as would, in the circumstances, have a material adverse effect on the working capital requirements or the gearing position of the Company. The number of H Shares to be repurchased on any occasion and

VI. STATUS OF REPURCHASED H SHARE

The Listing Rules provide that the listing of all the H Shares repurchased by the Company shall automatically be cancelled and the relevant share certificates shall be cancelled and destroyed. Under the PRC laws, the H Shares repurchased by the Company will be cancelled and the Company's registered capital will be reduced by an amount equivalent to the aggregate nominal value of the H Shares so cancelled.
