(f) To authorise the Board of Directors to fix the emolument of the Directors. To re-appoint KPMG as Auditor and to authorise the Directors to fix their remuneration. To grant a general mandate to the Directors to allot, issue and deal with new shares of the Company. To grant a general mandate to the Directors to buy back the shares of the Company. To include the shares bought back by the Company to the mandate granted to the Directors under Resolution 5. A member of the Company entitled to attend, speak and vote at the Meeting is entitled to appoint one or more proxies to attend, speak and on a poll, to vote for him provided that each proxy is appointed to represent the respective number of shares held by such member as specified in the form of proxy. A proxy need not be a member of the Company. Please insert the number of shares registered in your name(s) to which this proxy relates in the box provided. If no number is inserted, this form of proxy will be deemed to relate to all the shares of the Company which are registered in your name(s) (whether alone or jointly with others). Please indicate with a tick in the appropriate box beside each of the resolutions how you wish the proxy to vote on your behalf on a poll. In the absence of any such indication, the proxy will vote or abstain at his/her discretion. This form of proxy must be signed by you or your attorney duly authorised in writing or, in the case of a corporation, this form of proxy must be executed either under its common seal or under the hand of an officer or attorney of the corporation duly authorised for the purpose. To be valid, this form of proxy, together with the power of attorney (if any) or other authority (if any) under which it is signed or a notarially certified copy of that power of attorney or authority, must be completed, signed and deposited with the Company's Share Registrar, Tricor Standard Limited, at 17/F, Far East Finance Centre, 16 Harcourt Road, Hong Kong, not less than 48 hours before the time appointed for holding the Meeting (accordingly, no later than 12:00 noon on 29 May 2023) or any adjournment or postponement thereof or, in the case of a poll taken more than 48 hours after it was demanded, not less than 24 hours before the time appointed for the taking of the poll. Completion and deposit of the form of proxy will not preclude you from attending, speaking and voting in person at the Meeting if you so wish, but in the event of your attending the Meeting, this form of proxy will be deemed to have been revoked. In calculating the periods for depositing the instrument appointing a proxy, no account is to be taken of any part of a day that is a public holiday. Where there are joint registered holders of any share, any one of such persons may vote at the Meeting, either personally or by proxy, in respect of such share as if he/she were solely entitled thereto; but if more than one of such joint holders are present at the Meeting personally or by proxy, that one of the said persons so present whose name stands first on the register of members of the Company in respect of such share shall alone be entitled to vote in respect thereof. Any alteration made to this form of proxy must be initialled by the person who signs it. The notice of Annual General Meeting is set out in the circular of the Company dated 24 April 2023.
