Election of Language and Means of Receipt of Corporate Communications

Pursuant to Rules 2.07A and 2.07B of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "Listing Rules"), the Companies Ordinance, Chapter 622 of the Laws of Hong Kong, and the Articles of Association of Hong Kong Ferry (Holdings) Company Limited (the "Company"), the Company is making available the following options for you to elect for the receipt of future corporate communication(s) of the Company (the "Corporate Communication(s)"), which means any document(s) issued or to be issued by the Company for the information or action of holders of any of its securities as defined in Rule 1.01 of the Listing Rules, including but not limited to the directors' report, annual accounts together with a copy of the auditor's report (and where applicable, the summary financial report), the interim report (and where applicable, the summary interim report), notices of meetings, listing documents, circulars and proxy forms in the following manners:

- to receive all future Corporate Communications by electronic means on the Company's website at www.hkf.com in place of printed copies and receive an email notification or a notification letter of the publication of Corporate Communications on the Company's website; or
- (ii) to receive the printed English version of all future Corporate Communications only; or
- (iii) to receive the printed Chinese version of all future Corporate Communications only; or
- (iv) to receive both the printed English and Chinese versions of all future Corporate Communications.

In support of environmental protection and for the purpose of saving printing and mailing costs, the Company recommends you to elect to receive all future Corporate Communications by electronic means. To make your election, please mark "X" in the appropriate box on the enclosed reply form (the "Reply Form") and sign and return it by post or by hand to the Company's share registrar, Tricor Standard Limited (the "Share Registrar") at 17/F, Far East Finance Centre, 16 Harcourt Road, Hong Kong. If you post your reply in Hong Kong, you may use the mailing label in the Reply Form and need not affix a stamp on the envelope when returning your Reply Form. Otherwise, please affix an appropriate stamp. The Reply Form may also be downloaded from the Company's website at www.hkf.com and the HKEXnews website at www.hkexnews.hk.

If the Company does not receive a duly completed and signed Reply Form from you (or another response from you indicating that you object to receiving the Corporate Communications in electronic form on the Company's website) on or before 22 May 2023, you will be deemed, until you inform the Company otherwise by reasonable notice (of not less than 7 days) in writing at the offices of the Share Registrar at the above address or by email to hkf50-ecom@hk.tricorglobal.com, to have consented to receive all future Corporate Communications by electronic means through the Company's website instead of receiving them in printed form. In that event, when the Company makes a Corporate Communication, it will only send to you notification that the Corporate Communication has been made available on the Company's website. The notification will be sent to you by email (if you have provided an email address) or (if you have not provided an email address) by post to you at your address as it appears in the Company's register of members maintained by the Share Registrar.

You are entitled at any time by reasonable notice (of not less than 7 days) in writing to the Share Registrar at the above address or by email to hktf50-ecom@hk.tricorglobal.com to change the choice of language and means of receipt of the Corporate Communications. Even if you have chosen (or are deemed to have consented) to receive all future Corporate Communications by electronic means but for any reason have difficulty in receiving or gaining access to the Corporate Communications, the Company will promptly, upon your request in writing to the Share Registrar at the above address or by email to hktf50-ecom@hk.tricorglobal.com, send the Corporate Communications to you in printed form free of charge.

Please note that (i) printed copies of the Corporate Communications in both English and Chinese are available from the Company or the Share Registrar upon request; and (ii) both language versions of the Corporate Communications are also available on the Company's website at www.hkf.com for at least 5 years from the date of first publication and on the HKEXnews website at www.hkexnews.hk.
