**ANNOUNCEMENT ON UNAUDITED OPERATING DATA
FOR THE FIRST QUARTER OF
THE THREE MONTHS ENDED 31 MARCH 2023**

This announcement is voluntarily made by Dynagreen Environmental Protection Group Co., Ltd.* (the “**Company**”, together with its subsidiaries, the “**Group**”).

The board of directors (the “**Board**”) of the Company is pleased to announce that the unaudited waste input volume of the Group amounted to 2,993,200 tons, representing a year-on-year increase of 10.99%; the electricity generation volume was 1,057,277,600 kWh, representing a year-on-year increase of 1.50%; the on-grid electricity volume was 880,247,100 kWh, representing a year-on-year increase of 2.05% respectively ; and the steam supply was 101,000 tons in the first quarter of the three months ended 31 March 2023.
