# COMPANY PROFILE

## 公司簡介

Readboy Education Holding Company Limited (“**Readboy**” or the “**Company**”, together with its subsidiaries, the “**Group**”) was listed on the Stock Exchange (Stock Code: 2385) on 12 July 2022, which marked an important milestone in the development of the Company. The Company is a smart learning device service provider in China, focusing on the design, development, manufacturing and selling of smart learning devices embedded with digital educational resources for China’s primary and secondary students, their parents and school teachers.

We have become a technology-powered smart learning device service provider with established education product and service offerings in China. According to the Frost & Sullivan Report, we ranked second among China’s smart learning device service providers in terms of total retailing market value and ranked fifth among China’s smart learning device service providers in terms of total device shipment in 2021.

Our Readboy brand was recognised as a reputable technology-powered education brand in China. We have accumulated over 6.69 million registered users by December 2022 and our average monthly active users amounted to over 1.4 million in the past 12 months.

In addition, we have established a nationwide offline distribution network with deep penetration. As at 31 December 2022, we contracted 131 offline distributors who controlled a total of 4,258 points of sales located in 324 cities covering 31 provinces and autonomous administrative regions, including municipalities, across China.

讀書郎教育控股有限公司(「**讀書郎**」或「**本公司**」，連同其子公司，統稱為「**本集團**」)於2022年7月12日在聯交所上市(股份代號：2385)，是本公司發展的一個重要里程碑。本公司為中國的智能學習設備服務供應商，專注於為中國的中小學生、其家長及學校教師設計、開發、製造及銷售嵌入數字化教輔資源的智能學習設備。

我們已成為中國擁有成熟教育產品及服務供應且以科技賦能的智能學習設備服務供應商。根據弗若斯特沙利文報告，於2021年，按總零售市值計，我們在中國的智能學習設備服務供應商中排名第二，而按總設備出貨量計，我們在中國的智能學習設備服務供應商中排名第五。

讀書郎品牌已成為中國著名教育科技品牌。截至2022年12月，我們的註冊用戶累計超過6.69百萬名，我們於過往12個月的平均月活躍用戶超過1.4百萬名。

此外，我們已經建立全國性線下經銷網絡，並具有很強的滲透力。於2022年12月31日，我們已與131名線下經銷商簽約，他們控制合共4,258個銷售點，遍佈中國31個省和自治行政區(包括直轄市)的324個城市。

# CHAIRMAN'S STATEMENT

## 主席報告

Dear Shareholders,

On behalf of the Board, I am pleased to present to our annual report for the year ended 31 December 2022, being our first annual report after our listing on the Stock Exchange.

### OVERVIEW

Year 2022 is a milestone year for us, which is not only the first year since our listing, but also the most challenging year since our founding in more than 20 years. During the year, we not only suffered from the dual pressures of epidemic prevention and control and economic downturn, but also faced with intensifying industry competition

Despite numerous difficulties, we remain steadfast in our mission to take advantage of technology empowerment to make study a pleasant experience, and adhere to our core values of responsibility, innovation, user-oriented, and result-oriented. We believe that it is of utmost importance to be closer to users, and only in this way can we better understand our users. Therefore, the construction of offline store channels has always been the focus of our work. According to our experience accumulated in more than 20 years, in order to achieve consumer satisfaction and truly help our users, we must fully explore front-line stores and strengthen localized operations. Despite the significant decrease in store traffic due to epidemic control, in 2022, we still increased investment in the construction of offline stores, as we always believe that only in this way can we create greater value for our users and achieve sustainable development.

Education informatisation is an irreversible trend. Since the Ministry of Education emphasised Education Informatisation 2.0, we have been promoting education informatisation as a key project and established the Smart Campus Business Unit in 2021. 2022 was a year of harvest for the Smart Campus, with a major breakthrough for the project. We made a good start by undertaking large-scale projects such as “Learning in Zhuji”, “Learning in Zhejiang”, “Zhongshan Joint Examination Marking” and “Greater Bay Area Joint Examination”. We have further verified that we are heading in the right direction, and in 2022, we have further increased our investment in the research and development of smart campuses in response to the national call, so as to promote the high-quality development of education informatisation.

尊敬的股東：

本人僅代表董事會提呈我們截至2022年12月31日止年度的年度報告，也是我們在聯交所上市以來的第一份年度報告。

### 業績概覽

2022年對我們而言是具有里程碑意義的一年，既是我們上市以來的第一個年頭，同時也是我們成立二十多年來最具挑戰的一年，不僅有疫情防控和經濟下行帶來的雙重壓力，同時還面臨著不斷加劇的行業競爭。

儘管困難重重，我們仍堅守「科技賦能，讓學習成為美好體驗」的使命，本分、創新、用戶導向、結果導向的核心價值觀。我們認為首先要離用戶更近，只有離用戶更近才能更懂用戶，所以線下門店渠道的建設始終是我們工作的重心。二十多年的經驗告訴我們，要做到消費者滿意，真正對用戶有幫助，必須深耕到一線門店做好本土化經營。儘管疫情管控的原因導致門店流量大幅減少，在2022年我們依然加大了線下門店的建設投入，我們始終堅信只有這樣，才能為用戶創造更大的價值，我們才能實現基業長青。

教育信息化是不可逆的大趨勢，自教育部強調教育信息化2.0開始，我們始終把教育信息化作為重點項目推進，並於2021年成立智慧校園事業部，2022年是智慧校園收穫的一年，項目取得了重大突破，我們前後承接了「學在諸暨」、「學在浙江」、「中山聯考閱卷」、「大灣區聯考」等大型項目，實現良好開局。也進一步驗證了我們的方向是正確的，對此，我們在2022年進一步加大了智慧校園的研發投入，響應國家號召，推進教育信息化高質量發展。

However, due to the impact of the “reduced shop traffic caused by the epidemic and increased investment in offline shops and smart campuses”, our revenue for 2022 was RMB605.2 million, down 26% year-on-year, and our net profit after deducting extraordinary profit and loss was RMB6.3 million, down 92% year-on-year, as compared to the previous financial year. Although our offline channel strategy and smart campus strategy are not yet reflected in our business performance, we are confident that we are doing the right thing and are laying a solid foundation for our core competencies, which will eventually be reflected in our long-term results.

### DEVELOPMENT PLANNING

The year of 2023 will be a new year of post-pandemic overall opening and economic recovery. As an intelligent education hardware equipment supplier with 24 years since its inception, we firmly believe that our strategy of adhering to offline distribution channels and smart campus business will bring us great opportunities. To this end, we will stick to the following strategies.

**Adhering to the development of traditional distribution channels,** we will develop the markets in lower-tier cities. With focus on the layout of markets in counties and townships, we will set up exclusive stores in achieving “localization service + operation” for products and thus building a moat of “product + service”. Also, we will give play to resource advantages to drive the consumption of consumers by products that target to government and business, thereby promoting revenue growth of the main business (student tablets, telephone watches, and dictionary pens).

**Adhering to the diversified development strategy.** Currently, revenue from student tablets accounted for approximately 86% of total revenue. In the future, we plan to gradually improve the proportion of revenue from other products, such as study desk sets, dictionary pens, printers, etc., so as to increase the proportion of revenue from non-tablet products to 25%.

**Focusing on developing smart campus business,** we will concentrate our investments in smart exam review, personalised learning manual, smart learning card, English teaching, testing and practicing, real testing bank learning eyes, AI precise learning, etc., comprehensively covering students, schools, families, education authorities and other aspects, in bid to achieve digitalization and informatisation of education.

但同時，也因為「疫情導致門店流量減少，以及加大線下門店及智慧校園投入」這三方面的影響，2022年與上一財政年度相比，本年度營收人民幣605.2百萬元，同比下降26%，扣非淨利潤630萬，同比下降92%，儘管我們的線下渠道戰略，智慧校園戰略暫時未反應在我們的業務表現，但我們堅信我們始終在做正確的事情，在為我們的核心競爭力奠定堅實的基礎，最終將反映在我們的長期業績中。

### 發展計劃

2023年是疫情全面開放的全新的一年，經濟也在不斷回暖。作為一家有著24年底蘊的智能教育硬件設備商，我們堅信，我們堅持的線下經銷渠道及智慧校園業務的戰略將會給我們帶來極大的機遇。為此，我們將堅持以下幾個戰略。

**堅持傳統經銷渠道建設，**開發下沉市場，重點佈局縣鄉鎮市場，開設專賣店，實現產品本地化服務+運營，構建產品+服務的護城河，利用資源優勢，GB端產品帶動C端消費等，促使主營業務（學生平板，電話手錶，詞典筆）的營收增長。

**堅持多元化發展戰略，**目前學生平板的佔營收約86%，我們計劃未來逐步提高其他產品品類的營收佔比，如學習桌椅，詞典筆，打印機等等。把非平板類產品佔比提升至25%。

**重點發展智慧校園業務，**重點投入智慧閱卷、個性化學習手冊、智能學習卡、英語教考練、真題庫學習眼、AI精準學等，全方面覆蓋學生、學校、家庭、教育局等環節，實現教育數字化，信息化。

# MANAGEMENT DISCUSSION AND ANALYSIS

## 管理層討論與分析

### BUSINESS REVIEW

Year 2022 was a milestone of the Company as the shares of the Company were successfully listed on the Main Board of the Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”) on 12 July 2022 (the “**Listing**”). The net proceeds from the initial public offering of the Shares were approximately HKD364.6 million, which will be used in accordance with the purposes as set out in the section headed “Future Plans and Use of Proceeds” in the prospectus of the Company dated 29 June 2022 (the “**Prospectus**”).

For 2022 Annual, the Group was engaged in the production and sales of personal student tablets, smart classroom solutions, wearable products, other products and advertisement and content licensing in China.

We design, develop, manufacture and market smart learning devices empowered by digital educational resources targeting primary and secondary school students in China, creating a flexible, efficient, effective, interactive and personalised learning experience. We design and develop our smart learning devices by utilising our in-house research and development capacities, with a substantial portion of the manufacturing and assembling process managed by ourselves.

We currently primarily offer our products under one brand, namely Readboy (讀書郎). Our Readboy brand was recognised as a reputable technology-powered education brand in China, including the Parents’ Most Trusted Education Brand for Kids in 2018 and the Technical Leading Education Brand in 2018, both recognised by Tencent News Annual Education Event, the Most Trusted Education Brand in 2019 awarded by Xinhua Net Education Forum. We derive revenue from the sales of our major products, which include (i) personal student tablets; (ii) smart classroom solutions; (iii) wearable products and (iv) other products including teaching and learning accessories, such as smart reader pens, smart scanner pens, and smart learning desks and chairs. On top of the above, we also generate revenue from advertisement and content licensing.

### 業務回顧

2022年是本公司的一個里程碑，乃由於本公司的股份已於2022年7月12日在香港聯合交易所有限公司（「聯交所」）主板成功上市（「上市」）。首次公開發售股份的所得款項淨額約為364.6百萬港元，將根據本公司日期為2022年6月29日的招股章程（「招股章程」）「未來計劃及所得款項用途」一節所載用途予以動用。

於2022年年度，本集團的業務是在中國從事生產及銷售學生個人平板、智慧校園解決方案、可穿戴產品、其他產品以及廣告及內容授權。

我們針對中國的中小學生設計、開發、製造及營銷配備數字化教輔資源的智能學習設備，從而創造靈活、高效、實用、互動和個性化的學習體驗。我們利用內部研發能力設計和開發智能學習設備，而大部分製造及裝配程序由我們自行管理。

我們現時主要使用單一品牌（即讀書郎）提供我們的產品。讀書郎品牌已成為中國著名教育科技品牌，獲得的榮譽包括騰訊網年度教育盛典「2018年度家長信賴兒童教育品牌」及「2018年度科技領先教育品牌」、新華網教育論壇「2019年度•公信力教育品牌」。我們自銷售我們的主要產品產生收入，其中包括(i)學生個人平板；(ii)智慧校園解決方案；(iii)可穿戴產品及(iv)其他產品，包括智能點讀筆、智能掃讀筆及智慧學習桌椅等教學配件。除上述者外，我們亦自廣告及內容授權產生收入。

### Personal Student Tablets

Our personal student tablets are designed for personal end-users who are primary and secondary (including middle and high school) students aged 6 to 18, equipped with digital educational resources, mainly synchronous lesson preparation, review and learning materials, which are supplemental to the in-school education for compulsory school education, and certain selected featured learning resources. Courseware is pre-installed and is extendable while connecting to our online learning platform which offers pre-recorded video resources.

Revenue derived from the sales of personal student tablets decreased by approximately 25.9% from RMB705.0 million in 2021 Annual to RMB522.2 million in 2022 Annual. The decrease was mainly due to the resurgent outbreak of COVID-19 in various cities in China and the tightening of pandemic control measures during 2022 Annual, which affected supply chain and distributor business to a certain extent, resulting in lower sales of personal student tablets.

### Smart Classroom Solutions

Our smart classroom solutions typically refer to the smart educational devices embedded with smart classroom management functions, which provide a connected and interactive learning environment for school teachers and students on one hand and enable parents to monitor the learning status of their children on the other hand. Currently, primary and secondary schools are our target customers of smart classroom solutions and we expect our products to enhance the way of teaching and learning digitally, promoting teaching quality and efficiency.

Revenue derived from the sales of smart classroom solutions decreased by approximately 35.1% from RMB23.6 million in 2021 Annual to RMB15.3 million in 2022 Annual. The decrease was mainly due to the delay or cancellation of promotional activities for smart classroom solutions resulting from the resurgent outbreak of COVID-19 in China during 2022 Annual, leading to the decrease in sales of smart classroom solutions in the period.

### 學生個人平板

我們的學生個人平板專為6至18歲的中小學(包括初中及高中)學生個人終端用戶設計，配備數字化教輔資源(主要是同步預習、複習及學習材料，是對義務教育課堂教學的補充)以及若干精選特色學習資源。課件已預裝且可擴展，同時連接到我們提供錄播視頻資源的線上學習平台。

學生個人平板的銷售收入由2021年年度的人民幣705.0百萬元減少約25.9%至2022年年度的人民幣522.2百萬元。該減少主要是由於2022年年度因中國城市的COVID-19疫情反覆以及疫情管控措施趨嚴，供應鏈及經銷商業務受到一定程度的影響，從而導致學生個人平板銷售減少。

### 智慧校園解決方案

我們的智慧校園解決方案通常指配備智慧校園管理功能的智能教育設備，其一方面為學校師生提供互聯互動的學習環境，另一方面可讓家長監控其孩子的學習情況。目前，中小學為我們智慧校園解決方案的目標客戶，且我們預期我們的產品將改善數字化教學方式，提高教學質量和效率。

智慧校園解決方案的銷售收入由2021年年度的人民幣23.6百萬元減少約35.1%至2022年年度的人民幣15.3百萬元。該減少主要是由於2022年年度因中國的COVID-19疫情反覆，智慧校園解決方案的推廣活動遭到推遲或取消，從而導致期內智慧校園解決方案的銷量減少。

### Wearable Products

We believe wearable education gadgets play an increasingly significant role in the new era of education by providing a wireless and hand-free access to various visual and audio educational resources beyond classroom in pockets of time. Such devices have expanded education scenarios and fueled the students with additional fun and motivation in learning during fragmentary time. In this regard, we have developed smartwatches specifically focusing on educational features and functions, for example they are embedded with Chinese and English Word of the Day for vocabularies learning, besides the traditional functions of GPS, video calls, health monitoring and emergency assistance.

Revenue from the sales of wearable products decreased by 49.7% from RMB53.7 million in 2021 Annual to RMB27.0 million in 2022 Annual, primarily due to the resurgent outbreak of COVID-19 in China in various cities and the tightening of pandemic control measures during 2022 Annual, which affected supply chain and distributor business to a certain extent, resulting in lower sales of wearable products.

### Other Products

We identify emerging market needs and trends, and from time to time develop teaching and learning accessories that are compatible to our smart learning devices, aiming to make learning more productive and efficient. We currently offer smart reader pens, which working with our online content, can identify and read the Chinese or English words and sentences out loud. Our smart scanner pens can translate the selected Chinese or English sentences instantly without connecting to the Internet. Revenue from the sales of these accessory products increased by 62.4% from RMB17.9 million in 2021 Annual to RMB29.1 million in 2022 Annual due to the increased sales of new products of smart scanner pens and smart learning desks and chairs launched in 2022 Annual.

### 可穿戴產品

我們認為，可穿戴式教育小配件在新時代的教育中發揮日益重要的作用，可以讓學生在課堂外碎片化時間以無線及免提方式獲取各種視聽教輔資源。此等設備拓展教育場景，增加學生在碎片化時間裡的學習樂趣和動力。為此，我們專門開發專注於教育特色及功能程序的智能手錶，如預裝學習詞彙的中英文每日一詞，還設有GPS、視頻電話、健康監測及緊急援助的傳統功能。

可穿戴產品的銷售收入由2021年年度的人民幣53.7百萬元減少49.7%至2022年年度的人人民幣27.0百萬元，主要是由於2022年年度因中國城市的COVID-19疫情反覆以及疫情管控措施趨嚴，供應鏈及經銷商業務受到一定程度的影響，從而導致可穿戴產品銷量下降。

### 其他產品

我們確定新興的市場需求及趨勢，並不時開發與我們智能學習設備相容的教學及學習配套產品，旨在使學習更富成效及高效。目前，我們提供智能點讀筆，配合我們的線上內容，可以識別及朗讀中文或英文詞彙及句子。我們的智能掃讀筆能夠離線即時翻譯選定的中文或英文句子。該等配套產品的銷售收入由2021年年度的人人民幣17.9百萬元增加62.4%至2022年年度的人人民幣29.1百萬元，是由於2022年年度推出的智能掃讀筆及智慧學習桌椅新產品銷量增加所致。

### Advertisement and Content Licensing

Revenue from advertisement and content licensing represented our revenue from third parties who placed in-app advertisements with us and third parties who offered our licensed digital educational resources on their platforms under profit-sharing arrangements. Generally, we would place links to the apps of the customers on the devices sold by us, and we would collect a fee based on the fixed price per click or download as agreed in the contract with the customers and number of clicks performed by the end users. Further, we also license pre-recorded video resources to third-party channels which place the digital educational resources on their platforms to sell to the end users. When the users purchase the digital educational resources from the platforms, we are entitled to a prescribed fixed percentage of gross proceeds collected by the channels.

Revenue generated from advertisement and content licensing decreased from approximately RMB13.0 million in 2021 Annual to approximately RMB11.7 million in 2022 Annual, primarily due to the result of the promulgation of the Opinion on Further Easing the Workload of Students in Compulsory Education and Burden of After-school Tutoring (《關於進一步減輕義務教育階段學生作業負擔和校外培訓負擔的意見》) by the PRC government (the so-called “double reduction” (雙減)), which led to the decrease in purchase of the digital educational resources on the platforms from the end users.

### Distribution Network

We primarily rely on third-party offline distributors for the sales of our products. We also distribute through online channels comprising of our self-operated online storefronts on mainstream e-commerce marketplaces and a limited number of online distributors.

### 廣告及內容授權

來自廣告及內容授權的收入指來自向我們投放應用內廣告的第三方及根據利潤分成安排在其平台提供我們授權的數字化教輔資源的第三方的收入。一般情況下，我們會在我們銷售的設備上放置客戶的應用程序的鏈接，並按照與客戶簽訂的合約中約定的每次點擊或下載的固定價格以及終端用戶的點擊次數來收取費用。此外，我們亦將預先錄製的視頻資源授權予第三方渠道，由第三方渠道將數字化教輔資源投放在其平台上銷售予終端用戶。當用戶從平台購買數字化教輔資源時，我們有權獲得渠道收取的總所得款項的固定百分比。

廣告及內容授權產生的收入由2021年年度的約人民幣13.0百萬元減少至2022年年度的約人民幣11.7百萬元，主要由於中國政府下發《關於進一步減輕義務教育階段學生作業負擔和校外培訓負擔的意見》(俗稱「雙減」政策)，導致終端用戶在平台上購買數字化教輔資源減少。

### 經銷網絡

我們主要依賴第三方線下經銷商銷售我們的產品。我們亦通過線上渠道(包括我們在主流電子商務平台的自營網店及少數線上經銷商)進行經銷。

It is our in-house educational resource research and development center which is mainly responsible for content research, educational resource design and development, courseware and pre-recorded video resource production and other relevant supportive services.

我們致力挖掘教輔資源並向中國學生提供優質數字化教輔資源。於2017年，我們成立了讀書郎教育科技研究院。讀書郎教育科技研究院是我們的內部教輔資源研發中心，主要負責內容研究、教輔資源設計及開發、課件及錄播視頻資源製作及其他相關支援服務。

### FINANCIAL REVIEW

#### Revenue

The revenue of the Group decreased by approximately 25.6% from RMB813.2 million in 2021 Annual to RMB605.2 million to 2022 Annual. The decrease was primarily resulted from the decrease in sales of personal student tablets and wearable products due to the intensified COVID-19 pandemic control restrictions in place during the year, affecting our production schedule and the business of our offline distributors.

The table below sets forth a summary of revenues derived from each of our product categories:

### 財務回顧

#### 收入

本集團的收入由2021年年度的人民幣813.2百萬元減少約25.6%至2022年年度的人民幣605.2百萬元。該減少乃主要由於學生個人平板及可穿戴產品的銷售額減少，原因為於本年度強化落實COVID-19疫情管控限制影響了我們的生產計劃及線下經銷商的業務。

### Cost of Sales

Our cost of sales decreased by approximately 26.9% from RMB644.0 million in 2021 Annual to RMB471.0 million in 2022 Annual. The decrease was primarily due to (i) the decrease in the sales of tablets during 2022 Annual which resulted in the corresponding decrease in cost of sales; (ii) the increase of the Group's investment in digital educational resources, which has increased the content licensing fees, staff cost and bandwidth costs of our cost of sales during 2022 Annual.

### Gross Profit and Gross Profit Margin

Our gross profit decreased by approximately 20.7% from RMB169.2 million in 2021 Annual to RMB134.2 million in 2022 Annual, primarily due to the decrease in revenue as discussed above. The gross profit margin increased from 20.8% in 2021 Annual to 22.2% in 2022 Annual, primarily due to the tightening control of discounts offered on sales of personal student tablets and new products with higher gross profit margin launched during 2022 Annual, resulting in a slight increase in the overall gross profit margin for 2022 Annual.

### Other Income and Gains

Other income and gains increased by approximately 15.0% from RMB60.1 million in 2021 Annual to RMB69.1 million in 2022 Annual, which was mainly due to (i) the increase in exchange gain by RMB18.0 million, which was in connection with the net proceeds from the Listing denominated in HKD, which was a result of the depreciation of RMB in 2022 Annual; (ii) the decrease in repair and maintenance service income by RMB8.3 million for products of which the warranty had expired, for which we charge service fees, as a result of the decrease in maintenance orders in 2022 Annual.

### Selling and Distribution Expenses

Our selling and distribution expenses increased by approximately 32.0% from RMB73.1 million in 2021 Annual to RMB96.4 million in 2022 Annual, which was primarily due to the increase in advertising and marketing expenses as a result of the increased online sales promotion efforts to enhance brand recognition and exposure in conjunction with the launch of new products and the expansion of marketing channels such as social media under the Group's strategy.

### 銷售成本

我們的銷售成本由2021年年度的人民幣644.0百萬元減少約26.9%至2022年年度的人民幣471.0百萬元。該減少主要是由於(i) 2022年年度平板銷售縮減導致銷售成本相應減少；(ii) 本集團的數字化教輔資源投入增加，導致2022年年度的銷售成本中的內容許可費、員工成本及寬帶成本增加。

### 毛利及毛利率

我們的毛利由2021年年度的人民幣169.2百萬元減少約20.7%至2022年年度的人民幣134.2百萬元，主要是由於上述收入減少。毛利率由2021年年度的20.8%上升至2022年年度的22.2%，主要是由於2022年年度銷售學生個人平板提供的折扣管控收緊及推出高毛利率的新產品，致使2022年年度總體毛利率略微上漲。

### 其他收入及收益

其他收入及收益由2021年年度的人民幣60.1百萬元增加約15.0%至2022年年度的人民幣69.1百萬元，主要由於(i) 2022年年度人民幣貶值導致與以港元計值的上市所得款項淨額有關的匯兌收益增加人民幣18.0百萬元；(ii) 2022年年度保養訂單減少，致使我們對收取服務費的保修期屆滿產品的維修和保養服務收入減少人民幣8.3百萬元。

### 銷售及經銷開支

銷售及經銷開支由2021年年度的人民幣73.1百萬元增加約32.0%至2022年年度的人民幣96.4百萬元，主要是由於隨著根據本集團策略推出新產品及拓展社交媒體等營銷渠道，加大線上銷售推廣力度，提升品牌知名度、曝光率等導致廣告及營銷開支增加。

### Administrative Expenses

Our administrative expenses increased by approximately 27.4% at RMB44.0 million in 2021 Annual and RMB56.1 million in 2022 Annual which was primarily due to (i) the increase in professional service fees by RMB7.5 million which was mainly due to fees incurred for professional consultancy and investor relations management services rendered after the Listing to enhance the investors awareness of the Company in light of the volatility of the Hong Kong stock market; (ii) the increase in maintenance expenses by RMB2.1 million which was in connection with the renovation and upgrades of offices and other fixed assets; and (iii) the increase in impairment loss of financial assets by RMB1.3 million which were mainly related to unrecovered trade receivables and other receivables.

### Research and Development Expenses

Our research and development expenses decreased by 13.6% from RMB43.9 million in 2021 Annual to RMB37.9 million in 2022 Annual, primarily due to the decrease in professional service fees paid to third parties and material expenses, partially offset by the increased in staff costs to motivate our research and development personnel, reflecting the enhanced research and development activities in 2022.

### Other Expenses

Our other expenses decreased by approximately 3.1% from RMB22.9 million in 2021 Annual to RMB22.2 million in 2022 Annual, primarily due to (i) the decrease in cost of maintenance by RMB2.4 million which was mainly related to the repair and maintenance services for products of which the warranty had expired, as a result of the decrease in maintenance orders in 2022 Annual; (ii) the decrease in exchange loss by RMB1.8 million which was in connection with the proceeds received from our Pre-IPO Investors denominated in USD, which was a result of the appreciation of RMB in 2021 Annual; (iii) the increase in the cost of raw materials and accessory parts sold by RMB4.5 million, which was primarily attributed to a larger amount of raw materials disposed in 2022 Annual as we strategically restructured our product mix, (iv) the decrease in cost of compensation by RMB0.8 million, which was in connection with the settlement of lawsuits in 2021 Annual, there was no compensation took place in 2022 Annual.

### Finance Costs

Our finance costs increased by approximately 52.3% from RMB88,000 in 2021 Annual to RMB134,000 in 2022 Annual, primarily due to the increase of incurred interest on lease liabilities.

### 行政開支

我們的行政開支增加約27.4%，於2021年年度為人民幣44.0百萬元，於2022年年度為人民幣56.1百萬元，乃主要由於(i)專業服務費增加人民幣7.5百萬元，該增加乃主要由於在香港證券市場波動的環境下，為增強投資者對本公司的認識所產生的上市後專業諮詢及投資者關係管理服務費所致；(ii)與辦公室及其他固定資產翻新升級有關的保養開支增加人民幣2.1百萬元；及(iii)金融資產減值虧損增加人民幣1.3百萬元，乃主要與未收回的貿易應收款項及其他應款項有關。

### 研發開支

我們的研發開支由2021年年度的人民幣43.9百萬元減少13.6%至2022年年度的人民幣37.9百萬元，主要由於向第三方支付的专业服務費及材料成本減少，部分被增加員工成本以激勵研發人員(反映了2022年研發活動增加)所抵銷。

### 其他開支

我們的其他開支由2021年年度的人民幣22.9百萬元減少約3.1%至2022年年度的人民幣22.2百萬元，主要由於(i)保養成本減少人民幣2.4百萬元，乃主要與2022年年度保養訂單減少，保修期屆滿產品的維修和保養服務有關；(ii)匯兌虧損減少人民幣1.8百萬元，與已收首次公開發售前投資者的以美元計值的所得款項有關，乃由於2021年年度人民幣升值所致；(iii)原材料及配件的成本增加人民幣4.5百萬元，乃主要由於我們戰略性重組產品組合，2022年年度原材料處置數量增加；(iv)賠償費用減少0.8百萬元，乃主要與2021年年度的訴訟解決有關，而2022年年度並無賠償。

### 財務成本

我們的財務成本由2021年年度的人民幣88,000元增加約52.3%至2022年年度的人民幣134,000元，主要由於租賃負債產生的利息增加。

### Changes in fair value of financial assets/liabilities at fair value through profit or loss

The changes in fair value of financial assets/liabilities at fair value through profit or loss consisted of (i) a gain in fair value of financial liabilities at fair value through profit or loss of approximately RMB3.6 million in 2022 Annual (2021 Annual: RMB26.6 million), which was related to the issue of an aggregate of 67,288 shares to three Pre-IPO Investors at a total consideration of USD22.7 million (equivalent to RMB147.0 million). The carrying amount was derecognised from financial liabilities at fair value through profit or loss and reclassified to the equity upon the lapse of redemption right upon the completion of the listing of the shares of the Company on 12 July 2022, and (ii) a gain in fair value of financial assets at fair value through profit or loss of approximately RMB16.5 million in 2022 Annual (2021 Annual: Nil) which was related to the equity investment in Hong Kong listed company, namely, Flowing Cloud Technology Ltd (Stock Code: 6610). The fair value of listed equity investment were based on the quoted price in the active stock market.

### Profit Before Tax

As a result of the foregoing, our profit before tax was RMB72.0 million in 2021 Annual and our profit before tax was RMB10.7 million in 2022 Annual.

### Income Tax (Expense)/Credit

We recorded income tax expense of RMB5.9 million in 2022 Annual, mainly as a result of deferred tax expense of contract liabilities, preferential tax reduction for one subsidiary and tax losses not recognised for certain subsidiaries resulting from operating loss. Income tax credit amounted to RMB10.1 million in 2021 Annual.

### Profit for the Year

As a result of the foregoing, we recognised net profit of RMB4.9 million and net profit of RMB82.1 million for 2022 Annual and 2021 Annual, respectively. The decrease was mainly attributable to the decrease in gross profit by approximately RMB35.0 million, an increase in selling and distribution expenses of approximately RMB23.3 million and an increase in administrative expenses of approximately RMB12.1 million.

### 按公允價值計入損益的金融資產／負債的公允價值變動

按公允價值計入損益的金融資產／負債的公允價值變動包括：(i) 於2022年年度按公允價值計入損益的金融負債公允價值收益約人民幣3.6百萬元(2021年年度：人民幣26.6百萬元)，與以總代價22.7百萬美元(相當於人民幣147.0百萬元)向三名首次公開發售前投資者發行合共67,288股股份有關。於2022年7月12日本公司股份上市完成後贖回權失效時，其賬面值於按公允價值計入損益的金融負債中終止確認並重新分類至權益項下，及(ii)於2022年年度按公允價值計入損益的金融資產公允價值收益約人民幣16.5百萬元(2021年年度：零)，與於一家香港上市公司飛天雲動科技有限公司(股份代號：6610)的股權投資有關。上市股權投資的公允價值乃基於活躍股市報價釐定。

### 稅前利潤

由於上述原因，我們於2021年年度錄得稅前利潤人民幣72.0百萬元，於2022年年度錄得稅前利潤人民幣10.7百萬元。

### 所得稅(開支)／抵免

於2022年年度，我們錄得所得稅開支人民幣5.9百萬元，主要由於合同負債的遞延稅項開支、一家子公司的減稅優惠以及若干子公司因經營虧損而產生的未確認稅項虧損。於2021年年度，錄得所得稅抵免人民幣10.1百萬元。

### 年內利潤

由於上述原因，於2022年年度及2021年年度，我們分別確認淨利潤人民幣4.9百萬元及淨利潤人民幣82.1百萬元。該減少乃主要由於毛利減少約人民幣35.0百萬元、銷售及經銷開支增加約人民幣23.3百萬元及行政開支增加約人民幣12.1百萬元。

### Non-HKFRS Measures

To supplement the Group's consolidated financial statements, which are presented in accordance with HKFRS, we also present adjusted net profit as additional financial measures, which are not required by, or presented in accordance with, HKFRS. Adjusted net profit, as we present it, represents profit for the year before listing expenses and changes in fair value of financial assets/liabilities at fair value through profit or loss. Listing expenses are expenses in relation to the initial public offering of the shares of the Company. Changes in fair value of financial assets at fair value through profit or loss are non-cash expenses in connection with the Group' listed equity investment in Flowing Cloud Technology Ltd (Stock Code: 6610). Changes in fair value of financial liabilities at fair value through profit or loss are non-cash expenses in connection with the shares we issued to our pre-IPO investors. We believe that the presentation of non-HKFRS measures, when shown in conjunction with the corresponding HKFRS measures, provides useful information to investors and management.

While these non-HKFRS measures provide additional financial measures for investors to assess our operating performance, the use of these non-HKFRS measures has certain limitations because they do not reflect all items of income and expense that affect our operations. Our presentation of these non-HKFRS measures should not be construed as an inference that our future results will be unaffected by such unusual item.

These non-HKFRS measures should not be considered in isolation or construed as a substitute for analysis of HKFRSs financial measures. In addition, as these measures may not be calculated in the same manner by all companies, our adjusted net profit (a non-HKFRS measure) may not be comparable to the same or similarly titled measures presented by other companies.

### 非香港財務報告準則計量

為補充本集團根據香港財務報告準則呈列的綜合財務報表，我們亦呈列經調整淨利潤作為額外的財務指標，惟該等數據並非香港財務報告準則所要求，亦不是按該準則所呈列。經調整淨利潤（誠如我們所呈列）指扣除上市開支及按公允價值計入損益的金融資產／負債的公允價值變動前的年內利潤。上市開支為與本公司股份首次公開發售有關的開支。按公允價值計入損益的金融資產公允價值變動為與本集團於飛天雲動科技有限公司（股份代號：6610）的上市股權投資有關的非現金開支。按公允價值計入損益的金融負債的公允價值變動是與我們向首次公開發售前投資者發行股份相關的非現金開支。我們認為，當非香港財務報告準則計量的呈列與相應香港財務報告準則計量一併顯示時，可為投資者及管理層提供有用資料。

儘管該等非香港財務報告準則計量為投資者提供評估我們營運表現的額外財務計量方法，由於其並不反映所有影響我們營運的收支項目，使用該等非香港財務報告準則計量存在若干限制。我們呈列此等非香港財務報告準則計量不應被詮釋為推斷我們未來的業績將不受該等非正常項目的影響。

The Group has always pursued a prudent treasury management policy and actively manages its liquidity position to cope with daily operation and any demands for capital for future development.

The Group funded and is expected to continue to fund its operations principally from cash generated from operations, net proceeds from the initial public offering of shares and unutilized banking facilities.

### Cash Position

As at 31 December 2022, the Group had cash and cash equivalents of RMB149.0 million (as at 31 December 2021: RMB333.3 million), which primarily consisted of deposits in bank denominated in RMB, USD and HKD.

### Gearing Ratio

As at 31 December 2022, our gearing ratio, which is calculated as total liabilities divided by total assets, was 27.3%, as compared with 68.1% as at 31 December 2021. The decrease was mainly due to the decrease in the Group's total liabilities resulting from the decrease in amounts due to shareholders and financial liabilities at fair value through profit or loss. The amounts due to shareholders as at 31 December 2021 were entirely settled prior to the listing of the Company on 12 July 2022. The carrying amount of financial liabilities at fair value through profit or loss which was related to the issue of shares to three Pre-IPO Investors was derecognised from financial liabilities at fair value through profit or loss and reclassified to the equity upon the lapse of redemption right upon the completion of the listing of the shares of the Company on 12 July 2022.

### Contingent Liabilities and Guarantees

As at 31 December 2022, the Group did not have significant contingent liabilities, guarantees or any litigations or claims of material importance.

### Significant Investments, Major Acquisitions and Disposals

During the year ended 31 December 2022, save as disclosed in this report, the Group did not have any significant investments, or conduct material acquisitions or disposals of subsidiaries, joint ventures and associates. Save as disclosed in the sections headed "Business" and "Future Plans and Use of Proceeds" in the Prospectus, the Group did not have any specific plans for significant investment or acquisition of material capital assets or other businesses. As at 31 December 2022, the Group did not have any future plan for material investments or capital assets.

### Charge on Group Assets

As at 31 December 2022, the Group did not pledge any group assets (as at 31 December 2021: Nil).

### Exchange Risk

Other than the bank deposits, some of which are denominated in USD and HKD, the Group's business is principally conducted in Renminbi and therefore did not have any material direct exposure to foreign exchange fluctuation in 2022 Annual. Accordingly, the Group considers its exposure to currency risk to be insignificant. As at 31 December 2022, the Group has not entered into any hedging transaction against foreign currency risks. However, the Board will remain alert to any relevant risks and, if necessary, consider to hedge any material potential foreign exchange risk.

### EMPLOYEE REMUNERATION

As at 31 December 2022, the Group had a total of 553 full-time employees (as at 31 December 2021: 574 full-time employees). For the year ended 31 December 2022, the Group recognised staff costs of approximately RMB70.1 million (as at 31 December 2021: RMB75.8 million). The Group provided employees with salaries and benefits that, in its opinion, were competitive with market standards and regularly reviewed the remuneration policies based on employees' contributions and industry standards. The Group also contributed to medical insurance, pension insurance, maternity insurance, unemployment insurance, work-related injury insurance and housing provident funds for our employees and paid relevant insurance premiums. In addition, the Group also engaged external experts to provide internal training courses for its employees from time to time. Further, the Group has adopted the RSU Scheme and the Share Option Scheme to reward the eligible participants their past contribution to the success of the Group and to provide incentives for their continuing contribution.

### 匯兌風險

除部分銀行存款以美元及港元計值外，本集團之業務主要以人民幣進行，因此於2022年年度並無任何外匯波動的重大直接風險。因此，本集團認為其貨幣風險並不重大。於2022年12月31日，本集團並無訂立任何針對外幣風險的對沖交易。然而，董事會仍會警惕任何相關風險，並在必要時考慮對沖任何重大的潛在匯兌風險。

### OUTLOOK FOR THE YEAR OF 2023

Looking ahead, we expect the market environment will go up, with a surge in consumer spending as a result of the post-pandemic reopening and economic recovery in the near term.

Moving into the year of 2023, we are in the process of developing devices adopting 5G technologies, in anticipation of the era of 5G, which will support faster transmission speed and lower latency.

In addition, we are planning to accelerate the structural reform of our distribution network by promoting the single-layer distribution model while continuing to expand the geographic coverage of the network and deepen its penetration into additional lower-tier cities.

We shall also continue to actively promote the adoption of our smart classroom solutions nationwide. We plan to further enhance our educational resources research and development efforts on localised educational content and special teaching functions, so as to offer customised smart classroom solutions that better respond to the needs of different users.

Meanwhile, the Group will continue to explore other suitable business and investment opportunities to drive its business growth.

### 2023 年展望

From January 1988 to December 1995, Mr. Chen served as the deputy general manager of marketing department of Zhongshan Xiaobawang Electronic Industry Co., Ltd\* (中山小霸王電子工業有限公司), where he was responsible for product development and marketing work. From April 1996 to April 2004, Mr. Chen served as the chairman of the board of directors of Zhongshan Rijia Electronics Co., Ltd\* (中山市日佳電子有限公司).

**Ms. Liu Zhilan (劉志蘭)**, aged 48, is our executive Director and deputy general manager. She was appointed as the deputy general manager of Readboy Technology on 28 December 2017 and was later appointed as an executive Director on 13 April 2021. Ms. Liu is responsible for supervising overall operations, management, strategic planning and business development.

Prior to joining our Group, Ms. Liu Zhilan served as an accountant of Zhongshan Yuncai Cosmetics Co., Ltd\* (中山市雲彩化妝品有限公司) from July 1997 to September 1999. Ms. Liu Zhilan joined our Group since September 1999 and she has served in various roles related to accounting or operations. He will continue to serve as the deputy general manager of Readboy Technology. Mr. Chen has confirmed that he has no disagreement with the Board and there is no matter in respect of his resignation that would need to be brought to the attention of the shareholders of the Company or The Stock Exchange of Hong Kong Limited. The Board confirms that the resignation of Mr. Chen as an executive Director will not result in material impact on its function and there is no current plan of replacement for such position.

### COMPLIANCE WITH NON-COMPETITION UNDERTAKINGS

#### Deed of Non-Competition

To protect the Group from any potential or actual conflict of interest and competition, Mr. Chen Zhiyong, Mr. Qin Shuguang, Kimlan Limited, Sky Focus Holdings Limited and Trade Honour Holdings Limited (the “**Covenantors**”), being the Controlling Shareholders, has entered into a deed of non-competition in favour of the Company (the “**Deed of Non-Competition**”) on 21 June 2022, pursuant to which each of Mr. Chen Zhiyong, Mr. Qin Shuguang, Kimlan Limited, Sky Focus Holdings Limited and Trade Honour Holdings Limited has irrevocably and unconditionally undertaken that each of them shall and shall procure their respective close associates not to, directly or indirectly, engage in any business which is or may be in competition with the business of any member of the Group from time to time, including the business as a smart learning device service provider (the “**Restricted Business**”), or hold shares or interest in any companies or business (other than the Shares or interest in our Group) that competes or may compete directly or indirectly with the Restricted Business, except (a) where our Controlling Shareholders and their close associates individually and in aggregate hold or control, directly or indirectly, less than 5% of the total issued share capital of any company (whose shares are listed on the Stock Exchange or any other stock exchange) which is engaged in any business that is or may be in competition with the Restricted Business engaged by the Group; and (b) they do not control 10% or more of the composition of the board of directors of such company. The above restrictions also do not apply to the business of any of our Controlling Shareholders and his/its close associates that (i) is different from or dissimilar to or does not compete with the Restricted Business; or (ii) was a Restricted Business but later no longer a Restricted Business.

For details of the Deed of Non-Competition, please refer to the section headed “Relationship with Our Controlling Shareholders – Deed of Non-Completion” in the Prospectus.

#### Annual Review

The Covenantors have confirmed that they did not refer, or procured the referral of, any investment or commercial opportunities relating to the Restricted Business to the Group during the year ended 31 December 2022.

The Company has received a written confirmation from each of the Covenantors in respect of the compliance by them and their close associates with the terms of the Deed of Non-Competition. The independent non-executive Directors have reviewed the Deed of Non-Competition and assessed whether the Covenantors and their close associates have complied with the terms of the Deed of Non-Competition, and were satisfied that each of the Covenantors has complied with its/his/her undertakings under the Deed of Non-Competition during the year ended 31 December 2022.

### CONTRACTUAL ARRANGEMENTS

We currently conduct our smart learning device service business through Zhuhai Readboy in the PRC. Our digital educational resources production and sales business, comprising the production of short-form animation courseware, offering of pre-recorded video resources held by us through our online platform and mobile apps and making available access to online free educational resources provided by third parties on our smart learning devices, is considered as value-added telecommunications services in the PRC. PRC laws and regulations generally restrict foreign ownership in value-added telecommunications services in the PRC and also impose qualification requirements on the foreign owners. Given that our business falls within the scope of “value-added telecommunications” which requires an ICP License to operate in the PRC, we cannot hold a direct controlling interest in Zhuhai Readboy, which holds the licenses and permits required for its business operations. Instead, to comply with the relevant PRC laws and regulations, we maintain effective control over Zhuhai Readboy and its business operations through Contractual Arrangements. For further details of the Contractual Arrangements and the foreign investment restrictions relating to the Contractual Arrangements, please refer to the section headed “Contractual Arrangements” in the Prospectus. For the year ended 31 December 2022 and up to the Latest Practicable Date, the Board has reviewed the overall performance of the Contractual Arrangements and confirmed that the Group has complied with the Contractual Arrangements in all material respects.

The Board confirmed that during 2022, save as disclosed in the Prospectus (please refer to the paragraph headed “Contractual Arrangements – PRC laws and regulations relating to foreign ownership restriction” in the Prospectus for details), there is no material change in the Contractual Arrangements and/or the circumstances under which they were adopted.

我們目前通過珠海讀書郎於中國開展智能學習設備服務業務。我們的數字化教輔資源製作及銷售業務(包括製作短篇動畫課件、通過我們的網絡平台及移動應用程序提供由我們講授的錄播視頻資源及在我們的智能學習設備上提供第三方提供的線上免費教輔資源的訪問權限)於中國被認為是增值電信業務。中國法律法規通常限制外資擁有權參與中國增值電信業務，並對外資擁有人提出資格規定。鑒於我們的業務屬於「增值電信」範疇，於中國的經營須取得ICP許可證，我們無法持有珠海讀書郎的直接控股權，而珠海讀書郎持有其業務運營所需的牌照及許可證。相反，為遵守相關中國法律及法規，我們透過合約安排保持對珠海讀書郎及其業務運營的有效控制。有關更多合約安排及有關合約安排的外商投資限制的詳情，請參閱招股章程「合約安排」一節。截至2022年12月31日止年度及直至最後實際可行日期，董事會已審閱合約安排的整體表現，並確認本集團已在所有重大方面均遵守合約安排。

董事會確認，於2022年年度，除招股章程(詳情請參閱招股章程「合約安排 — 有關外資擁有權限制的中國法律法規」一段)所披露者外，所採納的合約安排及/或相關情況概無發生重大變動。

Since the Listing Date and up to the Latest Practicable Date, there has been no update on the Foreign Investment Law (《中華人民共和國外商投資法》) (the “**FIL**”) and the relevant foreign investor qualification requirements, and the Company is not aware of any non-compliance of the Contractual Arrangements with the relevant PRC laws, rules and regulations (including but not limited to the FIL) and the Foreign Investment Regulation as stipulated under the paragraphs headed “Development in the PRC Legislation on Foreign Investment” in the Prospectus, and had not encountered interference or encumbrance from any governing bodies in operating our businesses through the PRC Operating Entity under the Contractual Arrangements. There have been no change in our plan and progress in acquiring the relevant experience to meet the qualification requirement; and the Company will continue to monitor the developments of the relevant laws, decision, regulations, rules and administration measures in this regard, and will make further announcements in respect thereof in accordance with the Listing Rules as and when necessary.

During 2022, there were no business or interest of each Director (including independent non-executive Directors) and his/her associates that competes or may compete with the business of the Group and any other conflicts of interests which have or may have with the Group, which were required to be discussed or reviewed by the Board.

The Contractual Arrangements which were in place during the year ended 31 December 2022 are as follows:

### (1) Exclusive Business Cooperation Agreement

Pursuant to the Exclusive Business Cooperation Agreement dated 23 March 2021 entered into by and between WFOE and the PRC Operating Entity, WFOE agrees to leverage its human, technical and information strengths to provide the PRC Operating Entity with the relevant exclusive technical services, technical consultation, and other services.

### (2) Exclusive Call Option Agreement

Under the Exclusive Call Option Agreement dated 23 March 2021 entered into by and among WFOE, the PRC Operating Entity and the Registered Shareholders, the Registered Shareholders irrevocably and unconditionally agreed to grant WFOE or its designated third party an exclusive option to purchase all or part of the equity interests in the PRC Operating Entity held by the Registered Shareholders.

自上市日期起及直至最後實際可行日期，《中華人民共和國外商投資法》（「**外商投資法**」）及相關外國投資者資格規定並無任何更新，且本公司並不知悉合約安排有任何不遵守相關中國法律、規則及法規（包括但不限於外商投資法）以及外商投資條例（定義見招股章程「中國外商投資立法的發展」各段）的情況，且根據合約安排通過中國經營實體經營業務時亦無面臨任何管理機構的干擾或阻礙。我們招攬具備相關經驗人士以符合資格規定的方案及進展並無變動；本公司將繼續監察相關法律、決策、法規、規則及行政措施於此方面的發展，並於必要時根據上市規則就此作出進一步公告。

根據外商獨資企業與中國經營實體訂立的日期為2021年3月23日的獨家業務合作協議，外商獨資企業同意利用其人力、技術和信息優勢，向中國經營實體提供有關的獨家技術服務、技術諮詢及其他服務。

### (2) 獨家購買權協議

根據外商獨資企業、中國經營實體及登記股東訂立的日期為2021年3月23日的獨家購買權協議，登記股東不可撤回地無條件同意，授予外商獨資企業或其指定第三方獨家購買權，購買登記股東持有的中國經營實體全部或部分股權。



### (3) Equity Pledge Agreement

Pursuant to the equity pledge agreement dated 23 March 2021 entered into by and among the WFOE, the PRC Operating Entity and the Registered Shareholders, all of the Registered Shareholders' equity interests were pledged to the WFOE as a first priority charge to guarantee the performance of contractual obligations and the payment of outstanding debts under the Contractual Arrangements.

### (4) Shareholders' Powers of Attorney

Each of the Registered Shareholders has executed an irrevocable power of attorney dated on 23 March 2021, exclusively appointing WFOE, or any person designated by WFOE as his or her attorney-in-fact to appoint directors and vote on his or her behalf as set out under the Shareholders' Rights Entrustment Agreement.

### (5) Individual Shareholder Spouse Undertakings

Pursuant to the Individual Shareholder Spouse Undertakings dated on 23 March 2021, the spouse of each of the Registered Shareholders, has undertaken they have full knowledge and has consented unconditionally and irrevocably to the entering into of the Exclusive Business Cooperation Agreement, the Exclusive Call Option Agreement, the Shareholders' Rights Entrustment Agreement and the Equity Pledge Agreement signed by the Registered Shareholders and the WFOE.

### (6) Shareholders' Rights Entrustment Agreement

Pursuant to the Shareholders' Rights Entrustment Agreement, each of the Registered Shareholders has unconditionally and irrevocably authorize the WFOE, or directors of the WFOE's offshore parent company designated by the WFOE, or a liquidator or other successors who perform the duties of such directors to exercise all shareholder's rights as shareholders of the PRC Operating Entity.

No service fee was paid to WFOE pursuant to the Exclusive Management and Consultation Agreement for the year ended 31 December 2022.

The revenue and net loss of the Consolidated Affiliated Entities subject to the Contractual Arrangements amounted to approximately RMB5.1 million and RMB10.9 million for the year ended 31 December 2022, respectively. The total assets and total liabilities of the Consolidated Affiliated Entities subject to the Contractual Arrangements amounted to approximately RMB11.5 million and RMB8.8 million as at 31 December 2022, respectively.

### (3) 股權質押協議

根據外商獨資企業、中國經營實體及登記股東訂立的日期為2021年3月23日的股權質押協議，所有登記股東以第一順位優先質押的方式質押股權給外商獨資企業，作為履行合同義務及支付合約安排項下未償還債務的擔保。

根據日期為2021年3月23日的個人股東配偶承諾函，各登記股東的配偶已承諾，彼等已完全知曉且同意無條件並不可撤銷地訂立登記股東與外商獨資企業簽署的獨家業務合作協議、獨家購買權協議、股東表決權委託協議及股權質押協。

### (6) 股東表決權委託協議

根據股東表決權委託協議，各登記股東無條件並不可撤銷地授權外商獨資企業或授權外商獨資企業指定的外商獨資企業境外母公司的董事或代行該等董事職責的清盤人或其他繼任人行使其作為中國經營實體的股東的全部股東權利。

截至2022年12月31日止年度，並無根據獨家管理諮詢協議向外商獨資企業支付服務費。

## CONNECTED TRANSACTION

### Zhuhai Dreamcatcher

Zhuhai Dreamcatcher and Readboy Technology entered into a share transfer agreement (the “**Share Transfer Agreement**”) on 2 November 2022, pursuant to which Readboy Technology agreed to purchase, and Zhuhai Dreamcatcher agreed to sell the 2,290,909 shares of the Guangzhou OED, representing approximately 2.81% of its issued shares with the consideration of RMB28.0 million. The consideration will be paid in cash and funded by the net proceeds from the Global Offering earmarked for strategic investments and/or acquisitions in optimizing the products and service offerings of the Group and settled in full by no later than 30 November 2022 by Readboy Technology.

As one of the major products of the Group is personal student tablets and Guangzhou OED specialises in e-Paper display technologies and their associated products with eyesight protection function, which are commonly applied to tablets and hence would complement well with the Group's personal student tablets. To respond to and support the PRC government policies on eyesight protection of the youths in the recent years, the Group intends to adopt and integrate Guangzhou OED's relevant display technologies and products to the Group's personal student tablets in the future.

As Zhuhai Dreamcatcher is held as to 51.02% by Mr. Chen (one of the Controlling Shareholders and a non-executive Director of the Company) and 48.98% by Mr. Qin (one of the Controlling Shareholders, an executive Director, chairman of the Board and the chief executive officer of the Company), Zhuhai Dreamcatcher is a connected person of the Company pursuant to Rule 14A.07(4) of the Listing Rules. Accordingly, the Share Transfer Agreement and the transaction contemplated thereunder constitute a connected transaction of the Company under Chapter 14A of the Listing Rules.

珠海市追夢與讀書郎科技於2022年11月2日訂立股份轉讓協議（「**股份轉讓協議**」），據此，讀書郎科技同意購買及珠海市追夢同意出售廣州奧翼2,290,909股股份（相當於其已發行股份的約2.81%），代價為人民幣28.0百萬元。代價將以現金支付並由全球發售所得款項淨額（專門用於戰略投資及／或收購以優化本集團提供的產品及服務）撥付且須不遲於2022年11月30日由讀書郎科技悉數支付。

由於本集團的主要產品之一為學生個人平板而廣州奧翼專門從事電子紙顯示技術，其相關產品具有護眼功能，可普遍用於平板，故與本集團學生個人平板相輔相成。為響應及支持中國政府近年來保護青少年視力的政策，本集團有意於未來將廣州奧翼的相關顯示技術及產品應用並整合至本集團的學生個人平板。

由於珠海市追夢乃由陳先生（本公司其中一名控股股東及非執行董事）及秦先生（本公司其中一名控股股東、執行董事、董事會主席及首席執行官）分別持有51.02%及48.98%，故根據上市規則第14A.07(4)條，珠海市追夢為本公司之關連人士。因此，根據上市規則第14A章，股份轉讓協議及其項下擬進行之交易構成本公司的關連交易。

Our operations and future financial results could be materially and adversely affected by various risks. The following highlights the principal risks that the Group is susceptible to and is not meant to be exhaustive:

- PRC education industry is currently subject to evolving regulatory and policy changes. Uncertainties with respect to the PRC legal system, especially the education related laws and regulations, could have a material adverse effect on us and limit the legal protection available to investors.
- Our business depends heavily on the strength of our brand awareness and reputation, and end users' recognition and their trust in our smart learning devices may be materially and adversely affected if we fail to maintain and enhance our brand and reputation.
- We may not be able to launch and diversify new products and educational resources to adapt to changing customer demands in a timely manner.
- We depend on our dedicated and capable educational resource research and development crew and other research staff, and if we are not able to continue to hire, train and retain such qualified staff, we may not be able to maintain consistent quality of our courseware, pre-recorded video resources and other digital educational resources. As such, our brand, business and operating results may be materially and adversely affected.
- Our development strategies may not achieve the expected goals in the near term, or at all.
- We may not be able to successfully expand and strengthen our distribution network.
- Our nationwide offline distribution network consists primarily of points of sales that are controlled by independent third-party distributors. Our results of operations are significantly subject to the performance of such points of sales. We may not be able to effectively control and monitor their operations or maintain our current relationship with the distributors.

### CORPORATE GOVERNANCE

Principal corporate governance practices adopted by the Company are set out in the section headed "Corporate Governance Report" in this annual report.

### KEY RELATIONSHIPS WITH EMPLOYEES, CUSTOMERS AND SUPPLIERS

The Group is committed to establishing a close and caring relationship with its employees, providing quality services and products to its customers and enhancing cooperation with its business partners. The Group understands that it is important to maintain good relationship with customers and provide the products in a way that satisfies needs and requirements of the customers. The Group is also dedicated to developing good relationship with suppliers as long-term business partners to ensure stability of the Group's business. The Group provides a fair and safe workplace, promotes diversity to its staff, competitive remuneration and benefits and career development opportunities based on their merits and performance.

### EMPLOYEE AND REMUNERATION POLICY

As at 31 December 2022, the Group employed a total of 553 employees (as at 31 December 2021: 574 employees). For the year ended 31 December 2022, the staff cost recognised of the Group amounted to approximately RMB70.1 million (for the year ended 31 December 2021: approximately RMB75.8 million).

The remuneration policy of the Group is to provide remuneration packages including salary, bonuses and various allowances, so as to attract and retain top quality staff. In general, the Group determines employee salaries based on each employee's qualifications, position and seniority. The Group has designed a periodical review system to assess the performance of its employees, which forms the basis of the determination on salary rises, bonuses and promotions. As required by PRC regulations, the Group makes contributions to mandatory social security funds for the benefit of the Group's PRC employees that provide for pension insurance, medical insurance, unemployment insurance, personal injury insurance, maternity insurance and housing funds.

Furthermore, the Group has implemented systematic, specialty-focused vocational training programs for its employees at different levels on a regular basis to meet different requirements and emphasise individual initiative and responsibility. The Group believes that these initiatives have contributed to increased employee productivity.

The Group's employees do not negotiate their terms of employment through any labor union or by way of collective bargaining agreements. During the year ended 31 December 2022, no labor dispute had occurred which materially and adversely affected or was likely to have a material and adverse effect on the operations of the Group.

本集團的薪酬政策旨在提供薪酬方案，包括薪金、花紅及多項津貼，以吸納及挽留優質員工。一般而言，本集團按各僱員的資質、職位及資歷釐定僱員薪金。本集團已設立定期評審制度評估僱員的表現，評估結果即為釐定薪金升幅、花紅及晉升的依據。按中國法規所規定，本集團為本集團的中國僱員利益向養老保險、醫療保險、失業保險、工傷保險、生育保險及住房公積金等強制性社會保障基金供款。

此外，本集團已定期為不同水平的僱員實施有系統且專門的職業培訓計劃以滿足不同的要求，並重視個人的主動性及責任感。本集團相信，該等措施有助提升僱員工作效率。

### ENVIRONMENTAL, SOCIAL AND GOVERNANCE

#### Environmental Protection

The Group recognize the importance of environmental protection and sustainability, and our commitment to environmental protection and sustainability was recognized by ISO14001:2015 — Environmental Management System Certification.

As at 31 December 2022, the Group did not have any non-compliance incidents arising from waste and water emission and the discharge of each of the key pollutants generated during our production process had remained within prescribed regulatory limits. In addition, our production and assembly facility has obtained the required permits for waste and water emission from the relevant authorities. We believe that our business operations do not have a material adverse impact on the environment.

#### Social Responsibility

The Group has been actively participating in social causes. In the year of 2020, we have proactively participated in various local governments' campaigns in response to the COVID-19 outbreak. We took the initiative to provide free courseware and learning resources to students to facilitate learning at home when school classes were suspended during the pandemic. Due to our efforts in connection with fulfilling our social responsibilities, we were awarded the title of "2020 Enterprise with Outstanding Contributions to Anti-epidemic" (2020抗疫傑出貢獻企業) granted by the Organizing Committee of the 10th China Charity Festival (第十屆中國公益節組委會).

#### Occupational Health and Safety

The Group has implemented stringent work safety policies and procedures for our production and assembly processes, including fire safety, work-related injuries, electricity safety and emergency and evacuation procedures. We provide our employees with occupational safety education and training to enhance their awareness of safety issues. We also carry out equipment maintenance on a regular basis to ensure their smooth and safe operation. We have implemented stringent waste treatment procedures in our production and assembly facility.

During the year ended 31 December 2022, the Group had complied with applicable laws and regulations on occupational health and work safety in all material respects and did not record any material accidents. As at the year ended 31 December 2022, no material claims had been brought against us as a result of an accident.

### SUFFICIENCY OF PUBLIC FLOAT

Rule 8.08 of the Listing Rules requires there to be an open market in the securities for which listing is sought and a sufficient public float of an issuer's listed securities to be maintained. This normally means that at least 25% of the issuer's total issued share capital must at all times be held by the public.

Based on the information that is publicly available to the Company and to the knowledge of the Directors as at the Latest Practicable Date prior to the issue of this annual report, the Company has maintained a sufficient public float as required under the Listing Rules.

To the best knowledge of the Directors, save as the deviation disclosed below, the Company has complied with all the principles and the applicable code provisions under Part 2 of the CG Code during the year ended 31 December 2022 and up to the date of this annual report.

The Directors will use their best endeavors to procure the Company to continue to comply with the CG Code.

### THE BOARD

#### 1. Responsibilities

The Board assumes the responsibility of leadership and control of the Company, and supervises and approves significant decisions regarding financial performance, strategic development objectives and operations of the Company. The Board delegates to the management authority and responsibility for the Company's daily operations and businesses management according to the Board's instructions. The Board has established various committees and has delegated to the audit committee (the “**Audit Committee**”), the remuneration committee (the “**Remuneration Committee**”), the nomination committee (the “**Nomination Committee**”), the environmental, social and governance committee (the “**ESG Committee**”) of the Board (collectively, the “**Board Committees**”) various duties. All the Board Committees perform their distinct roles in accordance with their respective terms of reference.

All Directors shall at all times ensure that they carry out duties in good faith, in compliance with applicable laws and regulations, and in the interests of the Company and the Shareholders.

The Board has established mechanisms to ensure independent views and input from any Director of the Company are conveyed to the Board for enhancing an objective and effective decision making. The governance framework and the following mechanisms are reviewed annually by the Board, through its Nomination and Remuneration Committee, to ensure their effectiveness:

1. Three out of the eight Directors are Independent Non-Executive Directors, which meets the requirements of the Listing Rules that the Board must have at least three Independent Non-Executive Directors and must appoint Independent Non-Executive Directors representing at least one-third of the Board.
2. The Nomination Committee and Remuneration Committee will assess the independence, qualification and time commitment of a candidate who is nominated to be a new Independent Non-Executive Director before appointment and also the continued independence of existing independent non-executive Directors and their time commitments annually. On an annual basis, all independent non-executive Directors are required to confirm in writing their compliance of independence requirements pursuant to Rule 3.13 of the Listing Rules, and to disclose the number and nature of offices held by them in public companies or organisations and other significant commitments.

### 董事會

#### 1. 責任

currently do not propose to separate the functions of chairman and chief executive officer. While this would constitute a deviation from Code Provision C.2.1 of Part 2 of the CG Code, the Board believes that this structure will not impair the balance of power and authority between the Board and the management of our Company, given that: (i) there are sufficient checks and balances in the Board, as a decision to be made by our Board requires approval by at least a majority of our Directors, and our Board comprises three independent non-executive Directors, which is in compliance with the requirement under the Listing Rules; (ii) Mr. Qin and the other Directors are aware of and undertake to fulfill their fiduciary duties as Directors, which require, among other things, that he acts for the benefit and in the best interests of our Company and will make decisions for our Group accordingly; and (iii) the balance of power and authority is ensured by the operations of the Board which comprises experienced and high caliber individuals who meet regularly to discuss issues affecting the operations of our Company. Moreover, the overall strategic and other key business, financial, and operational policies of our Group are made collectively after thorough discussion at both Board and senior management levels.

The Board will continue to review the effectiveness of the corporate governance structure of our Group in order to assess whether separation of the roles of chairman of the Board and chief executive is necessary.

During the year ended 31 December 2022, the Board at all times met the requirements of the Listing Rules relating to the appointment of at least three independent non-executive Directors representing at least one-third of the Board and at least one independent non-executive Director with appropriate professional qualifications, or accounting or related financial management expertise.

The Company has received written annual confirmation from each of our independent non-executive Directors of his or her independence pursuant to the requirements of the Listing Rules. The Company considers all the independent non-executive Directors to be independent in accordance with the independence requirements set out in the Listing Rules.

### Appointment, Re-election and Removal of Directors

The procedures and process of appointment, re-election and removal of the Directors are laid down in the Articles of Association. The primary duties of the Nomination Committee include, but are not limited to, reviewing the structure, size and composition of the Board, assessing the independence of the independent non-executive Directors and making recommendations to the Board on matters relating to the appointment of the Directors.

Each of the executive Directors has entered into a service contract with the Company, under which they agreed to act as executive Directors for an initial term of three years commencing from 12 July 2022 and will continue thereafter until terminated by not less than three months' written notice in writing served by either of the Director or the Company at any time.

Each of the non-executive Directors and independent non-executive Directors has entered into a letter of appointment with the Company.

Each of the non-executive Director (including the independent non-executive Directors) is appointed with an initial term of three years commencing from 12 July 2022 subject to termination in certain circumstances as stipulated in the relevant letters of appointment.

In accordance with the Articles of Association, all of the Directors are subject to retirement by rotation at least once every three years and the Board has power from time to time and at any time to appoint any new Director to fill a causal vacancy or as an addition to the Board. Any Director so appointed shall hold office until the next following annual general meeting of the Company and shall then be eligible for re-election at that meeting.

### Induction and Continuing Development for Directors

Each newly appointed Director receives formal, comprehensive and tailored induction on the first occasion of his or her appointment, so as to ensure that he or she understands the business and operations of the Company and that he or she is fully aware of his or her responsibilities and obligations under the Listing Rules and other relevant regulatory requirements.

The Directors are continually provided with information relating to the developments in the legal and regulatory regime and the business and market environments to facilitate the execution of their responsibilities. Continuing briefings and professional development for the Directors were arranged by the Company and its professional advisers.

### *Practices and Conduct of Meetings*

Notices of regular board meetings are served to all of the Directors at least 14 days before the meetings to provide all Directors with an opportunity to attend and include matters in the agenda. For other board and committee meetings, reasonable notices were generally given.

Board papers together with all appropriate, complete and reliable information were sent to all of the Directors at least three days before each Board meeting or committee meeting to keep the Directors apprised of the latest developments and financial position of the Company and to enable them to make informed decisions. When Directors or committee members are unable to attend a meeting, they will be advised of the matters to be discussed and given an opportunity to make their views known to the chairman of the Board or the committee members prior to the meeting.

Each Director also had separate and independent access to the senior management of the Company whenever necessary.

The senior management of the Company attend all regular board meetings and where necessary, other Board and committee meetings, to advise on business developments, financial and accounting matters, statutory and regulatory compliance, corporate governance policy and other major aspects of the Company.

The joint company secretaries are responsible for taking and keeping minutes of all board meetings and committee meetings. Draft minutes are normally circulated to the Directors for comment within a reasonable time after each meeting and the final version is open for the Directors' inspection.

### *會議常規及指引*

The Company has established the Audit Committee, the Remuneration Committee, the Nomination Committee and the ESG Committee. Each of these committees has specific written terms of reference which deal clearly with their authority and duties. The chairmen of these committees will report their findings and recommendations to the Board after each meeting.

#### 1. Audit Committee

The Company has established the Audit Committee with written terms of reference in compliance with the CG Code as set out in Appendix 14 to the Listing Rules. The primary duties of the Audit Committee are to review and supervise our financial reporting process and internal control system of the Company, oversee the audit process, provide advice and comments to the Board and perform other duties and responsibilities as may be assigned by the Board.

The Audit Committee consists of two independent non-executive Directors, namely Mr. Li Xinshou, Ms. Kong Fanhua and one non-executive director, namely Mr. Chen Zhiyong. The chairman of the Audit Committee is Mr. Li Xinshou who possesses appropriate accounting and related financial management expertise.

The primary duties of the Audit Committee comprise communication, supervision and verification work for internal and external auditors of the Company, including:

- to propose the appointment, re-appointment or replacement of external auditor, to provide advice to the Board, to approve the remuneration and engagement terms of external auditor;
- to review and monitor external auditor to see if it is independent and objective and whether its auditing process is effective, to discuss the nature, scope and method of auditing and the relevant reporting responsibilities with the audit institution prior to the commencement of audit work, to formulate and implement policies for engaging external auditor to provide non-audit services;
- to supervise the internal audit system of the Company and its implementation, to review financial information of the Company and its disclosure;

The Remuneration Committee consists of two independent non-executive Directors, namely Ms. Kong Fanhua, Mr. Li Xinshou and one non-executive director, namely Mr. Chen Zhiyong. The chairlady of the Remuneration Committee is Ms. Kong Fanhua.

The primary duties of the Remuneration Committee are to formulate appraisal standards and conduct appraisals for Directors and senior management of the Company, and to formulate and review the remuneration policies and proposals for Directors and senior management of the Company. The details are as follows:

The Nomination Policy was approved and adopted by the Board on 21 June 2022 for evaluating and selecting any candidate for directorship. The Nomination Committee would consider the following criteria, including, among other things, character and integrity, qualifications (cultural and educational background, professional qualifications, skills, knowledge and experience and diversity aspects under the Board Diversity Policy), any potential contributions the candidate can bring to the Board in terms of qualifications, skills, experience, independence and diversity, and willingness and ability to devote adequate time to discharge duties as a member of the Board and/or Board committee(s).

The Nomination Committee and/or the Board should, upon receipt of the proposal on appointment of new Director and the biographical information (or relevant details) of the candidate, evaluate such candidate based on the criteria as set out above to determine whether such candidate is qualified for directorship. The Nomination Committee should then recommend to the Board to appoint the appropriate candidate for directorship with a ranking of the candidates (if applicable) by order of preference based on the needs of the Company and reference check of each candidate.

### Board Diversity Policy

In order to enhance the effectiveness of the Board and to maintain the high standard of corporate governance, the Company has adopted the board diversity policy which sets out the objective and approach to achieve and maintain diversity of the Board. Pursuant to the board diversity policy, the Company seeks to achieve Board diversity through the consideration of a number of factors when selecting the candidates to the Board, including but not limited to gender, skills, age, professional experience, knowledge, cultural, education background, ethnicity and length of service. The ultimate decision of the appointment will be based on merit and the contribution which the selected candidates will bring to the Board.

The Directors have a balanced mix of knowledge and skills, including overall management and strategic development, human resources, information technology, accounting and financial management, risk management, corporate governance and evaluation of properties and assets. They obtained degrees in various majors including accounting, software engineering, electronics physics technology, mechanical technology manufacture and equipment, statics planning and infrastructure, constitutional and administrative law, and public affairs management. The Board has three independent non-executive Directors with different industry backgrounds, representing more than one third of the members of the Board. Furthermore, the Board has a wide range of age, ranging from 36 years old to 67 years old. Taking into account our existing business model and specific needs as well as the different background of our Directors, the composition of the Board satisfies our board diversity policy.

As at 31 December 2022, the Board comprises nine Directors, two of which are female and as such has achieved gender diversity in respect of the Board. We will continue to strive to enhance female representation and achieve an appropriate balance of gender diversity with reference to the shareholders' expectation and international and local recommended best practices. We will also ensure that there is gender diversity when recruiting staff at mid to senior level and we are committed to provide career development opportunities for female staff so that we will have a pipeline of female senior management and potential successors to our Board in near future.

As at 31 December 2022, the Company had 553 employees, of which the number of male and female employees are 290 and 263, respectively (accounted for 52.44% and 47.56% respectively).

### 董事會多元化政策

7. general economic conditions, business cycle of the Group's business and other internal or external factors that may have an impact on the business or financial performance and position of the Group; and
8. other factors that the Board deems relevant.

The Directors consider that the consolidated financial statements of the Company for the year ended 31 December 2022 have been prepared in conformity with all applicable accounting standards and requirements and reflect amounts that are based on the best estimates and reasonable, informed and prudent judgment of the Board and the management or supplement disclosure on any material uncertainties matters. The Directors are not aware of any material uncertainties relating to events or conditions which may cast significant doubt upon the Company's ability to continue as a going concern. Accordingly, the Directors have prepared the financial statements of the Company on a going concern basis. The statements of the auditor of the Company about its reporting responsibility on the consolidated financial statements of the Company are set out in the section headed "Independent Auditor's Report" in this annual report.

### INTERNAL CONTROLS AND RISK MANAGEMENT

#### Risk Management and Internal Control System

During the reporting year, the Group has complied with Code D.2 of the Part 2 of the CG Code through the establishment of an appropriate and effective risk management and internal control system. Management is responsible for the design, implementation and monitoring of such system and the Board continuously monitors the performance of management in discharging its responsibilities by the internal control staff of the Group to review the Group's risk management and internal control system for the year. The review procedures performed by the internal control staff of the Group include reviewing the existing risk management and internal control system, assessing the adequacy of material internal controls for the Group, including financial, operational and compliance controls and reporting key risk information and internal control findings to the Board and management, and the management has reported the internal control findings and risk assessment results identified by the internal control staff of the Group to the Board and has implemented an action plan and will provide the Board with regular updates on the remediation progress.

### Reviewing the Effectiveness of Risk Management and Internal Control System

The Board acknowledged that it has the responsibility for the risk management and internal control systems and reviewing their effectiveness and such systems are designed to manage rather than eliminate the risk of failure to achieve business objectives, and can only provide reasonable and not absolute assurance against material misstatement or loss. During the reporting year, the Board has conducted a review of the Group's risk management and internal control system, including but not limited to (i) changes in the nature and extent of significant risks and the Company's ability to respond to changes in its business and external environment, (ii) the scope and quality of management's continuing oversight of the risk and internal control system, (iii) communication of oversight results with the Board and the Audit Committee to assess the scope and frequency of the effectiveness of the Company's control and risk management, (iv) significant control deficiencies or weaknesses identified, and (v) the effectiveness of the Company's financial reporting process and compliance with the Listing Rules, and (vi) review of the risk management and internal control reviews conducted by the internal control staff of the Group during the year.

Based on the above review, the Board is of the opinion that the Group's risk management and internal control system are effective and adequate and no material issues have been identified that may have an impact on the financial controls, operational controls, compliance controls and risk management functions of the Group. In addition, the Board also considers that the resources, staff qualifications and experience, training courses and budget of the Company's accounting, compliance, legal and financial reporting functions were adequate and effective during the reporting year.

### USE OF PROCEEDS FROM THE GLOBAL OFFERING

The Company's Shares have been listed on the Stock Exchange since the Listing Date.

Net proceeds from the Global Offering received by the Company were approximately HKD364.6 million with 52,000,000 new ordinary Shares issued at the price of HKD7.6 per Share. The total amount of net proceeds from the Global Offering are proposed to be used for the purposes and in the amounts (adjusted on pro rata basis based on the actual net proceeds) as disclosed in the Prospectus as follows:

### INSIDE INFORMATION

With respect to procedures and internal controls for the handling and dissemination of inside information, the Company takes seriously of its obligations under the new Part XIVA of the SFO and the Listing Rules. The Company has adopted a continuous disclosure compliance policy which sets out guidelines and procedures to the Directors and officers of the Group to ensure inside information of the Group is to be disseminated to the public in equal and timely manner. Briefing session is held regularly for officers to facilitate their understanding and compliance with the policy.

### INVESTOR RELATIONS

#### General Meetings and Shareholders' Rights

The Company shall in each year hold a general meeting as its annual general meeting in addition to any other meetings in that year and shall specify the meetings as such in the notices calling them. The extraordinary general meetings are convened irregularly.

In accordance with the Articles of Association, an extraordinary general meeting shall be convened either by the Board or on the requisition of one or more Shareholders holding, at the date of deposit of the requisition, not less than one tenth of the paid up capital of the Company having the right of voting at general meetings. Such requisition shall be made in writing to the Board or any one of the joint company secretaries for the purpose of requiring an extraordinary general meeting to be called by the Board for the transaction of any business specified in such requisition. Such meeting shall be held within two months after the deposit of such requisition. If within 21 days of such deposit, the Board fails to proceed to convene such meeting, the requisitionist(s) himself (themselves) may do so in the same manner, and all reasonable expenses incurred by the requisitionist(s) as a result of the failure of the Board shall be reimbursed to the requisitionist(s) by the Company.

There are no provisions in the Articles of Association or in the Companies Act of the Cayman Islands for putting forward proposals of new resolutions by Shareholders at general meetings. Shareholder(s) who wish to move a resolution may request the Company to convene an extraordinary general meeting in accordance with the procedures set out in the preceding paragraph. For proposing a person for election as a Director, please refer to the "Procedures for Shareholders to propose a Director" posted on the Company's website.

#### 4. 授出購股權

##### (a) 提呈要約

向合資格參與者提呈要約，須以董事會不時釐定形式的要約文件（「**要約文件**」）作出，要求參與者承諾根據授出購股權的條款持有購股權並受購股權計劃的條文約束。

An option shall be deemed to have been granted to (subject to certain restrictions in the Share Option Scheme), and accepted by, the Eligible Participant (the “**Grantee**”) and to have taken effect upon the issue of an option certificate after the duplicate Offer Document constituting acceptance of the option duly signed by the Grantee, together with a remittance in favor of our Company of HKD1.00 by way of consideration for the grant of the option is received by our Company on or before the last day for acceptance set out in the Offer Document. The remittance is not in any circumstances refundable and shall be deemed as part payment of the Exercise Price (as defined below). Once accepted, the option is granted as from the date on which it was offered to the Grantee (the “**Offer Date**”).

### (c) Restrictions on time of grant

No grant of options shall be made after any inside information has come to the knowledge of our Company until such inside information has been announced pursuant to the requirements of the Listing Rules. In particular, no option shall be granted during the period of one month immediately preceding the earlier of: (i) the date of our Board meeting as shall have been notified to the Stock Exchange for the approval of our Company's results for any year, half-year, quarterly or any other interim period (whether or not required under the Listing Rules); and (ii) the deadline for our Company to publish an announcement of its results for any year or half-year under the Listing Rules or quarterly or any other interim period (whether or not required under the Listing Rules), and ending on the actual date of the results announcement for such year, half year, quarterly or interim period (as the case may be). The period during which no option may be granted will cover any period of delay in the publication of a results announcement.

### (b) 接納要約

在本公司於要約文件所載的最後接納日期或之前接獲要約文件副本(包括由承授人正式簽署的購股權接納文件)連同作為授出購股權對價以本公司為受款人的1.00港元匯款後，購股權應被視為已授予(受購股權計劃若干限制的規限)合資格參與者(「承授人」)並獲其接受，且於簽發購股權證書時視作已生效。有關匯款在任何情況下概不退還，且應視為行使價(定義見下文)的部分付款。一經接納，購股權即自提呈要約之日(「要約日期」)起授予相關承授人。

### (c) 授出時間的限制

### *(d) Grant to connected persons*

Any grant of options to a connected person must be approved by all independent non-executive Directors (excluding any independent non-executive Director who is also a proposed Grantee (as defined above) of the options, the vote of such independent non-executive Director shall not be counted for the purposes of approving the grant).

### *(e) Grant to substantial shareholders and independent non-executive directors*

Without prejudice to sub-paragraph 4(c) above, any grant of options to a substantial shareholder or an independent non-executive Director of our Company or any of their respective associates shall be subject to, in addition to the approval of our independent non-executive Directors in sub-paragraph (d) above, the issue of a circular by our Company to its Shareholders and the approval of our Shareholders in general meeting if our Shares issued and to be issued upon exercise of all options already granted and proposed to be granted to him (whether exercised, canceled or outstanding) under the Share Option Scheme or any other scheme in the twelve (12) month period up to and including the Offer Date:

在上市規則規定的上市發行人董事進行證券交易的標準守則或本公司所採納的任何相應守則或證券買賣限制規定禁止董事買賣股份的期間或時限內，董事不得向該等身為董事的參與人士授出任何購股權。

### *(d) 授予關連人士*

向關連人士授出任何購股權必須經全體獨立非執行董事(不包括同時身為購股權建議承授人(定義見上文)的任何獨立非執行董事，且該獨立非執行董事的投票不得計入批准該項授出的票數當中)批准。

### *(e) 授予主要股東及獨立非執行董事*

在不損害上文第4(c)分段的情況下，倘於截至要約日期(包括該日)止十二(12)個月期間內，因購股權計劃或任何其他計劃項下的所有已授出及建議授出的購股權(包括已行使、已註銷或尚未行使的購股權)獲行使後已發行及將予發行的股份滿足以下條件，則向本公司主要股東或獨立非執行董事或彼等各自的任何聯繫人授出任何購股權，除必須獲得上文第(d)分段獨立非執行董事的批准外，本公司亦須向其股東寄發通函並在股東大會上獲得股東批准：

### *(f) Proceedings in general meeting to approve the grant of option*

At the general meeting to approve the proposed grant of options under sub-paragraph 4(e) above, the Grantee, his associates and all core connected persons of our Company must abstain from voting. At such general meeting, the vote to approve the grant of such options must be taken on a poll in accordance with the Articles and the relevant provisions of the Listing Rules.

### *(g) Performance target*

Our Board has the discretion to require a particular Grantee to achieve certain performance targets specified at the time of grant before any option granted under the Share Option Scheme can be exercised. There is no specific performance targets stipulated under the terms of the Share Option Scheme and our Board currently has no intention to set any specific performance targets on the exercise of any options granted or to be granted under the Share Option Scheme.

The price per Share at which a Grantee may subscribe for Shares upon exercise of an option (the “**Exercise Price**”) shall, subject to any adjustment pursuant to paragraph 7 below, be determined by our Board in its sole discretion but in any event shall be at least the highest of:

- (i) the official closing price of our Shares as stated in the Stock Exchange’s daily quotations sheets on the Offer Date;

承授人因行使購股權而認購股份的每股股份價格(「**行使價**」)應由董事會全權酌情釐定，可以根據下文第7段進行任何調整，惟在任何情況下不得低於以下最高者：

- (i) 要約日期聯交所每日報價表所列股份的官方收市價；
- (ii) 緊接要約日期前五個營業日，聯交所每日報價表所列股份的平均官方收市價；及
- (iii) 股份的賬面值；惟就根據上文第5(ii)分段釐定行使價而言，倘要約日期前股份於聯交所上市少於五個營業日，則有關該上市的股份發行價應被視作股份於聯交所上市前期間內的各營業日的股份收市價。

### 6. Maximum number of Shares available for subscription

#### (a) Scheme limit

Subject to sub-paragraphs 6(b) and 6(c) below, the maximum number of Shares in respect of which options may be granted under the Share Option Scheme and any other Share Option Schemes of our Company shall not in aggregate exceed the number of Shares that shall represent 10% of the total number of Shares in issue immediately upon completion of the Global Offering and the Capitalization Issue (assuming that the Over-allotment Option is not exercised and without taking into account Shares that may be allotted and issued pursuant to the RSU Scheme and the Share Option Scheme) (the “**Scheme Limit**”) which is expected to be 35,200,000 Shares. For the purpose of calculating the Scheme Limit, options which have lapsed in accordance with the terms of the Share Option Scheme (or any other share option schemes of the Company) shall not be counted.

#### (b) Renewal of scheme limit

Our Company may seek approval by our Shareholders in general meeting for renewing the Scheme Limit provided that the total number of Shares in respect of which options may be granted under the Share Option Scheme and any other schemes of our Company under the Scheme Limit as renewed from time to time must not exceed 10% of the total number of Shares in issue as at the date of our Shareholders’ approval. Options previously granted under the Share Option Scheme, whether outstanding, canceled, lapsed in accordance with its applicable rules or already exercised, will not be counted for the purpose of calculating the limit as renewed.

For the purpose of seeking the approval of our Shareholders under this sub-paragraph 6(b), a circular containing the information required under Rule 17.02(2) of the Listing Rules and the disclaimer required under Rule 17.02(4) of the Listing Rules must be sent to our Shareholders.

### 6. 可供認購的最高股份數目

#### (a) 計劃限額

受下文第6(b)及6(c)分段所規限，與根據購股權計劃及本公司任何其他購股權計劃可能授出的購股權相關的最高股份數目，合共不得超過佔緊隨全球發售及資本化發行完成後已發行股份（假設超額配股權未獲行使及並未計及根據受限制股份單位計劃及購股權計劃而可能配發及發行的股份）總數10%的股份數目（「**計劃限額**」），而計劃限額預期為35,200,000股股份。就計算計劃限額而言，按照購股權計劃（或本公司任何其他購股權計劃）條款已失效的購股權不應計算在內。

#### (b) 更新計劃限額

本公司可於股東大會上尋求股東批准更新計劃限額，惟根據不時更新的計劃限額，有關因根據購股權計劃及本公司任何其他計劃而可能授予的購股權的股份總數，不得超過股東批准當日已發行股份總數的10%。就計算更新限額而言，先前根據購股權計劃授予的購股權（不論是按照其適用法規尚未行使、已註銷、失效還是已行使的購股權）將不被計算在內。

為尋求本6(b)分段下股東的批准，必須把載有上市規則第17.02(2)條所要求的資料及上市規則第17.02(4)條所要求的免責聲明的通函發送給股東。

### *(c) Grant of options beyond scheme limit*

Our Company may seek separate approval by our Shareholders in general meeting for granting options beyond the Scheme Limit provided that the options in excess of the Scheme Limit are granted only to Eligible Participants who are specifically identified by our Board before such approval is sought.

For the purpose of seeking the approval of our Shareholders under this sub-paragraph (6)(c), our Company must send a circular to our Shareholders containing a generic description of the specified Eligible Participants who may be granted such options, the number and terms of the options to be granted, the purpose of granting such options to the Grantees with an explanation as to how the terms of options serve such purpose and the information required under Rule 17.02(2)(d) of the Listing Rules and the disclaimer as required under Rule 17.02(4) of the Listing Rules.

### *(d) Maximum number of Shares issued pursuant to the Share Option Scheme*

Notwithstanding anything to the contrary in the Share Option Scheme, the maximum limit on the number of Shares which may be issued upon exercise of all outstanding options granted and yet to be exercised under the Share Option Scheme and any other schemes of our Company must not in aggregate exceed such number of Shares as shall represent 30% of our Shares in issue from time to time. No options may be granted under any schemes of our Company or subsidiaries if such grant will result in this 30% limit being exceeded.

### *(c) 授予超過計劃限額的購股權*

本公司可於股東大會上尋求股東另行批准授予超過計劃限額的購股權，惟超出計劃限額的購股權僅可授予於尋求該批准前董事會特別指定的合資格參與者。

為尋求本(6)(c)分段的股東的批准，本公司必須向股東發送載有可獲授予該等購股權的特定合資格參與者的一般描述、將授予的購股權的數目及條款、向承授人授予該等購股權的目的（附有購股權條款如何達到該目的之解釋）及上市規則第17.02(2)(d)條所要求的資料及上市規則第17.02(4)條所要求的免責聲明的通函。

### *(d) 根據購股權計劃發行的最高股份數目*

儘管有任何與購股權計劃相反的規定，根據購股權計劃及本公司任何其他計劃授出但尚未行使的全部尚未行使購股權獲行使而可予發行的最高股份數目，合共不得超過佔不時已發行股份30%的該等股份數目。若授予購股權將致使超過此30%限額，則不可根據本公司或子公司的任何計劃授予購股權。

Unless approved by our Shareholders in general meeting in the manner prescribed in the Listing Rules, our Board shall not grant options to any Grantee if the acceptance of those options would result in the total number of Shares issued and to be issued to that Grantee on exercise of his options during any twelve (12) month period up to the Offer Date exceed 1% of the total Shares then in issue.

Where any further grant of options to a Grantee, if exercised in full, would result in the total number of Shares already issued or to be issued upon exercise of all options granted and to be granted to such Grantee (including exercised, canceled and outstanding options) in any twelve (12) month period up to and including the date of such further grant exceed 1% of the total number of Shares in issue, such further grant must be separately approved by our Shareholders in general meeting with such Grantee and his close associates (or associates if the Grantee is a connected person) abstaining from voting. Our Company must send a circular to our Shareholders and the circular must disclose the identity of the Grantee, the number and terms of the options to be granted and options previously granted to such Grantee and the information required under Rule 17.02(2) of the Listing Rules and the disclaimer required under Rule 17.02(4) of the Listing Rules. The number and terms (including the Exercise Price) of the options to be granted to such Grantee must be fixed before our Shareholders' approval. The date of the meeting of our Board for proposing such further grant of option should be taken as the date of grant for the purpose of calculating the Exercise Price.

### (e) 承授人的最高持股量

若任何承授人接納董事會授出的購股權後於截至要約日期止任何十二(12)個月期間內因行使其購股權而使向承授人發行或將予發行的股份總數超過當時已發行股份總數的1%，則董事會不得向該承授人授出購股權，除非按照上市規則所述的方式在股東大會上獲得股東批准。

倘向承授人進一步授出任何購股權(如獲悉數行使)將導致於截至及包括有關進一步授出日期止任何十二(12)個月期間內因授予及將授予有關承授人的所有購股權(包括已行使、已註銷及尚未行使購股權)獲行使而已發行或將予發行的股份總數超過已發行股份總數的1%，則有關進一步授出須獲股東在股東大會上另行批准，而有關承授人及其緊密聯繫人(或倘承授人為關連人士，則為聯繫人)須放棄投票。本公司必須向股東發出一份通函，而該通函必須披露該承授人的身份、將授予及先前已授予該承授人的購股權數目及條款、上市規則第17.02(2)條所要求的資料及上市規則第17.02(4)條所要求的免責聲明。將授予該承授人的購股權數目及條款(包括行使價)必須在獲得股東批准前釐定。就計算行使價而言，提議進一步授出購股權的董事會會議日期應視為授出日期。

### 7. Rights attached to the Shares

Shares to be allotted upon exercise of an option will be subject to all the provisions of the Articles and will rank pari passu with the fully paid Shares in issue on the date of issue. Accordingly, such Shares will entitle the holders to have the same voting, dividend, transfer and other rights, and to participate in all dividends or other distributions paid or made on or after the date on which the allottee is registered as a member (the “**Registration Date**”) other than any dividends or other distributions previously declared or recommended or resolved to be paid or made with respect to a record date which is before the Registration Date.

A Share issued upon the exercise of an option shall not carry any voting rights until completion of registration of the Grantee or his nominee as the holder of such Share on the register of members of our Company. Shares issued on the exercise of an option shall not rank for any rights attaching to Shares by reference to a record date preceding the date of allotment.

### 8. Exercise of options

Unless otherwise provided in the respective Grantee’s Offer Document, an option may be exercised by a Grantee at any time or times during the period notified by our Board during which the Grantee may exercise his option(s) (the “**Option Period**”) provided that:

- (a) in the event of the Grantee ceasing to be an Eligible Participant for any reason other than his death, ill-health, injury, disability or the termination of his relationship with our Company and/or any of its subsidiaries on one or more of the grounds specified in sub-paragraph 12(v) below, the Grantee may exercise the option up to his entitlement at the date of cessation of being an Eligible Participant (to the extent not already exercised) within the period of thirty (30) days (or such longer period as our Board may determine) following the date of such cessation (which date shall be, in relation to a Grantee who is an Eligible Participant by reason of his employment with our Company or any of its subsidiaries, the last actual working day with our Company or the relevant subsidiary whether salary is paid in lieu of notice or not);

購股權獲行使時將予配發的股份須受細則的所有條文規限，並將與於發行日期已發行的繳足股份享有相同權益。因此，該等股份將賦予持有人相同的投票、收取股息、轉讓及其他權利，分享於承配人登記成為股東之日（「**登記日期**」）或之後所派付或作出的所有股息或其他分派，惟不包括先前所宣派或建議或決議將會派付或作出且其記錄日期早於登記日期的任何股息或其他分派。

- (d) if a compromise or arrangement between our Company and our Shareholders and/or creditors is proposed for the purposes of or in connection with a scheme for the reconstruction of our Company or its amalgamation with any other company or companies pursuant to the Companies Law, our Company shall give notice thereof to all the Grantees (together with a notice of the existence of the provisions of this paragraph) on the same day as it despatches to Shareholders and/or creditors of our Company a notice summoning the meeting to consider such a compromise or arrangement, and thereupon each Grantee shall be entitled to exercise all or any of his options in whole or in part at any time prior to noon (Hong Kong time) on the Business Day immediately preceding the date of the general meeting directed to be convened by the relevant court for the purposes of considering such compromise or arrangement and if there is more than one meeting for such purpose, the date of the first meeting. With effect from the date of such meeting, the rights of all Grantees to exercise their respective options shall forthwith be suspended. Upon such compromise or arrangement becoming effective, all options shall, to the extent that they have not been exercised, lapse and determine. Our Board shall endeavor to procure that our Shares issued as a result of the exercise of options in such circumstances shall for the purposes of such compromise or arrangement form part of the issued share capital of our Company on the effective date thereof and that such Shares shall in all respects be subject to such compromise or arrangement. - (e) in the event a notice is given by our Company to its shareholders to convene a general meeting for the purposes of considering, and if thought fit, approving a resolution to voluntarily wind-up our Company, our Company shall on the same date as or soon after it despatches such notice to each member of our Company give notice thereof to all Grantees and thereupon, each Grantee (or in the case of the death of the Grantee, his personal representative(s)) shall be entitled to exercise all or any of his options (to the extent not already lapsed or exercised) at any time not later than two Business Days prior to the proposed general meeting of our Company by giving notice in writing to our Company, accompanied by a remittance for the full amount of the aggregate Exercise Price for our Shares in respect of which the notice is given whereupon our Company shall as soon as possible and, in any event, no later than the Business Day immediately prior to the date of the proposed general meeting referred to above, allot and issue the relevant Shares to the Grantee credited as fully paid.

In order to create the long-term value, the Group actively integrates sustainable development into our daily operation. We conduct a top-down management approach to establish the decision-making level, organizational level and executive level related to ESG. Our ESG committee, led by three members of the Board and composed of the management, is responsible for assisting the Board in reviewing, evaluating and recommending ESG initiatives to be implemented by business units to achieve the stated goals and regularly reporting to the Board on ESG issues and the progress and performance of implemented measures. At the same time, the Group also organizes ESG-related training for the ESG committee from time to time. 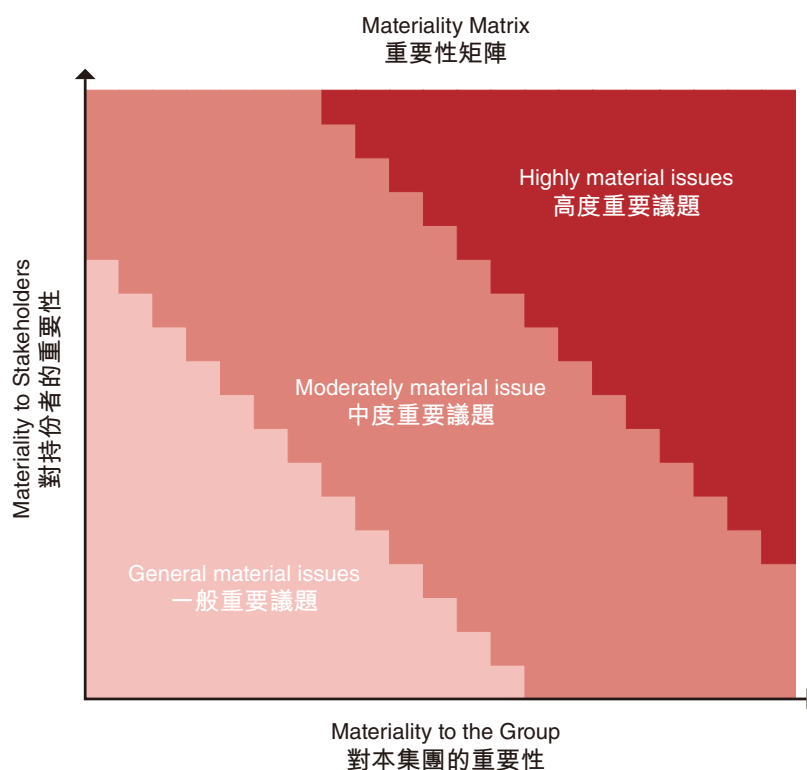

### 2.4 Materiality Assessment

In order to further determine the key areas of the Group's practice and disclosure in ESG work, we focused our reference on the important issue database of the disclosure obligation covered by the "Guidelines" of the Stock Exchange, and conducted peer benchmarking to consider common material issues in the industry. After comparing the ubiquity of issues among peers and the Group's operating conditions, 20 material issues applicable to the Group's business were finally summarized, including 17 highly material issues, 1 moderately material issue and 2 generally material issues. The prioritization of material issues for the Year has been confirmed by the Board of Directors. This report will focus on the following topics to reflect our contribution to ESG work.

### 2.4 重要性評估

### 3. PRODUCT LIABILITY

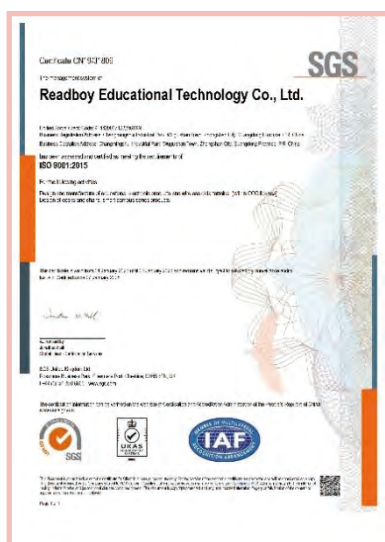
#### 3.1 Product Quality Management

The Group is committed to being user-oriented and constantly improving the quality management system in order to create high-quality products. The Group strictly abides by laws and regulations related to product liability, such as the Law on the Protection of the Rights and Interests of Consumers of the PRC (《中華人民共和國消費者權益保護法》) and the Product Quality Law of the People's Republic of China (《中華人民共和國產品質量法》), and strictly controls the quality of products throughout their life cycle. At the same time, referring to the management methods and requirements of the ISO9001:2015 quality management system, the Group has established the “Quality Manual” (《質量手冊》) and a series of quality control program documents to manage and monitor product quality and safety. During the Year, we passed the ISO9001 quality management system certification, and all product models obtained the “China Compulsory Product Certification” (“3C”) quality assurance certificate.

### 3. 產品責任

#### 3.1 產品質量管理

本集團致力於以用戶為導向，不斷完善質量管理體系，以打造高質量的產品。本集團嚴格遵守《中華人民共和國消費者權益保護法》及《中華人民共和國產品質量法》等有關產品責任的法律法規，嚴格把控產品全生命周期的質量。同時，本集團參照ISO9001:2015質量管理體系的管理方法及要求，建立《質量手冊》及一系列質量控制程序文件，以管理及監察產品質量及安全。本年度，我們已通過ISO9001質量管理體系認證，而且所有產品型號皆獲得「中國強制性產品認證」(「3C」)質量保證證書。



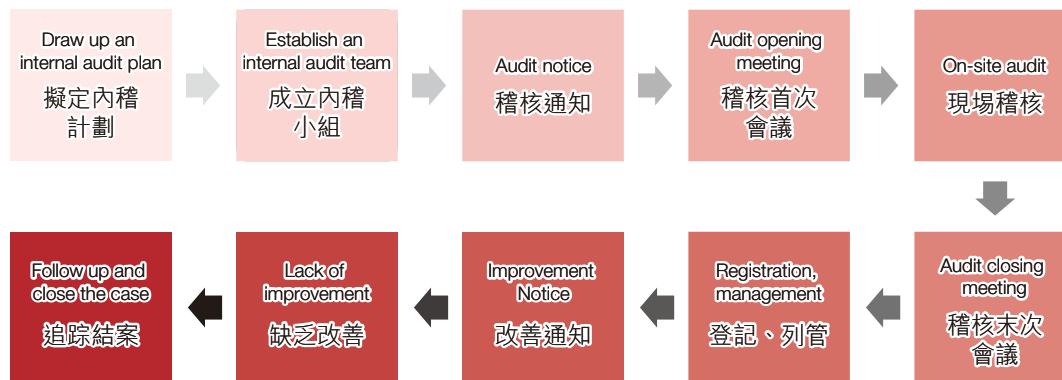
ISO9001 Quality Management System Certification

The Group has formulated the “Product Protection Operation Procedures” (《產品防護作業程序》), the “Internal Quality Audit Procedures” (《內部品質稽核作業程序》), the “Product Measurement and Monitoring Operation Procedures” (《產品的量測與監控作業程序》), the “Lean Production Management System of Manufacturing Department” (《製造部精益生產管理制度》) and established a dedicated team (such as quality control team and testing team), to measure, supervise and audit our quality management system and manufactured to help identify problems in a timely manner and take appropriate improvement measures. The entire production process from handling raw materials and semi-finished products to producing final products and delivery is closely supervised by designated departments (such as quality department, manufacturing department and warehouse department). In addition, we conduct annual and occasional audits on the Group’s quality and environmental protection (“HSPM”) management production system and manufactured quality and HSPM control related operations to improve the operating system and ensure product quality and environmental compliance. The operation process is as follows:

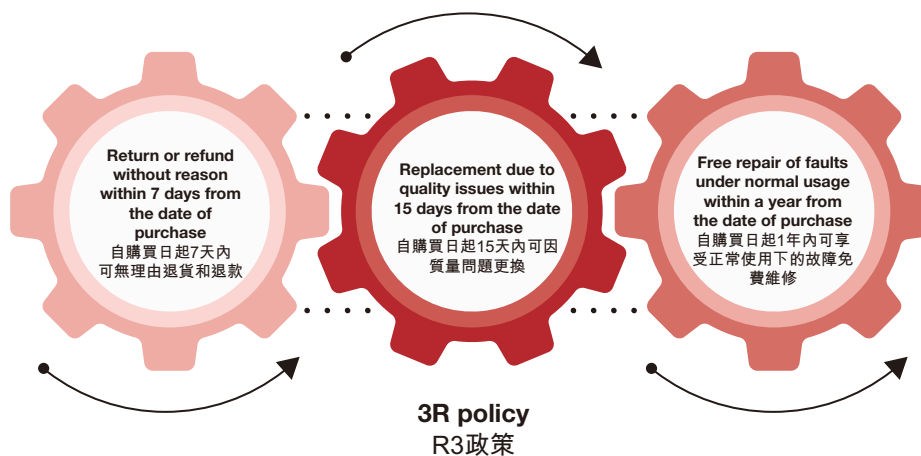


Internal quality audit process

We have developed the Non-conformance Control Procedures (《不符合管制程序》) and the Corrective and Preventive Operation Procedures (《矯正與預防作業程序》) to standardize the handling of substandard products and to prevent potential problems discovered through analysis and statistics. In order to ensure the identification and control of products that do not meet requirements, the unintentional use or delivery of which might result in quality issues affecting the Company's reputation, we will label, record, isolate, access, and handle quality- and environmental non-conforming products. In the event of any significant quality abnormalities, the quality department will conduct data statistics and analysis in accordance with the Corrective and Preventive Operation Procedures, and make judgements on abnormalities accordingly. In case of any significant abnormalities, production will be ceased. If there is room for improvements, the quality department will formulate countermeasures and make sure their implementation. The effectiveness thereof will be confirmed again in the end and if the result is positive, it will be submitted to and approved by leaders above deputy general manager, who will leave it to formulation unit for standardization. In addition, our after-sales products generally apply 3R policy for product returns and warranty.

我們制定《不符合管制程序》及《矯正與預防作業程序》，以規範不合格產品的處理，並通過分析統計所發現的潛在問題得以預防。為確保不符合要求的產品已被鑒別和管制，以防非意圖使用或交貨造成品質問題影響公司信譽，我們將質量與環保不合格品標示、記錄、隔離、評估和處理。一經確保質量發生顯著異常時，品質部將按照《矯正與預防作業程序》進行資料統計分析，並由品質部進行異常判定。如產生重大異常，則會停止生產，若可改善，則由品質部擬定對策，並落實對策的實施，最後再一次進行效果確認，如通過再次的效果確認，則由副總經理以上領導呈核後交由制訂單位標準化。此外，我們的售後產品一般適用3R政策進行產品退貨及質保。

### Product Innovation

The Group firmly believes that technology innovation may render learning a joyful experience. We focus on the inputs in technology field, including the design, development, manufacturing and selling of smart learning devices for providing supplemental products to China's primary and secondary students in assisting their in-school education. Meanwhile, we focus on user experience, continuously optimize product design, and improve product convenience.

We have developed the Product Design and Development Procedures (《產品設計開發程序》) which clearly outline the responsibilities of each department during the product design and development stage and strictly control product design and development with the aim to align our design and development with contractual or customer requirements. At the same time, we apply advanced technologies and strong AI and big-data capabilities to realize personalized precision education and maintain a large and growing user base. In addition, we actively cooperate with third parties to explore the application of cutting-edge technologies such as AI and big data in the field of education.

At present, the Group has applied cutting-edge technologies in launching various intelligent learning devices including AI learning machines, telephone watches, children's tablets, AI dictionary pens, and smart learning desks and chairs. These products are designed for children of different age groups, empowering education through technology and fully stimulating children's interest in learning; while breaking geographical limitations, they also allow more children to enjoy quality educational resources and broadened horizons.

### 3.2 Quality Customer Services

The Group adheres to a customer-first concept and is committed to providing customers with high-quality and high-standard customer services. In order to standardize customer services management in a more comprehensive manner, we have formulated various customer services policies and procedures, including the Customer Satisfaction Measurement Procedures (《顧客滿意測量作業程序》) and the Readboy "315" Special Inspection Management 2022 (《讀書郎2022年315專項檢核管理》), which detail the requirements and processes for handling and improving customer complaints, so as to improve customer services quality and lay an important and stable foundation for establishing long-term and good customer relationships.

### 產品創新

本集團深信科技創新，能讓學習成為美好體驗。我們注重在前沿科技領域的投入，包括：設計、開發、製造和銷售各種智能學習設備，為國內中小學生校內學習提供輔助產品。同時，我們注重用戶使用體驗，持續優化產品設計，提升產品使用便捷性。

我們制定《產品設計開發程序》，明確列明各部門在產品設計和開發階段的職責，對產品設計和開發進行嚴格管控，使設計和開發能滿足合同或顧客的要求。同時，我們應用先進的技術以及強大的AI和大數據能力，實現個性化的精準教學，及維持龐大且持續增長的用戶群。此外，我們積極與第三方合作，共同探索AI及大數據等前沿技術在教育領域的應用。

目前，本集團已採用前沿技術推出多項智能學習設備，包括AI學習機、電話手錶、兒童平板電腦、AI詞典筆及智慧學習桌椅等。這些產品針對不同年齡段的兒童設計，通過科技賦能教育，全面激發孩子學習興趣，同時打破地理局限，讓更多的孩子享受到優質的教育資源，拓寬孩子視野。

### 3.2 優質客戶服務

本集團堅持客戶優先的理念，致力於為客戶帶來高質量、高標準的客戶服務。為了更全面地規範客戶服務管理，我們制定了客戶服務政策及程序，當中包括《顧客滿意測量作業程序》及《讀書郎2022年315專項檢核管理》，詳細說明客戶投訴處理及改進的要求及流程，以優化客戶服務質量，為建立長遠而良好的客戶關係奠下重要穩妥的基石。

The Group has implemented an emergency handling process arrangement for its stores. Upon receiving customer complaints or the occurrence of other emergencies, store sales personnel will promptly fulfill their responsibilities of comforting customers and contacting first-tier distributors. After understanding the reasons behind, the distributors will immediately offer assistance in resolving and provide feedback, as well as send salespersons to communicate and handle on site, striving to properly solve the relevant issues. Meanwhile, the customer services department of the Company will rapidly formulate a plan according to the event, timely respond to customers' pinions in a professional manner, handle customers' complaints in a sincere and prudent manner, and follow up the handling results of the event. The regional leaders of the Company are responsible for providing solutions and monitoring public opinions. We will continuously optimize and improve our products and services based on customer feedbacks, which will become our driving force for making further progress.

We are committed to enhancing customer satisfaction and encourage clients offer us suggestions or recommendations relating to our products and services that are a critical basis for us to understand their needs, improve products and optimize management. Every half a year, our sales department will conduct a customer satisfaction survey on all existing customers, the results of which will be recorded in "customer satisfaction questionnaire" and be used as a reference for adjusting our operational strategies and improve sales direction with the aim of grasping more business opportunities with improved services.

In addition, the Group has strictly complied with the Advertising Law of the People's Republic of China (《中華人民共和國廣告法》) and has formulated the Information Distribution Management System of the Company (《公司信息發佈管理制度》), "the Self-inspection and Self-correction List of Market Promotion Contents", "the Notice on Prohibiting the Defamation of Online Products in the Company's Name and with its Unauthorized Engraved Official Seals" to standardize the Group and its distributors' external information release procedures in a bid to ensure no violations of relevant laws and regulations in advertising or product promotion methods and to protect the rights and interests of consumers.

During the year, the Group had not received any complaints in relation to its products and services.

本集團設有門店緊急事件處理流程安排，當接獲客戶投訴或出現其他緊急事件後，門店銷售人員會在第一時間盡到安撫顧客、聯繫一級經銷商的職責。經銷商了解事情原委後會立即配合解決並進行反饋，同時派遣業務員進行現場溝通處理，力爭妥善解決相關問題。同時，公司客戶服務部會根據事件情況迅速制定方案，以專業的態度及時響應客戶的意見，並以真誠嚴謹的態度處理客戶的投訴，跟進事件處理結果。公司區域負責人提供解決方案，監控輿情。我們會根據客戶對產品及服務提出的意見進行持續優化改進，並以此作為我們不斷前進的動力。

我們致力持續提升客戶滿意度，鼓勵客戶針對產品和服務提出意見或建議，將其作為了解客戶需求，改善產品、優化管理的重要依據。我們每半年由銷售部針對所有現有客戶進行一次客戶滿意度調查，並將結果記錄於「客戶滿意度調查表」，以作為調整經營策略及加強服務方向的參考，以改善服務開拓商機。

此外，本集團嚴格遵守《中華人民共和國廣告法》，並制定《公司信息發佈管理制度》、「市場宣傳內容自查自糾清單」及「關於禁止冒用公司名義、私刻公章詆毀在線產品行為的通知」，以規範集團及經銷商對外信息發佈流程，盡力確保廣告或產品宣傳手段中並無違反相關法律法規的情形，及保障消費者權益。

本年度，本集團無接獲任何關於產品及服務的投訴案件。



### 3.3 Respecting Intellectual Property Rights

The Group acknowledges the importance of intellectual property to the research and development of our products and strictly abides by the laws and regulations such as the Patent Law of the PRC (《中華人民共和國專利法》), the Implementing Regulations of the Copyright Law of the PRC (《中華人民共和國著作權法實施條例》), the Regulations on the Protection of Computer Software (《計算機軟件保護條例》), the Trademark Law of the PRC (《中華人民共和國商標法》) and the Administrative Measures on the Internet Domain Names (《互聯網域名管理辦法》). In addition, the Group has formulated the Intellectual Property Management System (《知識產權管理制度》) to strengthen the Group's intellectual property and patent management, encourage employees' participation in invention and creation, and maintain the Group's intangible assets, including but not limited to patents, trademarks, works, business confidential, computer software, so as to enhance the Company's market competitiveness and economic efficiency.

We have established an Intellectual Property Leading Group to promote the Group's protection of intellectual property rights. The intellectual property leading group is mainly responsible for formulating strategies and regulations for the development of intellectual property, supervising and guiding the implementation of intellectual property management, and coordinating intellectual property management. Intellectual Property Department under the intellectual property leading group is mainly responsible for drafting work plans and studies for the Company's intellectual property management, managing the application and registration of intellectual property rights, and promoting and publicizing intellectual property knowledge and related laws and regulations in the Company.

### 3.3 尊重知識產權

本集團明白知識產權對我們產品的研究及開發至關重要，嚴格遵守《中華人民共和國專利法》、《中華人民共和國著作權法實施條例》、《計算機軟件保護條例》、《中華人民共和國商標法》及《互聯網域名管理辦法》等相關法律法規，並制定《知識產權管理制度》，以加強本集團的知識產權及專利的管理工作，鼓勵員工發明創造，維護本集團的無形資產，包括但不限於專利、商標、著作、商業機密、計算機軟件等，提高公司市場競爭力和經濟效益。

我們成立知識產權領導小組，以推動本集團保護知識產權的工作。知識產權領導小組主要負責制定知識產權工作發展的策略及規定，監督及指導知識產權管理工作的執行情況，並協調知識產權管理工作。知識產權領導小組其下的知識產權部主要負責草擬本公司知識產權管理的工作規劃研究，管理知識產權的申請、註冊，並在公司推廣、宣傳知識產權知識及有關法律法規。

Prior to a patent application publication or announcement, patent workers and relevant personnel shall assume the responsibility to keep its contents confidential. After obtaining the patent application number and patent right, the Company shall reward the inventor or designer of the service invention in accordance with the relevant regulations. The Company and its employees have the right to protect the patent rights of the Group from infringement. If any infringement is found, they should report to the Intellectual Property Department in a timely manner and handle the incident under the guidance of administrative law enforcement agencies and judicial agencies. At the same time, we must avoid infringing on the patent rights and intellectual property rights of others. When cooperating with third parties to develop and introduce third-party patents, we formulate guarantee clauses to clarify the rights, obligations and responsibilities of both parties when involving third-party patents, in order to protect the interests of ourselves and others.

The Group obtained the certification (GB/T29490-2013) of the intellectual property management system issued by Zhongzhi (Beijing) Certification Co., Ltd. (September 2021) in October 2020, which is valid for 3 years. The scope of certification includes the intellectual property management for R&D, production and sales of student tablets, children's learning tablets (early education tablets), telephone watches and smart scanning pens.

During the year, the Group has been granted a total of 286 patents and has registered 280 trademarks.

在專利申請公布或公告前，專利工作者及有關人員對其內容負有保密的責任；在取得專利申請號及取得專利權後，公司應當依據有關規定對職務發明創造的發明人或者設計人給予獎勵。公司及員工有權保護本集團專利權不受侵犯，如發現任何侵權行為，應及時向知識產權部報告，並依照行政執法機關和司法機關的指導下處理事件。同時，我們亦要避免侵犯他人的專利權及知識產權。在與第三方合作研發及引進第三方專利時，我們制定擔保條款，明確雙方在涉及第三方專利時的權利、義務和責任，以保障自身及他人的利益。

本集團於2020年10月獲得由中知(北京)認證有限公司(2021年9月)簽發知識產權管理體系認證證書(GB/T29490-2013)，有效期為3年，認證範圍包括學生平板，兒童學習平板(早教平板)，電話手錶，智能掃讀筆研發、生產、銷售的知識產權管理。

本年度，本集團已獲授權專利共286件，已註冊商標共280件。

### 3.4 Privacy and Data Protection

Information security and customer privacy protection have always been important to operational compliance and are core competencies of modern enterprises. The Group strictly abides by laws and regulations such as the Cyber Security Law of the PRC (《中華人民共和國網絡安全法》), the Personal Information Protection Law of the PRC (《中華人民共和國個人信息保護法》) and the Civil Code of the PRC (《中華人民共和國民法典》), and has formulated a series of policies and systems in accordance with the above regulations, including but not limited to the User Information Protection System (《用戶信息保護制度》), the Cyber Security Management System (《網絡安全管理制度》), the Account Authority Management System (《賬號權限管理制度》), the Cyber Security Service Outsourcing Management System (《網絡安全服務外包管理制度》), the Establishment of Information Construction Security and Confidentiality System (《建立信息建設安全保密制度》) and the Security Operation and Maintenance Management Regulations (《安全運維管理規範》) to effectively protect the data and privacy of customers and their consumers.

The Group shall not collect or use personal information and data of customers and consumers on any platform, including websites, application systems and internal information services without the consent of the customers and consumers, and shall ensure strict confidentiality of customer and consumer data after collection. Their data is used by employees of the Group under the principles of legality, justification and necessity, and will not be disclosed, tampered with, damaged, sold, or provided to users. The Group will cease collecting and using personal information from customers and will cancel their numbers or accounts after they have terminated or not agreed to use the services.

### 3.4 隱私及數據保護

信息安全及客戶隱私保護對於運營合規而言始終十分重要，亦是現代企業的核心能力。本集團嚴格遵守《中華人民共和國網絡安全法》、《中華人民共和國個人信息保護法》和《中華人民共和國民法典》等法律法規，並根據以上法規，制定一系列政策及制度，包括但不限於《用戶信息保護制度》、《網絡安全管理制度》、《賬號權限管理制度》、《網絡安全服務外包管理制度》、《建立信息建設安全保密制度》及《安全運維管理規範》等，以有效地保護客戶及其消費者的數據及隱私。

在未經客戶及消費者同意情況下，本集團不得在任何平台，包括網站、應用系統及內部信息服務收集或使用客戶及消費者的個人信息及數據，並會確保客戶及消費者資料在收集後受嚴格保密。其數據在本集團員工在合法、正當、必要的原則下使用，並不會被泄露、篡改、毀損、出售或、提供用戶數據。在客戶終止或者不同意使用服務後，本集團會停止收集和使用客戶個人資料，並為客戶註銷號碼或賬號。

To enhance the Group's cyber security and information management, the Information Technology Department assigns network administrators and security auditors to carry out daily uniform network planning, including regular updating of firewalls, regular backup of server data, data recovery and strengthening of intranet and extranet management. The IT department also conducts regular vulnerability scans of the network system using vulnerability scanning tools, patches the vulnerabilities in the network, and conducts risk assessments. This series of policies can reduce the vulnerability of the network and reduce the occurrence of user data leakage. In addition, we implement hierarchical information management, and protect it by installing confidential software on specific personnel's computers to set decryption permissions. Access permissions are regulated according to employees' authority to prevent them from obtaining excessive information.

During the year, the Group did not have any complaints or lawsuits regarding protection of data and privacy.

### 3.5 Supply Chain Management

Long-term cooperation with its suppliers is essential for the Group to maintain its business operations. Therefore, it is of utmost significance to use excellent supply chain management to ensure the quality of our suppliers and products. We have formulated the "Supplier Evaluation Control Procedures" (《供應商評鑒管制作業程序》) and "Procurement Control Procedures" (《採購管制作業程序》), which stipulate the relevant requirements for supplier screening, audit, evaluation and approval.

We have a dedicated procurement team to approach and identify suppliers through market research and word of mouth recommendations. In addition to considering the supplier's past performance, technical strength, production capacity, quality control, timely delivery ability and price, the Group will also consider its environmental and social responsibility performance. In addition to complying with relevant national environmental protection policies, regulations and standards, we ensure that they do not employ illegal workers and whether they provide reasonable wages and working conditions for their employees. Under the same quality, we will give priority to suppliers who use environmentally friendly products. We sign "Procurement Contract" (《採購合同》), "Quality Assurance Agreement" (《品質保證協議書》), "Integrity Agreement" (《廉潔協議》), "Confidentiality Agreement" (《保密協議》) and other documents with suppliers to standardize suppliers' code of conduct in terms of environmental and social responsibilities.

為增強本集團網絡安全及信息管理，信息技術部門會指派網絡管理員和安全審計員，負責進行日常統一網絡規劃工作，包括定期更新防火牆，定期備份服務器的數據，恢復數據，加強內網和外網管理等。信息技術部門亦會定期利用漏洞掃描工具對網絡系統進行漏洞掃描，對網絡存在的漏洞進行修補，並且進行風險評估。這一系列政策能減低網絡漏洞，降低用戶數據泄露事件發生。另外，我們在信息管理上實施分級管理，通過在特定人員計算機上安裝保密軟件設定解密權限的方式保護，訪問權限根據員工職權進行規管，以防止員工獲取過多的信息。

本年度，本集團沒有任何關於數據保護和隱私保護的投訴或訴訟。

### 3.5 供應鏈管理

本集團與其供應商的長期合作對維持業務營運而言十分重要。因此，依靠卓越的供應鏈管理來保證我們供應商及產品的質量乃重中之重。我們制定《供應商評鑒管制作業程序》及《採購管制作業程序》，規定了供應商初篩、審計、評估及批准的相關要求。

我們設有專責採購團隊，通過市場調研及口碑推薦接洽及識別供應商。本集團除了考慮供應商過往業績、技術實力、生產能力、控制質量、及時交付能力及價格，亦會考慮其環境及社會責任的表現，是否遵守國家環境保護相關政策、法規與標準、確保沒有非法用工以及是否為其員工提供合理的薪酬及工作環境等。在同等的質素下，我們會優先考慮採用環保產品的供應商。我們與供應商簽訂《採購合同》、《品質保證協議書》、《廉潔協議》、《保密協議》及等文件，以規範供應商在環境及社會責任方面的行為準則。

In order to ensure the performance of suppliers in all aspects, the Group regularly evaluates suppliers according to the “Monthly Statistics of Supplier Evaluation Results” (《供應商評核成績月統表》), “Supplier Survey Form” and “Supplier Evaluation Form” to ensure that the raw materials they supply meet stringent internal and relevant national quality standards. Suppliers with priority ratings may apply for access to the supplier pool and we will consider increasing their orders. Suppliers with poor or questionable ratings will be considered for termination of business relationships.

This year, the Group had a total of 247 suppliers, mainly providing raw materials such as customized metal parts, plastic parts, electronic components, lithium-ion batteries, liquid crystal displays, etc. The number of suppliers by region is as follows:

### 3.6 Integrity Operation

The Group attaches great importance to corporate integrity and is committed to establishing a fair and honest corporate culture. In accordance with relevant regulations such as the “Civil Code” (《民法典》), “Basic Standards for Enterprise Internal Control” (《企業內部控制基本規範》) and “Articles of Association” (《公司章程》), the Group has formulated the “Anti-fraud System” (《反舞弊制度》) to regulate the professional conduct of all employees of the Company. We oppose any form of unfair competition such as commercial bribery, money laundering, and monopoly. We signed the “Integrity Agreement” (《廉潔協議》) with our partners, requiring our partners to abide by relevant anti-commercial bribery and anti-corruption policies and regulations, and establish a good cooperative relationship with them based on mutual respect and win-win cooperation.

為確保供應商於各方面的表現，本集團定期根據《供應商評核成績月統表》、「供應商調查表」及「供應商評鑒表」對供應商進行評估，以確保彼等提供的原材料符合嚴格的內部及相關國家質量標準。對於評分優先的供應商可申請進入供應商庫，並會考慮增加對其的訂購量；對於獲得差評或存在問題的供應商，我們會考慮終止與其的業務關係。

本年度，本集團供應商總計247家，主要為定制的金屬件、塑料件、電子元器件、鋰離子電池、液晶顯示器等原材料，供應商按地區劃分供應商數目如下：

### 3.6 廉潔營運

本集團重視企業的廉潔，致力於樹立公正廉明的企業文化。本集團依據《民法典》、《企業內部控制基本規範》及《公司章程》等有關規定，制定了《反舞弊制度》，以規範公司所有員工的職業行為，反對任何形式的商業賄賂、洗錢、壟斷等不正當競爭行為。我們與合作方簽訂《廉潔協議》，要求合作伙伴遵守反商業賄賂和反腐敗有關政策規定，與商業夥伴建立相互尊重、合作共贏的良好合作關係。

We have established a reporting mechanism to encourage employees or other stakeholders to report or uncover fraud through telephone, email, letters and other channels. Once a report is substantiated, the whistleblower will be rewarded appropriately. All reports will be handled confidentially to prevent any interference with the investigation or retaliation against the whistleblower. Any reported cases are referred to the Audit Committee, which forms a special investigation team with relevant departments to conduct joint investigations. We handle all reports carefully and investigate the matter in a fair and proper manner. We will provide feedback to the whistleblower on the outcome of the investigation of a report made by a named person. During the year, we have organized anti-corruption training for our directors and employees, covering topics such as corporate governance responsibility regulations and case studies on various types of misconduct, consequences and prevention, in order to enhance compliance awareness and self-discipline and prevent corruption loopholes.

During the year, the Group did not have any corruption cases against the Group or its employees.

## 4. PEOPLE-ORIENTED PRINCIPLE

### 4.1 Legal Labour

We value and respect the legal rights of all employees, uphold the principle of equal employment, and provide a fair, inclusive, healthy and safe working environment. We also provide excellent career development opportunities, create a diverse and inclusive work atmosphere, and grow together with our employees.

我們已設立了舉報機制，以鼓勵員工或其他利益相關方透過電話、電子郵件及信函等渠道，檢舉或揭發舞弊事件。舉報案件一經查證屬實，舉報人予以適當獎勵。我們會保密處理所有舉報，防止任何人對調查進行干擾或對舉報人作出報復式行為。任何舉報個案均轉交審計委員會處理，其與相關部門人員共同組成特別調查小組進行聯合調查。我們會審慎處理所有舉報個案，並以公平和妥善的方式調查有關事宜。對於實名舉報，我們會向舉報人反饋調查結果。本年度，我們已向董事及員工組織反貪污培訓，涵蓋企業管治責任法規及各類不當行為的個案研究、後果及預防等主題，以加強合規意識及自律精神，防範貪污漏洞。

本年度，本集團概無任何對集團或員工提出的貪污訴訟案件。

### 4.1 合法勞工

我們重視及尊重所有員工的合法權益，堅持平等僱傭原則、為員工提供一個公平、包容、健康和安全的工作環境，及良好的職業發展機會，營造多元包容的工作氛圍，與員工共同成長。

### Recruitment and Resignation

The Group adheres to the principles of reasonable and legal recruitment and strictly complies with laws and regulations such as the Labor Law of the People's Republic of China (《中華人民共和國勞動法》), the Labor Contract Law of the People's Republic of China (《中華人民共和國勞動合同法》), the Implementation Regulations of the Labor Contract Law of the People's Republic of China (《中華人民共和國勞動合同法實施條例》), the Law on the Protection of Minors (《未成年人保護法》), and the Regulations on the Prohibition of Child Labor (《禁止使用童工規定》).

The Group recruits talents based on the standards of both morality and talent. We adhere to the principles of fairness, justice and openness in talent recruitment and treatment, emphasize the concept of employee diversity, reject discrimination based on gender, age, disease, race, ethnicity, and respect the human rights of employees. We have formulated the Employment Regulations (《聘用規定》) and Employee Handbook (《員工手冊》) to standardize the recruitment process and principles, ensuring that our recruitment process is rigorous and reliable. We carefully review the identity information of candidates and only recruit those who have reached the legal working age to prevent child labor recruitment. At the same time, we will also conduct background checks on candidates to ensure that they meet the qualifications such as education, work experience, and professional skills required for the relevant position. If any violations are found, we will terminate the labor contract in accordance with legal labor regulations. In addition, we have established fixed working hours. If there is a need for overtime, we will record the employees who work overtime and provide overtime wages. Compulsory labor is strictly prohibited.

The Group respects the departure and retention of employees and will follow the resignation guidelines and procedures listed in the Employee Handbook when handling employee dismissal and resignation matters, ensuring that all employee resignation procedures comply with relevant laws and regulations to safeguard the rights and interests of both parties. If an employee seriously violates labor discipline, we will also proceed the dismissal procedures in accordance with the procedures.

### 招聘及離職

本集團秉持合理合法招聘的準則，嚴格遵守《中華人民共和國勞動法》、《中華人民共和國勞動合同法》、《中華人民共和國勞動合同法實施條例》、《未成年人保護法》及《禁止使用童工規定》等法律法規。

本集團以德才兼備的標準招聘人才。我們在人才招聘及待遇上，遵循公平、公正、公開的原則，重視員工多元化理念，拒絕性別、年齡、疾病、種族、民族等方面的歧視，尊重勞工人權。我們已制定《聘用規定》及《員工手冊》，規範錄用流程和招聘原則，確保我們的招聘流程嚴謹可靠。我們審慎審核應聘者身份信息，只聘用已達合法的工作年齡人士，杜絕童工招聘。同時，我們也會向應聘者進行背景審查，確保應聘者符合相關崗位任職要求的學歷、工作經驗、職業技能等條件。若發現有違規情況，我們將按照勞動合法規定解除勞動合同。此外，我們已制定固定的上班時間。如有加班需要，我們會將為加班的員工記錄在案，並提供加班工資，嚴禁強制勞工的行為。

本集團尊重員工的去留，在處理員工解僱離職事務時將按照《員工手冊》列明的離職指引及程序辦理手續，確保所有員工的離職程序符合相關法律法規，以保障雙方權益。如員工嚴重違反勞動紀律，我們亦將依照程序辦理辭退手續。

During the year, the Group did not have any breach regarding the employment of child labor or forced labor. The Group is not aware of any matters that have had a significant impact on the Group due to non-compliance with laws and regulations related to compensation and dismissal, recruitment and promotion, working hours, holidays, equal opportunities, diversification, anti-discrimination, and other benefits and welfares.

### Salary and benefits

The Group respects and values the legitimate rights and interests of all employees, and is committed to safeguarding their basic rights and providing them with the necessary benefits. We strictly comply with the Labor Law of the People's Republic of China (《中華人民共和國勞動法》) and other regulations of the regions in which we operate, as well as the Employee Welfare Management Measures (《員工福利管理辦法》), to provide employees with fair and competitive compensation and welfare benefits.

The Group continuously improves the relevant welfare system and provides employees with various benefits, including Five social insurance and one housing fund, life welfare, insurance and health welfare, comfort welfare, paid vacation, marriage and childbirth welfare, bonus, and so on. We also arrange accommodation and canteen for our employees. In addition, we also care about the lives of our employees. If an employee is hospitalized due to illness, we will provide them with comfort money or gifts. To celebrate traditional Chinese festivals, we also distribute holiday consolation money or gifts to our employees during the Spring Festival, Dragon Boat Festival, and Mid-Autumn Festival. At the same time, we have multiple holidays, including personal leave, sick leave, marriage leave, maternity leave, funeral leave, work-related injury leave, traditional festivals, etc., to achieve a balance between employees' work and life.

## 4.2 Employee Training and Development

We focus on the development and growth of our employees in the Group, therefore we have established a sound employee training system and a smooth talent promotion and development system to enhance the core competitiveness of the Group.

本集團不斷完善相關福利體系，為員工提供包括五險一金類福利、生活福利、保險健康類福利、慰問類福利、有薪假期類福利、婚育類福利、獎金類福利等多方面福利。我們更為員工安排住宿福利及飯堂。另外，我們也關心員工的生活，如有員工因病住院，我們會為員工發放慰問金或禮品。為慶祝中國傳統節日，每逢春節、端午節和中秋節，我們還會為員工發放佳節慰問禮金或禮品。同時，我們設有多項假期，包括事假、病假、婚假、產假、喪假、工傷假、傳統節日等，為員工的工作與生活取得平衡。

Therefore, we have formulated a comprehensive and competitive Company Employee Promotion Management System (《公司員工晉升管理制度》). We motivate grassroots employees to continuously improve their professional skills, personal qualities, and abilities through a competition mechanism of fairness, justice and openness.

Based on the assessment results, we use work performance, capabilities, professional attitude and team spirit as the criteria for employee promotion. At the same time, we have also established the Employee Confirmation Management System (《員工轉正管理制度》). We will conduct assessments to preliminarily determine whether new employees meet the comprehensive quality and development potential requirements of their positions, and determine the retention and salary level of employees based on the assessment results. In addition, we have established a scientific and reasonable salary system to ensure that our salary system is fair and competitive in the market. We record the performance of our employees and provide corresponding compensation and benefits for their positions and abilities.

### 4.3 Occupational Health and Safety

The Group always strives to provide employees with a safe, healthy, and guaranteed work environment. We strictly abide by relevant laws and regulations such as the Law of the People's Republic of China on the Prevention and Control of Occupational Diseases (《中華人民共和國職業病防治法》), the Production Safety Law of the People's Republic of China (《中華人民共和國安全生產法》), the Fire Protection Law of the People's Republic of China (《中華人民共和國消防法》), the Measures on the Administration and Supervision on Occupational Hygiene of Workplace (《工作場所職業衛生監督管理規定》) and the Industrial Injury Insurance Regulations (《工傷保險條例》), with a commitment to providing employees with a healthy and safe working environment. The Group neither received any complaints and lawsuits on the violations of relevant laws related to health and safety during the reporting period, nor there were cases of work-related fatalities occurred over the past three years.

We, always prioritising the health and safety of employees, have considered the business nature of the Group and regularly conduct testing on occupational hazard factors for different job positions. We have ensured that the occupational hazard factors in all positions within the Group do not exceed the occupational exposure limit and comply with hygiene and health requirements. In order to eliminate safety hazards, we have formulated safety production regulations to provide guidance for fire safety, electrical safety and mechanical safety. We have also developed the Emergency Plan for Emergency Environmental Events (《突發環境事件應急預案》) and accidents that may affect safety production during nighttime fire emergencies. In addition, we regularly organise trainings for relevant departments and personnel of emergency rescue plans to familiarize them with rescue procedures and help employees developing comprehensive self-help and self-protection abilities.

In addition, we also require employees involved in special type of work shall possess required work permits, and personnel other than full-time employees are not allowed to approach equipment for avoiding safety production accidents. Moreover, we also arrange physical examinations for employees and regularly track their health status. At the same time, we organised fire safety training and fire drills, traffic safety education and nighttime fire emergency evacuation drills during the year to enhance safety awareness of employees.

### 4.3 職業健康與安全

本集團始終努力為員工提供安全、健康及有保障的工作環境。我們嚴格遵守《中華人民共和國職業病防治法》、《中華人民共和國安全生產法》、《中華人民共和國消防法》、《工作場所職業衛生監督管理規定》、《工傷保險條例》等相關法律法規，致力於為員工提供健康安全的工作環境。本集團未在報告期間內受到任何關於違反健康安全相關法律的投訴及訴訟，過去三年也未出現過因工亡故的個案。

我們時刻將員工的健康及安全放在首位，因此我們已考慮本集團的業務性質，針對不同的工作崗位定期進行職業病危害因素檢測。我們已確保本集團所有崗位的職業病危害因素均不超過職業接觸限值，並符合衛生及健康要求。為消除安全隱患，我們已制定生產安全規定，為防火安全、電氣安全、機械安全提供指引。我們也編製了《突發環境事件應急預案》，以及夜間消防緊急可能影響生產安全的事務。我們定期組織應急救援預案的相關部門及人員進行培訓，使其熟悉救援程序，幫助員工培養全方位的自救自護能力。

另外，我們亦要求特殊工種需持證上崗，非專職人員不得靠近設備，避免安全生產事故。此外，我們也會為員工安排身體檢查，定期追蹤員工的健康狀況。同時，本年度我們已組織消防安全培訓及火警演習、交通安全的教育，以及夜間消防緊急疏散演練，提升了員工的安全意識。

### 5. GREEN OPERATION

The Group, acknowledging the importance of environmental protection, is committed to implementing the environmental sustainability policy in the operation process and actively performs environmental responsibilities. We strictly abide by the Environmental Protection Law of the People's Republic of China (《中華人民共和國環境保護法》), the Water Pollution Prevention and Control Law of the People's Republic of China (《中華人民共和國水污染防治法》), the Energy Conservation Law of the People's Republic of China (《中華人民共和國節約能源法》) and the relevant environmental laws and regulations of the place where our business is operated, strictly control the generation and discharge of air pollutants, wastes, etc., in bid to ensure that the Group's operation and management do not violate the relevant environmental laws and regulations.

#### Environmental goal setting

We actively optimise process technology in production and assembly, and always adhere to low-carbon and environmentally friendly management in all aspects of production, operation, and management. We promote continuous improvement and optimisation through refined operations, and promote resource conservation and environmentally friendly production models. While constantly improving internal management, the Group actively carries out external environmental management system certification. Our Zhongshan production base has obtained ISO 14001 environmental management system certification, standardized resource consumption and waste discharge management in business operations, and reduced the impact of business operations on the environment.

We have set environmental goals. During the year, we preliminarily set directional goals for greenhouse gases, energy efficiency, water efficiency and waste reduction. We retrospect and review the progress of implementing various environmental protection goals and measures, monitor various emission sources, identify more opportunities for energy conservation and emission reduction, and establish relevant policies to ensure the utilization of resources effectively, with an aim to reduce environmental footprint.

### 5. 綠色運營

本集團深明環境保護的重要性，致力在運營過程中貫徹環境可持續方針，積極履行環境責任。我們嚴格遵守《中華人民共和國環境保護法》、《中華人民共和國水污染防治法》、《中華人民共和國節約能源法》及業務經營所在地之相關環境法例及法規，嚴格控制空氣污染物、廢棄物等的產生與排放，以保證本集團的運營及管理不觸犯相關的環境法律法規。

#### 環境目標設定

我們積極優化生產及裝配方面的工藝技術，在生產運營管理等各個環節始終堅持低碳環保，通過精細化運營推動持續改善與優化，促進資源節約與環境友好的生產模式。在不斷完善內部管理的同時，本集團積極開展外部環境管理體系認證工作，我們的中山生產基地已獲得ISO 14001環境管理體系認證，規範業務運營中資源消耗與廢棄物排放管理，降低業務運營對環境的影響。

我們已制定環境目標，本年度在有關溫室氣體及能源使用效益、用水效益、減少廢棄物方面訂立初步的方向性目標。我們會回顧及審查各項環保目標及措施的執行進度，並監察各個排放源，識別更多節能減排的機會，並設立相關政策，有效地確保資源用得其所，旨在減少環境足跡。

In order to achieve environmental targets, we constantly improve our environmental management system and identify potential environmental impact and emission sources which our business may cause. We monitor and regulate the environmental parameters of our pollutant control procedures, and strictly manage the impact of our emissions on the environment.

為達成環境目標，我們不斷完善自身環境管理制度，並識別我們業務可能造成的潛在環境影響及排放源，對污染物治理過程的環境參數進行監測與管控，嚴格管控排放物對環境造成的影響。

### Environmental factors identification 環境因素識別

We have established Environmental Appraisal Team. Taking into account the product's lifetime from raw material selection to, production and procession of products, distribution and usage of products, we identified seven areas of potential environmental impact that our business may cause, such as air emission, water discharge, waste management, land contamination, community impact, use of raw materials and natural resources and other local environmental impact.

我們已成立環境評審小組，考慮產品的生命周期（包括原材料的篩選、產品的生產與加工、產品的運銷及使用），共在7個層面識別了我們業務可能造成的環境影響，如大氣排放、水體排放、廢物管理、土地污染、對社區的影響、原材料與自然資源的使用、其它地方性環境問題等。

### Environmental target monitoring 環境目標監測

We identified potential emission sources in the course of the operation and have established ISO specialists and coordinate each department to conduct daily inspection, monthly monitoring and annual identification.

我們識別在運營過程中的潛在排放源，並已設立ISO專員以及協調各部門，負責展開每日檢查、每月監控、每年識別的工作。

For the management of emissions from our production and assembly business, we monitor the amount of production waste, noise, dust emissions, water and electricity usage on a daily basis; conduct inspection on pollutants from production and sanitation of workplace on a monthly basis; and engage the third-party organization to carry out environmental inspection and reporting on an annual basis.

針對生產及裝配業務的排放物管理，我們會每日監測對生產基地的生產垃圾量、噪聲、粉塵排放、水電使用等；每月對生產過程中對排放的污染物和工作環境的衛生狀況進行檢測；每年委聘第三方機構進行環境檢測報告。

For office resources and energy consumption, we remind employees to conserve water and electricity on a daily basis; record electricity consumption and the amount of consumables on a monthly basis to timely control of energy consumption; and conduct inspection on the implementation of environmental target indicators and management plan on an annual basis, as well as assessment on other significant environmental factors.

### 5.1 Emission Management

Emissions from the Group's business operation mainly include domestic wastewater, exhaust gas, hazardous waste and non-hazardous waste and GHG emission caused by electricity consumption. During the year, we have conducted a third-party inspection on the amount of emissions from production. Our environmental indicators for as wastewater, exhaust gas, lampblack and noise all met the standard.

### 5.1 排放管理

本集團業務運營過程中產生的排放主要包括生活污水、廢氣污染物、有害廢棄物與無害廢棄物，以及耗電導致的溫室氣體排放。本年度，我們已為生產環境的排放量進行第三方檢測，我們的廢水、廢氣、油煙及嘈音等方面的環境指標均達標。

#### Wastewater management 廢水管理

Our water consumption includes domestic water for staff accommodation and food and industrial water from production and assembly process. Due to the fact that only assembly processes are involved in our production process, the water resources required for our industrial water demand are recycled and there is no need for discharge. Accordingly, wastewater generated from operation is mainly domestic wastewater and does not involve the discharge of production wastewater.

我們的用水量包括員工食宿方面的生活用水，以及生產及裝配工序方面的工業用水。由於我們在生產過程中只涉及裝配工序，我們在工業用水需求中所需的水資源均為循環用水，並無排放需要。因此，我們營運所產生的污水主要是一般生活廢水，不涉及生產廢水排放。

During the year, the Group's wastewater discharge was in line with the national and local government emission requirements and no incompliance occurred.

### Exhaust gas management 廢氣管理

There is no vehicle fuel used in our operations and therefore no nitrogen oxides (NO<sub>x</sub>), sulfur oxides (SO<sub>x</sub>) and particular matter (PM) are generated. 我們的業務運營過程中不涉及車輛燃油使用，因此沒有產生氮氧化物 (NO<sub>x</sub>)、硫氧化物 (SO<sub>x</sub>) 及顆粒物 (PM)。

During our production process, emissions containing Volatile Organic Compounds (VOCs), ozone and tin are generated. We acknowledged that process exhaust gas and dust are unavoidable emissions in the Groups' operation. We have therefore minimize environmental impact of exhaust gas on surroundings by improving ventilation in production plants and installing exhaust gas treatment facilities as well as developing plan on emissions of exhaust gas facilities.

我們在生產過程中會產生了含有揮發性有機化合物 (VOCs)、臭氧和錫的工序廢氣。我們深明工序廢氣及粉塵是本集團運營中無可避免的排放物，因此我們通過改善生產廠房的通風和安裝廢氣處理設施。同時，我們做好廢氣設施排放規劃，盡可能降低將廢氣對四周環境的影響。

Kitchen in our eatery generates lampblack. We have managed lampblack emission by installing lampblack purification facilities that meet national emission standard and developing conduct code in kitchen for employees. 我們的食堂廚房產生油煙排放。我們已通過安裝符合國家排放標準的油煙淨化設施，以及制定員工於廚房的操作守則，管理油煙排放。

During the year, the Group's exhaust gas emissions were in compliance with the national and local government emission requirements and no incompliance occurred.

本年度，本集團的廢氣排放已符合國家及當地政府的排放要求，並無發生違規事件。

### Noise management 嘈聲管理

We develop relevant guideline to limit mechanical noise from production equipment during the production process, noise from transportation and employees. At the same time, our production workshops were equipped with low-noise products, sound-insulating materials and layouts.

我們制定相關指引，限制生產設備在生產過程中的機械嘈聲，以及運輸及員工生活嘈聲。同時，我們已為生產車間配備低噪聲產品、良好隔音性的材質及布局。

Other than emissions from production activities, we are also committed to managing impact of our operations on environment and resources. Our production and assembly process are simple assembly and do not involve heavy industrial construction, the use of highly polluting fuels or the manufacture of circuit boards. We minimize the total amount of emission through abovementioned emission control and scientific environmental management. Accordingly, there is no pollutant of our emission that is harmful to land and vegetation. There are no significant environmental or natural resource impacts from our operations.

### 5.2 Resource Management

The main resources used by the Group during its business operation include purchased electricity, water and office consumables. In order to rationally improve the utilization of resources, we always pay attention to the ways of energy saving and consumption reduction, while planning on environment-friendly measures at all the places where the Group operates.

除生產活動所產生的排放物外，我們也致力管理運營過程對環境及天然資源的影響。我們的生產及裝配工序為簡單組裝，不屬重污染行業建設項目、不使用高污染燃料，亦不涉及線路板製造。我們已透過上述的排放物治理，以及科學化的環境管理，盡可能減少在生產及裝配業務中的排放物總量。因此，我們的排放物不存在對土壤、植被等造成危害的污染物，我們的業務對環境及天然資源沒有重大影響。

### 5.2 資源管理

本集團在業務運營活動中主要使用的資源包括外購電力、水和辦公耗材。為合理提升資源利用率，我們時刻關注節能降耗的方式，並在本集團所有運營地中規劃環境友好措施。

### Energy management 能源管理

We have formulated the Management System on Safe Use of Electricity and Electricity Saving (《安全節約用電管理制度》) to standardize various electricity consumptions and enhance the awareness of safely using electricity and saving electricity among our employees.

我們已制定《安全節約用電管理制度》，規範各類用電行為，提高員工安全節約用電意識。

In terms of lighting systems, we reduced the use of electric lights by dividing the office into several different lighting areas and setting up independent and controllable lighting switches. We have installed motion sensor lights at places that are not used frequently and have sufficient daylight, using daylight lighting as much as possible to reduce the dependence on the use of electric lights. When the office is vacant, we also require our staff to turn off the lights, so as to cultivate a good habit of “turning off the lights when leaving”. In order to improve the energy efficiency of our lighting devices, we also keep our lighting devices clean to reduce their unnecessary energy consumption.

在照明系統方面，我們減少電燈的使用，將辦公室劃分為多個不同的照明區域，設立獨立可控的照明開關。我們已在非經常使用及日光充足的地方安裝動態感應燈，盡可能使用日光照明，減少對電燈使用的依賴。如在辦公室空置時，我們亦要求員工關上電燈，培養員工「隨手關燈」的良好習慣。為提高照明裝置的能源效率，我們亦會保持照明裝置清潔，以減少其不必要的能源消耗。

In terms of air conditioning system, we adopt a central control and monitoring system. We regularly check and replace the pressure gauge, pressure hose and air compressor connector to prevent the leakage of chiller. During the periods of peak power, we limit the temperature of each office and the number of air conditioners turned on. We also clean the filters or coil fans on a regular basis, and install the air-conditioning systems at a place without being covered by direct sunlight, so as to ensure their high efficiency.

在空調系統方面，我們採用中央控制及監測系統，定期檢查及更換壓力錶、壓力軟管及空氣壓縮機的連接器，防止製冷器洩漏。我們在電力峰段期間各辦公室空調限制空調溫度以及空調開機台數。我們亦會定期清洗過濾網或盤管式風機，及避免太陽直接照射到的地方安裝空調系統，確保空調系統高效能。

In terms of electronic devices, we use products with certification of high energy efficiency and initiate modes of electricity saving, such as computers and printers that can be put into automatic standby or sleeping mode when idling. We also procure electronic devices that can accommodate multiple servers, such as printing facilities with multi-function printing and copying devices, and avoid the use of a single server with higher capacity to save electricity.

在電子設備方面，我們使用具高能源效益認證的產品及啓動省電模式，如電腦及打印機在閒置時可放入自動待機或睡眠模式。我們亦採購可容納多個服務器的電子設備，如具有多功能打印及複印裝置的打印設施，及避免使用單一較高容量的服務器，以節省用電。

### Water resource management 水資源管理

Start from reducing unnecessary waste of water, we conduct regular tests on the leakage of water pipes and dripping of water taps to check for water leaks. We foster a culture of water conservation within the Company by recycling and reusing the washing sewage for cleaning and irrigation. We also continuously monitor the water consumption of the Company by regularly checking the water meter, and reduce the water pressure to the lowest practicable level, so as to control the output of water consumption. 我們從減少不必要的水資源浪費入手，定期進行水管滲漏及水龍頭滴水測驗，檢查是否有漏水現象。我們培養公司內容惜水文化，循環再用洗滌污水進行清潔及灌溉。我們透過定期檢查水錶讀數，持續監測公司用水表現，並把水壓降低至可行的最低程度，以控制用水量輸出。

The water consumed by our business operation is mainly sourced from the municipal water supply, and there is no risk in obtaining suitable water sources.

我們的業務運營消耗的水資源主要來源於市政供水，在求取適用水源方面無風險。

### Waste management 廢棄物管理

We have identified non-hazardous and hazardous waste generated during our operation, of which, our non-hazardous waste is mainly discarded paper and general household waste; while hazardous waste is mainly waste electronic equipment, including waste circuit boards and other electronic components, waste lead-free solder paste packaging, waste pipes, waste rags and cleaning agent packaging, as well as waste defective products.

我們已識別在運營過程中產生的無害及有害廢棄物，其中我們的無害廢棄物主要為棄置紙張和一般生活垃圾；而有害廢棄物則主要為廢棄電子設備，包括廢線路板及其他電子組件、廢無鉛錫膏包裝、廢棄管、廢抹布及清洗劑包裝物以及廢次品。

In order to reduce the non-hazardous waste, we promote waste sorting by placing waste sorting and recycling bins at our offices and employee dormitories. We also strengthen the publicity of waste sorting among our employees and advocate the management policy of reducing waste at source, so as to encourage our employees to reduce the use of disposable and non-recyclable products. In terms of hazardous waste, we cooperate with the qualified recycling companies to dispose of the waste electronic equipment.

為減少無害廢棄物，我們推進垃圾分類工作，在辦公室及員工宿舍放置垃圾分類回收箱。我們向員工加強宣傳廢棄物分類，以及倡導源頭減廢的管理方針，鼓勵員工減少使用一次性及不可回收的產品。在有害廢棄物方面，我們與合資格的回收公司合作，處理廢棄電子設備。

In terms of paper management, we have implemented a paperless office to avoid the unnecessary use of paper due to redundant working procedures. We also encourage our employees to prioritize the use of electronic documents to convey information in lieu of unnecessary paper documents. Meanwhile, we closely monitor and regularly calculate the paper consumption.

在用紙管理方面，我們已實行無紙化辦公，避免冗贅的工作程序導致不必要的紙張使用。我們鼓勵員工優先使用電子文檔傳遞信息，以取代非必要的紙本檔。同時，我們密切監察及定期統計耗紙情況。

### 5.3 Response to Climate Change

Climate change and global warming are the major environmental issues around the world. We understand that climate change will lead to extreme weather events such as tropical cyclones, heavy rainfall and thunderstorms, which will ultimately pose a threat to our business operation and may result in economic losses. Therefore, we continuously monitor our business activities that may be affected by the climate change and have carried out identification and assessment on the impacts on the Group's business of climate change risks.

In terms of physical risks, our supply chain and places of operation may disrupt the supply and normal operation due to extreme weather. When acquiring the above resources, we may face a significant cost to maintain our daily operation. In order to contain further global warming, the Company has optimized its process and technology of production and assembly, while reduced and monitored the carbon dioxide emissions, thereby mitigating the rise of greenhouse gas.

In terms of transition risks, the Group understands that the international policies and regulations on climate change will become increasingly stringent. In order to minimize the risk of negative impacts of climate change on our business, we will continue to monitor the latest laws and regulations about climate change, and strictly comply with the environmental laws, regulations and industry standards at the places where we operate. Meanwhile, we will continue to implement measures of green office, with an aim to improve the energy efficiency at the office. We also reduce the carbon emissions by optimizing the use of energy and resources.

### 5.3 應對氣候變化

氣候變化及全球變暖為全球主要的環境問題。我們明白氣候變化將導致極端天氣事件，例如熱帶氣旋、暴雨和雷暴，最終對我們的業務運營構成威脅並可能導致經濟損失。我們持續關注可能受氣候變化影響的業務活動，並對本集團的業務展開了氣候變化風險識別和評估的影響。

在物理風險方面，我們的供應鏈及運營地可能受極端天氣影響而中斷供應及正常運營。在獲取以上資源時，我們將可能面臨較大的成本維持日常營運。為進一步遏制全球增溫，本公司已優化生產及裝配方面的工藝技術，減少及監測二氧化碳排放，以緩減溫室氣體上升的水平。

在轉型風險方面，本集團明白有關氣候變化的國際政策及法規將會日益嚴格。為儘量減少氣候變化對我們業務造成的負面影響的風險，我們將繼續監測有關氣候變化法律法規的最新資料，並嚴格遵守運營所在地的環保法律、法規及行業標準。同時，我們將繼續實施綠色辦工的措施，致力提高辦公室的能源使用效益，利用優化能源及資源利用，減少碳排放。

### 2.1 BASIS OF PREPARATION

These financial statements have been prepared in accordance with Hong Kong Financial Reporting Standards (“**HKFRSs**”) (which include all Hong Kong Financial Reporting Standards, Hong Kong Accounting Standards (“**HKASs**”) and Interpretations) issued by the Hong Kong Institute of Certified Public Accountants (“**HKICPA**”), accounting principles generally accepted in Hong Kong and the disclosure requirements of the Hong Kong Companies Ordinance. They have been prepared under the historical cost convention, except for equity investments designated at fair value through other comprehensive income, financial assets at fair value through profit or loss and financial liabilities at fair value through profit or loss which have been measured at fair value. These financial statements are presented in Renminbi (“**RMB**”), and all values are rounded to the nearest thousand except when otherwise indicated.

#### Basis of consolidation

The consolidated financial statements include the financial statements of the Company and its subsidiaries (collectively referred to as the “**Group**”) for the year ended 31 December 2022. A subsidiary is an entity (including a structured entity), directly or indirectly, controlled by the Company. Control is achieved when the Group is exposed, or has rights, to variable returns from its involvement with the investee and has the ability to affect those returns through its power over the investee (i.e., existing rights that give the Group the current ability to direct the relevant activities of the investee).

Generally, there is a presumption that a majority of voting rights results in control. When the Company has, directly or indirectly, less than a majority of the voting or similar rights of an investee, the Group considers all relevant facts and circumstances in assessing whether it has power over an investee, including:

- (a) the contractual arrangement with the other vote holders of the investee;
- (b) rights arising from other contractual arrangements; and
- (c) the Group’s voting rights and potential voting rights.

### 2.1 編製基準

#### 合併基準

綜合財務報表包括本公司及其子公司（統稱為「本集團」）截至2022年12月31日止年度的財務報表。子公司為本公司直接或間接控制的實體（包括結構性實體）。當本集團於參與被投資公司的業務中分享或有權享有可變回報，並可使用其權力影響被投資公司的回報（即給予本集團現時能力直接參與被投資公司的相關業務的現有權利）時，本集團即屬擁有控制權。

於一般情況下均存在多數投票權形成控制權之推定。當本公司直接或間接擁有少於被投資方大多數的表決或類似權利，在評估其是否擁有對被投資方的權力時，本集團會考慮所有相關事實及情況，包括：

The financial statements of the subsidiaries are prepared for the same reporting period as the Company, using consistent accounting policies. The results of subsidiaries are consolidated from the date on which the Group obtains control, and continue to be consolidated until the date that such control ceases.

Profit or loss and each component of other comprehensive income are attributed to the owners of the parent of the Group and to the non-controlling interests, even if this results in the non-controlling interests having a deficit balance. All intra-group assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control described above. A change in the ownership interest of a subsidiary, without a loss of control, is accounted for as an equity transaction.

If the Group loses control over a subsidiary, it derecognises (i) the assets (including goodwill) and liabilities of the subsidiary, (ii) the carrying amount of any non-controlling interest and (iii) the cumulative translation differences recorded in equity; and recognises (i) the fair value of the consideration received, (ii) the fair value of any investment retained and (iii) any resulting surplus or deficit in profit or loss. The Group's share of components previously recognised in other comprehensive income is reclassified to profit or loss or retained profits, as appropriate, on the same basis as would be required if the Group had directly disposed of the related assets or liabilities.

### 2.4 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### Subsidiaries

A subsidiary is an entity (including a structured entity), directly or indirectly, controlled by the Company. Control is achieved when the Group is exposed, or has rights, to variable returns from its involvement with the investee and has the ability to affect those returns through its power over the investee (i.e., existing rights that give the Group the current ability to direct the relevant activities of the investee).

When the Company has, directly or indirectly, less than a majority of the voting or similar rights of an investee, the Group considers all relevant facts and circumstances in assessing whether it has power over an investee, including:

- (a) the contractual arrangement with the other vote holders of the investee;
- (b) rights arising from other contractual arrangements; and
- (c) the Group's voting rights and potential voting rights.

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control described above. A change in the ownership interest of a subsidiary, without a loss of control, is accounted for as an equity transaction. The results of subsidiaries are included in the Company's profit or loss to the extent of dividends received and receivable. The Company's investments in subsidiaries are stated at cost less any impairment losses.

#### 子公司

子公司指本公司直接或間接控制的實體(包括結構性實體)。當本集團通過參與被投資方的相關活動而承擔可變回報的風險或有權享有可變回報，並且有能力運用對被投資方的權力(即使本集團目前有能力主導被投資方的相關活動的現有權利)影響該等回報時，即取得控制權。

當本公司直接或間接擁有少於被投資方大多數的表決或類似權利，在評估其是否擁有對被投資方的權力時，本集團會考慮所有相關事實及情況，包括：

- (a) 與被投資方其他表決權持有者的合約安排；
- (b) 其他合約安排產生的權利；及
- (c) 本集團的表決權及潛在表決權。

倘有事實及情況顯示上述三項控制因素中有一項或多項出現變化，本集團會重新評估其是否對被投資方擁有控制權。於子公司的擁有權權益變動(並無失去控制權)於入賬時列作權益交易。子公司的業績按已收及應收股息計入本公司損益。本公司於子公司的投資按成本減任何減值虧損列賬。

#### Fair value measurement

The Group measures its financial assets at fair value through profit or loss at fair value at the end of each reporting period. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value measurement is based on the presumption that the transaction to sell the asset or transfer the liability takes place either in the principal market for the asset or liability, or in the absence of a principal market, in the most advantageous market for the asset or liability. The principal or the most advantageous market must be accessible by the Group. The fair value of an asset or a liability is measured using the assumptions that market participants would use when pricing the asset or liability, assuming that market participants act in their economic best interest.

A fair value measurement of a non-financial asset takes into account a market participant's ability to generate economic benefits by using the asset in its highest and best use or by selling it to another market participant that would use the asset in its highest and best use.

The Group uses valuation techniques that are appropriate in the circumstances and for which sufficient data are available to measure fair value, maximising the use of relevant observable inputs and minimising the use of unobservable inputs.

All assets and liabilities for which fair value is measured or disclosed in the consolidated financial statements are categorised within the fair value hierarchy, described as follows, based on the lowest level input that is significant to the fair value measurement as a whole:

- Level 1 – based on quoted prices (unadjusted) in active markets for identical assets or liabilities
- Level 2 – based on valuation techniques for which the lowest level input that is significant to the fair value measurement is observable, either directly or indirectly
- Level 3 – based on valuation techniques for which the lowest level input that is significant to the fair value measurement is unobservable

#### 公允價值計量

本集團於各報告期間末按公允價值計量其按公允價值計入損益的金融資產。公允價值為市場參與者於計量日期在有序交易中出售資產所收取或轉讓負債所支付的價格。公允價值計量乃基於假設出售資產或轉讓負債的交易於資產或負債的主要市場或(在無主要市場的情況下)資產或負債的最有利市場進行。主要或最有利市場必須為本集團可進入的市場。資產或負債的公允價值乃採用市場參與者為資產或負債定價時所用的假設計量，並假設市場參與者依照彼等的最佳經濟利益行事。

非金融資產的公允價值計量計及市場參與者能否以最高及最佳用途使用有關資產或能否將有關資產出售予會以最高及最佳用途使用有關資產的另一名市場參與者以產生經濟利益。

本集團採用適用於有關情況且具備充分數據以供計量公允價值的估值技巧，以盡量使用相關可觀察輸入數據及盡量減少使用不可觀察輸入數據。

於綜合財務報表內計量或披露公允價值的所有資產及負債基於對公允價值計量整體屬重要的最低級輸入數據，按如下所述在公允價值層級中分類：

- 第一級 – 基於相同資產或負債於活躍市場的報價(未經調整)
- 第二級 – 基於可直接或間接觀察對公允價值計量而言屬重大的最低級輸入數據的估值技巧
- 第三級 – 基於不可觀察對公允價值計量而言屬重大的最低級輸入數據的估值技巧

#### Fair value measurement (Continued)

For assets and liabilities that are recognised in the financial statements on a recurring basis, the Group determines whether transfers have occurred between levels in the hierarchy by reassessing categorisation (based on the lowest level input that is significant to the fair value measurement as a whole) at the end of each reporting period.

#### Impairment of non-financial assets

Where an indication of impairment exists, or when annual impairment testing for an asset is required (other than inventories, deferred tax assets, financial assets and investment properties), the asset's recoverable amount is estimated. An asset's recoverable amount is the higher of the asset's or cash-generating unit's value in use and its fair value less costs of disposal, and is determined for an individual asset, unless the asset does not generate cash inflows that are largely independent of those from other assets or groups of assets, in which case the recoverable amount is determined for the cash-generating unit to which the asset belongs. In testing a cash-generating unit for impairment, a portion of the carrying amount of a corporate asset (e.g., a headquarters building) is allocated to an individual cash generating unit if it can be allocated on a reasonable and consistent basis or, otherwise, to the smallest group of cash-generating units.

An impairment loss is recognised only if the carrying amount of an asset exceeds its recoverable amount. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset. An impairment loss is charged to profit or loss in the period in which it arises in those expense categories consistent with the function of the impaired asset.

An assessment is made at the end of each reporting period as to whether there is an indication that previously recognised impairment losses may no longer exist or may have decreased. If such an indication exists, the recoverable amount is estimated. A previously recognised impairment loss of an asset other than goodwill is reversed only if there has been a change in the estimates used to determine the recoverable amount of that asset, but not to an amount higher than the carrying amount that would have been determined (net of any depreciation/amortisation) had no impairment loss been recognised for the asset in prior years. A reversal of such an impairment loss is credited to profit or loss in the period in which it arises.

#### 公允價值計量(續)

就按經常性基準於財務報表確認的資產及負債而言，本集團透過於各報告期間末重新評估分類(基於對公允價值計量整體而言屬重大的最低級輸入數據)確定是否發生不同等級轉移。

#### 非金融資產減值

倘有跡象顯示出現減值，或須就資產進行年度減值測試(存貨、遞延稅項資產、金融資產及投資物業除外)，則會估計資產的可收回金額。資產的可收回金額按資產或現金產生單位的使用價值及其公允價值減出售成本兩者中的較高者計算，並就個別資產而釐定，除非相關資產並無產生在頗大程度上獨立於其他資產或資產組別的現金流入，在此情況下，可收回金額就資產所屬的現金產生單位而釐定。在測試現金產生單位減值時，若公司資產(如總部大樓)一部分賬面金額可以在合理一致的基礎上進行分配，則分配至單個現金產生單位，否則將分配至最小現金產生單位組別。

減值虧損僅會在資產的賬面值超出其可收回金額時方予以確認。於評估使用價值時，估計未來現金流量按可反映現時市場評估之貨幣時間價值及資產特有風險的稅前折現率折現至現值。減值虧損在其產生期間自損益中與減值資產功能相符的相關開支類別扣除。

於各報告期間末均會評估是否有跡象顯示先前已確認的減值虧損已不再存在或可能減少。倘出現該跡象，則估計可收回金額。先前已確認的資產(不包括商譽)減值虧損僅會在用以釐定資產可收回金額的估計發生變動時方會撥回，惟有關金額不得高於該資產在過往年度並無確認減值虧損的情況下原應釐定的賬面值(扣除任何折舊/攤銷)。減值虧損的撥回於產生期間計入損益內。

#### Related parties

A party is considered to be related to the Group if:

- (a) the party is a person or a close member of that person's family and that person
  - (i) has control or joint control over the Group;
  - (ii) has significant influence over the Group; or
  - (iii) is a member of the key management personnel of the Group or of a parent of the Group;

or

- (b) the party is an entity where any of the following conditions applies:
  - (i) the entity and the Group are members of the same group;
  - (ii) one entity is an associate or joint venture of the other entity (or of a parent, subsidiary or fellow subsidiary of the other entity);
  - (iii) the entity and the Group are joint ventures of the same third party;
  - (iv) one entity is a joint venture of a third entity and the other entity is an associate of the third entity;
  - (v) the entity is a post-employment benefit plan for the benefit of employees of either the Group or an entity related to the Group;
  - (vi) the entity is controlled or jointly controlled by a person identified in (a);
  - (vii) a person identified in (a)(i) has significant influence over the entity or is a member of the key management personnel of the entity (or of a parent of the entity); and
  - (viii) the entity, or any member of a group of which it is a part, provides key management personnel services to the Group or to the parent of the Group.

#### Property, plant and equipment and depreciation

Property, plant and equipment, other than construction in progress, are stated at cost less accumulated depreciation and any impairment losses. The cost of an item of property, plant and equipment comprises its purchase price and any directly attributable costs of bringing the asset to its working condition and location for its intended use.

Expenditure incurred after items of property, plant and equipment have been put into operation, such as repairs and maintenance, is normally charged to profit or loss in the period in which it is incurred. In situations where the recognition criteria are satisfied, the expenditure for a major inspection is capitalised in the carrying amount of the asset as a replacement. Where significant parts of property, plant and equipment are required to be replaced at intervals, the Group recognises such parts as individual assets with specific useful lives and depreciates them accordingly.

Depreciation is calculated on the straight-line basis to write off the cost of each item of property, plant and equipment to its residual value over its estimated useful life. The principal annual rates used for this purpose are as follows:

Where parts of an item of property, plant and equipment have different useful lives, the cost of that item is allocated on a reasonable basis among the parts and each part is depreciated separately. Residual values, useful lives and the depreciation method are reviewed, and adjusted if appropriate, at least at each financial year end.

An item of property, plant and equipment including any significant part initially recognised is derecognised upon disposal or when no future economic benefits are expected from its use or disposal. Any gain or loss on disposal or retirement recognised in profit or loss in the year the asset is derecognised is the difference between the net sales proceeds and the carrying amount of the relevant asset.

#### 物業、廠房及設備及折舊

物業、廠房及設備(在建工程除外)按成本減累計折舊及任何減值虧損列賬。物業、廠房及設備項目的成本包括其購買價及任何使資產達致其運作狀況及地點作擬定用途的直接應佔成本。

物業、廠房及設備項目投入營運後產生的支出(如維修及保養費用)一般於產生期間自損益扣除。在符合確認條件的情況下,重大檢查支出會於資產的賬面值中撥充資本作為重置成本。倘物業、廠房及設備的主要部分須定期更換,本集團會確認該等部分為有特定可使用年期的個別資產,並對其作出相應折舊。

折舊乃按各項物業、廠房及設備的估計可使用年期以直線法撇銷其成本至其剩餘價值計算。就此採用的主要年率如下:

倘物業、廠房及設備項目各部分的可使用年期不同,則會將該項目的成本按合理基準分配至各部分,而各部分將分別折舊。剩餘價值、可使用年期及折舊方法至少於各財政年度末進行檢討及調整(如適用)。

物業、廠房及設備項目(包括任何初始確認的重大部分)於出售時或預期使用或出售該項目不會產生未來經濟利益時終止確認。於資產終止確認年度在損益確認的出售或報廢的任何收益或虧損,乃有關資產出售淨所得款項與賬面值的差額。

#### Property, plant and equipment and depreciation (Continued)

Construction in progress represents buildings under construction, which is stated at cost less any impairment losses, and is not depreciated. Construction in progress is reclassified to the appropriate category of property, plant and equipment when completed and ready for use.

#### Investment properties

Investment properties are interests in land and buildings (including the leasehold property held as a right-of-use asset which would otherwise meet the definition of an investment property) held to earn rental income and/or for capital appreciation, rather than for use in the production or supply of goods or services or for administrative purposes; or for sale in the ordinary digital educational resources of business. Such properties are measured initially at cost, including transaction costs. Subsequent to initial recognition, investment properties are measured at historical cost less accumulated depreciation and provision for any impairment in value. Depreciation is calculated on the straight-line basis to write off the cost of an investment property to its residual value over its estimated useful life. The principal annual rates used for this purpose are as follows:

Subsequent expenditure is capitalised in the asset's carrying amount only when it is probable that future economic benefits associated with the item will flow to the Group and the costs of the item can be measured reliably, otherwise, the expenditures are recognised in profit or loss in the year in which they are incurred.

Any gains or losses on the retirement or disposal of an investment property are recognised in profit or loss in the year of the retirement or disposal.

If an investment property becomes an owner-occupied property, it is reclassified as property, plant and equipment, and its carrying amount at the date of reclassification becomes its cost for accounting purposes. If an item of property, plant and equipment becomes an investment property because its use has changed, the transfer does not change the carrying amount of the property transferred, nor does it change the cost of that property for measurement or disclosure purposes.

#### 物業、廠房及設備及折舊(續)

在建工程指正在建造的樓宇，按成本減任何減值虧損列賬，且不計提折舊。在建工程在建設完工且達到可使用狀態時，會被重新分類至物業、廠房及設備的適當類別。

#### 投資物業

投資物業乃為賺取租金收入及／或資本增值，而非用以生產或提供商品或服務或作行政用途又或於業務的日常數字化教輔資源中出售而持有的土地及樓宇(包括作為符合投資物業定義的使用權資產持有的租賃物業)的權益。該等物業初步以成本(包括交易成本)計量。於初始確認後，投資物業按歷史成本減累計折舊及任何減值撥備計量。折舊乃以直線法計算，在投資物業的估計可使用年內撇銷其成本至其剩餘價值。就此所使用的主要年率如下：

後續支出僅在與該項目相關的未來經濟利益很可能流入本集團，並且該項目的成本能可靠計量時計入資產的賬面值；否則，支出在其產生年度於損益內確認。

報廢或出售投資物業的任何收益或虧損在報廢或出售年度於損益確認。

倘投資物業成為業主自用物業，則重新分類為物業、廠房及設備，而就會計目的而言，於重新分類當日的賬面值為其成本。倘物業、廠房及設備項目因其用途改變而成為投資物業，就計量或披露而言，該轉撥並無改變所轉撥物業的賬面值，亦無改變該物業的成本。

#### Intangible assets (other than goodwill)

Intangible assets acquired separately are measured on initial recognition at cost. The useful lives of intangible assets are assessed to be either finite or indefinite. Intangible assets with finite lives are subsequently amortised over the useful economic life and assessed for impairment whenever there is an indication that the intangible asset may be impaired. The amortisation period and the amortisation method for an intangible asset with a finite useful life are reviewed at least at each financial year end.

#### Software

Purchased computer software is stated at cost less any impairment losses and is amortised on a straight-line basis over its estimated useful life of 5 years. The useful life of the computer software is assessed by the Group considering the purposes and usage of the software.

#### Copyrights

Copyrights are stated at cost less any impairment losses and are amortised on a straight-line basis over their estimated useful lives of 2 to 5 years.

#### Research and development costs

All research costs are charged to profit or loss as incurred.

Expenditure incurred on projects to develop new products is capitalised and deferred only when the Group can demonstrate the technical feasibility of completing the intangible asset so that it will be available for use or sale, its intention to complete and its ability to use or sell the asset, how the asset will generate future economic benefits, the availability of resources to complete the project and the ability to measure reliably the expenditure during the development. Product development expenditure which does not meet these criteria is expensed when incurred.

#### 無形資產(商譽除外)

單獨收購的無形資產初始確認時按成本計量。無形資產的可使用年期被評定為有限期或無限期。具有有限年期的無形資產其後按可使用經濟年期攤銷，並於該無形資產可能出現減值的跡象時作減值評估。具有有限可使用年期的無形資產的攤銷年期及攤銷方法至少於各財政年度末進行檢討。

#### 軟件

購買的電腦軟件按成本減任何減值虧損列賬，並於其5年的估計可使用年期內以直線法攤銷。電腦軟件的可使用年期由本集團於考慮軟件的目的及用途後評估。

#### 著作權

著作權按成本減任何減值虧損列賬，並於其2至5年的估計可使用年期內以直線法攤銷。

#### 研發成本

所有研究成本均於產生時自損益扣除。

新產品開發項目產生的支出僅於本集團可證明於技術上能夠完成無形資產供使用或出售、有意完成及有能力使用或出售該資產、該資產未來產生經濟利益的方式、具有完成項目所需的資源且能夠可靠地計量開發期間的支出時，方會撥充資本並以遞延方式入賬。未能符合該等條件的產品開發支出於產生時支銷。

#### Leases

The Group assesses at contract inception whether a contract is, or contains, a lease. A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration.

#### Group as a lessee

The Group applies a single recognition and measurement approach for all leases, except for short-term leases and leases of low-value assets. The Group recognises lease liabilities to make lease payments and right-of-use assets representing the right to use the underlying assets.

#### (a) Right-of-use assets

Right-of-use assets are recognised at the commencement date of the lease (that is the date the underlying asset is available for use). Right-of-use assets are measured at cost, less any accumulated depreciation and any impairment losses, and adjusted for any remeasurement of lease liabilities. The cost of right-of-use assets includes the amount of lease liabilities recognised, initial direct costs incurred, and lease payments made at or before the commencement date less any lease incentives received. Where applicable, the cost of a right-of-use asset also includes an estimate of costs to dismantle and remove the underlying asset or to restore the underlying asset or the site on which it is located. Right-of-use assets are depreciated on a straight-line basis over the shorter of the lease terms and the estimated useful lives of the assets as follows:

If ownership of the leased asset transfers to the Group by the end of the lease term or the cost reflects the exercise of a purchase option, depreciation is calculated using the estimated useful life of the asset.

#### 本集團作為承租人

本集團對所有租賃應用單一確認及計量方法，惟短期租賃及低價值資產租賃除外。本集團確認租賃負債以作出租賃付款，而使用權資產指使用相關資產的權利。

#### (a) 使用權資產

使用權資產於租賃開始日期(即可使用相關資產的日期)確認。使用權資產以成本減任何累計折舊及任何減值虧損計量，並就租賃負債的任何重新計量作出調整。使用權資產的成本包括已確認的租賃負債金額、已產生的初始直接成本，以及於開始日期或之前作出的租賃付款減已收取的任何租賃優惠。於適用情況下，使用權資產的成本亦包括拆卸及移除相關資產或將相關資產或相關資產所在地復原的估計成本。使用權資產在租期及資產估計可使用年期(以較短者為準)內按直線法折舊如下：

##### (b) Lease liabilities

Lease liabilities are recognised at the commencement date of the lease at the present value of lease payments to be made over the lease term. The lease payments include fixed payments (including in-substance fixed payments) less any lease incentives receivable, variable lease payments that depend on an index or a rate, and amounts expected to be paid under residual value guarantees. The lease payments also include the exercise price of a purchase option reasonably certain to be exercised by the Group and payments of penalties for termination of a lease, if the lease term reflects the Group exercising the option to terminate the lease. The variable lease payments that do not depend on an index or a rate are recognised as an expense in the period in which the event or condition that triggers the payment occurs.

In calculating the present value of lease payments, the Group uses its incremental borrowing rate at the lease commencement date because the interest rate implicit in the lease is not readily determinable. After the commencement date, the amount of lease liabilities is increased to reflect the accretion of interest and reduced for the lease payments made. In addition, the carrying amount of lease liabilities is remeasured if there is a modification, a change in the lease term, a change in lease payments (e.g., a change to future lease payments resulting from a change in an index or rate) or a change in assessment of an option to purchase the underlying asset.

##### (c) Short-term leases

The Group applies the short-term lease recognition exemption to its short-term leases of buildings (that is those leases that have a lease term of 12 months or less from the commencement date and do not contain a purchase option).

Lease payments on short-term leases are recognised as an expense on a straight-line basis over the lease term.

##### (b) 租賃負債

於租賃開始日期，本集團確認以租期內作出的租賃付款之現值計量的租賃負債。租賃付款包括固定付款(包括實物固定付款)減任何應收租賃優惠、取決於指數或利率的可變租賃付款，以及預期在剩餘價值擔保下支付的金額。租賃付款亦包括本集團合理地肯定行使的購買選擇權之行使價，及倘租期反映了本集團行使選擇權終止租賃，則終止租賃而需支付的罰款。於觸發付款的事件或條件發生時，不取決於指數或利率的可變租賃付款將於該期間確認為開支。

#### Group as a lessor

When the Group acts as a lessor, it classifies at lease inception (or when there is a lease modification) each of its leases as either an operating lease or a finance lease.

Leases in which the Group does not transfer substantially all the risks and rewards incidental to ownership of an asset are classified as operating leases. When a contract contains lease and non-lease components, the Group allocates the consideration in the contract to each component on a relative stand-alone selling price basis. Rental income is accounted for on a straight-line basis over the lease terms and is included in revenue in profit or loss due to its operating nature. Initial direct costs incurred in negotiating and arranging an operating lease are added to the carrying amount of the leased asset and recognised over the lease term on the same basis as rental income. Contingent rents are recognised as revenue in the period in which they are earned.

Leases that transfer substantially all the risks and rewards incidental to ownership of an underlying asset to the lessee, are accounted for as finance leases.

At the commencement date, the cost of the leased asset is capitalised at the present value of the lease payments and related payments (including the initial direct costs), and presented as a receivable at an amount equal to the net investment in the lease. The finance income on the net investment in the lease is recognised in profit or loss so as to provide a constant periodic rate of return over the lease terms.

Financial assets are classified, at initial recognition, as subsequently measured at amortised cost, fair value through other comprehensive income, and fair value through profit or loss.

當本集團作為出租人時，其於租賃開始（或於租賃修訂）時將各租賃分類為經營租賃或融資租賃。

本集團並未轉讓資產所有權附帶的絕大部分風險及回報的租賃分類為經營租賃。如合同包含租賃及非租賃部分，則本集團按相對獨立售價基準將合同對價分配至各個部分。租金收入於租期內按直線法入賬，並因其經營性質計入損益之收入。於磋商及安排經營租賃時產生的初始直接成本計入租賃資產的賬面值，並於租期內按相同方法確認為租金收入。或然租金於所賺取的期間內確認為收入。

向承租人轉讓相關資產所有權附帶的絕大部分風險及回報的租賃入賬為融資租賃。

於開始日期，租賃資產的成本按租賃付款及相關付款（包括初始直接成本）的現值資本化，並以等於租賃淨投資的金額呈列為應收款項。租賃淨投資的財務收入於損益確認以提供租期內固定週期回報率。

金融資產在初始確認時乃分類為其後按攤銷成本、按公允價值計入其他全面收益以及按公允價值計入損益計量。

The classification of financial assets at initial recognition depends on the financial asset's contractual cash flow characteristics and the Group's business model for managing them. With the exception of trade receivables that do not contain a significant financing component or for which the Group has applied the practical expedient of not adjusting the effect of a significant financing component, the Group initially measures a financial asset at its fair value plus, in the case of a financial asset not at fair value through profit or loss, transaction costs. Trade receivables that do not contain a significant financing component or for which the Group has applied the practical expedient are measured at the transaction price determined under HKFRS 15 in accordance with the policies set out for "Revenue recognition" below.

In order for a financial asset to be classified and measured at amortised cost or fair value through other comprehensive income, it needs to give rise to cash flows that are solely payments of principal and interest ("SPPI") on the principal amount outstanding. Financial assets with cash flows that are not SPPI are classified and measured at fair value through profit or loss, irrespective of the business model.

The Group's business model for managing financial assets refers to how it manages its financial assets in order to generate cash flows. The business model determines whether cash flows will result from collecting contractual cash flows, selling the financial assets, or both. Financial assets classified and measured at amortised cost are held within a business model with the objective to hold financial assets in order to collect contractual cash flows, while financial assets classified and measured at fair value through other comprehensive income are held within a business model with the objective of both holding to collect contractual cash flows and selling. Financial assets which are not held within the aforementioned business models are classified and measured at fair value through profit or loss.

All regular way purchases and sales of financial assets are recognised on the trade date, that is, the date that the Group commits to purchase or sell the asset. Regular way purchases or sales are purchases or sales of financial assets that require delivery of assets within the period generally established by regulation or convention in the marketplace.

金融資產在初始確認時的分類取決於金融資產的合同現金流量特徵以及本集團管理該等金融資產的業務模式。除不包含重大融資成分的貿易應收款項或本集團採取可行權宜方法不調整重大融資成分影響的貿易應收款項外，本集團初始按公允價值計量金融資產，如屬並非按公允價值計入損益的金融資產，則另加交易成本。不包含重大融資成分的貿易應收款項或本集團已採取可行權宜方法的貿易應收款項按依照下文「收入確認」所載政策根據香港財務報告準則第15號釐定的交易價計量。

金融資產需要產生僅為償還本金及未償還本金利息(「僅為償還本金及利息」)的現金流量，方可按攤銷成本或按公允價值計入其他全面收益進行分類及計量。現金流量並非僅為償還本金及利息的金融資產，不論其業務模式如何，均按公允價值計入損益分類及計量。

本集團管理金融資產的業務模式指其如何管理其金融資產以產生現金流量。業務模式釐定現金流量是否來自收取合同現金流量、出售金融資產或兩者同時進行。旨在持有金融資產以收取合同現金流量的業務模式中持有的金融資產按攤銷成本分類及計量；而旨在持有金融資產以收取合同現金流量及出售金融資產的業務模式中持有的金融資產則按公允價值計入其他全面收益分類及計量。並非以上述業務模式持有的金融資產按公允價值計入損益分類及計量。

所有按常規方式購買及出售的金融資產於交易日(即本集團承諾購買或出售該資產之日)確認。按常規方式購買或出售指須在一般按市場規則或慣例確定的期間內交付金融資產的購買或出售。

The subsequent measurement of financial assets depends on their classification as follows:

##### Financial assets at amortised cost (debt instruments)

Financial assets at amortised cost are subsequently measured using the effective interest method and are subject to impairment. Gains and losses are recognised in profit or loss when the asset is derecognised, modified or impaired.

##### Financial assets designated at fair value through other comprehensive income (equity investments)

Upon initial recognition, the Group can elect to classify irrevocably its equity investments as equity investments designated at fair value through other comprehensive income when they meet the definition of equity under HKAS 32 Financial Instruments: Presentation and are not held for trading. The classification is determined on an instrument-by-instrument basis.

Gains and losses on these financial assets are never recycled to profit or loss. Dividends are recognised as other income in profit or loss when the right of payment has been established, it is probable that the economic benefits associated with the dividend will flow to the Group and the amount of the dividend can be measured reliably, except when the Group benefits from such proceeds as a recovery of part of the cost of the financial asset, in which case, such gains are recorded in other comprehensive income. Equity investments designated at fair value through other comprehensive income are not subject to impairment assessment.

金融資產的後續計量取決於其以下分類：

##### 按攤銷成本計量的金融資產(債務工具)

按攤銷成本計量的金融資產其後使用實際利率法計量並受減值影響。當資產終止確認、修訂或減值時，收益及虧損於損益確認。

##### 被指定為按公允價值計入其他全面收益的金融資產(股權投資)

初始確認時，本集團可選擇不可撤銷地將其股權投資分類為被指定為按公允價值計入其他全面收益的股權投資，惟該等投資符合香港會計準則第32號金融工具：列報下的股權定義，且並非持作買賣。分類乃按個別工具基準釐定。

該等金融資產的收益及虧損概不會被重新計入損益。當支付權確立、與股息有關之經濟利益可能流入本集團且股息金額能夠可靠計量時，股息於損益中確認為其他收入，惟當本集團於作為收回金融資產一部分成本的所得款項中獲益時則除外，於此等情況下，該等收益於其他全面收益入賬。指定為按公允價值計入其他全面收益的股權投資不受減值評估影響。

Financial assets at fair value through profit or loss are carried in the statement of financial position at fair value with net changes in fair value recognised in profit or loss.

##### Derecognition of financial assets

A financial asset (or, where applicable, a part of a financial asset or part of a group of similar financial assets) is primarily derecognised (i.e., removed from the Group's consolidated statements of financial position) when:

- the rights to receive cash flows from the asset have expired; or
- the Group has transferred its rights to receive cash flows from the asset or has assumed an obligation to pay the received cash flows in full without material delay to a third party under a "pass-through" arrangement; and either (a) the Group has transferred substantially all the risks and rewards of the asset, or (b) the Group has neither transferred nor retained substantially all the risks and rewards of the asset, but has transferred control of the asset.

When the Group has transferred its rights to receive cash flows from an asset or has entered into a pass-through arrangement, it evaluates if, and to what extent, it has retained the risk and reward of ownership of the asset. When it has neither transferred nor retained substantially all the risks and rewards of the asset nor transferred control of the asset, the Group continues to recognise the transferred asset to the extent of its continuing involvement. In that case, the Group also recognises an associated liability. The transferred asset and the associated liability are measured on a basis that reflects the rights and obligations that the Group has retained.

Continuing involvement that takes the form of a guarantee over the transferred asset is measured at the lower of the original carrying amount of the asset and the maximum amount of consideration that the Group could be required to repay.

按公允價值計入損益的金融資產在財務狀況表以公允價值列示，而公允價值淨變動於損益確認。

##### 終止確認金融資產

金融資產(或金融資產的一部分，或一組相類似金融資產的一部分，如適用)主要會於下列情況終止確認(即自本集團的綜合財務狀況表移除)：

- 收取資產產生的現金流量的權利已屆滿；或

倘以已轉讓資產提供擔保的方式持續參與，則以該資產原賬面值及本集團或須償還的對價上限中較低者計量。

##### Impairment of financial assets

The Group recognises an allowance for expected credit losses (“ECLs”) for all debt instruments not held at fair value through profit or loss. ECLs are based on the difference between the contractual cash flows due in accordance with the contract and all the cash flows that the Group expects to receive, discounted at an approximation of the original effective interest rate. The expected cash flows will include cash flows from the sale of collateral held or other credit enhancements that are integral to the contractual terms.

##### General approach

ECLs are recognised in two stages. For credit exposures for which there has not been a significant increase in credit risk since initial recognition, ECLs are provided for credit losses that result from default events that are possible within the next 12 months (a 12-month ECL). For those credit exposures for which there has been a significant increase in credit risk since initial recognition, a loss allowance is required for credit losses expected over the remaining life of the exposure, irrespective of the timing of the default (a lifetime ECL).

At each reporting date, the Group assesses whether the credit risk on a financial instrument has increased significantly since initial recognition. When making the assessment, the Group compares the risk of a default occurring on the financial instrument as at the reporting date with the risk of a default occurring on the financial instrument as at the date of initial recognition and considers reasonable and supportable information that is available without undue cost or effort, including historical and forward-looking information. The Group considers that there has been a significant increase in credit risk when contractual payments are more than 30 days past due.

The Group considers a financial asset in default when contractual payments are 90 days past due. However, in certain cases, the Group may also consider a financial asset to be in default when internal or external information indicates that the Group is unlikely to receive the outstanding contractual amounts in full before taking into account any credit enhancements held by the Group.

##### 金融資產減值

本集團會就所有並非按公允價值計入損益的債務工具確認預期信貸虧損(「**預期信貸虧損**」)的撥備。預期信貸虧損乃基於根據合同到期的合同現金流量與本集團預期收取的所有現金流量之間的差額而釐定，並以原實際利率的近似值折現。預期現金流量將包括出售所持抵押的現金流量或組成合同條款的其他信貸提升措施。

##### 一般方法

預期信貸虧損分兩個階段進行確認。就自初始確認起未有顯著增加的信貸風險而言，預期信貸虧損就未來12個月內可能發生違約事件而導致的信貸虧損(12個月預期信貸虧損)計提撥備。就自初始確認起已經顯著增加的信貸風險而言，不論何時發生違約，於餘下風險年期內的預期信貸虧損均須計提虧損準備(全期預期信貸虧損)。

於各報告日期，本集團評估金融工具信貸風險自初始確認以來是否大幅上升。於作出評估時，本集團會比較於報告日期評估的金融工具發生違約的風險與於初始確認日期評估的金融工具發生違約的風險及本集團會考慮合理可靠、無須付出過多成本或努力即可獲得的資料，包括過往資料及前瞻性資料。倘合同付款逾期超過30日未還款，則本集團認為信貸風險大幅上升。

本集團會將合同付款逾期達90日的金融資產視作已違約。然而，在若干情況下，倘內部或外部資料反映，在沒有計及本集團任何信貸提升措施前，本集團不大可能悉數收到未償還合同款項，則本集團亦可認為金融資產發生違約。

A financial asset is written off when there is no reasonable expectation of recovering the contractual cash flows.

Financial assets at amortised cost are subject to impairment under the general approach and they are classified within the following stages for measurement of ECLs except for trade receivables which apply the simplified approach as detailed below.

- Stage 1 – Financial instruments for which credit risk has not increased significantly since initial recognition and for which the loss allowance is measured at an amount equal to 12-month ECLs
- Stage 2 – Financial instruments for which credit risk has increased significantly since initial recognition but that are not credit-impaired financial assets and for which the loss allowance is measured at an amount equal to lifetime ECLs
- Stage 3 – Financial assets that are credit-impaired at the reporting date (but that are not purchased or originated credit-impaired) and for which the loss allowance is measured at an amount equal to lifetime ECLs

#### Simplified approach

For trade receivables that do not contain a significant financing component or when the Group applies the practical expedient of not adjusting the effect of a significant financing component, the Group applies the simplified approach in calculating ECLs. Under the simplified approach, the Group does not track changes in credit risk, but instead recognises a loss allowance based on lifetime ECLs at each reporting date. The Group has established a provision matrix that is based on its historical credit loss experience, adjusted for forward-looking factors specific to the debtors and the economic environment.

金融資產於無合理期望可收回合同現金流量時撇銷。

按攤銷成本計量的金融資產按一般方法進行減值，並按下列階段分類以計量預期信貸虧損，惟下文詳述應用簡化方法的貿易應收款項除外。

- 階段1 – 信貸風險自初始確認後並無顯著增加的金融工具，其虧損準備按等同12個月預期信貸虧損的金額計量
- 階段2 – 信貸風險自初始確認後顯著增加但並非已信貸減值金融資產的金融工具，其虧損準備按等同全期預期信貸虧損的金額計量

#### 簡化方法

##### Initial recognition and measurement

Financial liabilities are classified, at initial recognition, as payables and financial liabilities at fair value through profit or loss, as appropriate.

All financial liabilities are recognised initially at fair value and, in the case of payables, net of directly attributable transaction costs.

The Group's financial liabilities include trade payables, other payables and accruals, lease liabilities, amounts due to shareholders, an amount due to a related party and financial liabilities at fair value through profit or loss.

##### Subsequent measurement

The subsequent measurement of financial liabilities depends on their classification as follows:

##### Financial liabilities at fair value through profit or loss

Financial liabilities at fair value through profit or loss include financial liabilities designated upon initial recognition as at fair value through profit or loss.

Financial liabilities designated upon initial recognition as at fair value through profit or loss are designated at the initial date of recognition, and only if the criteria in HKFRS 9 are satisfied. Gains or losses on liabilities designated at fair value through profit or loss are recognised in profit or loss, except for the gains or losses arising from the Group's own credit risk which are presented in other comprehensive income with no subsequent reclassification to profit or loss. The net fair value gain or loss recognised in profit or loss does not include any interest charged on these financial liabilities. The Group designated the ordinary shares as financial liabilities at fair value through profit or loss. They are initially recognised at fair value.

Subsequent to initial recognition, the ordinary shares are carried at fair value with changes in fair value recognised in profit or loss.

Amortised cost is calculated by taking into account any discount or premium on acquisition and fees or costs that are an integral part of the effective interest rate. The effective interest rate amortisation is included in finance costs in profit or loss.

##### Derecognition of financial liabilities

A financial liability is derecognised when the obligation under the liability is discharged or cancelled or expires.

When an existing financial liability is replaced by another from the same lender on substantially different terms, or the terms of an existing liability are substantially modified, such an exchange or modification is treated as the derecognition of the original liability and the recognition of a new liability, and the difference between the respective carrying amounts is recognised in profit or loss.

#### Offsetting of financial instruments

Financial assets and financial liabilities are offset and the net amount is reported in the statement of financial position if there is a currently enforceable legal right to offset the recognised amounts and there is an intention to settle on a net basis, or to realise the assets and settle the liabilities simultaneously.

#### Inventories

Inventories are stated at the lower of cost and net realisable value. Cost is determined on the first-in, first-out basis and, in the case of work in progress and finished goods, comprises direct materials, direct labour and an appropriate proportion of overheads. Net realisable value is based on estimated selling prices less any estimated costs to be incurred to disposal.

#### Cash and cash equivalents

For the purpose of the consolidated statement of cash flows, cash and cash equivalents comprise cash on hand and demand deposits, and short-term highly liquid investments that are readily convertible into known amounts of cash, are subject to an insignificant risk of changes in value, and have a short maturity of generally within three months when acquired, less bank overdrafts which are repayable on demand and form an integral part of the Group's cash management.

For the purpose of the consolidated statements of financial position, cash and cash equivalents comprise cash on hand and at banks, including term deposits and assets similar in nature to cash, which are not restricted as to use.

#### Provisions

A provision is recognised when a present obligation (legal or constructive) has arisen as a result of a past event and it is probable that a future outflow of resources will be required to settle the obligation, provided that a reliable estimate can be made of the amount of the obligation.

The Group provides for warranties in relation to the sale of devices for general repairs of defects occurring during the warranty period. Provisions for these assurance-type warranties granted by the Group are recognised based on sales volume and past experience of the level of repairs and returns, discounted to their present values as appropriate.

#### Income tax

Income tax comprises current and deferred tax. Income tax relating to items recognised outside profit or loss is recognised outside profit or loss, either in other comprehensive income or directly in equity.

Current tax assets and liabilities are measured at the amount expected to be recovered from or paid to the taxation authorities, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of each of the reporting period, taking into consideration interpretations and practises prevailing in the countries in which the Group operates.

When the consideration in a contract includes a variable amount, the amount of consideration is estimated to which the Group will be entitled in exchange for transferring the goods or services to the customer. The variable consideration is estimated at contract inception and constrained until it is highly probable that a significant revenue reversal in the amount of cumulative revenue recognised will not occur when the associated uncertainty with the variable consideration is subsequently resolved. Some contracts for the sale of goods provide customers with deductions, which give rise to variable consideration.

Rebates may be provided to certain customers to support their sales activities. Rebates are offset against amounts payable by the customers. To estimate the variable consideration for the expected rebates, the Group applies the most likely amount method which best predicts the amount of variable consideration which usually is a fixed percentage of cash collection amount as agreed in the contract. The Group then applies the requirements on constraining estimates of variable consideration and the expected future rebates are deducted from receivables from customers.

##### (a) Sale of personal student tablets

The Group provides devices that are bundled together with the provision of digital educational resources and services to the customer. Contracts for bundled sale of devices and digital educational resources and services comprise two performance obligations because the promises to transfer the devices and provide digital educational resources and services are capable of being distinct and separately identifiable. Accordingly, the transaction price is allocated to each performance obligation based on the relative stand-alone selling prices of the devices and digital educational resources and services.

##### (c) Sale of wearable products and other products

Revenue from the sale of wearable products and other products is recognised at the point in time when control of the products is transferred to the customer, that is when the products are accepted by the customers.

##### (d) Sale of advertisement and content licensing

The Group places links in the apps of the customers on the devices sold by the Group. The Group collects a fee based on the fixed price per click or download as agreed in the contract with the customers and number of clicks performed by the end users. Monthly statements are issued and agreed by both parties to confirm the volume of actual clicks or downloads and the revenue amount. The Group estimates revenue based on available information which has no material differences with the confirmed amount on the monthly statement.

The Group licenses pre-recorded digital educational resources to third-party channels which place the digital educational resources on their platforms to sell to the end users. When the users purchase the digital educational resources from the platforms, the Group is entitled to a prescribed fixed percentage of gross proceeds collected by the channels. The Group views the channels as its customers as the channels control the digital educational resources and have the primary responsibility to sell the digital educational resources to the users. The Group recognises the net amount remitted from the channels as revenue based on the monthly statement issued and confirmed by the platforms.

#### Other income

Rental income is recognised on a time proportion basis over the lease terms.

Interest income from a financial asset is recognised on an accrual basis using the effective interest method by applying the rate that exactly discounts the estimated future cash receipts over the expected life of the financial instrument or a shorter period, when appropriate, to the net carrying amount of the financial asset.

#### Contract liabilities

A contract liability is recognised when a payment is received or a payment is due (whichever is earlier) from a customer before the Group transfers the related goods or services. Contract liabilities are recognised as revenue when the Group performs under the contract (i.e., transfers control of the related goods or services to the customer).

#### Employee benefits

#### Social pension plans

The employees of the Group's subsidiaries which operate in Mainland China are required to participate in a central pension scheme operated by the local municipal government. The subsidiaries operating in Mainland China are required to contribute a certain percentage of their payroll costs to the central pension scheme. The contributions are charged to profit or loss as they become payable in accordance with the rules of the central pension scheme.

#### Dividends

Final dividends are recognised as a liability when they are approved by the shareholders in a general meeting.

#### Foreign currencies

These financial statements are presented in RMB, which is the Company's functional currency. Each entity in the Group determines its own functional currency and items included in the financial statements of each entity are measured using that functional currency. Foreign currency transactions recorded by the entities in the Group are initially recorded using their respective functional currency rates prevailing at the dates of the transactions. Monetary assets and liabilities denominated in foreign currencies are translated at the functional currency rates of exchange ruling at the end of each reporting period. Differences arising on settlement or translation of monetary items are recognised in profit or loss.

Non-monetary items that are measured in terms of historical cost in a foreign currency are translated using the exchange rates at the dates of the initial transactions. Non-monetary items measured at fair value in a foreign currency are translated using the exchange rates at the date when the fair value was measured.

### 3. SIGNIFICANT ACCOUNTING JUDGEMENTS AND ESTIMATES

The preparation of the Group's financial statements requires management to make judgements, estimates and assumptions that affect the reported amounts of revenues, expenses, assets and liabilities, and their accompanying disclosures, and the disclosure of contingent liabilities. Uncertainty about these assumptions and estimates could result in outcomes that could require a material adjustment to the carrying amounts of the assets or liabilities affected in the future.

#### Judgements

In the process of applying the Group's accounting policies, management has made the following judgements, apart from those involving estimations, which have the most significant effect on the amounts recognised in the consolidated financial statements:

The Group applied the following judgements that significantly affect the determination of the amount and timing of revenue from contracts with customers:

#### (a) Identifying performance obligations in a bundled sale of devices and digital educational resources and services

A good or service that is promised to a customer is distinct if both of the following criteria are met: (a) the customer can benefit from the good or service either on its own or together with other resources that are readily available to the customer; and (b) the entity's promise to transfer the good or service to the customer is separately identifiable from other promises in the contract. The Group determined that both devices and digital educational resources and services are each capable of being distinct.

In assessing whether each item has a stand-alone value to the customer, the Group considers factors such as the availability of readily available resources in the market and whether the entity sells goods or services separately, which indicate that the customer can benefit from both devices and digital educational resources and services on their own.

#### (a) Identifying performance obligations in a bundled sale of devices and digital educational resources and services (Continued)

The Group determined that the promises to provide digital educational resources are not distinct from the maintenance and renewal services as the customer cannot exploit the value of the digital educational resources without receipt of such maintenance and renewal services. Therefore, the provision of digital educational resources and the maintenance and renewal services are consolidated as one performance obligation. The Group concluded that the promises to transfer devices and to provide digital educational resources and services are distinct. The device is separately identifiable in the contract and will be transferred upon the acceptance by customers. The digital educational resources represent academic curriculum offerings which are not an integrated part of the device. The Group is not providing a significant integration service because the presence of the devices and digital educational resources and services together in the contract does not result in any additional functionality and neither the device nor the digital educational resources modifies or customises the other. In addition, the devices and the digital educational resources and services are not highly interdependent or highly interrelated, because the delivery of device is not dependent on the digital educational resources and services to be provided in the future. Therefore, the devices and provision of digital educational resources and services are two separate performance obligations.

Consequently, the Group has allocated the transaction price to devices and digital educational resources and services based on relative stand-alone selling prices. The stand-alone selling prices are not directly observable; and therefore the Group estimates it using expected cost plus margin approach. The Group has considered all information that is reasonably available, including but not limited to, third-party or industry pricing, costs incurred to provide the good or service, related profit margins.

本集團確定提供數字化教輔資源的承諾與維護及續訂服務並無區別，原因為客戶需在獲得此類維護及續訂服務的情況下才能利用數字化教輔資源的價值。因此，提供數字化教輔資源以及維護及續訂服務合併為一項履約義務。本集團認為，轉讓設備以及提供數字化教輔資源和服務的承諾有所不同。設備可於合同中單獨識別，並將於客戶接受後轉讓。數字化教輔資源提供學術課程內容，並非設備的組成部分。由於合同中同時存在設備及數字化教輔資源和服務並不會導致任何額外作用，且設備及數字化教輔資源均不會修改或定製彼此，故本集團並無提供重要的整合服務。此外，設備及數字化教輔資源和服務並非高度互相依賴或高度相關，原因為設備交付並不取決於日後提供的數字化教輔資源和服務。因此，設備及提供數字化教輔資源和服務為兩項單獨的履約義務。

因此，本集團已根據相對獨立售價將交易價分配至設備及數字化教輔資源和服務。獨立售價不可直接觀察；因此，本集團使用預期成本加利潤法對其進行估計。本集團已考慮所有合理可得資料，包括但不限於第三方或行業定價、提供商品或服務所產生的成本、相關利潤率。

#### (b) Determining the timing of satisfaction of digital educational resources and services

The Group concluded that revenue from the provision of digital educational resources and services is recognised over time because the user is granted a right to access digital educational resources embedded in the devices and is provided with continuing maintenance and renewal services over the user life. The Group uses the average user life when estimating the period over which revenue is being recognised.

For the sale of personal student tablets, the Group tracks each user's log in history to estimate the average user life. For the sale of smart classroom solutions, the Group considers the types of schools and grade of end users to whom the smart classroom solutions are sold to estimate the average user life.

The determination of the average user life for each type of products is based on the Group's best estimate that takes into account all known and relevant information at the time of assessment. Future user classifications, patterns and behaviors may differ from the historical usage patterns and therefore the estimated average user life may change in the future. The Group will continue to monitor the estimated average user life, which may differ from the historical period, and any change in the estimate may result in the revenue being recognised on a different basis to that in prior periods. Any adjustments arising from changes in user life as a result of new information will be accounted for as a change in accounting estimate.

本集團認為，提供數字化教輔資源和服務的收入隨時間而確認，原因為用戶獲授權訪問嵌入設備的數字化教輔資源，並獲提供可使用年期內的持續維護及續訂服務。本集團估計收入確認期間時使用平均可使用年期。

就銷售學生個人平板而言，本集團追蹤每名用戶的登錄歷史，以估計平均可使用年期。就銷售智慧校園解決方案而言，本集團考慮銷售智慧校園解決方案的學校類型和終端用戶年級，以估計平均可使用年期。

每種產品的平均可使用年期的釐定乃基於本集團的最佳估計，該估計計及評估時的所有已知及相關資料。未來的用戶分類、模式及行為可能與過往使用模式不同，因此，估計平均可使用年期將來可能發生變更。本集團將持續監控估計平均可使用年期，該年期可能與過往期間有所不同，且估計的任何變更都可能導致以與過往期間不同的基準確認收入。由於新資料導致可使用年期的變更而產生的任何調整，均將入賬列作會計估計變更。

#### Classification between investment properties and owner-occupied properties

The Group determines whether a property qualifies as an investment property and has developed criteria in making that judgement. Investment property is a property held to earn rentals or for capital appreciation or both. Therefore, the Group considers whether a property generates cash flows largely independently of the other assets held by the Group. Some properties comprise a portion that is held to earn rentals or for capital appreciation and another portion that is held for use in the production or supply of goods or services or for administrative purposes. If these portions could be sold separately or leased out separately under a finance lease, the Group accounts for the portions separately. If the portions could not be sold separately, the property is an investment property only if an insignificant portion is held for use in the production or supply of goods or services or for administrative purposes. Judgement is made on an individual property basis to determine whether ancillary services are so significant that a property does not qualify as an investment property.

#### Current and deferred tax

Significant judgement is required in interpreting the relevant tax rules and regulation so as to determine whether the Group is subject to corporate income tax (the “CIT”). This assessment relies on estimates and assumptions and may involve a series of judgements about future events. New information may become available that causes the Group to change its judgement regarding the adequacy of the tax liabilities and such changes to tax liabilities will impact tax expenses in the period that such determination is made. Further details of the current and deferred tax are set out in note 10 to the financial statements.

Deferred tax liabilities have been established for withholding taxes that would be payable on certain profits of the subsidiaries in the PRC to be repatriated and distributed by way of dividends as the directors consider that the timing of the reversal of the related temporary differences can be controlled and such temporary differences will not be reversed in the foreseeable future. The plan of the distribution of dividends is influenced by projected future market and economic conditions and future financing requirements of the Group. If these undistributed earnings of subsidiaries in the PRC are considered to be repatriated and distributed by way of dividends, the deferred tax charge and deferred tax liabilities would have been recognised.

##### Estimation uncertainty

The key assumptions concerning the future and other key sources of estimation uncertainty at the end of the reporting period, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year, are discussed below.

##### Impairment of non-financial assets

The Group assesses whether there are any indicators of impairment for all non-financial assets as at the end of each reporting period. The non-financial assets are tested for impairment when there are indicators that the carrying amounts may not be recoverable. An impairment exists when the carrying value of an asset or a cash-generating unit exceeds its recoverable amount, which is the higher of its fair value less costs of disposal and its value in use. The calculation of the fair value less costs of disposal is based on available data from binding sales transactions in an arm's length transaction of similar assets or observable market prices less incremental costs for disposing of the asset. When value-in-use calculations are undertaken, management must estimate the expected future cash flows from the asset or cash-generating unit and choose a suitable discount rate in order to calculate the present value of those cash flows.

由於董事認為可控制撥回有關暫時差額的時間而該等暫時差額不會於可預見將來撥回，故已為若干中國子公司將匯返或以股息方式分派利潤時的應付預提稅確認遞延所得稅負債。股息分配計劃受估計未來市場及經濟狀況以及本集團未來融資需求的影響。倘該等中國子公司的未分派盈利被視為匯返或以股息方式分派，則應確認遞延稅項支出及遞延稅項負債。

##### 估計不確定因素

下文詳述有關未來的主要假設及於報告期末估計不確定因素的其他主要來源，而該等因素具有可能會導致對下一個財政年度的資產及負債賬面值作出重大調整的重大風險。

##### 非金融資產減值

本集團於各報告期末就所有非金融資產評估是否有任何減值跡象。當有跡象表明賬面值為不可收回，則非金融資產就減值進行測試。當資產或現金產生單位之賬面值超出其可收回金額（為其公允價值減出售成本及其使用價值之較高者為準），則存有減值。計算公允價值減出售成本乃基於來自類似資產公平交易中的具約束性銷售交易或可觀察市場價格減出售有關資產之增量成本的可用數據。當計算使用價值時，管理層須估計來自資產或現金產生單位的預期末來現金流量，並選擇一項合適的折現率，以計算該等現金流量的現值。

##### Useful lives and residual values of items of property, plant and equipment

In determining the useful lives and residual values of items of property, plant and equipment, the Group has to consider various factors, such as the expected usage of the asset, expected physical wear and tear, care and maintenance of the asset, and legal or similar limits on the use of the asset. The estimation of the useful life of the asset is based on the experience of the Group with similar assets that are used in a similar way. Additional depreciation is made if the estimated useful lives and/or residual values of items of property, plant and equipment are different from previous estimation. Useful lives and residual values are reviewed as at the end of the reporting period. Further details of property, plant and equipment are set out in note 13 to the financial statements.

##### Provision for expected credit losses on trade receivables and other receivables

The provision rate of receivables is made based on assessment of their recoverability and ageing analysis of receivables as well as other quantitative and qualitative information based on management's judgement and assessment of the forward-looking information. At each reporting date, the historical observed default rates are updated and changes in the forward-looking estimates are analysed.

The assessment of the correlation between historical observed default rates, forecast economic conditions and ECLs is a significant estimate. The amount of ECLs is sensitive to changes in circumstances and of forecast economic conditions. The Group's historical credit loss experience and forecast of economic conditions may also not be representative of a debtor's actual default in the future. The information about the ECLs on the Group's trade receivables and other receivables is disclosed in notes 21 and 22 to the financial statements, respectively.

##### 就貿易應收款項及其他應收款項的預期信貸虧損計提撥備

應收賬款撥備率乃根據對應收款項可收回性及賬齡分析的評估，以及其他基於管理層對前瞻性資料的判斷及評估的定量及定性資料。於各報告日期，本集團更新過往觀察所得的拖欠比率，並分析前瞻性估計中的變動。

評估過往觀察所得拖欠比率、預測經濟狀況及預期信貸虧損之間的關係乃一項重大估計。預期信貸虧損金額易受環境及預測經濟狀況的變更影響。本集團的過往信貸虧損經驗及對經濟環狀的預測亦未必一定反映債務人日後的實際拖欠情況。有關本集團貿易應收款項及其他應收款項的預期信貸虧損的資料分別於財務報表附註21及22披露。

##### Deferred tax assets

Deferred tax assets are recognised for deductible temporary differences to the extent that it is probable that taxable profit will be available against which the deductible temporary difference can be utilised. Significant management judgement is required to determine the amount of deferred tax assets that can be recognised, based upon the likely timing and level of future taxable profits together with future tax planning strategies. Further details are contained in note 17 to the financial statements.

##### Warranty provisions

The Group makes provisions for the warranties it gives on the sale of its products, taking into account the Group's current sales levels and past experience of the level of repairs. As the Group is continually upgrading its product designs and launching new products, it is possible that the past experience of the level of repairs and returns is not indicative of future claims that it will receive in respect of past sales. Any increase or decrease in the actual claims would affect profit or loss in future years.

##### Write-down of inventories to net realisable value

The Group, pursuant to the accounting policy for inventories, writes down inventories from cost to net realisable value and makes provision against obsolete and slow-moving items by using the lower of cost and net realisable value rule. The assessment of the write-down required involves management's judgement and estimates. Where the actual outcome or expectation in future is different from the original estimate, the differences will have an impact on the carrying amounts of inventories and the write-down of inventories in the period in which the estimate has been changed. As at 31 December 2022, the carrying amount of inventories was RMB246,715,000 (2021: RMB258,219,000).

##### 遞延稅項資產

遞延稅項資產就可扣減暫時差額予以確認，惟以可能出現應課稅利潤可用以抵銷有關可扣減暫時差額為限。管理層在釐定可予以確認的遞延稅項資產金額時，須根據日後應課稅利潤可能出現的時間及水平以及未來稅項規劃策略作出重大判斷。進一步詳情載於財務報表附註17。

##### 保修撥備

本集團經考慮本集團目前的銷售水平以及過往維修水平經驗，就其給予所銷售產品的保修作出撥備。由於本集團不斷升級其產品設計並推出新產品，維修及退回水平的過往經驗可能並不代表將來會收到有關過往銷售的索賠。實際索賠的任何增加或減少都會影響未來年度的損益。

##### 存貨撇減至可變現淨值

本集團根據存貨相關會計政策自成本中將存貨撇減至可變現淨值，並使用成本及可變現淨值兩者中較低者對廢棄及滯銷產品作出撥備。撇減所需的評估涉及管理層的判斷及估計。倘未來的實際結果或預期與原始估計不同，則該等差異將對估計變更期間的存貨及存貨撇減的賬面值產生影響。於2022年12月31日，存貨的賬面值為人民幣246,715,000元(2021年：人民幣258,219,000元)。

### 4. OPERATING SEGMENT INFORMATION

For management purposes, the Group is organised into business units based on their products and has five reportable operating segments as follows:

- (a) Production and sale of personal student tablets;
- (b) Production and sale of smart classroom solutions;
- (c) Production and sale of wearable products;
- (d) Production and sale of other products; and
- (e) Advertisement and content licensing.

Management monitors the results of the Group's operating segments separately for the purpose of making decisions about resource allocation and performance assessment. Segment result is evaluated based on gross profit. No analysis of segment assets and liabilities is presented as management does not regularly review such information for the purposes of resource allocation and performance.

##### Sale of devices, wearable products and other products

The performance obligation is satisfied upon acceptance of the goods by the customers and payment is generally due within 30 days from delivery, except for direct sales to end users where payment in advance is normally required. Some contracts with the distributors contain terms for sales rebates which give rise to variable consideration subject to constraint.

##### Digital educational resources and services

The performance obligation is satisfied over time as services are rendered and payment is generally made upfront together with the sale of the devices.

##### Advertisement

The performance obligation is satisfied when the services are rendered and the consideration is based on an agreed unit price and the volume of clicks or downloads. The payment is made on monthly basis when the monthly statement is received and confirmed.

##### Content licensing

The performance obligation is satisfied at a point in time when the control of digital educational resources is transferred to the customer but revenue is only determinable when the monthly statement is issued and confirmed.

### 10. INCOME TAX

The Group is subject to income tax on an entity basis on profits arising in or derived from the jurisdictions in which members of the Group are domiciled and operate.

#### Cayman Islands

The Company is incorporated in the Cayman Islands as an exempted company with limited liability under the Companies Act of the Cayman Islands and, accordingly, it is not subject to income tax from businesses carried out in the Cayman Islands.

#### British Virgin Islands

Pursuant to the rules and regulations of BVI, the subsidiary incorporated in the BVI is not subject to any income tax.

#### Hong Kong

No provision for Hong Kong profits tax has been made as the Group did not generate any assessable profits arising in Hong Kong during the year (2021: Nil).

#### Mainland China

All of the Group's subsidiaries which registered in the PRC and have operations in Mainland China are subject to PRC enterprise income tax on the taxable income as reported in their PRC statutory accounts adjusted in accordance with relevant PRC income tax laws based on a statutory rate of 25%.

Pursuant to relevant laws and regulations in the PRC and with approval from the tax authorities in charge, one of the Group's subsidiaries, Readboy Educational Technology Company Limited (讀書郎教育科技有限公司, "Readboy Technology"), is qualified as a high and new technology enterprise and entitled to a preferential tax rate of 15% from 2020 to 2022. Therefore, for Readboy Technology, it was entitled to this preferential tax rate for the years ended 31 December 2022 and 2021.

### 10. 所得稅

The most significant inputs into this valuation approach are estimated rental value, rental growth, vacancy rate and discount rate. The fair value measurement hierarchy of the investment property requires certain significant unobservable inputs (Level 3).

The investment properties are leased to third parties under operating leases, further summary details of which are included in note 15 to the financial statements.

The Group is therefore liable for withholding taxes on dividends distributed by those subsidiaries established in Mainland China in respect of earnings generated from 1 January 2008.

In accordance with the Company Law of the PRC, certain subsidiaries of the Group which are domestic enterprises are required to allocate 10% of their profit after tax, as determined in accordance with the relevant PRC accounting standards, to their respective statutory surplus reserves until the reserves reach 50% of their respective registered capital.

The Group's finance department headed by the financial controller is responsible for determining the policies and procedures for the fair value measurement of financial instruments. At each reporting date, the finance department analyses the movements in the values of financial instruments and determines the major inputs applied in the valuation. The valuation is reviewed and approved by the chief financial officer. The valuation process and results are discussed with the board of directors for annual financial reporting.

The Group's principal financial instruments comprise cash and cash equivalents. The main purpose of these financial instruments is to raise finance for the Group's operations. The Group has various other financial assets and liabilities such as other receivables, other non-current assets, other payables and accruals and amounts due to shareholders which arise directly from its operations.

The main risks arising from the Group's financial instruments are foreign currency risk, credit risk and liquidity risk. The directors of the Company review and agree policies for managing each of these risks and they are summarised below.

#### Foreign currency risk

The Group's main businesses are located in Mainland China and the transactions are conducted in Renminbi. Most of the Group's assets and liabilities are denominated in Renminbi, except for certain cash and bank balances, and time deposits denominated in HKD and USD. The Group has not hedged its foreign exchange rate risk.

The following table demonstrates the sensitivity at the end of the reporting period to a reasonably possible change in the Renminbi against the relevant currencies, with all other variables held constant, of the Group's profit before tax (due to changes in the fair value of monetary assets and loans).

The Group trades only with recognised and creditworthy third parties. It is the Group's policy that all customers who wish to trade on credit terms are subject to credit verification procedures. In addition, receivable balances are monitored on an ongoing basis and the Group's exposure to bad debts is not significant.
