The Board also proposes to adopt the second amended and restated memorandum and articles of association of the Company in substitution for, and to the exclusion of, the Existing Memorandum and Articles of Association in their entirety.

The key Proposed Amendments are mainly to bring the Existing Memorandum and Articles of Association in line with the recent amendments to the Listing Rules and the applicable laws of the British Virgin Islands.

The Proposed Amendments shall be subject to the passing of a special resolution by the shareholders of the Company (the "Shareholders") at the forthcoming annual general meeting of the Company to be held on 30 May 2023 (the "AGM") and the registration with the British Virgin Islands Registrar of Corporate Affairs.
