MAJOR EVENTS OF RADIANCE 金輝大事記

JANUARY 2022

On 19 January, the “13th Forum of House China and the Chinese Real Estate Red List Ceremony 2021” hosted by House.china.com.cn was held virtually online. The ceremony unveiled the “Chinese Real Estate Red List 2021”, and Radiance Holdings was successfully listed in the “Enterprise with Brand Influence”, which commended enterprises that promoted industry development and established their own brands in the past year and made outstanding cases, reviewed industry development and helped the industry move forward.

MARCH 2022

On 14 March, Lianyungang Jinhui donated RMB300,000 to the Lianyungang Red Cross to fight against the epidemic together with the city as a tribute. With our presence and investment in Lianyungang for 11 years, the donation is a reflection of the corporate mission and social responsibility of Radiance Group.

On 29 March, the China Real Estate Association issued the 2022 “Top 500 Real Estate Developers in terms of Comprehensive Strength”. Radiance Group ranked 38th and was named to the “2022 TOP 10 Real Estate Development Enterprises – Business Performance” list.

On 31 March, in the “2022 China Top 100 Real Estate Developer Research Results Conference” (2022中國房地產百強企業研究成果發佈會) jointly organised by the Tsinghua University Real Estate Research Institute (清華大學房地產研究所) and China Index Academy (中指研究院), Radiance Holdings was awarded the “2022 China Top 100 Real Estate Enterprises TOP 50”, citing its steady growth and annual results.

MAY 2022

On 26 May, Shanghai E-house China Research Institute (上海易居房地產研究院), and the China Real Estate Association jointly issued the latest “Evaluation and Research Report on Real Estate Listed Companies in 2022”. Radiance Holdings gained growing recognition from the market and investors for its superb market value management and steady development and operation philosophy, and was named to the “2022 TOP 30 Comprehensive Strength of Real Estate Listed Companies” list.

On 31 May, Radiance’s 2021 Sustainability Report was released. In the green initiative and responsibility-themed report, Radiance showcased the action items and achievements made in environmental protection, green operation, product and service responsibility, employee training and development, and social contribution, and disclosed data such as “Environmental Key Performance Indicators”, “Resource Consumption Data Summary”, “Pollutant and Exhaust Emission Targets” and “Customer Satisfaction”, showing Radiance’s determination to build and implementation in the build of an ESG working mechanism and fulfil its commitment to sustainable development.

2022年一月

1月19日，由中國網地產主辦的「第十三屆地產中國論壇暨2021中國房地產紅榜盛典」在線上雲進行，本次盛典揭曉了「2021中國房地產紅榜」，金輝控股成功上榜「品牌影響力企業榜單」，以褒獎在過去一年中推進行業發展、企業自身品牌樹立做出突出案例的企業，審視行業發展，助力行業前行。

2022年三月

3月14日，連雲港金輝向連雲港紅十字會捐助30萬元，與港城一起對抗疫情，貢獻金輝力量。深耕連雲港十一年，這份捐贈也體現了金輝集團的企業使命與社會責任感。

3月29日，中國房地產業協會發布2022房地產開發企業綜合實力TOP500，金輝集團排名第38名，獲「2022房地產開發企業經營績效TOP10」榮譽稱號。

3月31日，由清華大學房地產研究所和中指研究院聯合舉辦的「2022中國房地產百強企業研究成果發佈會」中，金輝控股全年業績穩健增長，榮登「2022中國房地產百強企業TOP50」。

2022年五月

5月26日，上海易居房地產研究院聯合中國房地產業協會發布了最新的《2022房地產上市公司測評研究報告》，金輝控股憑藉良好的市值管理、穩健的發展經營理念，獲得市場和投資人的一致認可，榮獲「2022房地產上市公司綜合實力TOP30」。

5月31日，金輝控股發布了2021年可持續發展報告。報告以綠色、責任為核心，詳盡展示了金輝在環境保護、綠色運營、產品與服務責任、職工培訓及發展、社會貢獻等方面的行動與成果，並披露了「環境關鍵績效指標」、「資源消耗數據摘要」、「污染物及廢氣排放目標」、「客戶滿意度」等相關數據，顯示出金輝著力構建ESG工作機制的決心與執行力度，履行對可持續發展的承諾。

MAJOR EVENTS OF RADIANCE 金輝大事記

JUNE 2022

In June, the second round of Radiance Group's "Wake Up of Sleeping Toys Project" (沉睡玩具喚醒計劃), a toy donation tour connecting different cities across China for over 20 days, was successfully completed. In this event, Radiance Group once again joined hands with the Ma Wei Social Work Development Center in Liangshan, Sichuan Province, so that more friends and children, big or small, could actively participate in the charity event and contribute to the children in Daliangshan. These newly donated toys will be sent to 110 towers of "Jincai Educational Garden" (金彩益智園) to provide continuous companionship to their childhood.

In June, Radiance Group donated RMB16 million to the Education Bureau of Quanzhou Municipality to support the development of education in Luojiang District and fulfil its corporate mission of "building properties with craftsmanship and making better homes (用心建好房, 讓家更美好)"。

JULY 2022

On 12 July, the TOP 500 of "Fortune China" 2022 was officially released, and Radiance Holdings was ranked among the top 500 companies for its consistent and excellent performance in the industry. Since its listing, Radiance Holdings has continued to rank in the list, reflecting the recognition of Radiance Holdings' comprehensive strength by authoritative international institutions.

In the afternoon of 28 July 2022, the Inaugurating Meeting of the Beijing Radiance Plaza Party Committee and Radiance Group Party Committee and the Opening Ceremony of Radiance Plaza Party Service Centre (北京金輝大廈黨委、金輝集團黨委成立大會暨金輝大廈黨群服務中心啟動儀式) was held in Beijing Radiance Plaza. The establishment of the Party Committee of Radiance Group will be a window for Radiance to learn the important instructions of the Central Committee of the CPC. It is believed that all party members of the Party Committee of Radiance Group will be a role model and become a bridge between the Party and the masses.

AUGUST 2022

On 9 August, the "2022 Boao Real Estate Forum" (「2022博鰲房地產論壇」) "hosted by www.guandian.cn released the "Influence Index – Prominent Real Estate Enterprises 2022". Radiance Holdings was named a "Influential Real Estate Enterprise 2022" for its strength and steady development.

On 19 August, the "Annual Forum and Finance Night" hosted by Leju was held in Hangzhou. Radiance Group was named a "2022 Quality Real Estate Benchmark Enterprise" for its outstanding performance in the industry during the year. The award focuses on the ability to build a quality real estate enterprise, and is determined based on multiple criteria including customer feedbacks, leadership, management system, improvement, and mutually beneficial supplier relationship, highlighting the steady and diversified development of Radiance.

2022年六月

6月，金輝集團「沉睡玩具喚醒計劃」第二季圓滿收官，歷時20多天，於全國多個城市共同完成了一場玩具的愛心接力。此次活動，金輝集團再度攜手四川省涼山瑪薇社工發展中心，讓更多的大朋友、小業主積極參與到公益行列中，為大涼山的孩子貢獻一份愛心，這些新捐助的玩具將被送往110座「金彩益智園」中，給與孩子們持續的陪伴。

6月，金輝集團向泉州市教育局捐贈人民幣1,600萬元，用於支持和幫助洛江區教育事業的發展，踐行用「心建好房，讓家更美好」的企業使命。

2022年七月

7月12日，2022年《財富》中國500強排行榜正式發布，金輝控股憑藉在行業內的持續優秀表現蟬聯500強榜單。金輝控股自上市後持續進入榜單排名，反映出國際權威機構對於金輝控股綜合實力的認可。

2022年7月28日下午，北京金輝大廈黨委、金輝集團黨委成立大會暨金輝大廈黨群服務中心啟動儀式在北京金輝大廈隆重舉行。金輝集團黨委的建立，將成為金輝學習黨中央重要指示精神的窗口，相信金輝黨委的全體黨員必將發揮先鋒模範作用，成為黨與群眾緊密聯繫的橋樑和紐帶。

2022年八月

8月9日，由觀點機構主辦的「2022博鰲房地產論壇」發布了「2022年影響力指數地產風尚企業表現」。金輝控股憑藉企業實力及穩健發展，榮膺「2022年度影響力地產企業」。

8月19日，由樂居財經主辦的「年度論壇暨財經之夜」在杭州舉辦，金輝集團憑藉本年度在行業內的優秀表現，榮膺「2022年品質地產標桿企業」。該獎項圍繞地產企業品質打造能力，從企業的顧客出發點、領導作用、管理系統化、持續改進、互利的供方關係等多角度進行評選得出，也證實了金輝穩健多元發展的均好態勢。

SEPTEMBER 2022

On 2 September, the 26th anniversary of Radiance Group, Radiance has been continuously empowering a better life through four dimensions: image revamp of Jin Xiao Rui (金小瑞, a convenient service), content and configuration upgrade of Jinhui Yansuan 3.0 (金輝顏選3.0), quality improvement of Radiance's themed activities, and the upgrade of transportation and security services. Besides, the Company published the main theme system of corporate culture of Jinhui 2.0 through all employees. The new cultural concept carries the new understanding of Radiance on the time and industry, gathers the new consensus of Radiance people on corporate development, and will also bring more warmth and power to all Radiance people. In the tide of the era, we will step further in better shape.

On 15 September, the delivery ceremony of Shishi Ninth Experimental Primary School (石獅市第九實驗小學) was held. Leaders of the Shishi government and education bureau and representatives of Radiance Group gathered to take urban education to the next level as a joint effort. The Shishi Ninth Experimental Primary School was a municipal public experimental primary school funded by Radiance Group and donated to the education bureau of Shishi. The delivery is not only a reflection of Radiance Group's corporate social responsibility, but also a demonstration of Radiance's brand recognition.

OCTOBER 2022

On 27 October, the "2022 Research Report on Evaluation of Brand Value of Real Estate Enterprises" issued by Shanghai E-house China Research Institute was released. With its stable operation and excellent overall quality, Radiance was named to the "Top 30 Chinese Real Estate Brand Value List" for five consecutive years, and its brand influence has been recognised by the industry again.

NOVEMBER 2022

On 23 November, China Bond Investment Co., Ltd. issued a credit enhancement letter to three private real estate enterprises, including Radiance Group, under the policy framework of the private enterprise bond financing support instrument (the "Second Arrow") to support Radiance to issue medium-term notes of RMB1.2 billion.

On 24 November, Industrial and Commercial Bank of China signed a strategic cooperation agreement with 12 national real estate enterprises, including Radiance Group, on a total-to-total basis to provide directional financing with a total amount of RMB655 billion, bringing together bank-enterprise cooperation to promote the stable and healthy development of the real estate market.

2022年九月

9月2日，正值金輝集團26週年，金輝通過四大維度：「金輝顏選生活官」金小瑞形像升級、「金輝顏選3.0」內容與配置產品升級、「金輝兌現季 看鑑美好家」主題活動品質升級、踐行溫暖守護服務升級，不斷賦能美好生活。並通過全員共創全新發布了金輝企業文化主旨體系2.0，新的文化理念承載著金輝對時代及行業的新理解，凝聚著金輝人對企業發展的新共識，也將帶給所有金輝人更暖的溫度和更強的力量，在時代的波濤之中，走得每一步更穩、更遠、更好。

9月15日，石獅市第九實驗小學交付盛典隆重舉行，活動現場石獅市政府領導、教育局領導及金輝集團代表等出席，齊聚一堂，共襄盛事，共同推動城市教育事業邁上新的台階。石獅市第九實驗小學，作為金輝集團出資建造無償捐贈給石獅教育局的一所市直屬公立實驗小學，此次交付既是金輝集團企業擔當社會責任的體現，也是金輝品牌兌現力的展現。

2022年十月

10月27日，由上海易居房地產研究院發布的《2022房地產企業品牌價值測評研究報告》出爐，憑藉穩健的經營實力和優秀的綜合素質，金輝連續5年蟬聯「中國房地產品牌價值30強」，品牌影響力再獲行業認可。

2022年十一月

11月23日，中債增進公司在民企債券融資支持工具（「第二支箭」）政策框架下，出具對金輝集團等三家民營房企發債信用增進函，支持金輝發行12億元中期票據。

11月24日，中國工商銀行與金輝集團等12家全國性房地產企業，以總對總方式簽訂戰略合作協議，提供意向性融資總額達6550億元，匯聚銀企合力，共促房地產市場平穩健康發展。

MAJOR EVENTS OF RADIANCE 金輝大事記

DECEMBER 2022

In December, Radiance Group entered into comprehensive strategic cooperation agreements with Industrial and Commercial Bank of China, China Minsheng Bank and Postal Savings Bank of China, and obtained more than 30 billion bank-level strategic credit in total.

On 5 December, Radiance Holdings has completed the issuance of the first tranche of the 2022 medium-term notes, with a principal amount of RMB1,200 million at a coupon rate of 4.00% and it is a three-year bond. The credit rating of the issuer was AA+, and the credit rating of this tranche was AAA. The medium-term notes were unconditionally and irrevocably guaranteed by China Bond Insurance Co., Ltd. ("China Bond Insurance") on a joint and several basis. It was also the first medium-term notes issued by an AA+ entity in the industry to be fully guaranteed by China Bond Insurance.

JANUARY 2023

On 4 January 2023, the "Signing Ceremony of the Bank-Enterprise Cooperation Agreement" sponsored by Xi'an Housing and Urban-Rural Development Bureau to support the stable and healthy development of the real estate industry was held, and Radiance Group signed a strategic agreement with Shaanxi Branch of Industrial and Commercial Bank of China and Shaanxi Branch of China Construction Bank. Subject to the national macro policies, regulatory requirements and credit system, the above banks will provide financing facilities to Radiance High-quality Projects for supporting delivery and new project loans.

In January 2023, Radiance Group entered into a strategic cooperation agreement with the Fujian Branch of China Construction Bank, pursuant to which, Radiance Group was granted an additional comprehensive credit facility of RMB10 billion. Both parties will establish a long-term strategic cooperation relationship and actively commit to constructive business cooperation in the financial field. As of 19 January, Radiance Group has successively entered into strategic cooperation agreements with the head offices and provincial branches of major banks, including Industrial and Commercial Bank of China, Agricultural Bank of China, Bank of China, China Construction Bank, Postal Savings Bank of China, China Minsheng Bank and Industrial Bank, and obtained credit facilities of more than RMB70 billion in aggregate, which provided sufficient credit support for the operation of the Company and demonstrated the recognition from financial institutions for the steady development of Radiance Group.

2022年十二月

12月，金輝集團先後與中國工商銀行、中國民生銀行、中國郵政儲蓄銀行簽署「總對總」全面戰略合作協議，累計獲得超300億總行級戰略授信。

12月5日，金輝控股完成公開發行2022年度第一期中期票據，發行規模為人民幣12億元，為期3年，票面利率為4.0%，本期債券企業主體信用等級AA+，本期中期票據信用評級AAA，由中債信用增進投資股份有限公司提供全額無條件不可撤銷的連帶責任保證擔保，也是全行業第一家AA+主體發行中債增全額擔保的中期票據。

2023年一月

2023年1月4日，由西安市住房和城鄉建設局主辦的「政銀聯動支持房地產平穩健康發展—銀企合作協議簽約儀式」舉行，金輝集團與中國工商銀行陝西分行、中國建設銀行陝西分行簽署戰略協議。在符合國家宏觀政策、監管要求及信貸制度的前提下，上述銀行將向金輝優質項目提供保交付配套融資、項目新增貸款的融資額度。

2023年1月，金輝集團與中國建設銀行福建省分行簽署戰略合作協議，再獲100億元的綜合授信支持。雙方將建立長期戰略合作關係，積極致力於金融領域的建設性業務合作。截至1月19日，金輝集團已經陸續與中國工商銀行、中國農業銀行、中國銀行、中國建設銀行、中國郵政儲蓄銀行、中國民生銀行、興業銀行等各大銀行總行及省分行簽署戰略合作協議，累計獲得授信金額突破700億，為公司運營提供了充足的信貸支持，展現出金融機構對於金輝穩健發展的認可。

CHAIRMAN'S STATEMENT

主席報告

DEAR SHAREHOLDERS,

I am pleased to present to all shareholders of Radiance Holdings (the "Shareholders") the annual results and business review for the year ended 31 December 2022 as well as the prospects for 2023 of Radiance Holdings.

ANNUAL RESULTS

For the year ended 31 December 2022, the revenue of the Group amounted to RMB35,318.0 million, representing a year-on-year decrease of 11.8% as compared to the corresponding period of last year. Gross profit amounted to RMB5,179.5 million, representing a year-on-year decrease of approximately 33.1% as compared to the corresponding period of last year. Profit attributable to the owners of the Company was RMB1,705.0 million, representing a year-on-year decrease of 47.9% as compared to the corresponding period of last year.

BUSINESS REVIEW

Eased policies with continuous market adjustment

Looking back at 2022, due to the repeated outbreaks of the pandemic in many places, the demand for housing was weakened, and the real estate market was operating at a low level due to the impact of various factors. The challenges faced by the real estate industry were unprecedented, and the overall situation was relatively sluggish. Since the beginning of 2022, despite the continuously optimised regulatory policies and credit environment, the effect of the policies was not obvious, and the real estate market remained to be subject to deep adjustments.

In 2022, the floor area sold of commercial properties nationwide was 1.36 billion square meters ("sq.m."), representing a decrease of 24.3% over last year, of which the floor area sold of residential properties decreased by 26.8%. The sales of commercial properties amounted to RMB13.3 trillion, representing a decrease of 26.7% over last year, of which the sales of residential properties decreased by 28.3%.

In addition, real estate enterprises suffered from the slowdown of capital recovery and the tightened financing environment, the increasing risks of debt default. In order to solve the financing difficulties faced by real estate enterprises, the central government has adopted a combination of policies, known as the "three-arrow" policy, on the three major financing channels, namely credit support, bond financing and equity financing, to support real estate enterprises to broaden their financing channels and address their financing difficulties. In addition, with the concerted efforts of financial institutions, shareholders and regulatory authorities, a large amount of funds was input to real estate projects and real estate enterprises through different channels. The "three-arrow" policy is gradually improving the external financing environment of real estate enterprises, and also directly supports to ensure the delivery of properties, thereby boosting market confidence.

尊敬的各位股東：

全年業績

截至二零二二年十二月三十一日止年度，本集團營業收入達到人民幣35,318.0百萬元，較去年同期同比下跌11.8%；毛利潤人民幣5,179.5百萬元，較去年同期同比下跌約33.1%；本公司擁有人應佔利潤為人民幣1,705.0百萬元，較去年同期同比下跌47.9%。

業務回顧

政策放寬，市場持續調整

回顧二零二二年，由於多地疫情反覆，住房需求減弱、在多重因素影響下房地產市場運行低落，房地產行業面臨的挑戰前所未有，整體呈現較為低迷的狀態。二零二二年初以來調控政策及信貸環境不斷優化，但政策效果並不明顯，房地產市場仍持續處於深度調整的態勢。

二零二二年，全國商品房銷售面積13.6億平方米（「平方米」），比去年下降24.3%，其中住宅銷售面積下降26.8%。商品房銷售額13.3萬億元，比去年下降26.7%，其中住宅銷售額下降28.3%。

除此之外，房企受困於資金回籠放緩、融資環境收緊，債務違約風險加大，為化解房地產企業面臨的融資困難，中央部門從信貸支持、債券融資、股權融資三個融資主渠道，採取「三支箭」的政策組合，支持房企拓寬融資途徑，解決房企資金難題，並通過金融機構、股東、監管方共同發力，通過不同渠道輸入大量資金到地產項目和房企。「三支箭」正在逐步改善房企的外部融資環境，也能直接支持「保交樓」，進而提振市場信心。

Steadily moving forward and strict performance of contracts

In response to the severe market changes, the Group has reinforced its development strategy of maintaining a stable financial structure. By actively responding to policy changes, focusing on sales, promoting payment collection and controlling costs, the Group continued to promote the reduction of financial leverage, adjust debt structure and control liquidity risk, thereby maintaining a stable financial position with remarkable results.

For the year ended 31 December 2022, the Group had a debt balance of RMB37,815.8 million, representing a decrease of 28.4% from RMB52,794.2 million as at 31 December 2021. The Group's weighted average cost of debt further decreased to 6.22%, representing a decrease of 0.36 percentage-point as compared to that of 6.58% for the year ended 31 December 2021.

Moreover, the Group completed the repurchase and payment of principal and interest of several domestic and overseas bonds and notes in 2022, strictly fulfilling its repayment obligations and safeguarded the rights and interests of the investors.

Receiving numerous industry awards for high-quality development

Radiance Holdings ranked 38th in the "Top 500 Real Estate Developers in terms of Comprehensive Strength" jointly released by China Real Estate Association and Shanghai E-House China Research Institute in 2022. In addition, the Company won a number of awards such as being included in the "List of Brand Influential Enterprise", the "Best Practicing Enterprise in ESG Social Responsibility for the Year", the "Influential Real Estate Enterprise for the Year", the "Real Estate Benchmark Enterprise in Term of Quality for the Year", and was awarded the "Fortune China Top 500 for 2022".

Adhering to the product concept of "crafting a sense of craftsmanship and building a home with utmost care", the Group continued to carry out product research and development in 2022, and won a number of design awards at home and abroad, including the "Innovation Design Award in Space Category" and the "U.S. TITAN Real Estate Award (Platinum Award)".

Consolidating the brand of "Jinhui Yanxuan" with a customer-oriented approach

In 2022, with a customer-oriented approach, the Company continued to consolidate the brand of "Jinhui Yanxuan" and completed 7 iterations of research and development achievements, including "Yanxuan Living Room", "Yanxuan Landscapes" and "Yanxuan Space", accomplishing 71 achievements and sorting out 396 product standards in 101 projects nationwide. It won 17 domestic and foreign product design awards, including the "MUSE Design Award in the United States" and the "AHLA Asian Habitat Design Award". In addition, in 2022, we focused on the "cost reduction without compromising quality" action for our products, whereby we exercised control over costs while ensuring product power and customer value, so as to maximise project profits and Shareholder returns.

穩健前行，嚴格履約

面對劇烈的市場變動，更加堅定了本集團保持穩健財務結構的發展策略。本集團通過積極應對政策變化，抓銷售、促回款，控成本的同時，繼續推進降低財務槓桿，調整債務結構，控制流動性風險，保持了穩健的財務狀況，並取得了顯著的效果。

截止二零二二年十二月三十一日年度，本集團債務餘額人民幣37,815.8百萬元，較截至二零二一年十二月三十一日的人人民幣52,794.2百萬元降低28.4%。本集團加權平均債務成本進一步下降至6.22%，相較於截止二零二一年十二月三十一日年度的加權平均債務成本6.58%下降0.36個百分點。

並且，本集團於二零二二年完成多筆境內外債券及票據本息的回購及兌付，嚴格履行償付義務，保證投資人的權益。

高質量發展，屢獲行業各項殊榮

由中國房地產業協會、上海易居房地產研究院共同發佈的《房地產開發企業綜合實力TOP500》中，金輝控股於二零二二年排名第38位。並榮獲「品牌影響力企業」、「年度ESG最佳社會責任實踐企業」、「年度影響力地產企業」、「年度質量地產標杆企業」等多項殊榮，蟬聯「二零二二年《財富》中國500強」。

遵循著「匠造質感，臻心築家」的產品理念，在二零二二年本集團在產品研發端步履不停，榮獲國內外多項設計類獎項，其中包含「空間類創新設計獎」和「美國TITAN地產大獎鉅金獎」等。

以客戶為中心，鞏固「金輝顏選」品牌

二零二二年以客戶為中心，持續鞏固「金輝顏選」品牌，研發成果完成「顏選會客廳」、「顏選景觀」、「顏選架空層」等7項迭代，在全國共實現71項成果落地、101個項目396項產品標準的梳理；獲得國內外產品設計類獎項17項，包括美國「MUSE設計大獎」、「AHLA亞洲人居設計獎」等。此外，二零二二年聚焦產品「同效降本」行動，在保證產品力和客戶價值的基礎上控制成本，從而實現項目利潤和股東回報最大化。

Optimising organisation and promoting high-quality corporate development

In order to adapt itself to the development and changes of the industry, meet customers' needs for product and service quality improvement and support the Group's future strategic direction, in terms of organisational management, the Group re-planned the organisational management mechanism by optimising its organisational structure, simplifying its management path and reconstructing its organisational role. In terms of corporate culture management, the Group organised the iterative upgrade of the corporate culture system. Adhering to the corporate mission of "build properties with craftsmanship and make better homes (用心建好房，讓家更美好)", the corporate vision has been updated to pursue better products and services, become a reliable benchmark enterprise of quality, put forward the core values of customer first, strive to promote high-quality development, win-win cooperation, pragmatism and integrity as well as the corresponding code of conduct for managers, and promote high-quality development.

Adhering to Original Commitments and Promoting the Sustainable Development of Public Welfare

The Group has always adhered to practising corporate social responsibility. In May 2022, the Group issued the 2021 Environmental, Social and Governance ("ESG") Report. The Group recognises that business activities are closely related to the society. Therefore, the Group actively incorporates ESG factors into all aspects of corporate operation and management, consolidates and drives the sustainable development of the Group, and reduces the impact of business on the environment. While striving to improve business performance and steady development, the Group will continue to optimise the management of projects in terms of working environment quality, environmental protection, humanities and social responsibility, and strive to maintain communication with stakeholders, identify material issues of the Group, and endeavours to align with the priorities of global sustainable development. The Group fulfils our commitment to sustainable development by constructing an ESG working mechanism.

As an enterprise full of sense of social responsibility, the Group always bears in mind its corporate social responsibility and actively participates in public welfare and charity activities such as poverty alleviation, education support, charity donation and disaster relief.

In May 2022, Radiance once again joined hands with the Mawei Social Work Development Centre in Liangshan, Sichuan Province to carry out the second season of the "Wake Up of Sleeping Toys Project (沉睡玩具喚醒計劃)" in more than 10 cities including Wuxi, Quanzhou, Shaoxing, Zhengzhou, Shijiazhuang and Hefei, continuing the previous toy donations to provide practical help and care for children in Daliangshan and help them grow healthily and happily.

優化組織，推動企業高質量發展

為了契合行業形勢的發展變化，適應客戶對產品和服務品質的需求提升，支持集團未來的戰略方向，在組織管理方面，本集團重新規劃組織管理機制，優化組織骨架，簡化管理路徑，重構組織角色。在企業文化管理方面，本集團組織開展了企業文化主旨體系的迭代升級。堅持「用心建好房，讓家更美好」的企業使命不動搖，企業願景更新為追求更好的產品及服務，成為可信賴的品質標杆企業，提出客戶第一、追求推動企業高質量發展卓越、協作共贏、務實擔當、陽光誠信的核心價值觀及相對應的管理者行為準則，推動企業高質量發展。

恪守初心，推動公益事業可持續發展

本集團一向堅持踐行企業社會責任，於二零二二年五月，本集團發佈二零二一年環境、社會及管治（「ESG」）報告。本集團理解商業活動與社會息息相關，因此積極將ESG要素注入企業營運管理的各個層面，鞏固並帶動本集團的可持續發展，減少業務對環境的影響。於致力提升業務表現和穩健發展同時，務求於項目的工作環境質量、環境保護、人文以及社會責任等範疇不斷優化管理，透過努力與持份者保持溝通，識別本集團的重大議題，努力與全球可持續發展的優次保持一致。本集團通過構建ESG工作機制，履行我們對可持續發展的承諾。

作為一家有社會責任感的企業，本集團始終不忘踐行企業社會責任，積極參與支持扶貧濟困、興教助學、公益捐贈、恤病救災等公益慈善事業。

二零二二年五月，金輝再度攜手四川省涼山瑪薇社工發展中心，在無錫、泉州、紹興、鄭州、石家莊、合肥等十餘座城市開展了「沉睡玩具喚醒計劃」第二季活動，延續前幾屆玩具捐贈的方式，為大涼山的孩子提供切實的幫助和關懷，助力健康快樂成長。

In June 2022, the Group donated RMB16 million to Quanzhou Municipal Education Bureau to support and help the development of education in Luojiang District and to fulfil its corporate mission of "build properties with craftsmanship and make better homes (用心建好房，讓家更美好)".

Looking ahead, the Group will stick to our original commitment, and continue to contribute to the development of education, science, culture, health, sports, overseas Chinese affairs and international exchanges, striving to become an important participant, promoter and contributor to the development of social charity and public welfare.

PROSPECTS FOR 2023

Looking forward to 2023, under the keynote of "houses are for living in, not for speculation", the policy will still focus on stabilising housing price. There is still room for optimising policies for both supply side and demand side, especially for the demand-side policy. Real estate enterprises will still face high cash flow pressure, and policy care is still needed to boost market confidence. Regarding the trend of real estate policy in 2023, the demand-side policy will be further strengthened. There is room for policy optimisation in core first-tier and second-tier cities, especially in core second-tier cities, where there is huge room for policy optimisation. We will continue to optimise the policy of "recognizing both properties and loans" and adjust the purchase restriction policy to further support the release of rigid demand and improved housing demand. The reasonable financing demand at enterprise side will continue to be supported, and the financing chain of real estate enterprises is expected to be further smoothed. In addition, the capital level of enterprises is expected to be improved, and the relevant funds of the "three-arrow" policy will be provided in an accelerated manner.

"Ensuring the delivery of properties" will remain the focal point, and the accelerated provision of special borrowings from policy banks and supporting financing from financial institutions is expected to make more substantial progress.

Although the challenging yet impressive year of 2022 has passed, the Group remains confident in the future development of the industry and the Company. In 2023, the Group will continue to strengthen its team building and strive to cultivate a more competitive, more efficient and pragmatic team in the next two to three years. It will develop a deep understanding of changes in the industry, improve its operation awareness, develop its determination and ability to solve problems, dare to take responsibility, stay diligent and dedicated, continue to improve professional capabilities and standards, enhance its management level and develop the awareness of innovation. In the spirit of team work, we will be able to complement each other and improve communications. we will insist on integrity and self-discipline, and will strictly abide by professional ethics and moral bottom line.

二零二三年展望

展望二零二三年，「房住不炒」主基調下，政策仍以托底為主，供需兩端尤其需求端政策仍有優化空間，房企現金流壓力尤在，市場信心提振仍需政策呵護。對於二零二三年的房地產政策趨勢，需求端政策將進一步加大力度，核心一二線城市存在政策優化空間，尤其是核心二線城市政策空間較大，繼續優化「認房又認貸」、調整限購政策等，進一步支持剛需和改善性住房需求釋放。企業端合理融資需求將繼續得到支持，房企融資鏈條有望進一步暢通，企業資金面有望得到改善，「三支箭」相關資金也將加速落地。

「保交樓」仍是側重點，政策性銀行專項借款、金融機構配套融資等資金加快落地有望取得更多實質性進展。

艱難而難忘的二零二二年已經過去，但本集團對行業和公司的未來發展仍然充滿信心。二零二三年要繼續加強本集團團隊建設，爭取在未來二至三年內培養出一支更有戰鬥力、更加高效務實的隊伍，對行業變化要有深刻的認知，轉變經營意識，要有解決問題的決心和能力，敢於擔當，勤奮敬業，持續提升專業能力和水平，敢於管理，具有創新意識。有合作精神，不計較、能補位、多交流。廉潔自律，嚴守職業操守和道德底線。

CHAIRMAN'S STATEMENT 主席報告

In 2023, we will continue to focus on customer sensitive points and improve product quality. We plan to iterate 9 innovative research and development achievements and implement 63 achievements, and will continue to promote the physical sample display of the Yanxuan Workshop on an "as is where is" basis.

In terms of operation, in 2023, we will safeguard the selling prices, strictly control costs, pay attention to operation quality and improve refined management level and operating efficiency, thereby smoothly passing through 2023.

FINANCIAL REVIEW

Revenue

For the year ended 31 December 2022, the revenue of the Group was approximately RMB35,318.0 million, represented a decrease of 11.8% as compared to RMB40,025.8 million of the corresponding period last year. Our revenue mainly derived from the development and sales of the Group's residential properties and commercial properties, we also derived revenue from leasing of commercial properties, and provision of management consulting services for the overall operation of property projects to our joint ventures and associates.

Revenue from Property Development and Sales

As of 31 December 2022, the revenue from property development and sales was approximately RMB34,906.7 million, represented a decrease of 11.7% as compared to approximately RMB39,521.6 million of the corresponding period last year. The decrease in the Group's revenue from property development and sales was primarily attributable to a decrease in the total GFA delivered by the Group.

財務回顧

物業開發及銷售的收入

於截至二零二二年十二月三十一日止，物業開發及銷售產生的收入約為人民幣34,906.7百萬元，較去年同期約為人民幣39,521.6百萬元減少11.7%。本集團物業開發及銷售收入減少乃主要歸因於本集團已交付總建築面積減少所致。

Rental Income

Revenue from property leasing consists of recurring rental revenue from leasing our commercial properties, such as office buildings, shopping malls and shopping streets. Our rental income decreased by approximately 1.7% to RMB390.4 million for the year ended 31 December 2022 from RMB397.1 million for the year ended 31 December 2021.

Management Consulting Services

The Group provides management consulting services to its joint ventures and associates, such services mainly include management consultation services provided to these entities in connection with the construction, sales and marketing of properties, and overall project management during the development and sales of properties. Our revenue from management consulting services decreased by approximately 80.5% to RMB20.9 million for the year ended 31 December 2022 from RMB107.2 million for the year ended 31 December 2021, which was mainly due the decrease in scale of projects developed by our joint ventures and associates which we provided management consulting services.

Cost of Sales

Cost of property development and sales mainly consists of construction costs, land acquisition costs and capitalized interest. During the year ended 31 December 2022, our cost of sales amounted to approximately RMB30,138.5 million, represented a decrease of 6.6% as compared to that of RMB32,278.4 million for the year ended 31 December 2021, which was primarily attributable to the contraction of our business scale, leading to a corresponding decrease in total GFA delivered.

Gross Profit and Gross Profit Margin

The Group's gross profit decreased to RMB5,179.5 million for the year ended 31 December 2022 from RMB7,747.5 million for the year ended 31 December 2021.

The Group's gross profit margin decreased to 14.7% for the year ended 31 December 2022 from 19.4% for the year ended 31 December 2021.

Finance Income

The Group's finance income primarily consists of interest income from bank deposits, interest income from funds the Group advanced to our joint ventures and associates and interest received from third parties. For the year ended 31 December 2022, the Group's finance cost was approximately RMB91.3 million, representing a decrease of approximately 50.2% as compared to RMB183.5 million for the year ended 31 December 2021, which was mainly due to the decrease in average bank deposits of the Group during the Year.

租金收入

物業租賃收入包括出租辦公樓、購物商場及購物街等商業物業的經常性租金收入。租金收入由截至二零二一年十二月三十一日止年度的人民幣397.1百萬元減少約1.7%至截至二零二二年十二月三十一日止年度的人民幣390.4百萬元。

管理諮詢服務

本集團向合營企業及聯營公司提供管理諮詢服務，相關服務主要包括於物業開發及銷售過程中向該等實體就建設、物業銷售及營銷以及整體項目管理提供管理諮詢服務。管理諮詢服務所得收入由截至二零二一年十二月三十一日止年度的人民幣107.2百萬元減少約80.5%至截至二零二二年十二月三十一日止年度的人民幣20.9百萬元，主要是由於我們所提供管理諮詢服務的合營企業及聯營公司開發的項目規模有所縮少。

銷售成本

物業開發及銷售成本主要包括建設成本、土地收購成本及資本化利息。截至二零二二年十二月三十一日止年度，銷售成本約為人民幣30,138.5百萬元，較截至二零二一年十二月三十一日止年度為人民幣32,278.4百萬元減少6.6%，主要是由於本集團的業務規模縮減，相應交付總建築面積因此減少。

毛利及毛利率

本集團的毛利由截至二零二一年十二月三十一日止年度的人民幣7,747.5百萬元減少至截至二零二二年十二月三十一日止年度的人民幣5,179.5百萬元。

本集團的毛利率由截至二零二一年十二月三十一日止年度的19.4%下降至截至二零二二年十二月三十一日止年度的14.7%。

財務收入

本集團的財務收入主要包括銀行存款產生的利息收入、向本集團的合營企業及聯營公司墊付資金而產生的利息收入以及自第三方收取的利息。截至二零二二年十二月三十一日止年度，本集團的財務收入約為人民幣91.3百萬元，較截至二零二一年十二月三十一日止年度為人民幣183.5百萬元減少約50.2%，主要是由於本年度本集團平均銀行存款減少導致。

Other Income and Gains

The Group's other income and gains decreased to RMB60.0 million for the year ended 31 December 2022 from RMB183.8 million for the year ended 31 December 2021, which was mainly due to the net exchange gain recorded in 2021 while a net exchange loss was recorded for the Year and there was a one-off gain on the disposal of subsidiaries recorded in the same period of 2021.

Selling and Distribution Expenses

The Group's selling and distribution expenses mainly consist of (i) promotion and advertising expenses, which primarily represent costs incurred in connection with advertisement in media and promotional events; (ii) employee benefit expenses, which primarily represent salaries paid to our Group's selling and marketing personnel; (iii) office and property management expenses, which primarily represent the expenses incurred in daily operation and management of the Group's sales offices; (iv) sales expenses, which primarily represent commissions paid to third-party sales agencies; (v) depreciation and amortization, which primarily represent the depreciation and amortization of equipment and devices used by the Group's selling and marketing personnel; (vi) travelling and entertainment expenses; and (vii) after-sales service expenses, which primarily represent expenses incurred during the provision of our Group's after-sales services to our customers.

The Group's selling and distribution expenses decreased by approximately 35.7% to RMB931.7 million for the year ended 31 December 2022 from RMB1,449.3 million for the year ended 31 December 2021, which was primarily attributable to the decrease in promotion and advertising expenses, salaries paid to the selling and marketing personnel and office expenses.

Administrative Expenses

Our administrative expenses mainly consist of (i) employee benefit expenses, which primarily represent salaries paid to our Group's administrative personnel; (ii) tax and surcharges, which primarily represent stamp duties in relation to sales contracts the Group entered into and property tax in relation to properties our Groups leased; (iii) depreciation and amortization, which primarily represent the depreciation and amortization of the Group's offices and office equipment; (iv) office expenses, which primarily represent the expenses incurred by our Group's administrative personnel in the daily operations of our Group's offices; (v) professional consulting expenses, which primarily represent the expenses for the consulting services the Group engaged in order to increase our operational efficiency; (vi) bank service charges, which primarily represent the expenses for miscellaneous bank services; (vii) travelling and entertainment expenses; and (viii) service expenditures.

The Group's administrative expenses decreased by approximately 28.6% to RMB853.7 million for the year ended 31 December 2022 from RMB1,195.4 million for the year ended 31 December 2021, which was primarily attributable to the decrease in salaries paid to the staff salaries and office expenses.

其他收入及收益

本集團的其他收入及收益由截至二零二一年十二月三十一日止年度的人民幣183.8百萬元減少至截至二零二二年十二月三十一日止年度的人民幣60.0百萬元，主要是由於二零二一年錄得淨匯兌收益而本年度錄得淨匯兌虧損及二零二一年同期錄得出售附屬公司之一次性收益導致。

銷售及分銷開支

本集團的銷售及分銷開支主要包括(i)促銷及廣告開支，其主要指與媒體廣告及促銷活動有關的已產生成本；(ii)僱員福利開支，其主要指支付予本集團銷售及營銷人員的薪金；(iii)辦公室及物業管理開支，其主要指本集團銷售辦公室日常經營及管理產生的開支；(iv)銷售開支，其主要指支付予第三方銷售代理的佣金；(v)折舊及攤銷，其主要指本集團銷售及營銷人員所用設備及裝置的折舊及攤銷；(vi)差旅及招待開支；及(vii)售後服務開支，其主要指本集團向客戶提供售後服務期間產生的開支。

本集團的銷售及分銷開支由截至二零二一年十二月三十一日止年度的人民幣1,449.3百萬元減少約35.7%至截至二零二二年十二月三十一日止年度的人民幣931.7百萬元，主要促銷及廣告開支、銷售及營銷人員薪金及辦公費用減少導致。

行政開支

行政開支主要包括(i)僱員福利開支，其主要指支付予本集團行政人員的薪金；(ii)稅項及附加費，其主要指與本集團所訂立的銷售合同有關的印花稅以及本集團所租賃物業的物業稅；(iii)折舊及攤銷，其主要指本集團辦公室及辦公室設備的折舊及攤銷；(iv)辦公室開支，其主要指本集團行政人員在本集團辦公室日常經營中所產生的開支；(v)專業諮詢開支，其主要指本集團為提高經營效率而委聘的諮詢服務開支；(vi)銀行服務費用，其主要指雜項銀行服務開支；(vii)差旅及招待開支；及(viii)服務開支。

本集團的行政開支由截至二零二一年十二月三十一日止年度的人民幣1,195.4百萬元減少約28.6%至截至二零二二年十二月三十一日止年度的人民幣853.7百萬元，主要是由於員工薪金及辦公費用減少導致。

Finance Cost

Our finance costs mainly consist of (i) interest on bank and other borrowings, corporate bonds, asset-backed securities, senior notes and lease liabilities; and (ii) interest expense arising from revenue contracts, which represents interest expenses recognised for the significant financing components included in contract liabilities during the period from the receipt of sales proceeds to the delivery of the underlying properties, less capitalized interest directly relating to properties under development.

The Group's finance cost decreased by approximately 32.5% to RMB236.1 million for the year ended 31 December 2022 from RMB349.9 million for the year ended 31 December 2021, which was primarily attributable to the decrease in interest-bearing debts and the reduction of average finance cost due to the continuous optimization of the Group's debt structure.

The Group's weighted average cost of debt as at 31 December 2022 was approximately 6.22% (31 December 2021: 6.58%).

Other Expenses

The Group's other expenses increased by approximately 326.7% to RMB191.6 million for the year ended 31 December 2022 from RMB44.9 million for the year ended 31 December 2021, which was primarily attributable to the exchange loss recorded due to the depreciation of Renminbi.

Fair Value Gains on Investment Properties

Fair value gains on investment properties represent the changes in the fair value of our investment properties. For the year ended 31 December 2022, the Group recorded fair value gains on investment properties of RMB844.6 million, represented an increase of 28.6% compared to that of RMB657.0 million for the year ended 31 December 2021. Such increase was primarily because Xi'an Jinhui Plaza (西安金輝廣場), Xi'an Jinhui World City Block J (西安金輝世界城J地塊) and Chongqing Lanyin World (重慶藍茵天地) were added to our investment properties portfolio, and accordingly we recorded a relatively high level of appreciation in value in 2022 as compared to the corresponding period of 2021.

Share of Profits and losses of Joint Ventures

For the year ended 31 December 2022, the Group recorded share of losses of joint ventures of RMB732.6 million, while we recorded share of profits of joint ventures of RMB98.4 million for the year ended 31 December 2021. Such change was mainly attributable to the provision for impairment losses of the property projects held by the Group's joint ventures during the year ended 31 December 2022.

Share of Profits of Associates

For the year ended 31 December 2022, the Group's recorded share of profits of associates of RMB491.0 million, while we recorded share of profits of associates of RMB641.1 million for the year ended 31 December 2021, which was primarily attributable to the decrease in GFA delivered property projects held by the Group's associates during the year ended 31 December 2022.

融資成本

融資成本主要包括(i)銀行及其他借款、公司債券、資產抵押證券、優先票據及租賃負債的利息；及(ii)收入合約利息開支，指於收到銷售所得款項至交付相關物業期間包括於合約負債內就重大融資組成部分確認之利息開支，減去開發中物業直接相關的資本化利息。

本集團的融資成本由截至二零二一年十二月三十一日止年度的人民幣349.9百萬元減少約32.5%至截至二零二二年十二月三十一日止年度的人民幣236.1百萬元，主要是由於本集團持續優化債務結構，有息債務減少及平均融資成本降低所致。

本集團於二零二二年十二月三十一日的加權平均債務成本約為6.22% (二零二一年十二月三十一日：6.58%)。

其他開支

本集團的其他開支由截至二零二一年十二月三十一日止年度的人民幣44.9百萬元增加約326.7%至截至二零二二年十二月三十一日止年度的人民幣191.6百萬元，主要是由於人民幣貶值錄得匯兌虧損所致。

投資物業公平值收益

投資物業公平值收益指投資物業公平值的變動。於截至二零二二年十二月三十一日止年度，本集團錄得投資物業公平值收益人民幣844.6百萬元，較截至二零二一年十二月三十一日止年度的人民幣657.0百萬元增加28.6%。有關增加主要是由於投資物業組合增加了西安金輝廣場、西安金輝世界城J地塊以及重慶藍茵天地，因此，二零二二年相較二零二一年同期錄得相對較高的物業增值水準。

應佔合營企業溢利及虧損

本集團於截至二零二二年十二月三十一日止年度錄得應佔合營企業虧損人民幣732.6百萬元，而於截至二零二一年十二月三十一日止年度則錄得應佔合營企業溢利人民幣98.4百萬元。有關變動主要是由於截至二零二二年十二月三十一日止年度本集團合營公司持有的物業項目計提減值撥備所致。

應佔聯營公司溢利

本集團於截至二零二二年十二月三十一日止年度錄得應佔聯營公司溢利人民幣491.0百萬元，而於截至二零二一年十二月三十一日止年度則錄得應佔聯營公司溢利人民幣641.1百萬元，主要是由於截至二零二二年十二月三十一日止年度本集團聯營公司持有的物業項目交付面積減少導致。

Profit before Tax

The Group's profit before tax decreased by approximately 42.7% to RMB3,706.4 million for the year ended 31 December 2022 from RMB6,465.6 million for the year ended 31 December 2021.

Income Tax Expenses

The Group's income tax expenses for the year included the provision made for PRC enterprise Income tax and land appreciation tax. The Group's income tax expenses decreased by approximately 41.4% to RMB1,623.3 million for the year ended 31 December 2022 from RMB2,771.9 million for the year ended 31 December 2021, which was primarily attributable to the decrease in provision for land appreciation tax.

The effective enterprise income tax rate (i.e. income tax divided by profit before tax) of the Group for the year ended 31 December 2022 was 43.8%, as compared to that of 42.9% for the year ended 31 December 2021.

Profit for the Year

As a result of the change in the Group's financial data mentioned above, the profit after tax of the Group decreased by approximately 43.6% to RMB2,083.2 million for the year ended 31 December 2022 from RMB3,693.7 million for the year ended 31 December 2021.

LIQUIDITY AND FINANCIAL RESOURCES

Net Current Assets

As at 31 December 2022, the Group's net current assets was RMB33,858.4 million (2021: RMB48,027.6 million). In particular, the Group's total current assets decreased by approximately 19.4% to RMB131,789.1 million as at 31 December 2022 from RMB163,474.6 million as at 31 December 2021. The Group's total current liabilities decreased by approximately 15.2% to RMB97,930.8 million as at 31 December 2022 from RMB115,447.1 million as at 31 December 2021. The decrease of the Group's net current assets was mainly attributable to (i) the decrease in properties under development as a result of our completion and delivery of properties; and (ii) the decrease in cash and cash equivalents. Such decrease was partly offset by the decrease in contracted liabilities as a result of decrease in sales of properties.

Cash Position

As at 31 December 2022, the Group's cash and bank balances was RMB12,319.5 million (2021: RMB19,728.5 million). Excluding the restricted cash and pledged deposits, our cash and cash equivalents amounted to RMB4,410.2 million, of which RMB4,374.9 million, RMB1.5 million and RMB33.8 million (2021: RMB11,221.9 million, of which RMB10,873.3 million, RMB97.7 million and RMB250.9 million) were denominated in Renminbi, Hong Kong dollars and US dollars.

除稅前溢利

本集團的除稅前溢利由截至二零二一年十二月三十一日止年度的人民幣6,465.6百萬元減少約42.7%至截至二零二二年十二月三十一日止年度的人民幣3,706.4百萬元。

所得稅開支

本集團本年度的所得稅開支包括就中國企業所得稅及土地增值稅所作撥備，經扣除遞延稅項。本集團的所得稅開支由截至二零二一年十二月三十一日止年度的人民幣2,771.9百萬元減少約41.4%至截至二零二二年十二月三十一日止年度的人民幣1,623.3百萬元，主要由於土地增值稅撥備減少導致。

本集團截至二零二二年十二月三十一日止年度的實際所得稅稅率（即所得稅除以除稅前溢利）為43.8%，而截至二零二一年十二月三十一日止年度則為42.9%。

年內溢利

基於上述的本集團財務數據變動，本集團的稅後溢利由截至二零二一年十二月三十一日止年度的人民幣3,693.7百萬元減少約43.6%至截至二零二二年十二月三十一日止年度的人民幣2,083.2百萬元。

流動資金及財務資源

流動資產淨額

於二零二二年十二月三十一日，本集團的流動資產淨值為人民幣33,858.4百萬元（二零二一年：人民幣48,027.6百萬元）。具體而言，本集團的流動資產總額由二零二一年十二月三十一日的人民幣163,474.6百萬元減少約19.4%至二零二二年十二月三十一日的人民幣131,789.1百萬元。本集團的流動負債總額由二零二一年十二月三十一日的人民幣115,447.1百萬元減少約15.2%至二零二二年十二月三十一日的人民幣97,930.8百萬元。本集團流動資產淨額的減少主要是由於(i)因我們竣工交付導致開發中物業減少及(ii)現金及現金等價物減少；該等減少部分被因物業銷售減少導致合約負債減少所抵減。

現金狀況

於二零二二年十二月三十一日，本集團的現金及銀行結餘為人民幣12,319.5百萬元（二零二一年：人民幣19,728.5百萬元）。不包括受限制現金及已抵押存款，現金及現金等價物為人民幣4,410.2百萬元，其中人民幣4,374.9百萬元、人民幣1.5百萬元及人民幣33.8百萬元（二零二一年：人民幣11,221.9百萬元，其中人民幣10,873.3百萬元、人民幣97.7百萬元及250.9百萬元）分別以人民幣、港元及美元計值。

管理層討論及分析

Indebtedness

As at 31 December 2022, the Group's outstanding borrowings amounted to RMB37,815.8 million (2021: RMB52,794.2 million), of which RMB19,109.5 million (2021: RMB26,893.8 million) carried interests at fixed rate. Save for the RMB2,516.4 million senior notes which were denominated in US dollars, all other borrowings of the Group were denominated in Renminbi.

Pledged Assets

As at 31 December 2022, the Group's borrowings was secured by the Group's assets that amounted to RMB55,954.2 million (2021: RMB70,721.9 million), such assets included (i) property, plant and equipment; (ii) land use rights; (iii) investment properties; (iv) properties under development; (v) completed properties held for sale; and (vi) pledged deposits.

Financial Risk

The Group's businesses exposed us to various financial risks, including interest rate risk, foreign exchange risk, credit risk and liquidity risk. In order to minimize such risk exposures of the Group, we do not use any derivatives and other instruments for hedging. The Group does not hold or issue financial derivatives for trading purpose.

Interest Rate Risk

The Group's exposure to changes in market interest rate relates primarily to the Group's interest-bearing bank and other borrowings. The Group does not use financial derivatives to hedge interest rate risk, and uses variable rate bank borrowings and other borrowings to manage its interest cost.

Foreign Exchange Risk

The Group mainly operates its business in China, and substantial of its revenue and expenses are denominated in Renminbi. As at 31 December 2022, among the Group's cash and bank balances, RMB1.5 million and RMB33.8 million was denominated in Hong Kong dollars and US dollars, respectively, such amounts were subject to the exchange rate fluctuation. The Group does not have any policy to hedge against foreign exchange risk. However, the Group will closely monitor its foreign exchange exposure, and strive to maintain the value of the Group's cash.

Credit Risk

The Group divides financial instruments on basis of shared credit risk characteristics, such as instrument type and credit risk ratings for the purpose of determining significant increases in credit risk and calculation of impairment. To manage risk arising from trade receivables, the Group has policies in place to ensure that credit terms are made only to counterparties with an appropriate credit history and management performs ongoing credit evaluations of the Group's counterparties. The credit quality of these customers is assessed after taking into account their financial position, past experience and other factors. The Group also has other monitoring procedures to ensure that follow-up action is taken to recover overdue receivables. In addition, the Group regularly reviews the recoverable amount of trade receivables to ensure that adequate impairment losses are made for irrecoverable amounts. The Group has no significant concentrations of credit risk, with credit risk spread over a large number of counterparties and customers.

資產抵押

於二零二二年十二月三十一日，本集團的借款以本集團人民幣55,954.2百萬元（二零二一年：人民幣70,721.9百萬元）的資產作抵押，該等資產包括(i)物業、廠房及設備；(ii)土地使用權；(iii)投資物業；(iv)開發中物業；(v)持作出售的已竣工物業；及(vi)已抵押存款。

財務風險

本集團的業務使其承受多種財務風險，包括利率風險、外幣風險、信貸風險及流動資金風險。為將本集團所面臨的該等風險保持最低，本集團並無使用任何衍生及其他工具作對沖目的。本集團未持有或發行作交易用途的衍生金融工具。

利率風險

本集團面臨的市場利率變動風險主要與本集團計息銀行及其他借款有關。本集團並無使用衍生金融工具對沖利率風險，並使用浮息銀行借款及其他借款管理其利息成本。

外幣風險

本集團主要在中國經營其業務，且其絕大部分收入及開支以人民幣計值。於二零二二年十二月三十一日，本集團的現金及銀行結餘中，人民幣1.5百萬元和人民幣33.8百萬元分別以港元和美元計值，該等款項受到匯率波動影響。本集團並無外幣對沖政策。然而，本集團將密切監察其匯率風險，以盡力維護本集團的現金價值。

信貸風險

本集團基於共同信貸風險特徵（比如工具類型及信貸風險等級）對金融工具進行分類，以釐定信貸風險大幅增加及計量減值。為管理貿易應收款項產生的風險，本集團已制定政策確保僅向具備適當信貸歷史的對手方授出信貸期，且管理層將對本集團的對手方持續進行信貸評估。客戶的信貸質量乃經考慮其財務狀況、過往經驗及其他因素而進行評估。本集團亦已擁有其他監控程序以確保落實跟進行動以收回逾期應收款項。此外，本集團定期檢討貿易應收款項的可收回金額，以確保就不可收回金額計提適當的減值虧損。本集團並無高度集中的信貸風險，且其信貸風險分散至大量對手方及客戶。

Liquidity Risk

The Group's objective is to maintain a balance between sustainability and flexibility of funding through the use of interest-bearing bank and other borrowings. The Group reviews its liquidity position on an ongoing basis.

Contingent Liabilities

The Group has arrangements with various banks for the provision of mortgage financing and, where required, provides our customers with guarantees as security for mortgage loans. The terms of such guarantees typically last until the issuance of the real estate ownership certificate upon the completion of guarantee registration or satisfaction of mortgage loan by the purchaser. As a guarantor, if the purchaser defaults in payment, the Group is obligated to repay all outstanding amounts owed by the purchaser to the mortgagee bank under the loan and have the right to claim such amount from the defaulting purchaser. As at 31 December 2022, the Group did not incur any material losses in respect of the guarantees provided for mortgage facilities granted to purchasers of the Group's completed properties held for sale. The Directors considered that the likelihood of default in payments by purchasers is minimal and therefore the financial guarantees measured at fair value was immaterial. As such, no provision has been made in connection with the guarantees.

As at 31 December 2022, the Group has provided guarantee to the banks amounting to RMB35,685.8 million (2021: RMB40,093.5 million) in total for the financing granted to the purchasers of the Group's properties. As at 31 December 2022, the Group has provided guarantee to the banks and other institutions amounting to RMB1,044.1 million (2021: RMB1,426.5 million) in total for the financing granted to the Group's related companies. As at 31 December 2022, the Group did not have any outstanding loan capital, bank overdrafts and acceptance liabilities or other similar indebtedness, debentures, mortgages, charges or loans, or acceptance credits or hire purchase commitments, guarantees or other material contingent liabilities or any covenant. The Directors have confirmed that there had not been any material change in the indebtedness, capital commitments and contingent liabilities of the Group up to the latest practicable date for the purpose of the indebtedness statement.

流動性風險

Legal Contingents

The Group may be involved in lawsuits and other proceedings from time to time during the ordinary course of business. The Group believes that the liabilities resulting from these proceedings will not have a material adverse effect on our business, financial condition or operating results.

Commitment

As at 31 December 2022, the Group had capital commitment of RMB24,893.2 million (2021: RMB23,147.5 million) in respect of properties under development, merger and acquisition of equity interest and capital injection for investment in joint ventures and associates.

Off-Balance Sheet Commitment and Arrangements

Save for the contingent liabilities disclosed above, as at 31 December 2022, the Group did not have any outstanding loan capital issued or agreed to be issued, bank overdrafts, loans, loan securities, borrowings or other similar indebtedness, acceptance liabilities (save for normal commercial notes), acceptance credits, debentures, mortgages, charges, finance lease or hire purchase commitments, guarantees or other material contingent liabilities.

Significant Investments Held, Material Acquisitions and Disposals of Subsidiaries, Associates and Joint Ventures

During the year ended 31 December 2022, the Company has no other significant investments held or material acquisitions or disposals of subsidiaries, associates and joint ventures.

Future Plan for Significant Investment

The Group did not have any other immediate plans for material investments and capital assets as at 31 December 2022.

Employees

As at 31 December 2022, the Group has a total of 2,257 employees (2021: 3,383 employees), with most of them were based in China. For the year ended 31 December 2022, staff costs (including Directors) was approximately RMB435.1 million (2021: approximately RMB605.6 million). The Group determined the salary based on the qualifications, position and experience of each employee. The Group has established a regular assessment mechanism to assess the performance of our employees, the assessment results are used as the basis for determining salary increment, bonuses and promotions.

CORPORATE GOVERNANCE REPORT

企業管治報告

The Board is pleased to present the corporate governance report of the Group for the year ended 31 December 2022.

BOARD COMPOSITION

As at 31 December 2022, the Board consists of four executive Directors, namely Mr. Lam Ting Keung (Chairman), Mr. Lam Yu, Mr. Huang Junquan and Mr. Xu Xiaodong and three independent non-executive Directors, namely Mr. Zhang Huaqiao, Mr. Tse Yat Hong, and Mr. Chung Chong Sun.

Mr. Lam Ting Keung is the father of Mr. Lam Yu, an executive Director. Other than that, there are no financial, business, family or other material relationships among the members of the Board.

During the year ended 31 December 2022, the Board has at all times met the requirements of Rules 3.10(1) and (2) of the Listing Rules relating to the appointment of at least three independent non-executive directors with at least one independent non-executive director possessing appropriate professional qualifications, or accounting or related financial management expertise. The three independent non-executive Directors represent more than one-third of the Board, complying with the requirement under Rule 3.10A of the Listing Rules whereby independent non-executive directors of a listed issuer must represent at least one-third of the board. The Board believes there is sufficient independence element in the Board to safeguard the interest of Shareholders.

During the year ended 31 December 2022, the Board performed the following corporate governance duties:

1. reviewed the Company's policies and practices on corporate governance;
2. reviewed the compliance with Model Code for Directors;
3. reviewed the training and continuous professional development of Directors;
4. reviewed the effectiveness of the risk management system and internal control system; and
5. reviewed the Company's compliance with the CG Code and disclosure in the Corporate Governance Report of this annual report.

董事會欣然呈列本集團截至2022年12月31日止年度的企業管治報告。

董事會組成

於2022年12月31日，董事會包括四名執行董事，分別為林定強先生（主席）、林宇先生、黃俊泉先生及徐小冬先生，以及三名獨立非執行董事，分別為張化橋先生、謝日康先生及鍾創新先生。

林定強先生為執行董事林宇先生的父親。除此之外，董事會成員之間概無財務、商業、家屬或其他重大關係。

截至2022年12月31日止年度，董事會一直遵守上市規則第3.10(1)及(2)條所載有關最少委任三名獨立非執行董事及最少其中一名獨立非執行董事須具備適當的專業資格或會計或相關財務管理專長的規定。三名獨立非執行董事於董事會佔比超過三分之一，符合上市規則第3.10A條項下有關上市發行人的獨立非執行董事須至少佔董事會三分之一的規定。董事會認為，董事會成員的組成有足夠的獨立性以保障本公司股東利益。

截至2022年12月31日止年度，董事會已履行以下企業管治職責：

1. 檢討本公司的企業管治政策及常規；
2. 檢討董事遵守標準守則的合規情況；
3. 檢討董事的培訓及持續專業發展；
4. 檢討風險管理制度及內部監控制度的有效性；及
5. 檢討本公司遵守企業管治守則的情況及於本年報的企業管治報告中之披露。

DIRECTORS' RESPONSIBILITIES

The Board is responsible for the leadership and control of the Company and oversees all major matters of the Company, including the formulation and approval of all policy matters, overall strategies, internal control and risk management systems, and monitor the performance of the senior executives. All Directors have carried out their duties in good faith and in compliance with the standards of applicable laws and regulations, and have acted in the interests of the Company and its shareholders at all times. As at 31 December 2022, the Board comprised seven Directors, including four executive Directors and three independent non-executive Directors. Their names and biographical details are set out in the "Biographies of Director and senior management" section of this report. Liability insurance for Directors and senior management of the Company is maintained by the Company with appropriate coverage for certain legal liabilities which may arise in the course of performing their duties.

The Board has also established mechanisms to ensure independent views are available to the Board, including providing the Directors with sufficient resources to perform its duties and shall seek, at the Company's expense, independent professional advice to perform its responsibilities if necessary. The Board shall at all times comprise at least three independent non-executive Directors that represent at least one-third of the Board, such that there is always a strong element of independence on the Board which can effectively exercise independent judgment. All the Directors, including the independent non-executive Directors, are given equal opportunity and channels to communicate and express their views to the Board and have separate and independent access to the management of the Group in order to make informed decisions. The chairman of the Board will hold meetings with the independent non-executive Directors without the involvement of other Directors at least annually to discuss any issues and concerns. Any Director or his/her associate who has a conflict of interest in a matter to be considered by the Board will be dealt with by a physical Board meeting rather than by written resolutions. Such Director will be required to declare his/her interests before the meeting and abstain from voting and not counted towards the quorum on the relevant resolutions. Independent non-executive Directors who, and whose associates, have no interest in the matter should attend the Board meeting. The Board has reviewed and considered that the mechanisms are effective in ensuring that independent views and input are provided to the Board during the year ended 31 December 2022.

董事的責任

董事會負責領導及控制本公司以及監督本公司所有主要事務，包括制定及批准所有政策事務、整體策略、內部控制及風險管理系統，以及監察高級行政人員的表現。全體董事已遵照適用法律及法規之準則真誠地履行彼等之職責，並一直按符合本公司及其股東利益的方式行事。於2022年12月31日，董事會由七名董事組成，包括四名執行董事及三名獨立非執行董事。彼等的姓名及履歷詳情載於本報告「董事及高級管理層簡歷」一節。本公司已為董事及本公司高級管理層購買責任保險，就彼等履行職責時引起的若干法律責任提供適當保障。

董事會亦已建立可確保董事會能夠獲得獨立意見的機制，包括向董事提供足夠的資源來履行其職責，並在必要時尋求獨立專業意見以履行其職責，費用由本公司承擔。董事會應始終由至少三名獨立非執行董事組成，彼等佔董事會成員至少三分之一，以使董事會始終具有很強的獨立性，能夠有效地作出獨立判斷。所有董事（包括獨立非執行董事）均享有與董事會溝通及向董事會表達意見的平等機會及渠道，並可單獨及獨立接觸本集團管理層以作出知情決定。董事會主席將在並無其他董事參與的情況下每年與獨立非執行董事舉行至少一次會議，以討論任何事宜及疑慮。任何在董事會將予考慮的事項中存在利益衝突的董事或其聯繫人，將通過現場董事會會議而非書面決議案來處理。有關董事將須在舉行會議前申報其利益並放棄投票，且會不計入相關決議案的法定人數。於該事項並無利益的獨立非執行董事及其聯繫人應出席董事會會議。董事會已檢討並認為該機制可有效確保於截至2022年12月31日止年度內向董事會提供獨立觀點及意見。

DELEGATION BY THE BOARD

The management, consisting of executive Directors along with other senior executives, is delegated with responsibilities for implementing the strategy and direction as adopted by the Board from time to time, and conducting the day-to-day management and operations of the Group. Executive Directors and senior executives meet regularly to review the performance of the businesses of the Group as a whole, co-ordinate overall resources and make financial and operational decisions. The Board also gives clear directions as to their powers of management including circumstances where management should report back, and will review the delegation arrangements on a periodic basis to ensure that they remain appropriate to the needs of the Group.

DIRECTORS' RESPONSIBILITIES FOR FINANCIAL STATEMENTS

The Directors acknowledge their responsibilities for preparing the consolidated financial statements of the Group in accordance with statutory requirements and applicable accounting standards. The Directors also acknowledge their responsibilities to ensure that the consolidated financial statements of the Group are published in a timely manner. The Directors are not aware of any material uncertainties relating to events or conditions which may cast significant doubt upon the Company's ability to continue as a going concern. Accordingly, the Directors have prepared the consolidated financial statements of the Group on a going concern basis.

INDEPENDENT NON-EXECUTIVE DIRECTORS

The independent non-executive Directors play a significant role in the Board by virtue of their independent judgment and their views carry significant weight in the Board's decision. The functions of independent non-executive Directors include bringing an impartial view and judgement on issues of the Company's strategies, performance and control; and scrutinising the Company's performance and monitoring performance reporting.

All independent non-executive Directors possess extensive academic, professional and industry expertise and management experience and have made positive contributions to the development of the Company through providing their professional advice to the Board.

All independent non-executive Directors are appointed for a term of three years.

董事會轉授權力

董事會授權管理層（由執行董事及其他高級行政人員組成），負責實行由董事會不時採納的策略及方針，並處理本集團日常營運業務。執行董事及高級行政人員會定期會面，檢討本集團整體的業務表現、協調整體資源及作出財務及營運決定。董事會亦對於彼等的管理權力，包括管理層須向董事會作報告的情況，作出清晰的指引，並會定期檢討轉授權力的安排，確保一直切合本集團的需要。

董事就財務報表承擔的責任

董事知悉其有責任根據法例規定及適用的會計準則，編製本集團的綜合財務報表，並知悉其有責任確保適時公佈本集團的綜合財務報表。董事並不知悉有任何關於重大不確定的事項或狀況可引發對本公司持續經營業務的能力產生重大疑問。因此，董事已按持續經營基準編製本公司的綜合財務報表。

獨立非執行董事

獨立非執行董事憑藉獨立判斷於董事會擔任重要角色，其意見對於董事會的決策舉足輕重。獨立非執行董事的職能是就本公司的策略、表現及監控事宜提供不偏不倚的意見及判斷，審查本公司的表現及監察表現報告。

全體獨立非執行董事擁有廣泛的學術、專業及行業專長以及管理經驗，透過向董事會提供專業意見而對本公司的發展作出積極貢獻。

全體獨立非執行董事的任期均為三年。

Confirmation of independence

The independence of the independent non-executive Directors has been assessed in accordance with the applicable Listing Rules and each of the independent non-executive Directors has made an annual written confirmation of independence to the Company pursuant to Rule 3.13 of the Listing Rules. The Company is of the view that all independent non-executive Directors meet the guidelines for assessing independence set out in Rule 3.13 of the Listing Rules and are independent.

BOARD DIVERSITY POLICY

The Board has adopted a board diversity policy which sets out the approach to achieve diversity of the Board. The Company recognises and embraces the benefits of having a diverse Board and sees increasing diversity at the Board level as an essential element in supporting the attainment of the Company's strategic objectives and sustainable development. The Company seeks to achieve Board diversity through the consideration of a number of factors, including but not limited to gender, age, cultural and educational background, ethnicity, professional experience, skills, knowledge and length of service. All Board appointments will be based on meritocracy and candidates will be considered against objective criteria, having due regard to the benefits of diversity on the Board.

The Directors have a balanced mix of knowledge, skills and experience, including commercial property operation, overall business management, finance and investment. They obtained degrees in various majors including business administration, electrical engineering and automation, real estate, computerized accounting. The Company has three independent non-executive Directors who have different industry backgrounds, representing over one-third of our Board members. Furthermore, the Board has a wide range of age, ranging from 32 years old to 59 years old. We have taken and will continue to take steps to promote gender diversity at all levels of our Company, including but without limitation at our Board and senior management levels. Taking into account our business model and specific needs, we consider that the composition of the Board satisfies our board diversity policy.

獨立性確認

本公司已根據適用的上市規則評估獨立非執行董事的獨立性，而各獨立非執行董事已根據上市規則第3.13條就其獨立性向本公司作出年度書面確認。本公司認為，所有獨立非執行董事均符合上市規則第3.13條所載評估獨立性的指引，且均為獨立人士。

董事會多元化政策

董事會已採納董事會多元化政策，其載有實現董事會多元化的方式。本公司認同及接受董事會多元化的好處，並認為董事會日漸多元化乃支持實現本公司戰略目標及可持續發展的重要因素。為尋求達致董事會多元化，本公司會考慮眾多因素，包括但不限於性別、年齡、文化及教育背景、種族、專業經驗、技能、知識及服務年限。董事會所有委任均以用人唯才為原則，並在考慮人選時以客觀標準充分顧及董事會多元化的裨益。

董事擁有各種知識、技能及經驗，包括商業物業運營、整體業務管理、融資及投資。彼等獲得工商管理、電氣工程及自動化、房地產、會計電算化等各種專業學位。本公司擁有三名具備不同行業背景的獨立非執行董事，佔董事會成員的三分之一以上。此外，董事會年齡範圍廣泛，介乎32歲至59歲之間。我們已採取並將繼續採取措施推進本公司所有層面（包括但不限於董事會及高級管理層層面）的性別多元化。經計及我們的業務模式及具體需求，我們認為董事會的組成符合董事會多元化政策。

With regard to gender diversity on the Board, all Board members are male and the Company is aware that a single gender Board will not be considered as having achieved gender diversity. The board diversity policy further provides that the Board shall take opportunities to increase the proportion of female members over time when selecting and making recommendations on suitable candidates for Board appointments. The Board would ensure that appropriate balance of gender diversity is achieved with reference to stakeholders' expectation and international and local recommended best practices, with the ultimate goal of bringing our Board to gender parity. Going forward and with a view to developing a pipeline of potential successors to the Board that may meet the targeted gender diversity ratio set out below, we will (i) continue to make appointments based on merits with reference to board diversity as a whole; (ii) take steps to promote gender diversity at all levels of the Group by recruiting staff of different gender; (iii) consider the possibility of nominating female management staff who has the necessary skills and experience to the Board; and (iv) provide career development opportunities and more resources in training female staff with the aim of promoting them to the senior management or board of the Company so that we will have a pipeline of female senior management and potential successors to our Board in a few years' time.

The Nomination Committee will use its best efforts to identify and recommend female candidates to the Board for consideration for appointment as Directors with an ultimate aim to achieve at least 20% female representation in the Board within five years of Listing, subject to there being suitable candidates and the Directors being satisfied with the qualification and experience of the relevant candidates after a reasonable review process based on selection criteria designed with the best interests of the Company's business in mind. The Directors will exercise fiduciary duties in the process, acting in the best interests of the Company and the Shareholders as a whole when making the relevant appointments.

The Nomination Committee is responsible for ensuring diversity of the Board members and will use its best efforts to identify and recommend suitable candidates, including female candidates, for the Board's consideration. We also welcome candidates of different gender to apply for our mid to senior level positions. The ultimate decision of the appointment will be based on merits and the contribution which the selected candidates could bring to our Board and management team. The Board believes that such merit-based selection criteria will best enable the Company to serve the Shareholders and other stakeholders going forward.

就董事性別多元化而言，所有董事會成員均為男性，而本公司知悉單性別董事會將不被視為已實現性別多元化。董事會多元化政策進一步規定，董事會應該隨著時間於選擇及推薦合適候選人加入董事會時適時增加女性成員的比例。董事會將參考持份者的期望以及國內外推薦的最佳慣例以確保實現性別多元化的適當平衡，最終目標為實現董事會在性別方面的平等。日後及為開發可能滿足下文所載性別多元化比率目標的董事會潛在繼任人管道，我們將(i)繼續基於才幹並參考董事會多元化(作為一個整體)進行委聘；(ii)透過招聘不同性別的員工，採取措施提升本集團各層級的性別多元化；(iii)考慮向董事會提名具備必要技能及經驗的女性管理層員工的可能性；及(iv)提供職業發展機會及在培訓女性員工時提供更多資源，旨在提拔彼等至高級管理層或本公司董事會，從而我們在幾年內將可擁有女性高級管理層以及為董事會潛在繼任人候選人。

提名委員會將盡最大努力向董事會識別及推薦女性候選人以獲聘為董事，最終目標為上市後五年內實現董事會內至少擁有20%女性席位，但須有合適的候選人，且董事根據以本公司業務的最佳利益為出發點而設計的甄選標準，經過合理的審查程序後信納相關候選人的資格及經驗。董事將在過程中行使受信責任，在進行相關任命時以本公司及股東的整體最佳利益行事。

提名委員會負責確保董事會成員的多元化並盡力物色和推薦合適的人選，包括女性候選人，供董事會考慮。我們亦歡迎不同性別的候選人申請我們的中高級職位。最終任命決定將根據經選定候選人的優點及能為董事會及管理層團隊作出的貢獻而作出。董事會認為，有關擇優選拔標準將使本公司往後能更好地為股東及其他利益相關者服務。

APPOINTMENT, RE-ELECTION AND REMOVAL OF DIRECTORS

Each of the executive Directors and independent non-executive Directors has entered into a service contract with the Company for a term of 3 years. Such term is subject to his retirement by rotation and re-election at an annual general meeting of the Company in accordance with the Company's Articles of Association. Pursuant to the Article 16.2 of the Articles, the Board shall have power from time to time and at any time to appoint any person as a Director either to fill a casual vacancy or as an addition to the Board. Any Director so appointed shall hold office only until the next following general meeting of the Company and shall then be eligible for re-election at that meeting.

Pursuant to the Article 16.19 of the Articles, at every annual general meeting of the Company one-third of the Directors for the time being (or, if their number is not three or a multiple of three, then the number nearest to, but not less than, one-third) shall retire from office by rotation provided that every Director (including those appointed for a specific term) shall be subject to retirement by rotation at least once every three years. Any Director required to stand for re-election pursuant to Article 16.2 shall not be taken into account in determining the number of Directors and which Directors are to retire by rotation. A retiring Director shall retain office until the close of the meeting at which he retires and shall be eligible for re-election thereat. The Company at any annual general meeting at which any Directors retire may fill the vacated office by electing a like number of persons to be Directors.

Pursuant to the Article 16.6 of the Articles, the Company may by ordinary resolution at any time remove any Director (including a Managing Director or other executive Director) before the expiration of his period of office notwithstanding anything in these Articles or in any agreement between the Company and such Director and may by ordinary resolution elect another person in his stead. Any person so elected shall hold office during such time only as the Director in whose place he is elected would have held the same if he had not been removed. Nothing in this Article should be taken as depriving a Director removed under any provision of this Article of compensation or damages payable to him in respect of the termination of his appointment as Director or of any other appointment or office as a result of the termination of his appointment as Director or as derogatory from any power to remove a Director which may exist apart from the provision of this Article.

委任、重選及罷免董事

各執行董事及獨立非執行董事已與本公司訂立為期三年的服務合約，並須根據本公司的組織章程細則於本公司股東周年大會告退及重選連任。根據章程細則第16.2條，董事會有權不時及隨時委任任何人士為董事以填補臨時空缺或加入董事會。任何就此獲委任的董事，任期僅直至本公司下屆股東大會為止，屆時於該大會上合資格重選連任。

根據章程細則第16.19條，於本公司每屆股東周年大會上，三分之一的在任董事（或倘若董事人數並非三或三的倍數，則最接近而不少於三分之一）須輪值退任，惟每名董事（包括獲指定任期的董事）須最少每三年輪值退任一次。在確定輪值退任的董事人數及人選時，並不計及根據章程細則第16.2條任命的董事。退任董事的任期僅至其須輪值退任的大會結束為止，屆時有資格於會上重選連任。本公司可於任何股東周年大會上選舉相同數目人士為董事，以填補任何董事離職空缺。

根據章程細則第16.6條，本公司可隨時通過普通決議案將任何任期末屆滿之董事（包括董事總經理或其他執行董事）罷免，而不受此等章程細則或本公司與該董事之間任何協議所影響，亦可通過普通決議案選舉另一名人士代替其職位。任何就此當選的人士僅能任職至其代替的董事在沒有被免職的情況下可以任職的時間。本章程細則的任何條文均不應被視為剝奪根據本章程細則任何規定而遭免職的董事因遭終止董事委任或因遭終止董事委任而失去任何其他職位任命而應獲支付的補償或賠償，也不會被視為削弱本章程細則規定之外罷免董事的任何權力。

DIRECTORS' TRAINING AND PROFESSIONAL DEVELOPMENT

On the first occasion of each Director's appointment, the Company would arrange a comprehensive, formal and tailored induction session on his/her appointment to ensure he/she would have a proper understanding of the Company's businesses and operations as well as his/her responsibilities under relevant statutes, laws, rules and regulations as a director of a listed company.

As part of continuous professional development of the Directors, the Company also provides briefings and other trainings to develop and refresh the Director's knowledge and skills, and continuously update Directors on the latest developments regarding the Group's business, the Listing Rules and other applicable legal and regulatory requirements to ensure compliance and enhance their awareness of good corporate governance practices.

During the year ended 31 December 2022, all the Directors namely, Mr. Lam Ting Keung, Mr. Lam Yu, Mr. Huang Junquan, Mr. Chen Chaorong (resigned on 25 March 2022), Mr. Xu Xiaodong (appointed on 25 March 2022), Mr. Zhang Huaqiao, Mr. Tse Yat Hong and Mr. Chung Chong Sun, have complied with code provision C.1.4 of the CG Code and participated in continuous professional development to develop and refresh their knowledge and skills.

董事培訓及專業發展

BOARD MEETINGS

The Board meets regularly to discuss and formulate the overall strategy as well as the operation and financial performance of the Group. Directors may participate either in person or through electronic means of communications.

Pursuant to code provision C.5.1 of the CG Code, the Board should meet regularly and board meetings should be held at least four times a year. In addition to regular Board meetings, the Directors also participate in deliberation and approval of routine and operational matters of the Company by way of written resolutions with supporting explanatory materials, supplemented by additional written information from the management when required. Additional Board meetings would be held whenever warranted.

During the year ended 31 December 2022, the Company held four Board meetings and one general meeting. Apart from that, the chairman also held a meeting solely with the independent non-executive Directors.

COMPLIANCE WITH THE MODEL CODE FOR SECURITIES TRANSACTIONS BY DIRECTORS

The Company has adopted the Model Code as its code of conduct for the Directors' dealings in the securities of the Company. Upon specific enquiries of all the Directors, each of them has confirmed that he had complied with all applicable code provisions under the Model Code for the year ended 31 December 2022.

As required by the Company, relevant officers and employees of the Company are also bound by the Model Code, which prohibits them to deal in securities of the Company at any time when he/she possesses inside information of the Group. No incident of non-compliance of the Model Code by the relevant officers and employees was noted by the Company.

DIVIDEND POLICY

The determination to pay dividends will be made at the discretion of our Directors, depending on our results of operations, working capital, financial position, future prospects, and capital requirements, as well as any other factors which our Directors may consider relevant. Dividends may be paid only out of our distributable profits as permitted under the relevant laws. Any final dividend distribution shall also be subject to the approval of the Shareholders in a Shareholders' meeting.

CORPORATE GOVERNANCE PRACTICES

The Directors recognise the importance of incorporating elements of good corporate governance in the management structures and internal procedures of the Group so as to achieve effective accountability. The Company is committed to the view that the Board should include a balanced composition of executive Directors and independent non-executive Directors so that there is a strong independent element on the Board, which can effectively exercise independent judgment. During the year ended 31 December 2022, the Company has applied the principles of good corporate governance and complied with the code provisions as set out in Part 2 of the CG Code except for the deviation from CG Code provision C.2.1 for reasons set out below.

企業管治慣例

董事深明在本集團管理架構及內部程序中融入良好企業管治元素對實現有效問責的重要性。本公司認為，董事會中執行董事與獨立非執行董事的組合應保持平衡，以使董事會具備較高的獨立性，能夠有效作出獨立判斷。截至2022年12月31日止年度，除出於以下理由偏離企業管治守則條文第C.2.1條外，本公司已應用良好企業管治原則及遵守企業管治守則第二部分所載的守則條文。

CHAIRMAN AND CHIEF EXECUTIVE OFFICER

CG Code provision C.2.1 stipulates that the roles of the chairman and chief executive officer should be separate and should not be performed by the same individual. Mr. Lam Ting Keung is the chairman of the Board and the chief executive officer of the Company. In view of the fact that Mr. Lam has been taking up day-to-day responsibilities in operating and managing the Group since its establishment, the Board believes that it is in the best interest of the Group to have Mr. Lam Ting Keung taking up both roles for effective management and business development. Therefore, the Directors consider that the deviation from CG Code provision C.2.1 is appropriate in such circumstance.

Notwithstanding the above, the Board views that such management structure is effective for the Group's operations and sufficient checks and balances are in place.

BOARD COMMITTEES

The Board has established three committees with specific written terms of reference to oversee particular aspects of the Group's affairs. All the Board committees are empowered by the Board under their own terms of reference which have been posted on Stock Exchange's website and/or the Company's website.

Audit Committee

The Company established an Audit Committee in compliance with Rule 3.21 of the Listing Rules with written terms of reference in compliance with the CG Code set forth in Appendix 14 to the Listing Rules on 5 October 2020. The primary duties of our Audit Committee are to assist our Board by providing an independent view of the effectiveness of our Group's financial reporting process, internal control and risk management system, to monitor the scope, effectiveness and results of internal audit functions, to oversee the audit process, to develop and review our policies and to perform other duties and responsibilities as assigned by our Board.

The Audit Committee consists of three independent non-executive Directors, namely Mr. Chung Chong Sun (being the chairman of the Audit Committee), Mr. Zhang Huaqiao and Mr. Tse Yat Hong.

Nomination policy

The Nomination Committee utilises various methods for identifying candidates for directorship, including recommendations from Board members, management, and professional search firms. In addition, the Nomination Committee will consider candidates for directorship properly submitted by the Shareholders. The evaluation of candidates for directorship by the Nomination Committee may include, without limitation, review of resume and job history, personal interviews, verification of professional and personal references and performance of background checks. The Board will consider the recommendations of the Nomination Committee and is responsible for designating the candidates for directorship to be considered by the Shareholders for their election at the general meeting of the Company, or appointing the suitable candidate to act as Director to fill the Board vacancies or as an additional to the Board members, subject to compliance of the constitutional documents of the Company. All appointments of Director should be confirmed by letter of appointment and/or service contract setting out the key terms and conditions of the appointment of Directors.

- the ability to assist and support management and make significant contributions to the Company's success;
- an understanding of the fiduciary responsibilities that is required for a member of the Board and the commitment of time and energy necessary to diligently carry out those responsibilities;
- independence: the candidates for independent non-executive directorship should meet the "independence" criteria as required under the Listing Rules and the composition of the Board is in conformity with the provisions of the Listing Rules.

Financial reporting system

The Board, supported by the finance department, is responsible for the preparation of the financial statements of the Company and the Group. The directors prepared the financial statements on a going concern basis, International Financial Reporting Standards have been adopted and the appropriate accounting policies have been consistently used and applied. The Board aims to present a clear and balanced assessment of the Group's performance in the annual and interim reports to the Shareholders, and make appropriate disclosure and announcements in a timely manner. Pursuant to code provision D.1.1 of the Code, management would provide such explanation and information to the Board as will enable the Board to make an informed assessment of the financial and other information put before the Board for approval.

The work scope and reporting responsibilities of Ernst & Young, the Company's external auditor, are set out in the "Independent Auditor's Report" on pages 92 to 98 of this report.

Risk management and internal control system

The Board has established a comprehensive risk management and internal control system, which consist of an organization framework, as well as policies, procedures and risk management methods that the Board considers to be appropriate for our business operations. The system is designed to allow us to identify, report and address those risk and incidents that may significantly affect our performance or otherwise expose us to significant losses, liability or non-compliance with applicable laws and regulations. The risk management system comprises the formulation and implantation of a set of policies and procedures relating to relevant risk areas, including compliance with laws and regulations, construction quality, work safety and environmental matters. We are constantly monitoring the effectiveness of our risk management system. The Board oversees the implementation of the risk management and internal control measures and is responsible with reviewing the effectiveness of such system. Such systems are designed to manage rather than eliminate the risk of failure to achieve business objectives, and can only provide reasonable and not absolute assurance against material misstatement or loss. The Board is responsible for approving our business and investment plans, adjusting the risk management plans and strategies in response to risks identified in our business operations. The internal control system covers various aspects of the operations, including information system control, procurement and accounts payable control, cash management, compensation management and financial reporting control. The Company has an internal audit function which has also been carried out under the leadership of the Board and the Audit Committee.

During the year ended 31 December 2022, the Group has implemented procedures and internal controls for the handling and dissemination of inside information. In particular, the Group:

- has conducted its affairs with close regard to the disclosure requirement under the Listing Rules as well as the "Guidelines on Disclosure of Inside Information" published by the Securities and Futures Commission in June 2012;
- has established its own disclosure obligation procedures, which set out the procedures and controls for the assessment of potential inside information and the handling and dissemination of inside information. The procedures have been communicated to the senior management and staff of the Company, and their implementation was monitored by the Company; and
- has made broad, non-exclusive disclosure of information to the public through channels such as financial reports, public announcements and its website.

The risk management and internal control systems are reviewed and assessed on an on-going basis by the Audit Committee and the executive Directors, and will be further reviewed and assessed at least once each year by the Board. During the year ended 31 December 2022, these systems covering all material controls, including financial, operational and compliance controls, were reviewed and considered effective and adequate.

The Company is an investment holding company and its subsidiaries are principally engaged in property development. An analysis of the Group's revenue and operating results for the year ended 31 December 2022 by its principal activities is set out in note 1 to the consolidated financial statements of the Group on page 106 to 126 in this report.

A retiring Director shall be eligible for re-election.

The Company at the general meeting at which a Director retires may fill the vacated office. Accordingly, Mr. Lam Yu, Mr. Zhang Huaqiao and Mr. Tse Yat Hong shall retire from office by rotation at the 2023 AGM and being eligible, will offer themselves for re-election.

The Company has received, from each of the independent non-executive Directors, an annual confirmation of his independence pursuant to Rule 3.13 of the Listing Rules. The Company considers all of the independent non-executive Directors are independent.

DIRECTORS' SERVICE CONTRACTS

Each of the executive Directors has entered into a service agreement with the Company and each of the independent non-executive Directors has signed an appointment letter with the Company for a term of 3 years. None of the Directors who are proposed for election or re-election at the 2023 AGM has a service contract with the Company which is not determinable within one year without payment of compensation, other than statutory compensation. There is no arrangement under which a director has waived or agreed to waive any emoluments.

DIRECTORS' INTERESTS IN COMPETING BUSINESS

During the year ended 31 December 2022, none of the Directors nor their respective associates (as defined in the Listing Rules) had any interest in a business that competed or might likely compete, either directly or indirectly, with the business of the Group.

NON-COMPETITION UNDERTAKING

Each of Mr. Lam, being the executive Director and the Controlling Shareholder, Ms. Lam, Radiance Group Holdings and Glowing Shine, all being the Controlling Shareholders, has confirmed to the Company that, since the Listing Date and up to 31 December 2022 he/she/it has complied with the Deed of Non-competition dated 13 October 2020 (the "Undertakings") as disclosed in the Prospectus.

The independent non-executive Directors had reviewed the status of compliance and the confirmation provided by the Controlling Shareholders as part of the annual review process. On the basis that: (i) the Company has received the confirmations from the Controlling Shareholders regarding the Undertakings; (ii) there was no competing business reported by the Controlling Shareholders; and (iii) there was no particular situation rendering the full compliance of the Undertakings being questionable, the independent non-executive Directors are of the view that the Undertakings have been complied with and been enforced by the Company in accordance with the terms.

SHARE OPTION SCHEME

Details of the Share Option Scheme

1) Purpose

The Share Option Scheme is a share incentive scheme established to recognise and acknowledge the contributions that the Eligible Participants (as defined in paragraph (2) below) had or may have made to our Group. The Share Option Scheme will provide the Eligible Participants an opportunity to have a personal stake in our Company with the view to achieving the following objectives:

- (i) motivate the Eligible Participants to optimize their performance efficiency for the benefit of our Group; and
- (ii) attract and retain or otherwise maintain an on-going business relationship with the Eligible Participants whose contributions are or will be beneficial to the long-term growth of our Group.

購股權計劃

購股權計劃的詳情

1) 目的

購股權計劃為一項股份獎勵計劃，旨在認可及嘉許合資格參與者（定義見下文(2)段）對本集團作出或可能已作出的貢獻。購股權計劃將向合資格參與者提供機會於本公司擁有個人權益，以達致下列目標：

- (i) 激勵合資格參與者為本集團的利益而優化其表現效率；及

2) Participants

The Board may, at its discretion, offer to grant an option to the following persons (collectively the "Eligible Participants") to subscribe for such number of new Shares as the Board may determine at an exercise price determined in accordance with paragraph (6) below:

- (i) any full-time or part-time employees, executives or officers of our Company or any of its subsidiaries;
- (ii) any directors (including independent non-executive directors) of our Company or any of its subsidiaries; and
- (iii) any advisors, consultants, suppliers, customers, distributors and such other persons who in the sole opinion of the Board will contribute or have contributed to our Company or any of its subsidiaries.

3) Maximum number of Shares

The total number of Shares which may be issued upon exercise of all options to be granted under the Share Option Scheme shall not in aggregate exceed 10% of the aggregate of the Shares in issue on the Listing Date, and such 10% limit represents 400,000,000 Shares, representing approximately 9.89% of the total Shares in issue as at the date of this report.

4) Maximum number of options to any one individual

Unless approved by the Shareholders, the total number of Shares issued and to be issued upon exercise of the options granted and to be granted under the Share Option Scheme and any other share option scheme of the Group (including both exercised and outstanding options) to each participant in any 12-month period shall not exceed 1% of the Shares in issue as at the date of grant.

5) Acceptance and exercise of options

An option shall be deemed to have been granted and accepted by the grantee and to have taken effect when the duplicate offer document constituting acceptances of the options duly signed by the grantee, together with a remittance in favor of the Company of HK\$1.00 by way of consideration for the grant thereof, is received by the Company on or before the relevant acceptance date.

The exercise period of any share option granted under the Share Option Scheme shall be determined by the Board in its absolute discretion but such period must not exceed ten years from the date of grant of the relevant share option. There is no minimum period specified by the Share Option Scheme, for which the option must be held before it can be exercised.

2) 參與者

4) 向任何個別人士授出購股權的數目上限

6) Price of Shares

The subscription price for a Share under the Share Option Scheme shall be determined by the Board in its absolute discretion, but must be at least the highest of:

- (i) the closing price of the Shares as stated in the Stock Exchange's daily quotations sheet on the date of grant, which must be a day on which the Stock Exchange is open for the business of dealing in securities;
- (ii) the average closing price of the Shares as stated in the Stock Exchange's daily quotations sheets for the five business days immediately preceding the date of grant; and
- (iii) the nominal value of a Share.

7) The duration of the Share Option Scheme

The Share Option Scheme shall be valid and effective until 4 October 2030, i.e. for the period of ten years commencing from the date of adoption of the Share Option Scheme, after which no further options shall be granted, but in all other respects the provisions of the Share Option Scheme shall remain in full force and effect to the extent necessary to give effect to the exercise of any options granted prior thereto or otherwise as may be required in accordance with the provisions of the rules of the Share Option Scheme. As at the date of the report, the remaining life of the Share Option Scheme is approximately 7 years and 6 months.

For further details of the Share Option Scheme, please refer to the section headed "Statutory and general information – D. Share Option scheme" in Appendix V to the Prospectus.

Since the adoption of the Share Option Scheme and up to the date of this report, no option has been granted by the Company pursuant to the Share Option Scheme. Property Management Services

On 13 October 2020, the Company entered into a property management related services framework agreement (the **"Old Property Management Related Services Framework Agreement"**) with Radiance Lifestyle Holdings Limited (**"Radiance Lifestyle Holdings"**), pursuant to which we agreed to engage Radiance Lifestyle Holdings and/or its subsidiaries to provide property management and related services to our Group, including but not limited to (i) management services for unsold units and unsold car parking spaces; (ii) pre-delivery management and value-added services which primarily include (a) planning and design consultancy; (b) inspection, cleaning and repair of units; (c) site security; and (d) ancillary facilities management services; and (iii) sales management services which primarily include property management of display units, and off- and on-site sales offices (the **"Property Management Related Services"**). The Property Management Related Services Framework Agreement has a term commencing from the Listing Date to 31 December 2022.

For the year ended 31 December 2022, the total amount of service fee payable by the Company to Radiance Lifestyle Holdings and/or its subsidiaries for the Property Management Related Services amounted to RMB171 million, which is within the annual cap of RMB401 million.

As the Old Property Management Related Services Framework Agreement had expired on 31 December 2022 and the Company was expected to carry on the transactions contemplated thereunder upon its expiry, the Company entered into a new property management related services framework agreement (the **"New Property Management Related Services Framework Agreement"**) on 30 December 2022 with Radiance Holdings Limited, pursuant to which we agreed to engage Radiance Lifestyle Holdings and/or its subsidiaries to provide the Property Management Related Services to our Group, with a term commencing from 1 January 2023 to 31 December 2025.

The maximum transaction amounts under the New Property Management Related Services Framework Agreement for the three years ending 31 December 2025 shall not exceed RMB300 million, RMB350 million and RMB400 million, respectively. For details, please refer to the announcement of the Company dated 30 December 2022.

Radiance Lifestyle Holdings is wholly owned by Radiance Group Holdings, which is in turn owned as to 64.97% by Mr. Lam and 35.03% by Ms. Lam. Radiance Lifestyle Holdings is therefore a connected person of our Company for the purpose of the Listing Rules. Accordingly, the transactions contemplated under the Old Property Management Related Services Framework Agreement and the New Property Management Related Services Framework Agreement constitute continuing connected transactions for our Company under Chapter 14A of the Listing Rules.

於2020年10月13日，本公司與輝生活控股有限公司（「輝生活控股」）訂立一份物業管理相關服務框架協議（「舊物業管理相關服務框架協議」），據此，我們同意委聘輝生活控股及／或其附屬公司向本集團提供物業管理及相關服務，包括但不限於(i)為未售單位及未售車位提供管理服務；(ii)提供交房前管理及增值服務，主要包括(a)規劃及設計諮詢；(b)驗房、清潔及維修單位；(c)現場安保；及(d)配套設施管理服務；及(iii)提供銷售管理服務，主要包括樣板間以及場外及場內售樓部之物業管理（「物業管理相關服務」）。物業管理相關服務框架協議的期限為自上市日期起至2022年12月31日止。

截至2022年12月31日止年度，本公司就物業管理相關服務而應向輝生活控股及／或其附屬公司的服務費總額為人民幣171百萬元，屬於年度上限人民幣401百萬元範圍內。

由於舊物業管理相關服務框架協議已於2022年12月31日屆滿，而本公司預期於其屆滿後繼續進行據其擬進行之交易，本公司與輝生活控股已於2022年12月30日訂立一份新的物業管理相關服務框架協議（「新物業管理相關服務框架協議」），據此，我們同意委聘輝生活控股及／或其附屬公司向本集團提供物業管理及相關服務，期限為自2023年1月1日起至2025年12月31日止。

截至2025年12月31日止三個年度，新物業管理相關服務框架協議下的最大交易金額將分別不得超過人民幣300百萬元、人民幣350百萬元及人民幣400百萬元。有關詳情，請參閱本公司日期為2022年12月30日的公告。

輝生活控股由金輝集團控股全資擁有，而金輝集團控股由林先生及林女士分別擁有64.97%及35.03%。因此，輝生活控股就上市規則而言為本公司的關連人士。相應地，根據上市規則第十四A章的規定，舊物業管理相關服務框架協議及新物業管理相關服務框架協議項下擬進行的交易將於上市後構成本公司的持續關連交易。

As each of the applicable percentage ratios (except for the profit ratio) under the Listing Rules in respect of the highest annual cap in relation to each of the Old Property Management Related Services Framework Agreement and the New Property Management Related Services Framework Agreement was over 0.1% but less than 5% on an annual basis, the transactions contemplated thereunder are exempt from the independent Shareholders' approval requirement but subject to the reporting, annual review and announcement requirements under Chapter 14A of the Listing Rules.

Pursuant to Rule 14A.55 of the Listing Rules, all independent non-executive Directors have reviewed and confirmed that the above continuing connected transaction has been entered into (i) in the ordinary and usual course of business of the Group; (ii) on normal commercial terms or better; and (iii) according to the relevant agreements governing the transaction on terms that are fair and reasonable and in the interests of the Shareholders as a whole.

For the purpose of Rule 14A.56 of the Listing Rules, Ernst and Young, the auditor of the Company, was engaged to report on the continuing connected transactions and has provided a letter to the Board, confirming that nothing has come to its attention that causes it to believe that the continuing connected transaction mentioned above (i) has not been approved by the Board; (ii) was not entered into, in all material respects, in accordance with the relevant agreements governing such transactions; and (iii) has exceeded the annual cap.

RELATED PARTY TRANSACTIONS

Details of related party transactions of the Group during the year ended 31 December 2022 are set out in note 41 to the consolidated financial statements. Save as disclosed in the section headed "Continuing Connected Transaction" above, certain of these transactions also constitute connected transactions or continuing connected transactions for the Company under Chapter 14A of the Listing Rules but are not required to be disclosed in this report under the Listing Rules. The Company confirmed that it has complied with the disclosure requirements in accordance with Chapter 14A of the Listing Rules.

PRE-EMPTIVE RIGHTS AND TAX RELIEF

There is no provision for pre-emptive rights under the Articles or the laws of the Cayman Islands, being the jurisdiction in which the Company is incorporated, under which would oblige the Company to offer new shares on a pro-rata basis to existing Shareholders.

The Company is not aware of any tax relief and exemption available to the Shareholders by reason of their holding of the Company's securities.

We have audited the consolidated financial statements of Radiance Holdings (Group) Company Limited (the “Company”) and its subsidiaries (the “Group”) set out on pages 99 to 237 which comprise the consolidated statement of financial position as at 31 December 2022, and the consolidated statement of profit or loss and other comprehensive income, the consolidated statement of changes in equity and the consolidated statement of cash flows for the year then ended, and notes to the consolidated financial statements, including a summary of significant accounting policies.

The Group owned investment properties in Mainland China, including completed investment properties and investment properties under construction, which were measured at fair value and their aggregate carrying amount was approximately RMB16,330,200,000 as at 31 December 2022.

The Group engaged Jones Lang LaSalle Corporate Appraisal and Advisory Limited and Shenzhen Cushman & Wakefield Real Estate Evaluation Co., Ltd., independent professionally qualified valuers to perform the valuations of the aforementioned properties as at 31 December 2022. Significant judgement was required to determine the fair values of the investment properties, which reflected market conditions as at the end of the reporting period. The fair value of completed commercial properties was determined using the income approach by taking into account the rental income of the properties derived from the existing leases and/or achievable in the existing market with due allowance for the reversionary income potential of the leases, which have been then capitalised to determine the fair value at an appropriate capitalisation rate. The fair value of commercial properties under construction was determined using the cost method, which has taken into account the market value of land use right plus the construction cost incurred so far and an appropriate gross margin. Changes in these assumptions would have significant effects on the valuation of the investment properties. Accordingly, the valuation of the investment properties was identified as a key audit matter.

The Group is a property developer in Mainland China focusing on the development of residential properties and the development, operation and management of commercial and mixed-use properties. Land appreciation tax ("LAT") in mainland China was one of the main components of the Group's taxation charge. LAT is levied on the sale of properties at progressive rates ranging from 30% to 60% based on the appreciation of land value. As at 31 December 2022, the management of the Group estimated the provision for LAT based on their understanding and interpretation of the relevant tax rules and regulations, and the estimated total sales of properties less total deductible expenditure, which included lease charges for land use rights, property development costs, borrowing costs and development expenditure. Provision for LAT in mainland China was significant to the consolidated financial statements of the Group and involved significant management's judgement and interpretation of the relevant tax provisions. Accordingly, provision for LAT was identified as a key audit matter.

The above table lists the subsidiaries of the Company which, in the opinion of the directors, principally affected the results for the year or formed a substantial portion of the net assets of the Group. To give details of other subsidiaries would, in the opinion of the directors, result in particulars of excessive length.

2.1 BASIS OF PREPARATION

These financial statements have been prepared in accordance with International Financial Reporting Standards ("IFRSs") (which include all standards and interpretations, International Accounting Standards ("IASs") and Standing Interpretations Committee interpretations) approved by the International Accounting Standards Board (the "IASB") and the disclosure requirements of the Hong Kong Companies Ordinance. They have been prepared under the historical cost convention, except for investment properties and financial assets at fair value through profit or loss which have been measured at fair value. These financial statements are presented in Renminbi ("RMB") and all values are rounded to the nearest thousand except when otherwise indicated.

Basis of consolidation

The consolidated financial statements include the financial statements of the Company and its subsidiaries (collectively referred to as the "Group") for the year ended 31 December 2022. A subsidiary is an entity, directly or indirectly, controlled by the Company. Control is achieved when the Group is exposed, or has rights, to variable returns from its involvement with the investee and has the ability to affect those returns through its power over the investee (i.e., existing rights that give the Group the current ability to direct the relevant activities of the investee).

2.1 編製基準

該等財務報表乃根據國際會計準則理事會（「國際會計準則理事會」）批准的國際財務報告準則（「國際財務報告準則」），包括所有準則及詮釋、國際會計準則（「國際會計準則」）及常設準則詮釋委員會的詮釋）以及香港公司條例的披露規定編製。除投資物業及按公平值計入損益的金融資產按公平值計量外，該等財務報表乃根據歷史成本慣例編製。該等財務報表以人民幣（「人民幣」）呈列，除另有指明者外，否則所有金額均約整至最接近的千位數。

合併基準

綜合財務報表包括本公司及其附屬公司（統稱「本集團」）截至二零二二年十二月三十一日止年度的財務報表。附屬公司指本公司直接或間接控制的實體。當本集團就參與投資對象業務而承擔可變回報風險或享有可變回報權利以及能透過對投資對象行使權力（即現有的可讓本集團有能力主導投資對象相關活動的權利）影響該等回報時，即取得控制權。

Basis of consolidation (Continued)

Generally, there is a presumption that a majority of voting rights results in control. When the Company has, directly or indirectly, less than a majority of the voting or similar rights of an investee, the Group considers all relevant facts and circumstances in assessing whether it has power over an investee, including:

- (a) the contractual arrangement with the other vote holders of the investee;
- (b) rights arising from other contractual arrangements; and
- (c) the Group's voting rights and potential voting rights.

The financial statements of the subsidiaries are prepared for the same reporting period as the Company, using consistent accounting policies. The results of subsidiaries are consolidated from the date on which the Group obtains control, and continue to be consolidated until the date that such control ceases.

Profit or loss and each component of other comprehensive income are attributed to the owners of the parent of the Group and to the non-controlling interests, even if this results in the non-controlling interests having a deficit balance. All intra-group assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control described above. A change in the ownership interest of a subsidiary, without a loss of control, is accounted for as an equity transaction.

If the Group loses control over a subsidiary, it derecognises (i) the assets (including goodwill) and liabilities of the subsidiary, (ii) the carrying amount of any non-controlling interest and (iii) the cumulative translation differences recorded in equity; and recognises (i) the fair value of the consideration received, (ii) the fair value of any investment retained and (iii) any resulting surplus or deficit in profit or loss. The Group's share of components previously recognised in other comprehensive income is reclassified to profit or loss or retained profits, as appropriate, on the same basis as would be required if the Group had directly disposed of the related assets or liabilities.

The amendments also add to IFRS 3 an exception to its recognition principle for an entity to refer to the Conceptual Framework to determine what constitutes an asset or a liability. The exception specifies that, for liabilities and contingent liabilities that would be within the scope of IAS 37 or IFRIC 21 if they were incurred separately rather than assumed in a business combination, an entity applying IFRS 3 should refer to IAS 37 or IFRIC 21 respectively instead of the Conceptual Framework. Furthermore, the amendments clarify that contingent assets do not qualify for recognition at the acquisition date. The Group has applied the amendments prospectively to business combinations that occurred on or after 1 January 2022. As there were no business combinations during the year, the amendments did not have any impact on the financial position and performance of the Group.

- (b) Amendments to IAS 16 prohibit an entity from deducting from the cost of an item of property, plant and equipment any proceeds from selling items produced while bringing that asset to the location and condition necessary for it to be capable of operating in the manner intended by management. Instead, an entity recognises the proceeds from selling any such items, and the cost of those items as determined by IAS 2 Inventories, in profit or loss. The Group has applied the amendments retrospectively to items of property, plant and equipment made available for use on or after 1 January 2021. Since there was no sale of items produced prior to the property, plant and equipment being available for use, the amendments did not have any impact on the financial position or performance of the Group.
- (c) Amendments to IAS 37 clarify that for the purpose of assessing whether a contract is onerous under IAS 37, the cost of fulfilling the contract comprises the costs that relate directly to the contract. Costs that relate directly to a contract include both the incremental costs of fulfilling that contract (e.g., direct labour and materials) and an allocation of other costs that relate directly to fulfilling that contract (e.g., an allocation of the depreciation charge for an item of property, plant and equipment used in fulfilling the contract as well as contract management and supervision costs). General and administrative costs do not relate directly to a contract and are excluded unless they are explicitly chargeable to the counterparty under the contract. The Group has applied the amendments prospectively to contracts for which it has not yet fulfilled all its obligations at 1 January 2022 and no onerous contracts were identified. Therefore, the amendments did not have any impact on the financial position or performance of the Group.

The Group has applied the amendment prospectively from 1 January 2022. As there was no modification or exchange of the Group's financial liabilities during the year, the amendment did not have any impact on the financial position or performance of the Group.

Amendments to IFRS 10 and IAS 28 address an inconsistency between the requirements in IFRS 10 and in IAS 28 in dealing with the sale or contribution of assets between an investor and its associate or joint venture. The amendments require a full recognition of a gain or loss resulting from a downstream transaction when the sale or contribution of assets between an investor and its associate or joint venture constitutes a business. For a transaction involving assets that do not constitute a business, a gain or loss resulting from the transaction is recognised in the investor's profit or loss only to the extent of the unrelated investor's interest in that associate or joint venture. The amendments are to be applied prospectively. The previous mandatory effective date of amendments to IFRS 10 and IAS 28 was removed by the IASB in December 2015 and a new mandatory effective date will be determined after the completion of a broader review of accounting for associates and joint ventures. However, the amendments are available for adoption now.

Amendments to IFRS 16 specify the requirements that a seller-lessee uses in measuring the lease liability arising in a sale and leaseback transaction to ensure the seller-lessee does not recognise any amount of the gain or loss that relates to the right of use it retains. The amendments are effective for annual periods beginning on or after 1 January 2024 and shall be applied retrospectively to sale and leaseback transactions entered into after the date of initial application of IFRS 16 (i.e., 1 January 2019). Earlier application is permitted. The amendments are not expected to have any significant impact on the Group's financial statements.

Amendments to IAS 1 *Classification of Liabilities as Current or Non-current* clarify the requirements for classifying liabilities as current or non-current, in particular the determination over whether an entity has a right to defer settlement of the liabilities for at least 12 months after the reporting period. Classification of a liability is unaffected by the likelihood that the entity will exercise its right to defer settlement of the liability. The amendments also clarify the situations that are considered a settlement of a liability. In 2022, the IASB issued the 2022 Amendments to further clarify that, among covenants of a liability arising from a loan arrangement, only those with which an entity must comply on or before the reporting date affect the classification of that liability as current or non-current. In addition, the 2022 Amendments require additional disclosures by an entity that classifies liabilities arising from loan arrangements as non-current when it has a right to defer settlement of those liabilities that are subject to the entity complying with future covenants within 12 months after the reporting period. The amendments are effective for annual periods beginning on or after 1 January 2024 and shall be applied retrospectively. Earlier application is permitted. An entity that applies the 2020 Amendments early is required to apply simultaneously the 2022 Amendments, and vice versa. The Group is currently assessing the impact of the amendments and whether existing loan agreements may require revision. Based on a preliminary assessment, the amendments are not expected to have any significant impact on the Group's financial statements.

國際會計準則第1號(修訂本)負債分類為流動或非流動澄清將負債分類為流動或非流動的規定，尤其是釐定實體是否有權將負債的結算遞延至報告期後至少12個月。負債的分類不受實體將行使其權利延遲清償負債的可能性的影響。該等修訂本亦釐清被視為清償負債的情況。於二零二二年，國際會計準則委員會頒佈二零二二年修訂本，以進一步澄清在貸款安排產生的負債契約中，僅實體須於報告日期或之前遵守的契約會影響該負債分類為流動或非流動。此外，二零二二年修訂本要求實體作出額外披露，倘實體有權延遲結算該等負債(實體須於報告期後12個月內遵守未來契約)，則將貸款安排產生的負債分類為非流動。該等修訂本於二零二四年一月一日或之後開始的年度期間生效，並須追溯應用。提早應用二零二零年修訂本的實體須同時應用二零二二年修訂本，反之亦然。本集團目前正在評估該等修訂的影響，以及現有貸款協議是否需要修訂。根據初步評估，該等修訂本預期不會對本集團的財務報表造成任何重大影響。

Amendments to IAS 1 *Disclosure of Accounting Policies* require entities to disclose their material accounting policy information rather than their significant accounting policies. Accounting policy information is material if, when considered together with other information included in an entity's financial statements, it can reasonably be expected to influence decisions that the primary users of general purpose financial statements make on the basis of those financial statements. Amendments to IFRS Practice Statement 2 provide non-mandatory guidance on how to apply the concept of materiality to accounting policy disclosures. Amendments to IAS 1 are effective for annual periods beginning on or after 1 January 2023 and earlier application is permitted. Since the guidance provided in the amendments to IFRS Practice Statement 2 is non-mandatory, an effective date for these amendments is not necessary. The Group is currently revisiting the accounting policy disclosures to ensure consistency with the amendments.

Amendments to IAS 8 clarify the distinction between changes in accounting estimates and changes in accounting policies. Accounting estimates are defined as monetary amounts in financial statements that are subject to measurement uncertainty. The amendments also clarify how entities use measurement techniques and inputs to develop accounting estimates. The amendments are effective for annual reporting periods beginning on or after 1 January 2023 and apply to changes in accounting policies and changes in accounting estimates that occur on or after the start of that period. Earlier application is permitted. The amendments are not expected to have any significant impact on the Group's financial statements.

Amendments to IAS 12 narrow the scope of the initial recognition exception in IAS 12 so that it no longer applies to transactions that give rise to equal taxable and deductible temporary differences, such as leases and decommissioning obligations. Therefore, entities are required to recognise a deferred tax asset (provided that sufficient taxable profit is available) and a deferred tax liability for temporary differences arising from these transactions. The amendments are effective for annual reporting periods beginning on or after 1 January 2023 and shall be applied to transactions related to leases and decommissioning obligations at the beginning of the earliest comparative period presented, with any cumulative effect recognised as an adjustment to the opening balance of retained profits or other component of equity as appropriate at that date. In addition, the amendments shall be applied prospectively to transactions other than leases and decommissioning obligations. Earlier application is permitted. The amendments are not expected to have any significant impact on the Group's financial statements.

國際會計準則第1號的修訂本會計政策披露要求實體披露其重大會計政策資料，而非其重大會計政策。倘會計政策資料與實體財務報表所載其他資料一併考慮時，可合理預期影響一般用途財務報表之主要使用者根據該等財務報表作出之決定，則有關會計政策資料屬重大。國際財務報告準則實務報告第2號的修訂本就如如何將重要性概念應用於會計政策披露提供非強制性指引。國際會計準則第1號的修訂本於二零二三年一月一日或之後開始之年度期間生效，並可提早應用。由於國際財務報告準則實務報告第2號的修訂本所提供之指引並非強制性，故該等修訂本之生效日期並非必要。本集團目前正在重新審查會計政策披露，以確保貫徹該等修訂本。

國際會計準則第8號(修訂本)澄清會計估計變更及會計政策變更的區別。會計估計的定義為財務報表中存在計量不確定因素的貨幣金額。該等修訂本亦澄清實體使用計量技術和輸入作出會計估計。該等修訂本於2023年1月1日或之後開始的年度報告期間生效，並適用於該期間開始或之後發生的會計政策變更及會計估計變更。允許提早應用。預期該等修訂不會對本集團財務報表產生任何重大影響。

國際會計準則第12號(修訂本)縮小了國際財務報告準則第12號初步確認例外情形的範圍，使其不再適用於產生相等應課稅及可扣稅暫時差額的交易，如租賃及退役責任。因此，實體須就該等交易產生的暫時差額確認遞延稅項資產(惟須有足夠的應課稅溢利)及遞延稅項負債。該等修訂本於2023年1月1日或之後開始的年度報告期生效，並於所呈現最早比較期初適用於與租賃及退役責任有關的交易，任何累積影響確認為於當日保留利潤或權益其他組成部分(如適用)期初結餘之調整。此外，該修訂本應前瞻性應用於除租賃及退役責任外的交易。允許提早應用。該等修訂本預期不會對本集團財務報表產生任何重大影響。

Investments in associates and joint ventures

An associate is an entity in which the Group has a long term interest of generally not less than 20% of the equity voting rights and over which it is in a position to exercise significant influence. Significant influence is the power to participate in the financial and operating policy decisions of the investee, but is not control or joint control over those policies.

A joint venture is a type of joint arrangement whereby the parties that have joint control of the arrangement have rights to the net assets of the joint venture. Joint control is the contractually agreed sharing of control of an arrangement, which exists only when decisions about the relevant activities require the unanimous consent of the parties sharing control.

The Group's investments in associates and joint ventures are stated in the consolidated statement of financial position at the Group's share of net assets under the equity method of accounting, less any impairment losses. Adjustments are made to bring into line any dissimilar accounting policies that may exist. The Group's share of the post-acquisition results and other comprehensive income of associates and joint ventures are included in the consolidated statement of profit or loss and other comprehensive income. In addition, when there has been a change recognised directly in the equity of the associate or joint venture, the Group recognises its share of any changes, when applicable, in the consolidated statement of changes in equity. Unrealised gains and losses resulting from transactions between the Group and its associates or joint ventures are eliminated to the extent of the Group's investments in the associates or joint ventures, except where unrealised losses provide evidence of an impairment of the assets transferred. Goodwill arising from the acquisition of associates or joint ventures is included as part of the Group's investments in associates or joint ventures.

If an investment in an associate becomes an investment in a joint venture or vice versa, the retained interest is not remeasured. Instead, the investment continues to be accounted for under the equity method. In all other cases, upon loss of significant influence over the associate or joint control over the joint venture, the Group measures and recognises any retained investment at its fair value. Any difference between the carrying amount of the associate or joint venture upon loss of significant influence or joint control and the fair value of the retained investment and proceeds from disposal is recognised in profit or loss.

When an investment in an associate or a joint venture is classified as held for sale, it is accounted for in accordance with IFRS 5 Non-current Assets Held for Sale and Discontinued Operations.

於聯營公司及合營企業的投資

聯營公司為本集團於其一般不少於20%股本投票權中擁有長期權益的實體，且可對其發揮重大影響力。重大影響力指參與投資對象的財務和經營決策的權力，但不是控制或共同控制該等決策的權力。

合營企業指一種合營安排，對安排擁有共同控制權的訂約方據此對合營企業的資產淨值擁有權利。共同控制指按照合約協定對一項安排所共有的控制，共同控制僅在有關活動要求享有控制權的訂約方作出一致同意的決定時存在。

本集團於聯營公司及合營企業的投資乃按本集團根據權益會計法應佔資產淨值減任何減值虧損於綜合財務狀況表列賬。倘出現任何不相符的會計政策，即會作出調整加以修正。本集團應佔聯營公司及合營企業收購後業績及其他全面收益計入綜合損益及其他全面收益表。此外，倘於聯營公司或合營企業的權益直接確認變動，則本集團會於綜合權益變動表確認其應佔任何變動(倘適用)。本集團與其聯營公司或合營企業間交易的未變現收益及虧損將以本集團於聯營公司或合營企業的投資為限對銷，惟倘未變現虧損證明所轉讓資產減值則除外。收購聯營公司或合營企業所產生的商譽計入本集團於聯營公司或合營企業的投資內作為其中一部分。

倘於聯營公司的投資變成於合營企業的投資或出現相反情況，則不會重新計量保留權益。反之，該投資繼續根據權益法入賬。在所有其他情況下，失去對聯營公司的重大影響力或對合營企業的共同控制權後，本集團按其公平值計量及確認任何保留投資。聯營公司或合營企業於失去重大影響力或共同控制權時的賬面值與保留投資及出售所得款項的公平值之間的任何差額乃於損益內確認。

當聯營公司或合營企業的投資歸類為持作出售時，則按國際財務報告準則第5號持作出售非流動資產及已終止經營業務入賬。

Fair value measurement

The Group measures its investment properties, derivative financial instruments and equity investments at fair value at the end of each reporting period. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value measurement is based on the presumption that the transaction to sell the asset or transfer the liability takes place either in the principal market for the asset or liability, or in the absence of a principal market, in the most advantageous market for the asset or liability. The principal or the most advantageous market must be accessible by the Group. The fair value of an asset or a liability is measured using the assumptions that market participants would use when pricing the asset or liability, assuming that market participants act in their economic best interest.

A fair value measurement of a non-financial asset takes into account a market participant's ability to generate economic benefits by using the asset in its highest and best use or by selling it to another market participant that would use the asset in its highest and best use.

The Group uses valuation techniques that are appropriate in the circumstances and for which sufficient data are available to measure fair value, maximising the use of relevant observable inputs and minimising the use of unobservable inputs.

All assets and liabilities for which fair value is measured or disclosed in the financial statements are categorised within the fair value hierarchy, described as follows, based on the lowest level input that is significant to the fair value measurement as a whole:

公平值計量

本集團於各報告期末按公平值計量其投資物業、衍生金融工具及股權投資。公平值乃在市場參與者於計量日期進行的有序交易中出售資產所收取或轉移負債所支付的價格。公平值計量乃基於假設出售資產或轉移負債的交易於資產或負債的主要市場或於未有主要市場的情況下，則於資產或負債的最有利市場進行。主要或最有利市場須位於本集團能到達的地方。資產或負債的公平值乃基於市場參與者為資產或負債定價所用的假設計量（假設市場參與者依照彼等的最佳經濟利益行事）。

非金融資產公平值的計量則參考市場參與者可從使用該資產得到的最高及最佳效用，或把該資產售予另一可從使用該資產得到最高及最佳效用的市場參與者所產生的經濟效益。

本集團使用適用於不同情況的估值方法，而其有足夠資料計量公平值，以盡量利用相關可觀察輸入數據及盡量減少使用不可觀察輸入數據。

Impairment of non-financial assets

Where an indication of impairment exists, or when annual impairment testing for an asset is required (other than properties under development, completed properties held for sale, deferred tax assets, financial assets, investment properties and non-current assets/a disposal group classified as held for sale), the asset's recoverable amount is estimated. An asset's recoverable amount is the higher of the asset's or cash-generating unit's value in use and its fair value less costs of disposal, and is determined for an individual asset, unless the asset does not generate cash inflows that are largely independent of those from other assets or groups of assets, in which case the recoverable amount is determined for the cash-generating unit to which the asset belongs. In testing a cash-generating unit for impairment, a portion of the carrying amount of a corporate asset (e.g., a headquarters building) is allocated to an individual cash-generating unit if it can be allocated on a reasonable and consistent basis or, otherwise, to the smallest group of cash-generating units.

An impairment loss is recognised only if the carrying amount of an asset exceeds its recoverable amount. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset. An impairment loss is charged to profit or loss in the period in which it arises in those expense categories consistent with the function of the impaired asset.

An assessment is made at the end of each reporting period as to whether there is an indication that previously recognised impairment losses may no longer exist or may have decreased. If such an indication exists, the recoverable amount is estimated. A previously recognised impairment loss of an asset other than goodwill is reversed only if there has been a change in the estimates used to determine the recoverable amount of that asset, but not to an amount higher than the carrying amount that would have been determined (net of any depreciation/amortisation) had no impairment loss been recognised for the asset in prior years. A reversal of such an impairment loss is credited to profit or loss in the period in which it arises, unless the asset is carried at a revalued amount, in which case the reversal of the impairment loss is accounted for in accordance with the relevant accounting policy for that revalued asset.

非金融資產減值

倘存在任何減值跡象，或當須每年就資產進行減值檢測（開發中物業、持作出售竣工物業、遞延稅項資產、金融資產、投資物業及非流動資產／分類為持作出售的出售組別除外），則會估計資產的可收回數額。資產的可收回數額乃按資產或現金產生單位的使用價值或公平值減出售成本兩者的較高者計算，而個別資產須分開計算，除非資產並不產生明顯獨立於其他資產或資產組別的現金流入，於此情況下，則可收回數額按資產所屬現金產生單位的可收回數額計算。對現金產生單位進行減值測試時，公司資產（如總部樓宇）的部分賬面值倘可按合理、一致基準分配，則分配至單個現金產生單位，否則分配至最小一組現金產生單位。

僅在資產賬面值高於其可收回數額的情況下，方會確認減值虧損。評估使用價值時，估計日後現金流量按可反映幣值時間值及資產特定風險的現時市場評估的稅前貼現率貼現至現值。減值虧損按與該減值資產功能相符的開支類別於產生期間自損益中扣除。

本集團會在各報告期末評估是否有任何跡象顯示以前所確認的減值虧損已不在或可能減少。倘出現此等跡象，則會估計可收回金額。僅當用以確定資產（商譽除外）可收回金額的估計有變時，方會撥回先前確認的減值虧損，但撥回後的數額不得超逾假設於過往年度並無就該項資產確認減值虧損而應釐定的賬面值（扣除任何折舊／攤銷）。減值虧損撥回會計入產生期間的損益，除非資產以重估金額入賬，在此情況下，減值虧損撥回根據重估資產的有關會計政策列賬。

A party is considered to be related to the Group if:

- (b) the party is an entity where any of the following conditions applies:

Property, plant and equipment and depreciation

Property, plant and equipment, other than construction in progress, are stated at cost less accumulated depreciation and any impairment losses. The cost of an item of property, plant and equipment comprises its purchase price and any directly attributable costs of bringing the asset to its working condition and location for its intended use.

Expenditure incurred after items of property, plant and equipment have been put into operation, such as repairs and maintenance, is normally charged to profit or loss in the period in which it is incurred. In situations where the recognition criteria are satisfied, the expenditure for a major inspection is capitalised in the carrying amount of the asset as a replacement. Where significant parts of property, plant and equipment are required to be replaced at intervals, the Group recognises such parts as individual assets with specific useful lives and depreciates them accordingly.

Depreciation is calculated on the straight-line basis to write off the cost of each item of property, plant and equipment to its residual value over its estimated useful life. The principal estimated useful lives and the annual depreciation rates are as follows:

Where parts of an item of property, plant and equipment have different useful lives, the cost of that item is allocated on a reasonable basis among the parts and each part is depreciated separately. Residual values, useful lives and the depreciation method are reviewed, and adjusted if appropriate, at least at each financial year end.

物業、廠房及設備(在建工程除外)乃按成本減累計折舊及任何減值虧損列賬。物業、廠房及設備項目的成本包括其購買價及任何令資產投入運作及將資產運往擬定用途地點的直接應佔成本。

所有於物業、廠房及設備項目投入運作後所引致的支出,如維修及保養費等,通常於該等支出期間計入損益。倘確認條件達標,相關主要檢查費用可作為重置於資產賬面值內予以資本化。倘大部分物業、廠房及設備須不時重置,本集團確認該部分物業、廠房及設備為具有特定使用年期的個別資產及相應地對其作出折舊。

An item of property, plant and equipment including any significant part initially recognised is derecognised upon disposal or when no future economic benefits are expected from its use or disposal. Any gain or loss on disposal or retirement recognised in profit or loss in the year the asset is derecognised is the difference between the net sales proceeds and the carrying amount of the relevant asset.

Construction in progress represents a building under construction, which is stated at cost less any impairment losses, and is not depreciated. Cost comprises the direct costs of construction and capitalised borrowing costs on related borrowed funds during the period of construction. Construction in progress is reclassified to the appropriate category of property, plant and equipment when completed and ready for use.

Investment properties

Investment properties are interests in land and buildings (including the leasehold property held as a right-of-use asset which would otherwise meet the definition of an investment property) held to earn rental income and/or for capital appreciation, rather than for use in the production or supply of goods or services or for administrative purposes; or for sale in the ordinary course of business. Such properties are measured initially at cost, including transaction costs. Subsequent to initial recognition, investment properties are stated at fair value, which reflects market conditions at the end of the reporting period.

Gains or losses arising from changes in the fair values of investment properties are included in profit or loss in the year in which they arise.

Any gains or losses on the retirement or disposal of an investment property are recognised in profit or loss in the year of the retirement or disposal.

包括最初經確認的任何重大部分在內，物業、廠房及設備的項目於出售或預期其使用或出售不會帶來任何未來經濟利益時終止確認。因出售或報廢而於該資產終止確認年度在損益內確認的任何盈虧乃有關資產出售所得款項淨額與賬面值的差額。

在建工程乃指興建中之樓宇，乃按成本減任何減值虧損列賬，且不予折舊。成本包括建築期間的直接建築成本及相關借貸資金的資本化借款成本。在建工程將於落成並可供使用後重新歸入適當之物業、機器及設備類別。

投資物業

投資物業為持作賺取租金收入及／或資本增值，而非作生產或供應貨品或服務或作行政用途，亦非在日常業務運作過程中作出售的土地及樓宇權益（包括作為使用權資產持有之租賃物業，而此項物業另行符合投資物業的定義）。該等物業初始按成本（包括交易成本）計量。於初始確認後，投資物業按反映各報告期末市況的公平值入賬。

投資物業公平值變動所產生的盈虧於產生年度歸入損益。

報廢或出售投資物業的任何盈虧於報廢或出售年度在損益確認。

For a transfer from investment properties to owner-occupied properties or inventories, the deemed cost of a property for subsequent accounting is its fair value at the date of change in use. If a property occupied by the Group as an owner-occupied property becomes an investment property, the Group accounts for such property in accordance with the policy stated under "Property, plant and equipment and depreciation" for owned property and/or accounts for such property in accordance with the policy stated under "Right-of-use assets" for property held as a right-of-use asset up to the date of change in use, and any difference at that date between the carrying amount and the fair value of the property is accounted for as a revaluation in accordance with the policy stated under "Property, plant and equipment and depreciation" above. For a transfer from inventories to investment properties, any difference between the fair value of the property at that date and its previous carrying amount is recognised in profit or loss.

Transfers to or from investment property

Transfers to or from investment property shall be made when and only when there is a change in use evidenced by:

- (a) commencement of owner-occupation, for a transfer from investment property to owner-occupied property;
- (b) commencement of development with a view to sale, for a transfer from investment property to inventories;
- (c) end of owner-occupation, for a transfer from owner-occupied property to investment property; or
- (d) commencement of an operating lease to another party, for a transfer from inventories to investment property.

Properties under development

Properties under development are intended to be held for sale after completion.

Properties under development are stated at the lower of cost comprising land costs, construction costs, borrowing costs, professional fees and other costs directly attributable to such properties incurred during the development period and net realisable value.

Properties under development are classified as current assets unless those will not be realised in the normal operating cycle. On completion, the properties are transferred to completed properties held for sale.

投資物業 (續)

由投資物業轉為自用物業或存貨時，該物業其後會計的認定成本為改變用途當日的公平值。如本集團的自用物業轉為投資物業，本集團直至改變用途當日前會根據「物業、廠房、設備與折舊」項下有關自有物業的政策把該物業入賬及／或根據「使用權資產」項下有關於使用權資產的政策把該物業入賬，而物業於當日的賬面值與公平值的任何差額則根據上文「物業、廠房、設備與折舊」項下的政策列作重估。由存貨轉為投資物業時，該物業於當日的公平值與先前的賬面值的任何差額於損益中確認。

轉至或轉出投資物業

當且僅當有以下證據顯示用途變更，方可轉至或轉出投資物業：

- (a) 業主開始自用時即自投資物業轉至自用物業；
- (b) 開始發展作銷售用途時即自投資物業轉至存貨；
- (c) 業主結束自用時即自自用物業轉至投資物業；或
- (d) 開始租予另一方的經營租約時即自存貨轉至投資物業。

開發中物業

開發中物業擬於完工後持作出售。

開發中物業按成本與可變現淨值的較低者列賬，成本包括土地成本、建築成本、借款成本、專業費用及於開發期內有關物業直接應佔的其他成本。

除非開發中物業不能於正常營運週期內變現，否則相關開發中物業分類為流動資產。物業於完工時轉至持作出售的完工物業。

Completed properties held for sale

Completed properties held for sale are stated in the statement of financial position at the lower of cost and net realisable value. Cost comprises development costs attributable to the unsold properties. Net realisable value is determined by reference to the sale proceeds of properties sold in the ordinary course of business, less applicable variable selling expenses, or by management estimates based on prevailing marketing conditions.

Allocation of property development cost

Land costs are allocated to each unit according to their respective saleable gross floor area ("GFA") to the total saleable GFA. Construction costs relating to units were identified and allocated specifically. Common construction costs have been allocated according to the saleable GFA similar to land costs.

Intangible assets (other than goodwill)

Intangible assets acquired separately are measured on initial recognition at cost. The cost of intangible assets acquired in a business combination is the fair value at the date of acquisition. The useful lives of intangible assets are assessed to be either finite or indefinite. Intangible assets with finite lives are subsequently amortised over the useful economic life and assessed for impairment whenever there is an indication that the intangible asset may be impaired. The amortisation period and the amortisation method for an intangible asset with a finite useful life are reviewed at least at each financial year end.

Software is stated at cost less any impairment loss and is amortised on the straight-line basis over its estimated useful life of 2 to 10 years.

Leases

The Group assesses at contract inception whether a contract is, or contains, a lease. A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration.

Group as a lessee

The Group applies a single recognition and measurement approach for all leases, except for short-term leases and leases of low-value assets. The Group recognises lease liabilities to make lease payments and right-of-use assets representing the right to use the underlying assets.

持作出售的竣工物業按成本與可變現淨值兩者的較低者於財務狀況表列賬。成本包括未出售物業應佔發展成本。可變現淨值乃參考在正常業務過程中出售物業的銷售所得款項減適用的銷售開支，或管理層按當時的市況估計預計售價釐定。

分配房地產開發成本

土地成本根據各單位的可售建築面積（「建築面積」）佔可售總建築面積的比例分配至各單位。單位相關建築成本按個別情況識別及分配。一般建築成本按與土地成本相若的方式根據可售建築面積分配。

無形資產（商譽除外）

單獨取得的無形資產於初始確認時按成本計量。通過業務合併取得的無形資產的成本為收購日期的公平值。無形資產的可使用年期分為有限期或無限期。有限期的無形資產隨後按可使用經濟年期攤銷，並於有跡象顯示無形資產可能出現減值時評估減值。有限可使用年期的無形資產的攤銷期及攤銷方法至少於每個財政年度末檢討一次。

軟件按成本減任何減值虧損列賬，並使用直線法於其2至10年的估計可使用年期內進行攤銷。

租賃

本集團於合約開始時評估合約是否為或包含租賃。倘合約為換取代價而給予在一段時間內控制已識別資產使用的權利，則該合約分類為或包含租賃。

本集團作為承租人

本集團對所有租賃（惟短期租賃及低價值資產租賃除外）採取單一確認及計量方法。本集團確認租賃負債以作出租賃款項，而使用權資產指使用相關資產的權利。

(a) Right-of-use assets

Right-of-use assets are recognised at the commencement date of the lease (that is the date the underlying asset is available for use). Right-of-use assets are measured at cost, less any accumulated depreciation and any impairment losses, and adjusted for any remeasurement of lease liabilities. The cost of right-of-use assets includes the amount of lease liabilities recognised, initial direct costs incurred, and lease payments made at or before the commencement date less any lease incentives received. Right-of-use assets are depreciated on a straight-line basis over the shorter of the lease terms and the estimated useful lives of the assets as follows:

If ownership of the leased asset transfers to the Group by the end of the lease term or the cost reflects the exercise of a purchase option, depreciation is calculated using the estimated useful life of the asset.

When the right-of-use assets relate to interests in leasehold land held as inventories, they are subsequently measured at the lower of cost and net realisable value in accordance with the Group's policy for "properties under development" or "completed properties held for sale". When a right-of-use asset meets the definition of investment property, it is included in investment properties. The corresponding right-of-use asset is initially measured at cost, and subsequently measured at fair value, in accordance with the Group's policy for "investment properties".

(b) Lease liabilities

Lease liabilities are recognised at the commencement date of the lease at the present value of lease payments to be made over the lease term. The lease payments include fixed payments (including in-substance fixed payments) less any lease incentives receivable, variable lease payments that depend on an index or a rate, and amounts expected to be paid under residual value guarantees. The lease payments also include the exercise price of a purchase option reasonably certain to be exercised by the Group and payments of penalties for termination of a lease, if the lease term reflects the Group exercising the option to terminate the lease. The variable lease payments that do not depend on an index or a rate are recognised as an expense in the period in which the event or condition that triggers the payment occurs.

In calculating the present value of lease payments, the Group uses its incremental borrowing rate at the lease commencement date because the interest rate implicit in the lease is not readily determinable. After the commencement date, the amount of lease liabilities is increased to reflect the accretion of interest and reduced for the lease payments made. In addition, the carrying amount of lease liabilities is remeasured if there is a modification, a change in the lease term, a change in lease payments (e.g., a change to future lease payments resulting from a change in an index or rate) or a change in assessment of an option to purchase the underlying asset.

(c) Short-term leases and leases of low-value assets

The Group applies the short-term lease recognition exemption to its short-term leases of machinery and equipment (that is those leases that have a lease term of 12 months or less from the commencement date and do not contain a purchase option). It also applies the recognition exemption for leases of low-value assets to leases of office equipment and electronic devices that are considered to be of low value.

Lease payments on short-term leases and leases of low-value assets are recognised as an expense on a straight-line basis over the lease term.

(b) 租賃負債

於租賃開始日期確認以租賃期內的租賃付款的現值計量租賃負債。租賃付款包括固定付款 (包括實物固定付款) 減去任何應收租賃優惠、取決於指數或利率的可變租賃付款, 以及預期在剩餘價值擔保下支付的金額。租賃付款亦包括本集團合理地肯定行使的購買選擇權的行使價, 及如果租賃期限反映了本集團行使終止租賃選擇權, 則終止租賃而需支付的罰款。於觸發付款的事件或條件發生時, 不依賴於指數或利率的可變租賃付款將於該期間確認為支出。

Group as a lessor

When the Group acts as a lessor, it classifies at lease inception (or when there is a lease modification) each of its leases as either an operating lease or a finance lease.

Leases in which the Group does not transfer substantially all the risks and rewards incidental to ownership of an asset are classified as operating leases. When a contract contains lease and non-lease components, the Group allocates the consideration in the contract to each component on a relative stand-alone selling price basis. Rental income is accounted for on a straight-line basis over the lease terms and is included in revenue in profit or loss due to its operating nature. Initial direct costs incurred in negotiating and arranging an operating lease are added to the carrying amount of the leased asset and recognised over the lease term on the same basis as rental income. Contingent rents are recognised as revenue in the period in which they are earned.

Leases that transfer substantially all the risks and rewards incidental to ownership of an underlying asset to the lessee are accounted for as finance leases.

Investments and other financial assets

Initial recognition and measurement

Financial assets are classified, at initial recognition, as subsequently measured at amortised cost, fair value through other comprehensive income, and fair value through profit or loss.

The classification of financial assets at initial recognition depends on the financial asset's contractual cash flow characteristics and the Group's business model for managing them. With the exception of trade receivables that do not contain a significant financing component or for which the Group has applied the practical expedient of not adjusting the effect of a significant financing component, the Group initially measures a financial asset at its fair value, plus in the case of a financial asset not at fair value through profit or loss, transaction costs. Trade receivables that do not contain a significant financing component or for which the Group has applied the practical expedient are measured at the transaction price determined under IFRS 15 in accordance with the policies set out for "Revenue recognition" below.

本集團作為出租人

倘本集團作為出租人，於租賃開始時(或修改租賃時)將其各個租賃分類為經營租賃或融資租賃。

所有本集團並未轉讓資產所有權所附帶的絕大部分風險及回報的租賃歸類為經營租賃。當合約包含租賃及非租賃部分時，本集團根據其相對獨立出售價格基準將合約中代價分配予各個部分。租金收入於租期內按直線法列賬並按其經營性質計入損益中的收益。於磋商及安排經營租賃時產生的初始直接成本乃計入租賃資產的賬面值，並於租期內按相同方法確認為租金收入。或然租金乃於所賺取的期間內確認為收益。

轉讓相關資產所有權所附帶的絕大部分風險及回報予承租人的租賃歸類為經營租賃。

投資及其他金融資產

初始確認及計量

金融資產於初始確認時分類為其後按攤銷成本、按公平值計入其他全面收益，以及按公平值計入損益計量。

於初始確認時，金融資產分類取決於金融資產的合約現金流量特點及本集團管理該等金融資產的業務模式。除並無重大融資成分或本集團已應用可行權宜方法(即不調整重大融資成分的影響)的貿易應收款項外，本集團初步按公平值(倘金融資產並非按公平值計入損益)另加交易成本計量金融資產。並無重大融資成分或本集團已應用可行權宜方法的貿易應收款項根據下文「收益確認」所載的政策按國際財務報告準則第15號釐定的交易價格計量。

Initial recognition and measurement (Continued)

In order for a financial asset to be classified and measured at amortised cost or fair value through other comprehensive income, it needs to give rise to cash flows that are solely payments of principal and interest ("SPPI") on the principal amount outstanding. Financial assets with cash flows that are not SPPI are classified and measured at fair value through profit or loss, irrespective of the business model.

The Group's business model for managing financial assets refers to how it manages its financial assets in order to generate cash flows. The business model determines whether cash flows will result from collecting contractual cash flows, selling the financial assets, or both. Financial assets classified and measured at amortised cost are held within a business model with the objective to hold financial assets in order to collect contractual cash flows, while financial assets classified and measured at fair value through other comprehensive income are held within a business model with the objective of both holding to collect contractual cash flows and selling. Financial assets which are not held within the aforementioned business models are classified and measured at fair value through profit or loss.

All regular way purchases and sales of financial assets are recognised on the trade date, that is, the date that the Group commits to purchase or sell the asset. Regular way purchases or sales are purchases or sales of financial assets that require delivery of assets within the period generally established by regulation or convention in the marketplace.

Subsequent measurement

The subsequent measurement of financial assets depends on their classification as follows:

Financial assets at amortised cost (debt instruments)

Financial assets at amortised cost are subsequently measured using the effective interest method and are subject to impairment. Gains and losses are recognised in profit or loss when the asset is derecognised, modified or impaired.

初始確認及計量 (續)

為使金融資產按攤銷成本或按公平值計入其他全面收益進行分類及計量，需產生純粹為支付本金及未償還本金利息（「純粹為支付本金及利息」）的現金流量。現金流並非純粹為支付本金及利息的金融資產則按公平值計入損益進行分類及計量且不論業務模式。

本集團管理金融資產的業務模式指其如何管理其金融資產以產生現金流量。業務模式確定現金流量是否來自收取合約現金流量、出售金融資產，或兩者兼有。按攤銷成本分類及計量的金融資產以持有金融資產收取合約現金流為目的按業務模式持有，而按公平值計入其他全面收入進行分類及計量的金融資產同時以持有收取合約現金流及出售為目的按業務模式持有。未按照上述業務模式持有的金融資產則以公平值計入損益進行分類及計量。

所有一般買賣之金融資產於交易日期（即本集團承諾購買或出售資產之日期）予以確認。一般買賣指按照市場規例或慣例須於一般指定之時限內交付資產的金融資產買賣。

後續計量

金融資產隨後視乎其分類按以下方式計量：

按攤銷成本計量的金融資產 (債務工具)

按攤銷成本列賬的金融資產其後使用實際利率法計量，並可能出現減值。當資產被終止確認、修訂或出現減值時，收益及虧損於損益確認。

Financial assets at fair value through profit or loss

Financial assets at fair value through profit or loss are carried in the statement of financial position at fair value with net changes in fair value recognised in profit or loss.

This category includes derivative instruments and equity investments which the Group had not irrevocably elected to classify at fair value through other comprehensive income. Dividends on equity investments classified as financial assets at fair value through profit or loss are also recognised as other income in profit or loss when the right of payment has been established, it is probable that the economic benefits associated with the dividend will flow to the Group and the amount of the dividend can be measured reliably.

Derecognition of financial assets

A financial asset (or, where applicable, a part of a financial asset or part of a group of similar financial assets) is primarily derecognised (i.e., removed from the Group's consolidated statement of financial position) when:

- the rights to receive cash flows from the asset have expired; or
- the Group has transferred its rights to receive cash flows from the asset or has assumed an obligation to pay the received cash flows in full without material delay to a third party under a "pass-through" arrangement; and either (a) the Group has transferred substantially all the risks and rewards of the asset, or (b) the Group has neither transferred nor retained substantially all the risks and rewards of the asset, but has transferred control of the asset.

When the Group has transferred its rights to receive cash flows from an asset or has entered into a pass-through arrangement, it evaluates if, and to what extent, it has retained the risk and rewards of ownership of the asset. When it has neither transferred nor retained substantially all the risks and rewards of the asset nor transferred control of the asset, the Group continues to recognise the transferred asset to the extent of the Group's continuing involvement. In that case, the Group also recognises an associated liability. The transferred asset and the associated liability are measured on a basis that reflects the rights and obligations that the Group has retained.

Continuing involvement that takes the form of a guarantee over the transferred asset is measured at the lower of the original carrying amount of the asset and the maximum amount of consideration that the Group could be required to repay.

按公平值計入損益的金融資產

按公平值計入損益的金融資產按公平值於財務狀況表列賬，而公平值變動淨額則於損益確認。

該類別包括本集團並無不可撤回地選擇分類為按公平值計入其他全面收益的衍生工具及股權投資。股權投資的股息分類為按公平值計入損益的金融資產，在支付權確立，與股息相關的經濟利益很可能流入本集團且股息能夠被可靠計量時，亦於損益中確認為其他收入。

終止確認金融資產

金融資產 (或 (如適用) 金融資產的部分或同類金融資產組別的部分) 主要在下列情況下終止確認 (即自本集團的綜合財務狀況表中剔除)：

- 自該資產收取現金流量的權利已屆滿；或
- 本集團已轉讓自該資產收取現金流量的權利，或須根據「轉移」安排向第三方在無嚴重延遲的情況下全數支付所獲得的現金流量；及(a)本集團已轉讓該資產的絕大部分風險及回報，或(b)本集團概無轉讓或保留該資產絕大部分風險及回報但已轉讓資產的控制權。

倘若本集團已轉讓自一項資產收取現金流量的權利或訂立轉移安排，則會評估是否保留該資產擁有權的風險及回報以及保留的程度。倘若概無轉讓或保留該資產絕大部分風險及回報，亦無轉讓資產的控制權，則本集團按本集團持續參與資產的程度繼續確認有關已轉讓資產。在此情況下，本集團亦確認相關負債。已轉讓的資產及相關負債按可反映本集團保留的權利及責任的基準計量。

本集團以擔保形式持續參與已轉讓資產，該已轉讓資產乃以該項資產的原賬面值與本集團可能需要支付的最高代價兩者之較低者計量。

Impairment of financial assets

The Group recognises an allowance for expected credit losses (“ECLs”) for all debt instruments not held at fair value through profit or loss. ECLs are based on the difference between the contractual cash flows due in accordance with the contract and all the cash flows that the Group expects to receive, discounted at an approximation of the original effective interest rate. The expected cash flows will include cash flows from the sale of collateral held or other credit enhancements that are integral to the contractual terms.

General approach

ECLs are recognised in two stages. For credit exposures for which there has not been a significant increase in credit risk since initial recognition, ECLs are provided for credit losses that result from default events that are possible within the next 12 months (a 12-month ECL). For those credit exposures for which there has been a significant increase in credit risk since initial recognition, a loss allowance is required for credit losses expected over the remaining life of the exposure, irrespective of the timing of the default (a lifetime ECL).

At each reporting date, the Group assesses whether the credit risk on a financial instrument has increased significantly since initial recognition. When making the assessment, the Group compares the risk of a default occurring on the financial instrument as at the reporting date with the risk of a default occurring on the financial instrument as at the date of initial recognition and considers reasonable and supportable information that is available without undue cost or effort, including historical and forward-looking information.

In certain cases, the Group may also consider a financial asset to be in default when internal or external information indicates that the Group is unlikely to receive the outstanding contractual amounts in full before taking into account any credit enhancements held by the Group. A financial asset is written off when there is no reasonable expectation of recovering the contractual cash flows.

金融資產減值

本集團就並非按公平值計入損益持有的所有債務工具確認預期信貸虧損(「預期信貸虧損」)撥備。預期信貸虧損乃基於根據合約應付的合約現金流量與本集團預期收取的所有現金流量之間的差額釐定，並按接近原有實際利率的比率貼現。預期現金流量將包括出售所持抵押品或構成合約條款的其他信貸提升措施所得的現金流量。

一般方法

預期信貸虧損分兩個階段確認。就自初始確認以來信貸風險並無大幅增加的信貸風險而言，會就未來12個月可能發生的違約事件所產生的信貸虧損計提預期信貸虧損撥備(12個月預期信貸虧損)。就自初始確認以來信貸風險大幅增加的信貸風險而言，須就預期於風險餘下存續期內產生的信貸虧損計提虧損撥備，不論違約的時間(整個存續期預期信貸虧損)。

於各報告日期，本集團評估金融工具的信貸風險自初始確認以來是否顯著增加。作此評估時，本集團比較金融工具於報告日期出現違約的風險與該金融工具於初始確認日期出現違約的風險，並考慮無須花費不必要成本或精力即可獲得的合理及有理據的資料，包括過往及前瞻性資料。

於若干情況下，倘若內部或外部資料顯示，在計及本集團持有的任何信貸提升措施前，本集團不大可能悉數收取未償還合約款項，則本集團亦可認為金融資產違約。倘若無法合理預期收回合約現金流量，則撇銷金融資產。

General approach (Continued)

Financial assets at amortised cost are subject to impairment under the general approach and they are classified within the following stages for measurement of ECLs except for trade receivables which apply the simplified approach as detailed below.

- Stage 1 – Financial instruments for which credit risk has not increased significantly since initial recognition and for which the loss allowance is measured at an amount equal to 12-month ECLs
- Stage 2 – Financial instruments for which credit risk has increased significantly since initial recognition but that are not credit-impaired financial assets and for which the loss allowance is measured at an amount equal to lifetime ECLs
- Stage 3 – Financial assets that are credit-impaired at the reporting date (but that are not purchased or originated credit-impaired) and for which the loss allowance is measured at an amount equal to lifetime ECLs

Simplified approach

For trade receivables that do not contain a significant financing component or when the Group applies the practical expedient of not adjusting the effect of a significant financing component, the Group applies the simplified approach in calculating ECLs. Under the simplified approach, the Group does not track changes in credit risk, but instead recognises a loss allowance based on lifetime ECLs at each reporting date. The Group has evaluated the expected loss rate that is based on its historical credit loss experience, adjusted for forward-looking factors specific to the debtors and the economic environment.

For trade receivables that contain a significant financing component and lease receivables, the Group chooses as its accounting policy to adopt the simplified approach in calculating ECLs with policies as described above.

按攤銷成本列賬的金融資產根據一般方法減值，並分類至以下階段以計量預期信貸虧損，惟下文所述應用簡化方法的貿易應收款項除外。

- 第一階段 – 自初始確認以來信貸風險未顯著增加，且其虧損撥備等於12個月預期信貸虧損的金融工具
- 第二階段 – 自初始確認以來信貸風險顯著增加但並非信貸減值，且其虧損撥備等於整個存續期預期信貸虧損的金融工具
- 第三階段 – 於報告日期出現信貸減值（但並非購入或原已出現信貸減值），且其虧損撥備等於整個存續期預期信貸虧損的金融資產

簡化方法

並無重大融資成分或本集團應用可行權宜方法（即不調整重大融資成分的影響）的貿易應收款項，本集團應用簡化方法計算預期信貸虧損。簡化方法下，本集團並無追蹤信貸風險的變化，但於各報告日期根據整個存續期預期信貸虧損確認虧損撥備。本集團已根據其以往信貸虧損經驗，評估預期虧損率，並就債務人及經濟環境的特定前瞻性因素作出調整。

就包含重大融資成分的貿易應收款項及租賃應收款項而言，本集團在計算預期信貸虧損時選擇採納上述政策的簡化方法作為其會計政策。

Financial liabilities

Initial recognition and measurement

Financial liabilities are classified, at initial recognition, as financial liabilities at fair value through profit or loss, loans and borrowings, payables or as derivatives designated as hedging instruments in an effective hedge, as appropriate.

All financial liabilities are recognised initially at fair value and, in the case of loans and borrowings and payables, net of directly attributable transaction costs.

The Group's financial liabilities include interest-bearing bank and other borrowings, corporate bonds and senior notes (collectively called "**loans and borrowings**"), lease liabilities, trade payables, other payables, and amounts due to related parties.

Subsequent measurement

The subsequent measurement of financial liabilities depends on their classification as follows:

Financial liabilities at amortised cost (loans and borrowings)

After initial recognition, loans and borrowings are subsequently measured at amortised cost, using the effective interest rate method unless the effect of discounting would be immaterial, in which case they are stated at cost. Gains and losses are recognised in profit or loss when the liabilities are derecognised as well as through the effective interest rate amortisation process.

Amortised cost is calculated by taking into account any discount or premium on acquisition and fees or costs that are an integral part of the effective interest rate. The effective interest rate amortisation is included in finance costs in profit or loss.

Financial guarantee contracts

Financial guarantee contracts issued by the Group are those contracts that require a payment to be made to reimburse the holder for a loss it incurs because the specified debtor fails to make a payment when due in accordance with the terms of a debt instrument. A financial guarantee contract is recognised initially as a liability at its fair value, adjusted for transaction costs that are directly attributable to the issuance of the guarantee. Subsequent to initial recognition, the Group measures the financial guarantee contracts at the higher of: (i) the ECL allowance determined in accordance with the policy as set out in "Impairment of financial assets"; and (ii) the amount initially recognised less, when appropriate, the cumulative amount of income recognised.

金融負債

初始確認及計量

金融負債於初始確認時分類為按公平值計入損益的金融負債、貸款及借款、應付款項或有效對沖中指定為對沖工具的衍生工具(如適用)。

所有金融負債均按公平值進行初始確認，對於貸款及借款以及應付款項，則扣除直接應佔交易成本。

本集團的金融負債包括計息銀行及其他借款、公司債券及優先票據(統稱為「貸款及借款」、租賃負債、貿易應付款項、其他應付款項及應付關連方款項。

後續計量

金融負債隨後視乎其分類按以下方式計量：

按攤銷成本列賬的金融負債(貸款及借款)

於初始確認後，貸款及借款其後使用實際利率法按攤銷成本計量，但於貼現影響不大的情況下則按成本列賬。收益及虧損在終止確認負債時及於攤銷過程中以實際利率法確認為損益。

計算攤銷成本時，計及購買時的任何折讓或溢價，以及視為實際利率一部分的費用或成本。按實際利率法計算的攤銷計入損益的財務成本。

財務擔保合約

本集團發出之財務擔保合約為因特定借款人未能根據債務工具之條款於債項到期時還款，而本集團須向有關持有人作出彌償虧損之合約。財務擔保合約初步按公平值確認為負債，並就作出擔保所直接應佔交易成本作出調整。初始確認後，本集團會以下列兩者之較高者計算財務擔保合約：(i)根據「金融資產減值」所載政策釐定之預期信貸虧損撥備；及(ii)初始確認之金額減(如適用)已確認之累計收入金額。

Derecognition of financial liabilities

A financial liability is derecognised when the obligation under the liability is discharged or cancelled, or expires.

When an existing financial liability is replaced by another from the same lender on substantially different terms, or the terms of an existing liability are substantially modified, such an exchange or modification is treated as a derecognition of the original liability and a recognition of a new liability, and the difference between the respective carrying amounts is recognised in profit or loss.

Offsetting of financial instruments

Financial assets and financial liabilities are offset and the net amount is reported in the statement of financial position if there is a currently enforceable legal right to offset the recognised amounts and there is an intention to settle on a net basis, or to realise the assets and settle the liabilities simultaneously.

Cash and cash equivalents

For the purpose of the consolidated statement of cash flows, cash and cash equivalents comprise cash on hand and demand deposits, and short term highly liquid investments that are readily convertible into known amounts of cash, are subject to an insignificant risk of changes in value, and have a short maturity of generally within three months when acquired, less bank overdrafts which are repayable on demand and form an integral part of the Group's cash management.

For the purpose of the consolidated statement of financial position, cash and cash equivalents comprise cash on hand and at banks, including term deposits, and assets similar in nature to cash, which are not restricted as to use.

Provisions

A provision is recognised when a present obligation (legal or constructive) has arisen as a result of a past event and it is probable that a future outflow of resources will be required to settle the obligation, provided that a reliable estimate can be made of the amount of the obligation.

When the effect of discounting is material, the amount recognised for a provision is the present value at the end of the reporting period of the future expenditures expected to be required to settle the obligation. The increase in the discounted present value amount arising from the passage of time is included in finance costs in the consolidated statement of profit or loss and other comprehensive income.

金融負債於負債責任獲解除、取消或到期時終止確認。

倘若現有金融負債由同一貸款方授予條款差異重大的其他債項取代，或現有負債的條款經重大修訂，則此類變更或修訂視作終止確認原有負債及確認新負債，各自賬面值的差額於損益確認。

抵銷金融工具

當現時存在法律上可強制執行的權利，可抵銷已確認金額，且有意以淨額結算或同時變現資產及償還負債，則金融資產及金融負債可互相抵銷，並於財務狀況表呈報淨額。

現金及現金等價物

編製綜合現金流量表時，現金及現金等價物包括手頭現金及活期存款，以及可隨時轉換為已知金額現金及所涉價值變動風險不高，且一般自取得起計三個月內到期的短期高流動性投資，但須扣減應要求即時償還及構成本集團現金管理組成部分的銀行透支。

編製綜合財務狀況表時，現金及現金等價物包括手頭及銀行現金（包括定期存款），以及與現金性質類似的用途不受限制的資產。

撥備

倘若本集團因過往事件須承擔現時責任（法定或推定），而履行該責任可能導致未來資源流出，且該責任涉及金額能夠可靠估計，則確認撥備。

倘若貼現影響重大，則確認為撥備的金額將為報告期末預期須用作履行責任的未來開支的現值。因時間流逝而產生的貼現現值增額計入綜合損益及其他全面收益表的財務成本內。

Income tax

Income tax comprises current and deferred tax. Income tax relating to items recognised outside profit or loss is recognised outside profit or loss, either in other comprehensive income or directly in equity.

Current tax assets and liabilities are measured at the amount expected to be recovered from or paid to the taxation authorities, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period, taking into consideration interpretations and practices prevailing in the countries in which the Group operates.

Deferred tax is provided, using the liability method, on all temporary differences at the end of the reporting period between the tax bases of assets and liabilities and their carrying amounts for financial reporting purposes.

Deferred tax liabilities are recognised for all taxable temporary differences, except:

- when the deferred tax liability arises from the initial recognition of goodwill or an asset or liability in a transaction that is not a business combination and, at the time of the transaction, affects neither the accounting profit nor taxable profit or loss; and
- in respect of taxable temporary differences associated with investments in subsidiaries, joint ventures and associates, when the timing of the reversal of the temporary differences can be controlled and it is probable that the temporary differences will not reverse in the foreseeable future.

Deferred tax assets are recognised for all deductible temporary differences, and the carryforward of unused tax credits and any unused tax losses. Deferred tax assets are recognised to the extent that it is probable that taxable profit will be available against which the deductible temporary differences, and the carryforward of unused tax credits and unused tax losses can be utilised, except:

- when the deferred tax asset relating to the deductible temporary differences arises from the initial recognition of an asset or liability in a transaction that is not a business combination and, at the time of the transaction, affects neither the accounting profit nor taxable profit or loss; and
- in respect of deductible temporary differences associated with investments in subsidiaries, joint ventures and associates, deferred tax assets are only recognised to the extent that it is probable that the temporary differences will reverse in the foreseeable future and taxable profit will be available against which the temporary differences can be utilised.

所得稅

所得稅包括即期及遞延稅項。與並非於損益確認的項目有關的所得稅於損益之外確認，即於其他全面收益或直接於權益確認。

即期稅項資產及負債按預期將自稅務機關收回或向稅務機關支付的金額計量，乃按報告期末已實施或實質已實施的稅率(及稅法)計算，並已考慮到本集團營運所在國家的現行詮釋及慣例。

按負債法就報告期末資產和負債的稅基與其財務申報賬面值之間的所有暫時性差異計提遞延稅項撥備。

所有應課稅暫時性差異均會確認遞延稅項負債，惟下述情況除外：

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profit will be available to allow all or part of the deferred tax asset to be utilised. Unrecognised deferred tax assets are reassessed at the end of each reporting period and are recognised to the extent that it has become probable that sufficient taxable profit will be available to allow all or part of the deferred tax asset to be recovered.

Deferred tax assets and liabilities are measured at the tax rates that are expected to apply to the period when the asset is realised or the liability is settled, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period.

Deferred tax assets and deferred tax liabilities are offset if and only if the Group has a legally enforceable right to set off current tax assets and current tax liabilities and the deferred tax assets and deferred tax liabilities relate to income taxes levied by the same taxation authority on either the same taxable entity or different taxable entities which intend either to settle current tax liabilities and assets on a net basis, or to realise the assets and settle the liabilities simultaneously, in each future period in which significant amounts of deferred tax liabilities or assets are expected to be settled or recovered.

Government grants

Government grants are recognised at their fair value where there is reasonable assurance that the grant will be received and all attaching conditions will be complied with. When the grant relates to an expense item, it is recognised as income on a systematic basis over the periods that the costs, for which it is intended to compensate, are expensed.

Where the grant relates to an asset, the fair value is credited to a deferred income account and is released to profit or loss over the expected useful life of the relevant asset by equal annual instalments or deducted from the carrying amount of the asset and released to profit or loss by way of a reduced depreciation charge.

遞延稅項資產的賬面值於各報告期末予以審閱；若不再可能有足夠應課稅溢利用以抵扣全部或部分遞延稅項資產，遞延稅項資產賬面值將予扣減。未確認遞延稅項資產於各報告期末予以重估，並於可能有足夠應課稅溢利令全部或部分遞延稅項資產可被收回時確認。

遞延稅項資產及負債按資產變現或負債清償期間預期適用的稅率計量，並以報告期末已實施或實際已實施的稅率（及稅法）為基準。

僅當本集團擁有可依法執行的權利可將即期稅項資產與即期稅項負債抵銷，且遞延稅項資產與遞延稅項負債與同一稅務機關對同一應課稅實體或不同應課稅實體（於各未來期間預期有大額遞延稅項負債或資產需要結算或清償時，擬按淨額基準結算即期稅務負債及資產或同時變現資產並結算負債）徵收的所得稅有關時，遞延稅項資產與遞延稅項負債方可予抵銷。

政府補助

倘能合理確定將會收取政府補助且符合所有附帶條件，則有關補助將按公平值予以確認。倘補助與開支項目有關，即於擬補償成本的支銷期間內系統地確認為收入。

倘補助與資產有關，公平值將計入遞延收入賬戶，並於有關資產的預期可使用年期內，以等額年金調撥至損益或從資產賬面值中扣減並以經扣減折舊開支調撥至損益。

Revenue recognition

Revenue from contracts with customers

Revenue from contracts with customers is recognised when control of goods or services is transferred to the customers at an amount that reflects the consideration to which the Group expects to be entitled in exchange for those goods or services.

When the consideration in a contract includes a variable amount, the amount of consideration is estimated to which the Group will be entitled in exchange for transferring the goods or services to the customer. The variable consideration is estimated at contract inception and constrained until it is highly probable that a significant revenue reversal in the amount of cumulative revenue recognised will not occur when the associated uncertainty with the variable consideration is subsequently resolved.

When the contract contains a financing component which provides the customer with a significant benefit of financing the transfer of goods or services to the customer for more than one year, revenue is measured at the present value of the amount receivable, discounted using the discount rate that would be reflected in a separate financing transaction between the Group and the customer at contract inception. When the contract contains a financing component which provides the Group with a significant financial benefit for more than one year, revenue recognised under the contract includes the interest expense accreted on the contract liability under the effective interest method. For a contract where the period between the payment by the customer and the transfer of the promised goods or services is one year or less, the transaction price is not adjusted for the effects of a significant financing component, using the practical expedient in IFRS 15.

a. *Sale of properties*

Revenues are recognised when or as the control of the asset is transferred to the customer.

In determining the transaction price, the Group adjusts the promised amount of consideration for the effect of a financing component if it is significant.

For a property development and sales contract for which the control of the property is transferred at a point in time, revenue is recognised when the customer obtains the physical possession, or the legal title of the completed property and the Group has present right to payment and the collection of the consideration is probable.

客戶合約收益

客戶合約收入於貨品或服務的控制權轉移予客戶時予以確認，而該金額反映本集團預期就提供該等貨品或服務有權獲得的代價。

當合約中的代價包括可變金額時，估計代價為本集團將貨品或服務轉移予客戶而有權獲得的金額。可變代價在合約開始時作出估計並受其約束，直至與可變代價相關的不確定性消除，累計已確認收入金額極有可能不會發生重大收入轉回時。

倘合約包括融資組成部分，而該部分就轉讓商品或服務予客戶而為客戶提供超過一年的重大財務利益，則收益按應收款項現值（採用將於本集團與客戶於合約開始時所進行獨立融資交易所反映的貼現率貼現）計量。倘合約包括為本集團提供超過一年的重大財務利益的融資組成部分，則根據該合約確認的收益包括合約負債按實際利率法附加的利息費用。對於自客戶付款的時間至轉讓該承諾商品或服務的時間之間的期間為一年或以下的合約，交易價格不會因重大融資組成部分的影響而作出調整，使用國際財務報告準則第15號的實際權宜方法。

收益於資產控制權轉移至客戶時確認。

釐定交易價格時，本集團就重大融資成分的影響調整承諾的代價金額。

對於物業控制權於某一時間點轉移的物業開發及銷售合約，收益於客戶取得竣工物業的實際管有權或合法業權且本集團已有現時收款權並可能收到代價時確認。

b. Management consulting services

Consulting services income derived from the provision of support services in connection with development of property projects is recognised when the relevant services are rendered, and the customer simultaneously receives and consumes the benefits provided by the entity's performance as the entity performs.

Revenue from other sources

Rental income

Rental income is recognised on a time proportion basis over the lease terms. Variable lease payments that do not depend on an index or a rate are recognised as income in the accounting period in which they are incurred.

Interest income

Interest income is recognised on an accrual basis using the effective interest method by applying the rate that discounts the estimated future cash receipts over the expected life of the financial instrument of the net carrying amount of the financial asset.

Dividend income

Dividend income is recognised when the shareholders' right to receive payment has been established, it is probable that the economic benefits associated with the dividend will flow to the Group and the amount of the dividend can be measured reliably.

Contract liabilities

A contract liability is recognised when a payment is received or a payment is due (whichever is earlier) from a customer before the Group transfers the related goods or services. Contract liabilities are recognised as revenue when the Group performs under the contract (i.e., transfers control of the related goods or services to the customer).

Contract cost assets

Other than the costs which are capitalised as inventories, property, plant and equipment and intangible assets, costs incurred to fulfil a contract with a customer are capitalised as an asset if all of the following criteria are met:

- The costs relate directly to a contract or to an anticipated contract that the entity can specifically identify.
- The costs generate or enhance resources of the entity that will be used in satisfying (or in continuing to satisfy) performance obligations in the future.
- The costs are expected to be recovered.

The capitalised contract cost assets are amortised and charged to profit or loss on a systematic basis that is consistent with the transfer to the customer of the goods or services to which the asset related. Other contract costs are expensed as incurred.

b. 管理諮詢服務

就物業項目開發提供支持服務產生的諮詢服務收入於提供相關服務且客戶於實體履約時同時收到並消耗實體履約提供的利益時予以確認。

其他來源收益

租金收入

租金收入於租期內按時間比例確認。不取決於指數或利率的可變租賃付款在其出現的會計期間內確認為收入。

利息收入

利息收入按應計基準以實際利率法確認，所採用利率於金融工具的預計年期內將估計未來現金收入貼現至金融資產的賬面淨值。

股息收入

股息收入在股東收取款項的權利確立，與股息相關的經濟利益很可能流入本集團，並且股息金額能夠可靠地計量時確認。

合約負債

倘客戶於本集團將貨品或服務轉讓予客戶前支付代價，則於作出付款或付款到期時(以較早者為準)確認合約負債。合約負債於本集團履行合約時確認為收入(即相關貨品或服務的控制權轉讓予客戶)。

合約成本資產

除資本化為存貨、物業、廠房及設備以及無形資產的成本外，倘符合所有下列條件，則將履行客戶合約產生的成本資本化為資產：

- 有關成本與實體可明確識別之合約或預期合約有直接關係。
- 有關成本令實體將用於履行(或持續履行)日後履約責任之資源得以產生或有所增加。
- 有關成本預期可收回。

資本化合約成本資產乃按與轉讓資產相關貨品或服務予客戶一致的系統基準攤銷並自損益扣除。其他合約成本於產生時支銷。

Employee retirement benefits

Pension scheme

The employees of the Company and its subsidiaries which operate in Mainland China are required to participate in a central pension scheme operated by the local municipal government. These subsidiaries are required to contribute a certain proportion of these payroll costs to the central pension scheme. The only obligation of the Company with respect to the central pension scheme is to make the required contributions. No forfeited contribution under the central pension scheme is available to reduce the contribution payable in future years. The contributions are charged to profit or loss as they become payable in accordance with the rules of the central pension scheme.

The Group also participates in a pension scheme under the rules and regulations of the Mandatory Provident Fund Scheme Ordinance ("MPF Scheme") for all employees in Hong Kong, which is a defined contribution retirement scheme. The contributions to the MPF Scheme are based on minimum statutory contribution requirement of 5% of eligible employees' relevant aggregate income. No forfeited contribution under the MPF Scheme is available to reduce the contribution payable in future years. The assets of this pension scheme are held separately from those of the Group in independently administered funds.

Borrowing costs

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, i.e., assets that necessarily take a substantial period of time to get ready for their intended use or sale, are capitalised as part of the cost of those assets. The capitalisation of such borrowing costs ceases when the assets are substantially ready for their intended use or sale.

Investment income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs capitalised.

All other borrowing costs are expensed in the period in which they are incurred.

Borrowing costs include interest expense, finance charges and exchange differences arising from foreign currency borrowings to the extent that they are regarded as an adjustment to interest costs. The exchange gains and losses that are adjustments to interest costs include the interest rate differences between borrowing costs that would be incurred if the entity had borrowed funds in its functional currency, and the borrowing costs actually incurred on foreign currency borrowings. Such amounts are estimated based on forward currency rates at the inception of the borrowings.

When the construction of the qualifying assets takes more than one accounting period, the amount of foreign exchange differences eligible for capitalisation is determined for each annual period and is limited to the difference between the hypothetical interest amount for the functional currency borrowings and the actual interest incurred for foreign currency borrowings. Foreign exchange differences that did not meet the criteria for capitalisation in previous years should not be capitalised in subsequent years.

僱員退休福利

退休金計劃

本公司及其於中國內地運營的附屬公司之僱員須參加由地方市政府運營的中央退休金計劃。該等附屬公司須按工資成本的一定比例向中央退休金計劃供款。本公司於中央退休金計劃的唯一責任為作出所需供款。中央退休金計劃項下概無沒收供款可用作減少未來年度應付的供款。供款於根據中央退休金計劃規則應付時自損益扣除。

本集團亦根據強制性公積金計劃(「強積金計劃」)條例的規則和規例，為其於香港的所有僱員參與一項退休金計劃，該計劃屬一項定額供款退休計劃。強積金計劃的供款乃按合資格僱員相關收入總額5%的最低法定供款規定作出。強積金計劃項下概無沒收供款可用作減少未來年度應付的供款。該退休金計劃的資產由獨立管理基金持有，並與本集團的資產分開持有。

借貸成本

收購、建築或生產未完成資產(即需要經過相當長的一段時間方可作擬定用途或出售的資產)直接應佔的借貸成本乃撥作資產成本的一部分。當資產基本可作擬定用途或出售時，該等借貸成本終止資本化。

尚未用於未完成資產開支的特定借貸的短期投資收入乃自資本化借貸成本中扣除。

所有其他借貸成本均於產生期間支銷。

借款成本包括外幣借貸產生之利息開支、財務費用及匯兌差額，惟有關成本須視為利息成本之調整。為利息成本調整之外匯盈虧包括倘實體於其功能貨幣借出資金涉及之借款成本及實際涉及外幣借款之借貸成本之間之外匯差額。該等金額乃根據獲得借款時的遠期匯率估計得出。

當興建合資格資產需時超過一個會計期間，合資格資本化之外匯差額金額於各年度期間釐定，並受限於功能貨幣借貸之假定利息金額及涉及外幣借款之實際利息之差額。於過去數年不符合資本化標準之外匯差額將不會於其後數年予以資本化。

Dividends

Final dividends are recognised as a liability when they are approved by the shareholders in a general meeting. Proposed final dividends are disclosed in the notes to the financial statements.

Interim dividends are simultaneously proposed and declared, because the Company's memorandum and articles of association grant the directors the authority to declare interim dividends. Consequently, interim dividends are recognised immediately as a liability when they are proposed and declared.

Foreign currencies

Items included in the financial information of each of the Group's entities are measured using the currency of the primary economic environment in which the entity operates (the "functional currency"). The consolidated financial statements are presented in RMB, which is the Company's functional currency because the Group's principal operations are carried out in the PRC. Foreign currency transactions recorded by the entities in the Group are initially recorded using their respective functional currency rates prevailing at the dates of the transactions.

Monetary assets and liabilities denominated in foreign currencies are translated at the functional currency rates of exchange ruling at the end of each reporting period. Differences arising on settlement or translation of monetary items are recognised in profit or loss.

Non-monetary items that are measured in terms of historical cost in a foreign currency are translated using the exchange rates at the dates of the initial transactions. Non-monetary items measured at fair value in a foreign currency are translated using the exchange rates at the date when the fair value was measured. The gain or loss arising on translation of a non-monetary item measured at fair value is treated in line with the recognition of the gain or loss on change in fair value of the item (i.e., translation difference on the item whose fair value gain or loss is recognised in other comprehensive income or profit or loss is also recognised in other comprehensive income or profit or loss, respectively).

In determining the exchange rate on initial recognition of the related asset, expense or income on the derecognition of a non-monetary asset or non-monetary liability relating to an advance consideration, the date of initial transaction is the date on which the Group initially recognises the non-monetary asset or non-monetary liability arising from the advance consideration. If there are multiple payments or receipts in advance, the Group determines the transaction date for each payment or receipt of the advance consideration.

股息

末期股息於經股東在股東大會上批准時確認為負債。建議末期股息在財務報表附註中披露。

由於本公司的組織章程大綱及細則授予董事宣派中期股息的權力，因此中期股息的建議及宣派同時進行。因而，中期股息於提出建議及宣派時即時確認為負債。

外幣

本集團旗下各實體的財務資料所列項目均以該實體營運所在的主要經濟環境的貨幣（「功能貨幣」）計量。綜合財務報表以本公司的功能貨幣人民幣呈列，因為本集團的主要營運在中國進行。本集團實體入賬的外幣交易初始使用其各自功能貨幣於交易日期的適用匯率入賬。

以外幣計值的貨幣資產及負債按各報告期末適用的功能貨幣匯率換算。貨幣項目的結算或換算產生的差額於損益確認。

按外幣歷史成本計量的非貨幣項目使用初始交易日期的匯率換算。以外幣計值按公平值計量的非貨幣項目按釐定公平值當日的匯率換算。按公平值計量的非貨幣項目換算產生的收益或虧損按與該項目的公平值變動收益或虧損的確認一致的方式處理（即公平值收益或虧損於其他全面收益或損益確認的項目的換算差額亦分別於其他全面收益或損益確認）。

在終止確認預付代價相關的非貨幣性資產或非貨幣性負債時，為釐定初步確認相關資產、費用或收入的匯率，首次交易日為本集團初步確認預付代價產生的非貨幣性資產或非貨幣性負債之日。如有多次支付或收取預付款項，本集團會釐定各項支付或收取預付代價的交易日期。

3. SIGNIFICANT ACCOUNTING JUDGEMENTS AND ESTIMATES

The preparation of the Group's financial statements requires management to make judgements, estimates and assumptions that affect the reported amounts of revenues, expenses, assets and liabilities, and their accompanying disclosures, and the disclosure of contingent liabilities. Uncertainty about these assumptions and estimates could result in outcomes that could require a material adjustment to the carrying amounts of the assets or liabilities affected in the future.

Judgements

In the process of applying the Group's accounting policies, management has made the following judgements, apart from those involving estimations, which have the most significant effect on the amounts recognised in the financial statements:

Operating lease commitments – Group as lessor

The Group has entered into commercial property leases on its investment property portfolio. The Group has determined, based on an evaluation of the terms and conditions of the arrangements, such as the lease term not constituting a major part of the economic life of the commercial property and the present value of the minimum lease payments not amounting to substantially all of the fair value of the commercial property, that it retains substantially all the risks and rewards incidental to ownership of this property and accounts for the contracts as operating leases.

Classification between investment properties and owner-occupied properties

The Group determines whether a property qualifies as an investment property and has developed criteria in making that judgement. Investment property is a property held to earn rentals or for capital appreciation or both. Therefore, the Group considers whether a property generates cash flows largely independently of the other assets held by the Group. Some properties comprise a portion that is held to earn rentals or for capital appreciation and another portion that is held for use in the production or supply of goods or services or for administrative purposes. If these portions could be sold separately or leased out separately under a finance lease, the Group accounts for the portions separately. If the portions could not be sold separately, the property is an investment property only if an insignificant portion is held for use in the production or supply of goods or services or for administrative purposes. Judgement is made on an individual property basis to determine whether ancillary services are so significant that a property does not qualify as an investment property.

編製本集團的財務報表時，管理層須作出影響收益、開支、資產與負債呈報金額及相關披露以及或然負債披露的判斷、估計及假設。有關該等假設及估計的不明朗因素可能引致日後須對受影響的資產或負債的賬面值作出重大調整。

判斷

管理層在應用本集團會計政策的過程中，除有關估計外，亦作出下列對財務報表中確認的數額有最重大影響的判斷：

經營租賃承擔—本集團作為出租人

本集團已就其物業投資組合訂立商業物業租約。基於對安排條款及條件的評估，如租期不構成商用物業之經濟年期的主要部分，且最低租賃款項現值未達到商用物業的絕大部分公平值，本集團已決定保留該物業所有權附帶的絕大部分風險及回報，並將有關合約以經營租賃入賬。

投資物業與自用物業的分類

本集團釐定一項物業是否符合資格列作投資物業，並於作出判斷時制定標準。投資物業指持有以賺取租金或資本增值或兩者兼備的物業。因此，本集團考慮一項物業所產生的現金流量是否大部分獨立於本集團持有的其他資產。若干物業包括部分持作賺取租金或資本增值，而其他部分則持有作生產或供應貨品或服務或作行政用途。倘該等部分物業可以獨立出售或根據融資租賃獨立出租，本集團會就各部分獨立入賬。倘該等部分物業不可獨立出售，則僅當持有作生產或供應貨品或服務或作行政用途的部分微不足道時，該物業方為投資物業。判斷按獨立物業基準釐定配套服務是否非常重要，以致該物業不符合資格列作投資物業。

Judgements (Continued)

Classification of subsidiaries, joint ventures and associates

The classification of an investment as a subsidiary, a joint venture or an associate is based on whether the Group is determined to have control, joint control or significant influence over the investee, which involves judgements through the analysis of various factors, including the Group's representation on the chief decision-making authorities of an investee, such as the board of directors' meetings and shareholders' meetings, as well as other facts and circumstances.

Subsidiaries are consolidated, which means each of their assets, liabilities and transactions are included line-by-line in the Group's consolidated financial statements, whereas the interests in joint ventures and associates are equity accounted for as investments in the consolidated statement of financial position.

Deferred tax assets

Deferred tax assets are recognised for all deductible temporary differences, and the carryforward of unused tax credits and unused tax losses, to the extent that it is probable that taxable profit will be available against which the deductible temporary differences, and the carryforward of unused tax credits and unused tax losses can be utilised. Significant management judgement is required to determine the amount of deferred tax assets that can be recognised, based upon the likely timing and level of future taxable profits together with future tax planning strategies. Further details are included in note 19 to the financial statements.

Estimation uncertainty

The key assumptions concerning the future and other key sources of estimation uncertainty at the end of the reporting period, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year, are described below.

Significant financing component

In determining the transaction price, the Group adjusts the promised amount of consideration for the effects of the time value of money if the timing of payments agreed by the parties to the contract provides the Group with a significant benefit of financing.

Certain advance payments received from customers provide a significant financing benefit to the Group. Although the Group is required by the government to place all deposits and periodic payments received from the pre-completion sales in a stakeholder account, the Group is able to benefit from those advance payments as it can withdraw money from that account to pay for expended construction costs on the project. The advance payments received in effect reduce the Group's need to rely on other sources of financing.

附屬公司、合營企業及聯營公司的分類

將投資分類為附屬公司、合營企業或聯營公司乃以本集團是否於被投資公司擁有控制權、共同控制權或重大影響為依據，當中涉及通過分析各種因素（包括本集團對被投資公司主要決策權的陳述），如董事會會議及股東大會以及其他事實及情況作出的判斷。

附屬公司會合併入賬，即該公司的各項資產、負債及交易逐項納入本集團的綜合財務報表，而合營企業及聯營公司的權益則在綜合財務狀況表中入賬列作投資。

遞延稅項資產

所有可扣減暫時性差異，以及結轉的未動用稅項抵免及未動用稅項虧損均確認為遞延稅項資產，以可能會產生應課稅溢利並可用於抵銷可扣減暫時性差異，以及結轉的未動用稅項抵免及未動用稅項虧損為限。管理層釐定可確認的遞延稅項資產金額時，須根據未來應課稅溢利的可能時間及水平，以及未來稅務規劃策略，作出重大判斷。進一步詳情載於財務報表附註19。

估計不明朗因素

有關於報告期末估計不明朗因素的未來及其他主要來源的主要假設，存在會導致下一個財政年度內資產及負債賬面值出現重大調整的重大風險，載列如下。

重大融資成分

於釐定交易價格時，倘訂約方所商定的付款時間為本集團提供重大融資利益，則本集團會根據金錢時間價值影響調整承諾的代價金額。

自客戶收取的若干預付款項為本集團提供重大融資利益。雖然政府規定本集團須將預售所得所有按金及分期付款存放在利益相關者賬戶中，但本集團能自該等預付款項中獲益，此乃由於其能自該賬戶中提取款項用於支付該項目的建築成本。實際收取的預付款項可減少本集團對其他融資來源的倚賴。

Significant financing component (Continued)

The amount of the financing component is estimated at the inception of the contract. After contract inception, the discount rate is not updated for changes in interest rates or other circumstances, such as a change in credit risk. The period of financing is from the time that the payment is received until the transfer of goods to the customers is completed.

Provision for expected credit losses on trade receivables and prepayments, other receivables and other assets

The Group uses a provision matrix to calculate ECLs for trade receivables and prepayments, other receivables and other assets. The provision rates are based on days past due for groupings of various customer segments that have similar loss patterns (i.e., by product type, customer type rating and counter party)

The expected loss rate is initially based on the Group's historical observed default rates. The Group will calibrate the matrix to adjust the historical credit loss experience with forward-looking information. For instance, if forecast economic conditions (i.e., gross domestic product) are expected to deteriorate over the next year which can lead to an increased number of defaults in the properties sector, the historical default rates are adjusted. At each reporting date, the historical observed default rates are updated and changes in the forward-looking estimates are analysed.

The assessment of the correlation among historical observed default rates, forecast economic conditions and ECLs is a significant estimate. The amount of ECLs is sensitive to changes in circumstances and forecast economic conditions. The Group's historical credit loss experience and forecast of economic conditions may also not be representative of a customer's actual default in the future. The information about the ECLs on the Group's trade receivables and prepayments, other receivables and other assets is disclosed in note 22 and note 24 to the financial statements, respectively.

重大融資成分 (續)

融資成分金額於訂立合約時進行估計。合約訂立後，不會就利率變動或其他情況(如信貸風險變動)更新貼現率。融資期間自收取付款之時起計直至向客戶轉移貨品時結束。

貿易應收款項及預付款項、其他應收款項及其他資產之預期信貸虧損撥備

本集團使用撥備矩陣計算貿易應收款項及預付款項、其他應收款項及其他資產之預期信貸虧損。撥備率乃基於擁有類似虧損模式(即產品類別、客戶類別評級以及對手方)的多個客戶分部組別的逾期日數釐定。

預期虧損率初始基於本集團的歷史觀察違約率。本集團將通過調整矩陣，並連同前瞻性資料調整歷史信貸虧損經驗。例如，倘預測經濟狀況(如國內生產總值)預期將於未來一年內惡化，這可能導致物業行業違約數量增加，歷史違約率將予以調整。歷史觀察違約率於各報告日期進行更新，並對前瞻性估計的變動進行分析。

對歷史觀察違約率、預測經濟狀況及預期信貸虧損之間相關性的評估為一項重要估計。預期信貸虧損之金額對環境及預測經濟狀況的變動敏感。本集團的歷史信貸虧損經驗及經濟狀況預測亦可能無法代表客戶日後的實際違約情況。有關本集團貿易應收款項及預付款項、其他應收款項及其他資產的預期信貸虧損資料分別於財務報表附註22及附註24披露。

Provision for properties under development and completed properties held for sale

The Group's properties under development and completed properties held for sale are stated at the lower of cost and net realisable value. Based on the Group's historical experience and the nature of the subject properties, the Group makes estimates of the selling prices, the costs of completion of properties under development, and the costs to be incurred in selling the properties based on prevailing market conditions.

If there is an increase in costs to completion or a decrease in net sales value, the net realisable value will decrease and this may result in a provision for properties under development and completed properties held for sale. Such provision requires the use of judgement and estimates. Where the expectation is different from the original estimate, the carrying value and provision for properties in the periods in which such estimate is changed will be adjusted accordingly.

Impairment of non-financial assets (other than goodwill)

The Group assesses whether there are any indicators of impairment for all non-financial assets at the end of each year. Other non-financial assets are tested for impairment when there are indicators that the carrying amounts may not be recoverable. An impairment exists when the carrying value of an asset or a cash-generating unit exceeds its recoverable amount, which is the higher of its fair value less costs of disposal and its value in use.

The calculation of the fair value less costs of disposal is based on available data from binding sales transactions in an arm's length transaction of similar assets or observable market prices less incremental costs for disposing of the asset. When value in use calculations are undertaken, management must estimate the expected future cash flows from the asset or cash-generating unit and choose a suitable discount rate in order to calculate the present value of those cash flows.

PRC corporate income tax ("CIT")

The Group is subject to corporate income taxes in the PRC. As a result of the fact that certain matters relating to the income taxes have not been confirmed by the local tax bureau, objective estimate and judgement based on currently enacted tax laws, regulations and other related policies are required in determining the provision for income taxes to be made. Where the final tax outcome of these matters is different from the amounts originally recorded, the differences will impact on the income tax and tax provisions in the period in which the differences realise.

開發中物業及持作出售已竣工物業撥備

本集團開發中物業及持作出售已竣工物業按成本與可變現淨值之間的較低者列賬。本集團根據其過往經驗及有關物業的性質，基於現行市況估計售價、開發中物業竣工成本及銷售物業產生的成本。

倘若竣工成本增加，或售價淨額減少，則可變現淨值會減少，並可能因而導致須就開發中物業及持作出售已竣工物業計提撥備。該撥備須運用判斷及估計。在預期與原有估計有差異時，將於該估計發生變動的期間對物業的賬面值及撥備作出相應調整。

非金融資產 (商譽除外) 減值

本集團於各年末評估所有非金融資產是否存在任何減值跡象。在有跡象表明非金融資產的賬面值不可收回時測試其他非金融資產是否減值。若資產或現金產生單位的賬面值超過其可收回金額 (為其公平值減出售成本與其使用價值兩者中的較高者)，則存在減值。

依據按公平原則交易類似資產的約束性銷售交易中可得的資料或可觀察到的市價減出售資產的增量成本計算公平值減出售成本。在計算使用價值時，管理層須估計資產或現金產生單位的預期未來現金流量，並選擇適當的貼現率以計算該等現金流量的現值。

中國企業所得稅 (「企業所得稅」)

本集團須繳納中國企業所得稅。由於有關所得稅的若干事宜尚未被地方稅務局確認，於釐定所作出的所得稅撥備時須以目前有效的稅法、法規及其他有關政策作為客觀估計及判斷依據。倘該等事宜的最終稅款數額有別於原本記錄的數額，差額會在所發生的期間對所得稅及稅項撥備產生影響。

PRC land appreciation tax ("LAT")

The Group is subject to LAT in the PRC. The provision for LAT is based on management's best estimates according to the understanding of the requirements set forth in the relevant PRC tax laws and regulations. The actual LAT liabilities are subject to the determination by the tax authorities upon the completion of the property development projects. The Group has not finalised its LAT calculation and payments with the tax authorities for certain of its property development projects. The final outcome could be different from the amounts that were initially recorded, and any differences will impact on the LAT expenses and the related provision in the period in which the differences realise.

Estimate of fair value of investment properties

Investment properties carried at fair value were revalued at each reporting date based on the appraised market value provided by independent professional valuers. Such valuations were based on certain assumptions, which are subject to uncertainty and might materially differ from the actual results. In making the estimation, the Group considers information from current prices in an active market for similar properties and uses assumptions that are mainly based on market conditions existing at the end of each year.

Deferred tax assets

Deferred tax assets are recognised for unused tax losses to the extent that it is probable that taxable profit will be available against which the losses can be utilised. Significant management judgement is required to determine the amount of deferred tax assets that can be recognised, based upon the likely timing and level of future taxable profits together with future tax planning strategies.

4. OPERATING SEGMENT INFORMATION

Management monitors the operating results of the Group's business which includes property development, property leasing, and the provision of management consulting services. Property leasing and the provision of management consulting services are not significant in revenue contribution. Thus, property development is the only reportable operating segment of the Group, and no further operating segment analysis thereof is presented.

Geographical information

No geographical information is presented as the Group's revenue from the external customers is derived solely from its operation in Mainland China and no non-current assets of the Group are located outside Mainland China.

Information about major customers

No revenue from sales to a single customer or a group of customers under common control accounted for 10% or more of the Group's revenue at the end of the reporting period.

中國土地增值稅 (「土地增值稅」)

本集團須繳納中國土地增值稅。土地增值稅撥備乃根據管理層按照中國相關稅法及法規所載規定的理解，從而作出的最佳估計計提。實際的土地增值稅負債，須待物業開發項目完成後由稅務當局釐定。本集團尚未就其若干物業開發項目與稅務當局最終確定土地增值稅的計算及付款。最終結果可能與初步入賬的金額有所不同，而任何差額會在所發生的期間對土地增值稅開支及相關撥備產生影響。

投資物業的公平值估計

按公平值列賬的投資物業於各報告日期根據獨立專業估值師提供的評估市值重新估值。該等估值乃基於若干假設作出，存在不確定性，可能與實際結果存在重大差異。進行估計時，本集團考慮活躍市場上類似物業的近期價格信息，並使用主要基於各年末的市況作出的假設進行估計。

遞延稅項資產

倘可能具有應課稅利潤抵銷虧損，則會就未動用稅項虧損確認遞延稅項資產。管理層在釐定可予以確認的遞延稅項資產金額時，須根據未來應課稅利潤可能出現的時間及水平連同未來稅務計劃策略作出重大判斷。

4. 經營分部資料

管理層監控本集團業務 (包括物業開發、物業租賃及提供管理諮詢服務) 的經營業績。物業租賃及提供管理諮詢服務並未貢獻重大收入，故物業開發為本集團的唯一可報告經營分部，且並無呈列其他經營分部分析。

地區資料

由於本集團來自外部客戶的收入僅自其於中國內地的經營所得且本集團並無非流動資產位於中國內地以外地區，故並無呈列地區資料。

有關主要客戶的資料

Management consulting services

The Group has elected the practical expedient not to disclose the remaining performance obligations for these types of contracts. The majority of the management consulting service contracts do not have a fixed term. The term of the contracts for pre-delivery and consulting services is generally set to expire when the counterparties notify the Group that the services are no longer required.

Pursuant to the PRC Corporate Income Tax Law, a 10% withholding tax is levied on dividends declared to foreign investors from the foreign investment enterprises established in Mainland China. The requirement is effective from 1 January 2008 and applies to earnings after 31 December 2007. A lower withholding tax rate may be applied if there is a tax treaty between Mainland China and the jurisdiction of the foreign investors. For the Group, the applicable rate is 10%. The Group is therefore liable for withholding taxes on dividends distributed by those subsidiaries established in Mainland China in respect of earnings generated from 1 January 2008.

As at 31 December 2022, no deferred tax has been recognised for withholding taxes that would be payable on the unremitted earnings that are subject to withholding taxes of the Group's subsidiaries established in Mainland China. In the opinion of the directors of the Company, the Group's fund will be retained in Mainland China for the expansion of the Group's operation, so it is not probable that these subsidiaries will distribute such earnings in the foreseeable future. The Group's finance department headed by the finance manager is responsible for determining the policies and procedures for the fair value measurement of financial instruments. The finance manager reports directly to the chief financial officer. At each reporting date, the finance department analyses the movements in the values of financial instruments and determines the major inputs applied in the valuation. The valuation is reviewed and approved by the chief financial officer. The valuation results are discussed with the audit committee twice a year for interim and annual financial reporting.

The fair values of the financial assets and liabilities are included at the amount at which the instrument could be exchanged in a current transaction between willing parties, other than in a forced or liquidation sale. The following methods and assumptions were used to estimate the fair values:

The Group invests in unlisted investments, which represent wealth management products issued by financial institutions in Mainland China. The Group has estimated the fair value of these unlisted investments by using a discounted cash flow valuation model based on the market interest rates of instruments with similar terms and risks.

The fair values of interest-bearing bank and other borrowings and certain proceeds from asset-backed securities have been calculated by discounting the expected future cash flows using rates currently available for instruments with similar terms, credit risk and remaining maturities. The Group's own non-performance risk for interest-bearing bank and other borrowings as at 31 December 2022 was assessed to be insignificant.

The fair values of certain proceeds from asset-backed securities, corporate bonds and senior notes are based on quoted market prices.

44. FINANCIAL RISK MANAGEMENT OBJECTIVES AND POLICIES

The Group's principal financial instruments mainly include cash and bank balances, restricted cash, trade receivables, and trade and other payables, which arise directly from its operations. The Group has other financial assets and liabilities such as interest-bearing bank and other borrowings, senior notes, corporate notes, financial instruments at fair value through profit or loss, amounts with related companies and other receivables. The main purpose of these financial instruments is to raise finance for the Group's operations.

The main risks arising from the Group's financial instruments are interest rate risk, foreign currency risk, credit risk and liquidity risk. Generally, the Group introduces conservative strategies on its risk management. The Group does not hold or issue derivative financial instruments for trading purposes. The board of directors reviews and agrees policies for managing each of these risks and they are summarised below.

(a) Interest rate risk

The Group's exposure to risk for changes in market interest rates relates primarily to the Group's bank and other borrowings set out in note 31. The Group does not use derivative financial instruments to hedge interest rate risk. The Group manages its interest cost using variable rate bank borrowings.

As at 31 December 2022, if the interest rate of bank borrowings had increased/decreased by 1% and all other variables held constant, profit before tax for the year of the Group would have decreased/increased by approximately RMB14,787,000 (2021: RMB17,513,000).

(c) Credit risk

The Group divides financial instruments on the basis of shared credit risk characteristics, such as instrument type and credit risk ratings for the purpose of determining significant increases in credit risk and calculation of impairment. To manage risk arising from trade receivables, the Group has policies in place to ensure that credit terms are made only to counterparties with an appropriate credit history and management performs ongoing credit evaluations of the Group's counterparties. The credit period granted to the customers is generally six months and the credit quality of these customers is assessed, taking into account their financial position, past experience and other factors. The Group also has other monitoring procedures to ensure that follow-up action is taken to recover overdue receivables. In addition, the Group reviews regularly the recoverable amount of trade receivables to ensure that adequate impairment losses are made for irrecoverable amounts. The Group has no significant concentrations of credit risk, with exposure spread over a large number of counterparties and customers.

Management makes periodic collective assessments for financial assets included in prepayments, other receivables and other assets and amounts due from related parties as well as individual assessments on the recoverability of other receivables and amounts due from related parties based on historical settlement records and past experience. The Group classified financial assets included in prepayments, other receivables and other assets and amounts due from related parties in Stage 1 and continuously monitored their credit risk. The directors of the Company believe that there is no material credit risk inherent in the Group's outstanding balance of financial assets included in prepayments, other receivables and other assets and amounts due from related parties.

Maximum exposure and year-end staging

The tables below show the credit quality and the maximum exposure to credit risk based on the Group's credit policy, which is mainly based on past due information unless other information is available without undue cost or effort, and year-end staging classification as at 31 December 2022. The amounts presented are gross carrying amounts for financial assets and the exposure to credit risk for the financial guarantee contracts.
