If the Company does not receive the duly completed Reply Form or receive a response indicating any objection from you by 26 May 2023, you will be deemed to have consented to receiving the Website Version for all the future Corporate Communications and a notification letter informing you of the posting of the Corporate Communications on the website of the Company will be sent to you in future as and when they are published.

You are entitled to change the choice of language and/or means of receipt of the Corporate Communications at any time by notice in writing to the HK Share Registrar or by email to the Company at **kerryprops@hk.tricorglobal.com**.
