COMPLETION OF THE PUBLIC ISSUANCE OF THE CORPORATE BONDS (TRANCHE 1) IN THE PRC BY CHINA UNIVERSAL LEASING CO., LTD., A WHOLLY-OWNED SUBSIDIARY OF THE COMPANY

This announcement is made by Genertec Universal Medical Group Company Limited (the “**Company**”) pursuant to Rule 13.09(2)(a) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and the Inside Information Provisions (as defined under the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571, Laws of Hong Kong).

Reference is made to the announcement of the Company dated 21 April 2023 (the “**Announcement**”) in relation to the public issuance of the first tranche of the corporate bonds in 2023 (the “**T1 Corporate Bonds**”) in the People’s Republic of China (the “**PRC**”) by China Universal Leasing Co., Ltd. (中國環球租賃有限公司) (the “**Issuer**”), a wholly-owned subsidiary of the Company. Unless the context requires otherwise, capitalized terms used herein shall have the same meanings as those defined in the Announcement.

The Company is pleased to announce that the issuance of the T1 Corporate Bonds in the PRC was completed on 26 April 2023. The total principal amount of the T1 Corporate Bonds is RMB600 million, with a basic term of four years from 26 April 2023, at the end of the second year and the third year of which the Issuer will be entitled to a repurchase option and a coupon rate adjustment option, while the investors will be entitled to a sell-back option. The T1 Corporate Bonds are with

a fixed interest rate of 3.5%. The issue price is RMB100 per bond, which is equal to 100% of the principal value of the T1 Corporate Bonds.
