If any proxy other than the chairman of the meeting is preferred, please cross out the words "THE CHAIRMAN OF THE MEETING, OR" and insert the name(s) and address(es) of the proxy(ies) desired in the spaces provided. A Shareholder may appoint one or more proxies to attend and vote on his/her behalf. A proxy need not be a Shareholder. ANY ALTERATION MADE TO THIS FORM OF PROXY MUST BE INITIALLED BY THE PERSON(S) WHO SIGNS IT.

Proxy of Shareholder will also be entitled to vote at his discretion on any resolution legally and properly put to the AGM other than those referred to in the Notice of AGM.

This form of proxy must be signed by you, or your attorney duly authorised in writing or, in the case that Shareholder is a legal person, this form of proxy must be either executed under its common seal or under the hand of its directors or attorney or a person duly authorised to sign the same. If this form of proxy is signed by an attorney of the appointor, the power of attorney authorising that attorney to sign, or other document of authorisation, must be notarised.
- 7. In case of any joint holder of Shares, only the join holder whose name appears first in the register of members is entitled to receive the Share certificates of relevant Shares and the Company's notices, and to attend and exercise all voting rights of such Shares at an annual general meeting of the Company. Any notice delivered to that person shall be deemed as having been delivered to all joint holders of the relevant Shares.
- 8. In order to be valid, the form of proxy and the notarised power of attorney or other authorisation documents must be lodged with the Company's H Share registrar in Hong Kong, Boardroom Share Registrars (HK) Limited, at 2103B, 21/F, 148 Electric Road, North Point, Hong Kong (for holders of H Shares) or the Company's headquarter in the PRC at 35/F, Huijin International Center, No. 105 Daxing Street, Fengze District, Quanzhou City, Fujian Province, the PRC (for holders of Domestic Shares) not less than 24 hours before the time fixed for holding the AGM (i.e. before 10:30 a.m. on Thursday, 8 June 2023).
