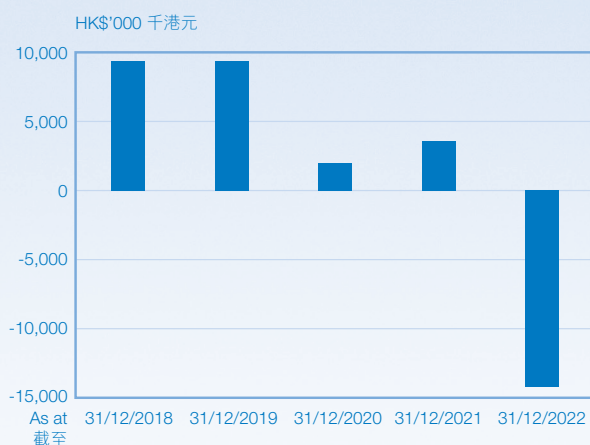

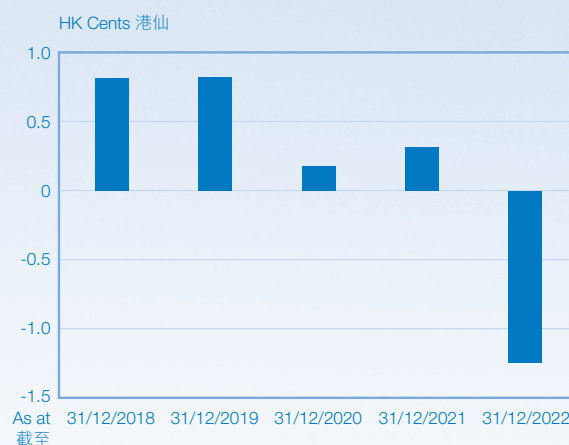

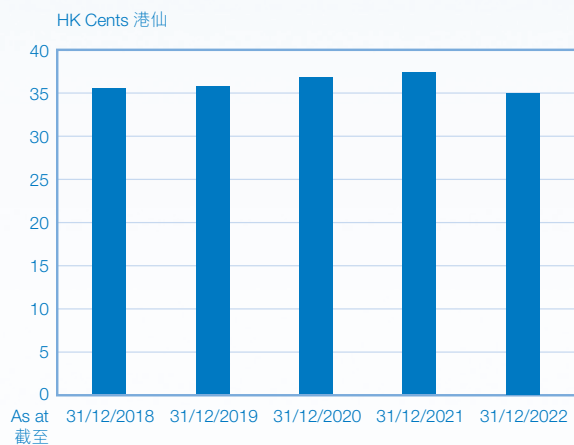

Chairman's Statement

主席報告

On behalf of the Board of Directors (the "Board" or "Directors") of Fujian Holdings Limited (the "Company"), I hereby present the annual report and the audited consolidated financial statements of the Company together with our subsidiaries (collectively the "Group") for the financial year ended 31 December 2022 ("2022" or the "current year" or "reporting year" or the "year under review") to the shareholders of the Company (the "Shareholders").

BUSINESS REVIEW

For the year ended 31 December 2022, the Group recorded a revenue of approximately HK\$18.90 million, as compared to approximately HK\$23.43 million in the corresponding period last year representing on decrease of approximately 19.33% for the corresponding financial year.

Net loss attributable to shareholders was approximately HK\$14.31 million (2021: profit HK\$3.64 million).

Loss per share was approximately 1.25 HK cents for year ended 31 December 2022 (2021: Earning per share 0.32 HK cents).

Net assets (total assets less total liabilities) decrease by approximately HK\$27.14 million to approximately HK\$402.52 million as compared with HK\$429.66 million as at 31 December 2021.

DIVIDENDS

The Directors do not recommend the payment of a dividend for the year ended 31 December 2022.

PROSPECTS

As the impact of the pandemic on the economy continues to diminish, the resumption of normal cross-border traffic between mainland China and Hong Kong is also beneficial for economic recovery. China's major economic indicators are showing a trend of recovery and improvement. However, market interest rate fluctuations have intensified and the foundation of economic stabilization is not yet stable. Our group will seize the long-term development trend of the green environmental protection industry, cultural tourism, and related industries, relying on our advantages in Fujian Province. We will adhere to the principle of seeking progress while maintaining stability, strengthen overall planning and coordination, actively promote transformation and integration, and continuously enhance the internal driving force and long-term competitiveness of our group for sustained development.

本人謹代表閩港控股有限公司(「本公司」)董事會(「董事會」或「董事」)提呈本公司及其附屬公司(統稱「本集團」)截至二零二二年十二月三十一日止之財政年度(「二零二二年」或「本年度」或「本報告期」或「回顧期」)報告及經審核之綜合財務報表，以供本公司股東(「股東」)省覽。

業務回顧

截至二零二二年十二月三十一日止年度，本集團收益約為1,890萬港元，去年同期則約為2,343萬港元比較，下降約19.33%。

本公司持有人應佔虧損約1,431萬港元(二零二一年：盈利364萬港元)。

截至二零二二年十二月三十一日止年度，每股虧損1.25港仙(二零二一年：每股盈利0.32港仙)。

淨資產(總資產減總負債)比截至二零二一年十二月三十一日之429.66萬港元下降約2,714萬港元至約為402.52萬港元。

股息

董事會不建議派發二零二二年十二月三十一日止年度任何股息。

前景展望

隨著疫情對經濟的影響進一步消減，內地與香港恢復正常通關也有利於經濟復蘇，我國主要經濟指標呈現回升向好走勢。但市場資金利率波動加劇，經濟回穩的基礎還不穩固。本集團將抓住綠色環保產業、文化旅遊及相關產業的長線發展態勢，依靠我們於福建省之優勢，堅持穩中求進，加強統籌協調，積極推進變革整合，不斷提升本集團持續發展的內在動力與長期競爭力。

The Group is actively responding to the complex and ever-changing external environment, accelerating the review of existing businesses and continuously updating business strategies to adapt to future development. It is actively studying the revitalization and optimization plan for stock assets such as Hong Kong properties to improve asset management efficiency and unlock value, and continues to strengthen the integration of hotel resources, cultural tourism industry, green environmental protection industry, equity investment, and other business clusters. It is actively expanding new business models, promoting further interconnection between the mainland and Hong Kong markets, establishing a core business industry chain, and strengthening its core competitiveness. The Group has always attached importance to corporate governance, actively promoted the construction of an internal control system and compliance management, strengthened governance mechanisms, and continuously enhanced its risk prevention and control capabilities to provide strong support for realizing the healthy and sustainable development of the Group.

The overall goal of the Group is to comprehensively utilise the Group's resources, effectively fulfill the corporate social responsibility and to maximise every shareholder's interest. The group will actively integrated into the national development, give full play to the institutional strengths of the "one country, two systems" and the unique effect of Hong Kong, adhere to the core business construction, adhere to seek improvement in stability development, improve brand connotation. With innovative thinking to promote reform of the Group, adopt market-oriented incentive mechanism combining internal training and external professional to build a professional, efficient and effective talent team so as to improve the potential and group resources of internal value.

BUSINESS REVIEW

For the year ended 31 December, 2022, the Group recorded net loss attributable to owners of the Company of approximately HK\$14.31 million (31 December 2021: profit of HK\$3.64 million). The Group's net loss is mainly attributable to a series of uncontrollable factors as explained below, as well as the decline in the number of tourists for the Group's hotel in Mainland China and office tenants have delayed or suspended office leases which negatively affected the financial performance of the Group.

Deemed disposal of interest in associate

As the goodwill arising from the deemed disposal of interest in associate is less than the prior year and combined with the impact of a home currency depreciation during the period, a loss incurred on the deemed disposal of interest in associate of approximately HK\$2.09 million for the year ended 31 December 2022 as compared to a profit of HK\$3.46 million for the year ended 31 December 2021.

Fair value of investment properties

As the Hong Kong Grade A office market is constantly under pressure, there was a net decrease in fair value of investment property of HK\$0.9 million for the year ended 31 December 2022 as compared to a net increase in fair value of investment properties of HK\$2 million for the year ended 31 December 2021.

Income tax (expense)/credit

Due to the reversal of a deferred tax assets of approximately HK\$1.89 million during the year, there was a debit incurred on income tax of approximately HK\$1.41 million for the year ended 31 December 2022 as compared to a credit of HK\$0.96 million for the year ended 31 December 2021.

Share of loss of an associate

Due to the adverse market conditions during the year, there was a share of loss of an associate (Fuzhou Harmony Piano Co., Ltd. PRC) of approximately HK\$1.74 million for the year ended 31 December 2022 as compared to a share of loss of an associate of HK\$0.06 million for the year ended 31 December 2021.

業務回顧

截至二零二二年十二月三十一日止之年度，本集團錄得持有人應佔虧損約1,431萬港元（二零二一年十二月三十一日：約364萬港元盈利）。本集團的虧損主要由於下面闡釋的一連串無法掌控因素，以及本集團內地酒店的旅遊接待人次下降及寫字樓租戶拖延或擱置寫字樓租約決定，並對本集團的財務業務造成負面影響。

視作出售聯營公司

因視作出售聯營公司所產生的商譽相對之前一年少，再加上當時區域貨幣減值所影響，截至二零二二年十二月三十一日止年度被視作出售聯營公司產生約209萬港元虧損，相對比截至二零二一年十二月三十一日止年度則為溢利346萬港元。

投資物業公允值

因香港甲級寫字樓市場持續受壓，截至二零二二年十二月三十一日止年度內集團投資物業公允值淨減少90萬港元，相對比截至二零二一年十二月三十一日止年度投資物業公允值則淨增加200萬港元。

所得稅(支出)／抵免

因本年度逆轉約189萬港元遞延稅項資產，因此截至二零二二年十二月三十一日止年度利得稅產生約141萬港元支出，相對比截至二零二一年十二月三十一日止年度利得稅則為96萬港元抵免。

應佔聯營公司之虧損

因本年度市場狀況不利，截至二零二二年十二月三十一日止年度應佔福州和聲鋼琴股份有限公司產生約174萬港元虧損，相對比截至二零二一年十二月三十一日止年度應佔聯營公司虧損則為6萬港元。

An associate ceased to be an associate during the year

In August 2022, the registered capital of the joint venture company of our company, Fujian Huamin Leasing Co., Ltd., (“Fujian Huamin Leasing”) has increased from RMB270,000,000 to RMB500,000,000. After the capital increase is completed, our company’s equity in Fujian Huamin Leasing reduced to 18.44%.

For the year ended 31 December 2022, the interest in finance leasing contributed approximately HK\$6.06 million profit for the period (31 December 2021: profit of approximately HK\$7.28 million).

Gain arising on change in fair value of financial assets at fair value through profit and loss and interest income

As the interest rate in mainland kept decreasing during the year and part of the financial asset loss arising on change in fair value through profit and loss, net loss arising on change in fair value of financial assets at fair value through profit and loss approximately HK\$1.57 million. Compared to a net gain arising on change in fair value of financial assets at fair value through profit and loss totaling of HK\$1.03 million for the year ended 31 December 2021.

Reduce in turnover and cost control

Due to weak market sentiment mentioned above, turnover of the group reduced to approximately HK\$18.90 million for the year ended 31 December 2022 as compared to HK\$23.40 million for the year ended 31 December 2021. After exercising more cost control which resulted in a decrease in staff cost from continuing operation approximately HK\$0.70 million for the year ended 31 December 2022.

Given our good balance sheet status and cash generation ability, our financial position continues to be strong. As at 31 December 2022, the gearing ratio (divided non-current liabilities by equity plus non-current liabilities multiple by 100 which results in percentage) of the Group was 0.29% (31 December 2021: 0.33%).

一間聯營公司不再被視為聯營公司

於二零二二年八月，本公司之聯營公司福建華閩租賃有限公司(「福建華閩租賃」)的註冊資本由270,000,000元人民幣增加至500,000,000元人民幣。增資完成後，本公司擁有福建華閩租賃的股權減少至18.44%。

截至二零二二年十二月三十一日止年度，融資租賃之權益貢獻約606萬港元盈利(二零二一年十二月三十一日：約728萬港元盈利)。

產生自金融資產之公允值改變之收益及銀行利息收入

因本年度內地利率持續下降及部份金融資產通過損益反映公允值的影響，截至二零二二年十二月三十一日止年度產生自金融資產之公允值改變約為157萬港元之虧損，相對比截至二零二一年十二月三十一日止年度產生自金融資產之公允值改變約為103萬港元之收益。

收益減少及成本控制

因市場氣氛疲軟，截至二零二二年十二月三十一日集團收益減少至約1,890萬港元，相對比截至二零二一年十二月三十一日止年度2,340萬港元。於實施更嚴格的成本控制措施後，導致持續經營業務中的員工成本減少約70萬港元。

基於本集團良好的資產負債狀況，現金增值能力及財務狀況持續穩健。截至二零二二年十二月三十一日止年度，本集團資本負債比率(非流動負債與股本權益總額加非流動負債之百分比)為0.29%(二零二一年十二月三十一日：0.33%)。

The Group has maintained a low debt-to-equity ratio and has sufficient liquid funds. Faced with a rapidly changing environment, the Group has implemented cost-saving measures, further strengthening cost control and minimizing cash expenditures. In the context of the ongoing pandemic, the Group prioritizes employee safety, strengthens internal training and development, and improves rules and regulations. The Group is actively seeking suitable primary reserve projects to prepare for its sustainable development in the next phase.

本集團一直保持低負債比率及擁有充裕的流動資金，面對多變的時代，集團推行各項節省成本的措施，進一步加強成本控制，儘量減低現金支出。集團在疫情持續的情況下，以保障員工安全為首要任務，加強內部培訓提升，健全完善規章制度，積極尋找合適主業儲備項目，為集團下一步可持續發展做準備。

OPERATIONAL REVIEW

營運回顧

A. Star-rated hotel operation

A. 星級酒店營運

Star-rated hotel operation is the main source of revenue for the Group. Based on the hotel location and its current facility structure, the hotel is positioned as a leisure and business hotel, expanding its sources of conference and training clients. It will also increase cultural cultivation such as the 'Comrade's Home', 'Chamber of Commerce Home', 'Calligrapher's Home' and 'Aid Friend's Home', and establish an 'Education and Training Base'.

星級酒店經營是本集團主要收入來源。根據酒店地段及自身設施結構現狀，酒店定位為休閒商務酒店，拓展會議、培訓客源，加大「戰友之家」、「商會之家」、「書法家之家」、「援友之家」等文化培育，建立「教育培訓基地」。

For the period under review, the average occupancy rate was approximately 25.61% (2021: 36.56%), representing a decrease of 29.95% over the corresponding period of last year. Average daily rate (ADR) was approximately RMB305 (2021: RMB319) representing a decrease of 4.39% over the corresponding period of last year.

於回顧期內，平均入住率約為25.61%（二零二一年：36.56%），較去年相應回顧期內下降約29.95%。平均每天房價則約為人民幣305元（二零二一年：人民幣319元），較去年相應回顧期內下降約4.39%。

Accommodation revenue

The accommodation revenue was mainly determined by the number of available rooms, occupancy rate and ADR of the Group's hotel. During the year under review, the accommodation revenue of star-rated hotel was approximately HK\$6.20 million, representing a decrease of approximately 39.12% over the corresponding period of 2021.

Affected by weak market sentiment of the domestic tourism industry, the operating income of the hotel industry has declined periodically and the rigid expenditure of operating costs cannot be reduced, which brings challenges to the industry. During the period under review, the source of customers accounted approximately 59% of the total source, 4 percentage points more than approximately 55% in the same period of last year. The Group will continue to increase its market expansion efforts and implement strict cost control measures, seeking to further improve operational efficiency to minimize adverse impacts.

Catering revenue

Since 2015, the hotel has vigorously developed its group catering business. During the review period, the group generated approximately HK\$6.24 million in revenue, accounting for approximately 43% of the hotel business turnover, a increase of 10 percentage points over 33% in the same period last year.

High-quality customer service, a rich cultural atmosphere, and a good geographical location are the core competitive advantages of the hotel. The hotel management is taking proactive measures to respond to the pandemic, improving its internal strength, expanding diversified operations, and launching food and beverage sales functions. It is consolidating its wedding banquet business and strengthening its online and offline business for events such as the Mid-Autumn Festival mooncake banquet, year-end party, and teacher appreciation banquet. It is also strengthening its online sales cooperation with banquet network platforms such as "Wedding100" and "Yangege" to achieve greater results in the expansion and extension of banquets and group meals.

客房銷售收入

房間出租收入主要取決於本集團酒店的可供出租客房、入住率及平均每天房價。於回顧期內，星級酒店營運房間出租收入為約620萬港元，較二零二一年同期下降約39.12%。

因境內旅遊氣氛疲軟影響，酒店業經營收入出現階段性下降，營運成本剛性支出無法減少，給行業帶來挑戰。回顧期內會議客源佔總客源約59%，比上年同期約55%增加4個百分點。本集團將繼續加大市場拓展實行嚴格成本控制措施，尋求進一步改善營運效率，務求儘量減低不利影響。

餐飲收入

自二零一五年，酒店大力發展其團膳業務。於回顧期內為本集團帶來約624萬港元的收入，佔酒店業務營業額約43%，比上年同期33%上升10個百分點。

優質的客戶服務、濃厚的文化氣息、良好的地理位置是酒店的核心競爭優勢。酒店管理層正採取積極措施應對疫情，練好內功，拓展多元化經營，啟動餐飲銷售功能。鞏固婚宴，中秋博餅宴、尾牙宴、謝師宴等宴會線上線下業務，加強與宴會網路平台「婚禮100」、「宴格格」開展線上銷售合作，爭取在宴會、團膳拓展延伸方面取得更大的成效。

Looking ahead, as the impact of the pandemic on the economy continues to diminish, the demand for leisure travel and business trips is gradually being released. Confidence in the domestic hotel market is gradually being restored, and hotel business is gradually returning to normal.

Rental revenue

In order to stabilise the income of the hotel operation, the hotel leased out the shopping centre in the Group's hotel. This contributed to approximately HK\$1.16 million in rental revenue during the year under review, representing approximately 8% of the hotel operation's turnover.

B. Hong Kong properties held by the Group

Due to uncertain economic factors, the market participation rate was lower in the leasing market this year. At the same time, the Hong Kong Grade A office market continued to be under pressure, with delays or suspensions in office lease decisions by tenants, resulting in a rental rate of only about 90% for the Group's invested property projects during the review period. After the full opening of Hong Kong in 2023, office leasing demand will gradually recover, but the increase in supply will lead to a continuous increase in overall vacancy rate, and demand is still weak. Therefore, it is expected that the rental market for commercial properties will still face pressure.

During the period under review, the rental income of the properties in Hong Kong was approximately HK\$4.51 million, compared to the corresponding period of last year representing a decrease of approximately 12%.

C. Piano Manufacturing

The Group diversified its business into piano manufacturing by acquiring a 25% equity interest in Fuzhou Harmony Piano Co. Ltd. ("Harmony Piano") in 2005. This business interest has brought a steady profit to the Group for the past few years. However, the Group recorded a share of loss from its interest in Harmony Piano approximately HK\$1.74 million for the period under review due to declining market sales and rising manufacturing costs. (2021: loss of approximately HK\$0.06 million).

展望未來，隨著疫情對經濟的影響進一步消減，休閒遊及商務差旅消費需求逐步釋放，境內酒店市場信心逐步恢復，酒店業務正在逐步回歸正軌。

出租收入

為保持穩定收入，酒店將本集團之酒店內商場出租。此舉為集團於回顧期內貢獻約116萬港元之出租收入，佔酒店業務營業額8%。

B. 香港物業

受到經濟存在不明朗因素影響，企業因而抱持觀望態度，年內租賃市場利淡，導致市場參與率較低。與此同時，香港甲級寫字樓市場持續受壓，寫字樓租戶拖延或擱置寫字樓租約決定，集團投資物業項目於回顧期內的出租率只有約九成。香港於2023年全面開關後，寫字樓租賃需求將會逐步恢復，但由於供應增加將導致整體空置率持續上升，預期商用物業市場租金仍面臨壓力。

於本回顧期內，香港物業租金收入約為451萬港元，較去年同期下降約12%。

C. 鋼琴製造

本集團於二零零五年透過完成收購福州和聲鋼琴股份有限公司(「和聲鋼琴」) 25%股權而擴展業務至鋼琴製造業。過去多年來此業務為本集團帶來穩定之盈利。受市場下降及製造成本上升雙重影響，回顧期內，應佔和聲鋼琴之權益錄得約174萬港元虧損(二零二一年：約6萬港元虧損)。

D. Finance Leasing

According to the business development needs of Fujian Huamin Financing Leasing Co., Ltd. (“Fujian Huamin Leasing”), the registered capital of the joint venture company of our company, Fujian Huamin Leasing, has increased from RMB270,000,000 to RMB500,000,000. After the capital increase is completed, our company’s equity in Fujian Huamin Leasing will be reduced to 18.44%; Fujian Huamin Industrial Group Company Limited (“FHIG”) holds 74.24% of the equity of Fujian Huamin Leasing, and Fujian Mingang Enterprises Co., Ltd (“FMEC”) holds 7.32% of the equity of Fujian Huamin Leasing. In addition, the total share premium generated from this capital increase settlement is approximately RMB680,000, which will be included in its capital reserve during the period in which it is generated.

For the year ended 31 December 2022, the interest in finance leasing contributed approximately HK\$6.06 million profit for the period (31 December 2021: profit of approximately HK\$7.41 million).

FUTURE DEVELOPMENT

Improving operational efficiency and driving revenue growth remain the group’s top priorities in 2023. The Group will continue to use investment and operation management as the core driver of enterprise value growth: continuously search assets with healthy profitability and excellent growth potential as long-term investment through our concept of investment management. On the other hand, Our Group will optimize its internal process and improve management efficiency so as to enhance the potential and intrinsic value of enterprise resources.

As at 31 December 2022, the total share capital of the Company was HK\$898,839,029 divided into 1,145,546,000 ordinary shares.

D. 融資租賃

根據福建華閩融資租賃有限公司(「福建華閩租賃」)業務發展需要，本公司之聯營公司福建華閩租賃的註冊資本由270,000,000元人民幣增加至500,000,000元人民幣。增資完成後，本公司擁有福建華閩租賃的股權將減少至18.44%；福建華閩實業(集團)有限公司(「華閩實業」)持有福建華閩租賃74.24%的股權及福建閩港實業有限公司(「福建閩港」)持有福建華閩租賃7.32%的股權。另外，是次增資結算產生的股權溢價合共約68萬元人民幣，將計入其產生期間的資本公積。

截至二零二二年十二月三十一日止年度，融資租賃之權益貢獻約606萬港元盈利(二零二一年十二月三十一日：約741萬港元盈利)。

未來發展

提高營運效率及推動收益增長乃是本集團二零二三年的首要任務。本集團將繼續以投資管理及營運管理作為推動企業價值持續增長的核心：一方面通過投資管理持續尋找具備健康盈利能力及優秀增長潛力的資產作為長期投資；另一方面通過在集團層面建立多維度的營運支援體系，優化內部流程及提升管理效率，以創新的思維規範及規劃企業未來的發展戰略，全面激發並提升企業資源的潛能和內在價值。

Liquidity and Financial Resources

As at 31 December 2022, the Group had a net cash balance of approximately HK\$39.73 million (2021: HK\$49.52 million). The Group's net asset value (assets less liabilities) was approximately HK\$402.54 million (2021: HK\$429.66 million), with a liquidity ratio (ratio of current assets to current liabilities) of 3.82 (2021: 4.83). During the year under review, there was no material change in the Group's funding and treasury policies. The Directors do not expect the Company to experience any problem with liquidity and financial resources in the foreseeable future.

Charge on Assets

As at 31 December 2022, the Group had not charged any of its assets (2021: Nil).

Funding and Treasury Policies

The funding and treasury policies of existing subsidiaries of the Group are centrally managed and controlled by the Group's senior management in Hong Kong.

Treasury Management and Cash Funding

The Group's funding and treasury policies are designed to maintain a diversified and balanced debt profile and financing structure. The Group continues to monitor its cash flow position and debt profile, and to enhance the cost-efficiency of funding initiatives by its centralised treasury function. In order to maintain financial flexibility and adequate liquidity for the Group's operations, potential investments and growth, the Group has built a strong base of funding resources and will keep exploring cost-efficient ways of financing.

Bank Loans and Other Borrowings

There was no outstanding bank loan and other borrowing by the Company and the Group as at 31 December 2022 (2021: Nil).

Capitalised Borrowing Costs

No borrowing cost was being capitalised during the year ended 31 December 2022 (2021: Nil).

Exposure to Fluctuation in Exchange Rate and Related Hedges

There has been no significant change in the Group's policy in terms of exchange rate exposure. The Group operates mainly in Hong Kong and Mainland China. Most of the transactions and cash and cash equivalents are denominated in Hong Kong dollars ("HK\$") and in Renminbi ("RMB"). The Group is exposed to foreign currency risk due to the exchange rate fluctuation of RMB against HK\$. Moderate fluctuation of RMB against HK\$ was expected. The Group considered the foreign currency risk exposure is acceptable. However, management of the Group will monitor foreign exposure closely and consider the use of hedging instruments when necessary.

As most of the Company's business operations are located in Hong Kong and Mainland China, the Company faces foreign currency risks due to exchange gain/loss from exchange rate fluctuations as well as currency conversion risk due to converted net asset value fluctuations of investment projects in Mainland China. To effectively manage foreign currency risk, the Company closely monitors foreign exchange markets, and utilises multiple strategic approaches, such as optimising cash management strategy and project finance instruments, to manage foreign exchange risk.

The funding and treasury policies of existing subsidiaries of the Group are centrally managed and controlled by the Group's senior management in Hong Kong.

Material Acquisitions and Disposals

During the year under review, there were no material acquisition or disposal of any subsidiary, associate or joint venture of the Group.

Capital Expenditure and Commitment

During the year under review, the Group's capital expenditure was HK\$0.62 million (2021: HK\$1.17 million). There was no outstanding capital commitments as at 31 December 2022 and 2021.

CORPORATE GOVERNANCE PRACTICES

To create a long term value for the interests of the Shareholders is the Board's main objective. As such, the Board is highly committed to achieving a high standard of corporate governance and striving to maintain the management practices in a transparent and responsible way. The Board reviews and improves the Group's corporate governance practices and business ethics on an ongoing basis.

For the year ended 31 December 2022 and up to the date of this annual report, the Company complied with all the code provisions, where applicable, as set out in the Corporate Governance Code (the "CG Code") and Corporate Governance Report in Appendix 14 to the Rules Governing the Listing of Securities (the "Listing Rules") on The Stock Exchange of Hong Kong Limited (the "Stock Exchange").

Directors' Securities Transactions

The Company has adopted the Model Code for Securities Transactions by Directors of Listed Issuers (the "Model Code") as set out in Appendix 10 to the Listing Rules as its own code of conduct for dealing in securities of the Company by the Directors. All the Directors have confirmed, following specific enquiry by the Company, their compliance with the required standard set out in the Model Code throughout the year ended 31 December 2022.

THE BOARD

Responsibilities

The Board is responsible for the Group's corporate policy formulation, business strategic planning, business development, risk management, material acquisitions and disposals and capital transactions, and other significant operational and financial matters. Major corporate matters that are specifically delegated by the Board to the management, such as the preparation of annual and interim accounts for the Board's final approval before its publication, execution of business strategies and initiatives adopted by the Board, implementation of adequate systems of internal controls and risk management procedures, and compliance with relevant statutory requirements and rules and regulations. The Board has also delegated to the relevant senior management the authority and responsibility for the day-to-day management and operation of the Group.

職責

董事會負責本集團的企業政策制訂、業務策略規劃、業務發展、風險管理、重大收購及出售及資本交易；以及其他重大營運及財務事宜。董事會特別指派管理層負責公司的主要事宜，如編製年度及中期賬目以於公佈前供董事會作最終審批、執行董事會採納的業務策略及措施、推行適當內部監控機制及風險管理程序以及遵守相關法定要求、規則及規例。董事會亦已將本集團之日常管理及營運的權力及責任轉授予相關高級管理層。

The Board has also established the Board Committees (as defined below) and has delegated to these Board committees various responsibilities as set out in their respective terms of reference.

The Board is also responsible for performing corporate governance duties of the Group and will assign relevant functions to other board committees, namely the remuneration committee (the “**Remuneration Committee**”), the nomination committee (the “**Nomination Committee**”) and the audit committee (the “**Audit Committee**”) collectively, the “**Board Committees**”) as and when appropriate.

Every Director is entitled to have access to Board papers and related materials, and the advice and services provided by the company secretary (the “**Company Secretary**”) of the Company, and has the liberty to seek independent professional advice at the Company’s expense if so reasonably required. The Directors will be continuously provided by the updates on the major development of the Listing Rules and other applicable regulatory requirements to ensure compliance and upkeep of good corporate governance practices.

The Company has arranged for appropriate insurance cover for Directors’ and officers’ liabilities in respect of legal actions against its Directors and senior management arising out of corporate activities.

BOARD COMPOSITION AND BOARD PRACTICES

The Board is primarily responsible for formulating the business strategy, reviewing and monitoring the business performance of the Group, approving the financial statements and annual budgets as well as directing and supervising the management of the Company. Execution of operational matters and the powers thereof are delegated to the management by the Board with clear directions.

As at the date of this report, the Board comprises a total of nine Directors, three of whom are Executive Directors, three Non-executive Directors and three Independent Non-executive Directors. One of the Independent Non-executive Directors has appropriate professional qualifications, or accounting or related financial management expertise.

Board composition review will be made regularly to ensure that it has a balance of expertise, skills and expertise appropriate for the requirements of the business of the Group. In accordance with article 101 of the Company's Articles of Association, one-third of the Directors for the time being, or, if their number is not three or a multiple of three, then the number nearest to one-third shall retire at the forthcoming annual general meeting and shall be eligible for re-election.

EMOLUMENT POLICY

All existing Executive Directors are entitled to a fixed salary per annum respectively. The remuneration of each Executive Director is subject to review of the Board with reference to his/her contribution in terms of time, effort and his/her expertise. The emolument policy for Non-executive Directors is to ensure that the Non-executive Directors are adequately compensated for their efforts and the time dedicated to the Company's affairs, including their participation in the Board Committees. Individual directors and senior management are not involved in the determination of their own remuneration.

Details of remuneration paid to each of the Directors and senior management during the year are disclosed in note 13 and note 14 to the financial statements.

All Executive Directors are entitled to be reimbursed for reasonable expenses incurred during the performance of their duties to the Company.

CHAIRMAN AND CHIEF EXECUTIVE OFFICER

The roles and duties of the Chairman and the Chief Executive Officer of the Company are carried out by different individuals. The Chairman of the Board is responsible for the overall strategic formulation, management and planning of our Group. During the year under review starting from 23 June 2022, Ms. LIN Nuchao was the Chairman. The Chief Executive Officer is Mr. YANG Liyu, who is responsible for business development and day-to-day management and operations of the Group.

CHAIRMAN'S ROLE AND RESPONSIBILITY

The Chairman of the Board ("Chairman") and the Chief Executive Officer are separate individuals, to maintain segregation of duties between the management of the Board and the day-to-day management of the Group's business. One important role of the Chairman is to provide leadership for the Board. The Chairman has to ensure that the Board works effectively, discharges responsibilities, and that all key and appropriate issues are discussed by the Board in a timely manner. All Directors are consulted about matters proposed for inclusion in the agenda. The Chairman has delegated to the Company Secretary the responsibility for drawing up the agenda for each Board meeting.

The Group supports the establishment of good corporate governance practices and procedures. The Group's Chief Executive Officer has been delegated such authority. The Board always acts in the best interests of the Group, and all Directors have made full and active contribution to the affairs of the Board. Meeting between the Chairman and Non-executive Directors (including Independent Non-executive Directors) without the presence of managing Directors has been scheduled as at least once a year.

Composition

As at the date of this report, the board of Directors comprises three Executive Directors namely Ms. LIN Nuchao, Mr. YANG Liyu and Mr. ZHANG Jianmin, three Non-executive Directors, namely Mr. WANG Ruilian, Ms. WENG Weijian and Ms. CHEN Danyun, and three Independent Non-executive Directors, namely Mr. LAM Kwong Siu, Mr. NG Man Kung and Ms. LIU Mei Ling Rhoda. Details of the Chairman and the other Directors of the Company are set out in the section "Directors' Biography" of this report.

With the various experience of both the Executive Directors and the Non-executive Directors and the nature of the Group's business, the board considered that the Directors have a balance of skills and experience for the business of the Group.

BOARD DIVERSITY POLICY

The Group adopted a board diversity policy (the "Board Diversity Policy"). A summary of this policy, together with the measurable objectives set for implementing this policy and the progress made towards achieving those objectives are disclosed as below.

有鑑於各執行董事及非執行董事擁有不同經驗及本集團之業務性質，董事會認為各董事於本集團之經營技巧及經驗方面取得適當平衡。

The ultimate decision will be based on merit and contribution that the selected candidates will bring to the board.

As at the date of this report, the Board's composition under diversified perspectives was summarised as follows:

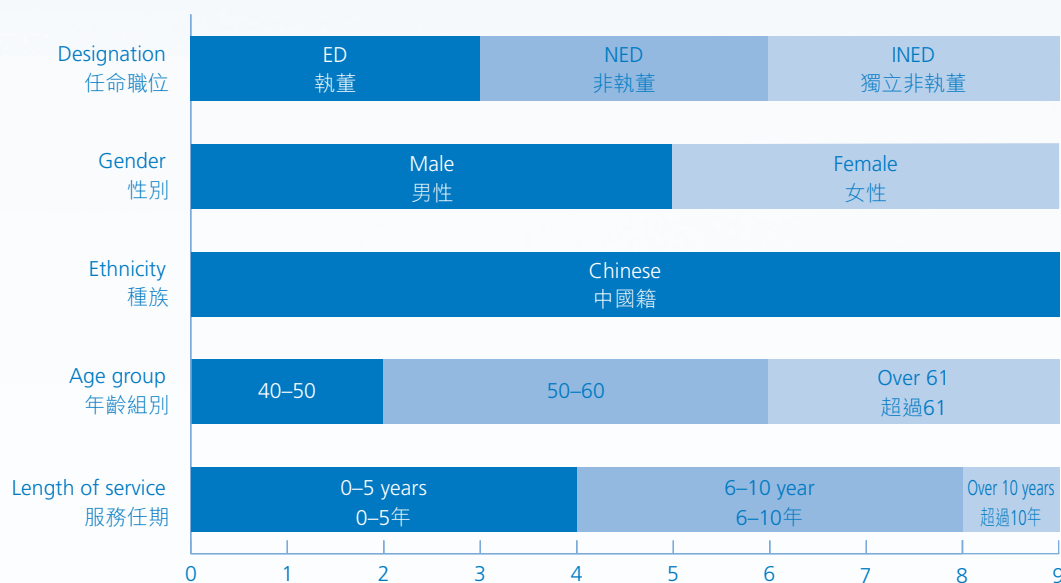

BOARD OF DIRECTORS

The Board meets regularly. For the year ended 31 December 2022, it held nine meetings. Regular Board meetings of the year are scheduled in advance. All notices of the meeting of the Board will be made to various directors at least 14 days prior to the meeting. The company secretary assists the Chairman in preparing the memorandum of the meeting as to give all Directors an opportunity to attend. Board papers are circulated not less than three days before the Board meetings, to enable the Directors to make informed decisions on matters to be raised at the Board meetings and to offer them sufficient time to review the documents. The company secretary normally attends all regular Board meetings to advise on corporate governance, statutory compliance, accounting and financial matters when necessary, as to ensure the compliance and maintenance of sound corporate governance practice. The company secretary shall prepare minutes and keep record of matters discussed and decisions resolved at all Board meetings.

There is no relationship (including financial, business, family or other material/relevant relationships) among members of the Board. All of them are free to exercise their independent judgment. The Company has received annual written confirmations from all Independent Non-executive Directors in respect of their independence during the year under review pursuant to the Listing Rules. The Company considers all Independent Non-executive Directors to be independent in accordance with the independence guidelines set out in the Listing Rules.

Draft and final versions of the minutes are sent to all Directors for their comment and records respectively. Minutes of Board meetings are kept by the Company Secretary and such minutes are open for inspection at any reasonable time on reasonable prior notice by any Director.

Insurance policy has been arranged to safeguard the interests of the Directors in case of legal proceedings.

Independent Non-executive Directors and Non-executive Directors

Mr. Lam Kwong Siu was appointed as an Independent Non-executive Director of the Company on 11 December 2003 and reappointed nine times with tenure of two years and expiring on 10 December 2023.

Mr. Ng Man Kung was appointed as an Independent Non-executive Director of the Company on 30 June 2014 and was reappointed four times with tenure expiring on 29 June 2024.

Ms. Liu Mei Ling Rhoda has appointed as an Independent Non-executive Director of the Company on 1 January 2019 and was reappointed two times with tenure expiring on 31 December 2024.

However, their tenure is subject to retirement by rotation at the Annual General Meeting in compliance with the amended and restated Articles of Association of the Company and the Code on Corporate Governance, under which they have to retire by rotation and make themselves eligible for re-election.

Mr. Wang Ruilian, Ms. Weng Weijian and Ms. Chen Danyun were appointed as Non-executive Directors on 19 October 2015, 11 September 2018 and 23 June 2022 respectively. All are subject to retirement by rotation at the Annual General Meeting in compliance with the amended and restated Articles of Association of the Company.

廖美玲女士於二零一九年一月一日獲委任為本公司獨立非執行董事，並獲重新委任兩次，其任期至二零二四年十二月三十一日。

然而，其任期須受本公司經修訂及重列的章程及企業管治常規守則之規定，在股東週年大會上董事須輪值告退及重選再任。

王瑞煉先生、翁衛建女士及陳丹雲女士分別於二零一五年十月十九日、二零一八年九月十一日及二零二二年六月二十三日獲委任為非執行董事，惟須按照本集團之經修訂及重列的公司組織章程細則之規定，於股東週年大會屆滿輪值告退並膺選連任。

CONFIRMATION OF INDEPENDENCE OF INDEPENDENT NON-EXECUTIVE DIRECTORS

Independence of Independent Non-Executive Directors

The Company has complied with the requirements under Rules 3.10(1), 3.10(2) and 3.10A of the Listing Rules. The Company has received confirmation of independence from the three Independent Non- Executive Directors, namely Mr. Lam Kwong Siu, Mr. Ng Man Kung and Ms. Liu Mei Ling Rhoda in accordance with Rule 3.13 of the Listing Rules.

Mr. Lam Kwong Siu have served the Board of the Company for more than 19 years. He has clearly demonstrated his willingness to exercise independent judgement and to provide objective challenges to the management. There is no evidence that length of tenure is having an adverse impact on his independence. The Board therefore considers that Mr. Lam remain independent, notwithstanding the length of his tenure.

The Board as well as the Nomination Committee have reviewed the independence of all Independent Non-executive Directors and have concluded that all of them are independent within the definition of the Listing Rules. Further, up to the date of this report, the Board is not aware of the occurrence of any events, which would cause it to believe that the independence of any of the Independent Non-executive Directors has been impaired.

Relationship

None of the members of the Board has any relationship (including financial, business, family or other material/ relevant relationships) between each other.

FINANCIAL REPORTING

The Board recognises the importance of integrity of financial information and acknowledges its responsibility for preparing interim and annual financial statements that give a true and fair view of the Group's affairs and its results and cash flows in accordance with Hong Kong Financial Reporting Standards and the Companies Ordinance. In presenting the financial information, as well as price-sensitive announcements and other financial disclosures as required by regulations, the Board endeavors to present in a timely manner to shareholders and other stakeholders a balanced and understandable assessment of the Company's performance, position and prospects. Accordingly, appropriate accounting policies are selected and applied consistently, and judgements and estimates made by the management for financial reporting purpose are prudent and reasonable. The Directors are also responsible for ensuring that the Group keeps accounting records which disclose with reasonable accuracy at any time the financial position of the Group and which enable the preparation of financial statements in accordance with the Companies Ordinance and the applicable accounting standards. Prior to the adoption of the financial statements and the related accounting policies, the relevant financial information is discussed between the external auditors and the management, and then submitted to the Audit Committee for review.

INTERNAL CONTROLS

Risk Management and Internal Control

The Board acknowledges its responsibility for maintaining proper and effective risk management and internal control systems and reviewing their effectiveness. Such systems are designed to identify, evaluate and manage risk exposures that may impact the efficiency and effectiveness of the Group's operations and provide reasonable assurance but not a guarantee about whether they are free from material misstatement, rather than to eliminate the risk of failure to achieve business objectives.

財務匯報

董事會確知財務資料完整的重要性，並須負責根據《香港財務報告準則》及《公司條例》編製半年及年度財務報表，藉以真實及公平地反映集團的財務狀況、業績及現金流。在提呈財務資料、股價敏感公告及規例規定的其他財務披露時，董事會致力向股東及其他持份者適時地對本公司的業績、現況及前景作出平衡及容易理解的評核。因此，適當的會計政策已被選用及貫徹地應用，而管理人員所作出關於財務匯報的判斷及估算均屬審慎及合理。董事亦須負責確保本集團保存會計記錄，該等記錄須於任何時間合理準確地披露本集團之財務狀況，並可據此按香港公司條例及適用之會計準則編製財務報表。在採納財務報表及相關會計政策前，相關財務資料均經外聘核數師及管理層討論，然後提交審核委員會審閱。

內部監控

風險管理及內部監控

董事會承擔的責任包括維持合適及有效的風險管理及內部監控系統，並檢討其有效性。有關系統旨在識別、評估及管理可能影響本集團營運效率及效益的風險，並提供合理保證（惟並不擔保）相關風險不會出現重大錯誤陳述，而非消除未能達成業務目標的風險。

The management is primarily in charge of designing, implementing and monitoring the risk management and internal control systems. The Board has the overall responsibilities for evaluating and determining the nature and extent of the risks it is willing to take in achieving the Company's strategic objectives, and overseeing the management in the design, implementation and monitoring of the risk management and internal control systems. Such duties have been carried out and performed with the assistance of the management and the Audit Committee.

The Company has engaged an internal control advisor for providing the internal audit function and performing independent review of the adequacy and effectiveness of the internal control systems annually, including reviewing guidelines and policies which are implemented throughout our operation, and risk management practices with an aim to, among other matters, improve our Group's corporate governance. The independent internal control advisor is also responsible for providing its findings and any recommendations, in respect of enhancing the Group's systems as appropriate, to the Audit Committee. Based on the findings and comments by the independent internal control advisor and the Audit Committee, the Board considered the internal control and risk management systems effective and adequate and was of the opinion that there were no significant areas of concern that might affect the Company's shareholders for the year ended 31 December 2022. The Company will continue to engage external independent professionals to review the Group's systems of internal control and risk management annually and further enhance the Group's system as appropriate.

In terms of management of liquidity risk, the Board monitors and maintains levels of cash and cash equivalents deemed adequate to finance the Group's operations with the assistance of the Group's management. In order to minimise the credit risk on receivables, the Board has adopted credit risk management policies and procedures by making periodic collective as well as individual assessments on the recoverability of receivables based on historical settlement records and past experience. Besides, the Board manages to formulate conservative strategies for mitigating other financial risks of the Group, which include overseeing the interest rate risk and currency risk.

管理層主要負責設計、執行及監控風險管理及內部監控系統。董事會全面負責評估及釐定本公司為達成策略目標所能承擔之風險性質及程度，並監督管理層設計、實施及監察風險管理及內部監控系統。有關職責已在管理層及審核委員會的協助下實行及履行。

本公司已委聘內部控制顧問以提供內部審核職能，以及每年就內部控制系統是否充分及有效進行獨立檢討，包括檢討在整個運營過程中實施的指引及政策，並檢討風險管理慣例，旨在(其中包括)改善本集團的企業管治水平。獨立內部控制顧問亦負責向審核委員會提供有關完善本集團系統的調查結果及任何建議。截至二零二二年十二月三十一日止年度，基於獨立內部控制顧問及審核委員會的調查結果及意見，董事會認為內部控制及風險管理系統有效及充分，且並無可能影響本公司股東的任何重大問題。

在管理流動資金風險方面，董事會在本集團管理層協助下，監控及維持管理層認為足以為本集團的經營提供資金的現金及現金等價物水平。為將應收款項的信貸風險降至最低，董事會採納信貸風險管理政策及程序，根據歷史結算紀錄及過往經驗定期按組合及個別方式對應收款項的可收回性作出評估。另外，董事會制定了減緩本集團其他金融風險的保守策略，包括監察利率風險及貨幣風險。

The Group has established internal control procedures which provide the Board and employees with guidelines on assessing, reporting and disseminating inside information. In addition, inside information is disseminated to relevant personnel on a need-to-know basis, and the Group will review the existing policy and practice from time to time to ensure full compliance with the regulatory requirements.

During its annual review, the Audit Committee also ensure the adequacy of resources, qualifications and experience of staff of the Group's accounting, financial reporting and internal audit functions, and their training programmes and budgets.

The scope of the internal control review carried out during the year including but not limited to:

- the nature and extent of significant risks (including ESG risks), and the issuer's ability to respond to changes in its business and the external environment;
- the scope and quality of management's ongoing monitoring of risks (including ESG risks) and of the internal control systems, and where applicable, the work of its internal audit function and other assurance providers;
- the extent and frequency of communication of monitoring results to the board (or board committee(s)) which enables it to assess control of the issuer and the effectiveness of risk management;
- significant control failings or weaknesses that have been identified during the year. Also, the extent to which they have resulted in unforeseen outcomes or contingencies that have had, could have had, or may in the future have, a material impact on financial performance or condition; and
- the effectiveness of processes for financial reporting and Exchange Listing Rule compliance.

The board's confirmation on risk management

Based on the risk management mechanism and internal audit review activities mentioned in the aforesaid paragraphs, the board was of the opinion that the Company had maintained an effective risk management mechanism and internal control system during the financial year ended 31 December 2022.

Convening of extraordinary general meeting on requisition by Shareholders

In accordance with section 566 of the Companies Ordinance (Chapter 622 of the Laws of Hong Kong) (the "Companies Ordinance"), Shareholder(s) representing at least 5% of the total voting rights of all Shareholders having a right to vote at general meetings may request the Directors to convene an extraordinary general meeting ("EGM"). The request(s) must state the general nature of the business to be dealt at the meeting and may include the text of a resolution that may properly be moved and is intended to be moved at the meeting. The request(s) may consist of several documents in like form and may be sent to the Company in hard copy form or in electronic form which must be authenticated by the person or persons making it.

In accordance with sections 567 and 568 of the Companies Ordinance, if the Directors do not within 21 days after the date on which they are subject to the requirement under section 566 of the Companies Ordinance to convene an EGM for a day not more than 28 days after the date on which the notice convening the EGM is given, the Shareholder(s) concerned, or any of them representing more than one-half of the total voting rights of all of them, may themselves convene an EGM, provided that the EGM so convened shall not be held after the expiration of 3 months from the said date.

The EGM convened by shareholders shall be convened in the same manner, as nearly as possible, as that in which general meetings are to be convened by the Directors.

The management considers that the investment risk management measures provide guarantee to the Group through its way of seeking new development opportunities, as to secure reasonable return in every investment, to reduce investment risks and to avoid possible loss attributable to investments.

The Group's risk management towards liquidity aims to ensure that under all circumstances there exists sufficient capital to fulfill repayment obligations of all debts due, to maintain good creditworthiness, to finance reasonable investment opportunities and to fuel business development. The Group's accounting department is responsible for daily financial activities and monitoring liquidity position from time to time to cope with business operation of the Company.

The Board had conducted a review on the effectiveness of the Group's internal control and risk management systems once during the year ended 31 December 2022 which covered financial, operational, compliance procedural and risk management functions and had considered the adequacy of resources, staff qualifications and experience, training programmes and budget of the Company's accounting and financial reporting function. In light of the size and scale of the Group's businesses, the Board is also delegated with the responsibilities for the internal control of the Group and for reviewing its effectiveness.

The Group believes that good corporate governance practices are very important for maintaining and promoting investor confidence and for the sustainable growth of the Group. The Group has therefore made continued efforts to uplift its quality of corporate governance. It has established a highly effective system of internal controls and adopted a series of measures to ensure its safety and effectiveness. As a result, the Group is able to safeguard its assets and protect the interests of its shareholders.

The Board is of the view that the systems of internal control and risk management are effective and there are no irregularities, improprieties, frauds or other deficiencies that suggest material deficiency in the effectiveness of the Group's internal control system.

1. GENERAL

Fujian Holdings Limited (the “Company”) is incorporated in Hong Kong as a public limited company and its shares are listed on The Stock Exchange of Hong Kong Limited (the “Stock Exchange”). Its immediate holding company is HC Technology Capital Company Limited, a company incorporated in the British Virgin Islands and its ultimate holding company is Fujian Tourism Development Group Company Limited (“FTDC”), a state-owned corporation in the People’s Republic of China (the “PRC”). The addresses of the registered office and principal place of business of the Company is Room 3306–08, 33/F, West Tower, Shun Tak Centre, 200 Connaught Road Central, Hong Kong.

The principal activities of the Company and its subsidiaries (collectively referred to as the “Group”) are investment holding, property investment in Hong Kong and hotel operations in the PRC.

The consolidated financial statements are presented in Hong Kong dollars, which is also the functional currency of the Company.

3.1 Basis of preparation of consolidated financial statements

The consolidated financial statements have been prepared in accordance with HKFRSs issued by the HKICPA. In addition, the consolidated financial statements include applicable disclosures required by the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (“Listing Rules”) and by the Hong Kong Companies Ordinance (“CO”).

The consolidated financial statements have been prepared on the historical cost basis except for certain investment properties and financial instruments that are measured at fair values at the end of each reporting period, as explained in the accounting policies set out below.

Historical cost is generally based on the fair value of the consideration given in exchange for goods and services.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date, regardless of whether that price is directly observable or estimated using another valuation technique. In estimating the fair value of an asset or a liability, the Group takes into account the characteristics of the asset or liability if market participants would take those characteristics into account when pricing the asset or liability at the measurement date. Fair value for measurement and/or disclosure purposes in these consolidated financial statements is determined on such a basis, except for share-based payment transactions that are within the scope of HKFRS 2 *Share-based Payment*, leasing transactions that are accounted for in accordance with HKFRS 16 *Leases* (“HKFRS 16”), and measurements that have some similarities to fair value but are not fair value, such as net realisable value in HKAS 2 *Inventories* or value in use in HKAS 36 *Impairment of Assets* (“HKAS 36”).

本綜合財務報表乃根據所有由香港會計師公會頒佈適用香港財務報告準則編製。此外，綜合財務報表乃根據包括香港聯合交易所有限公司證券上市規則(「上市規則」)及香港公司條例(「公司條例」)之披露要求編製。

A fair value measurement of a non-financial asset takes into account a market participant's ability to generate economic benefits by using the asset in its highest and best use or by selling it to another market participant that would use the asset in its highest and best use.

For financial instruments and investment properties which are transacted at fair value and a valuation technique that unobservable inputs is to be used to measure fair value in subsequent periods, the valuation technique is calibrated so that the results of the valuation technique equals the transaction price.

In addition, for financial reporting purposes, fair value measurements are categorised into Level 1, 2 or 3 based on the degree to which the inputs to the fair value measurements are observable and the significance of the inputs to the fair value measurement in its entirety, which are described as follows:

- Level 1 inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the entity can access at the measurement date;
- Level 2 inputs are inputs, other than quoted prices included within Level 1, that are observable for the asset or liability, either directly or indirectly; and
- Level 3 inputs are unobservable inputs for the asset or liability.

Basis of consolidation

The consolidated financial statements incorporate the financial statements of the Company and entities controlled by the Company and its subsidiaries. Control is achieved when the Company:

- has power over the investee;
- is exposed, or has rights, to variable returns from its involvement with the investee; and
- has the ability to use its power to affect its returns.

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control listed above.

Consolidation of a subsidiary begins when the Group obtains control over the subsidiary and ceases when the Group loses control of the subsidiary. Specifically, income and expenses of a subsidiary acquired or disposed of during the year are included in the consolidated statement of profit or loss and other comprehensive income from the date the Group gains control until the date when the Group ceases to control the subsidiary.

Profit or loss and each item of other comprehensive income are attributed to the owners of the Company and to the non-controlling interests. Total comprehensive income of subsidiaries is attributed to the owners of the Company and to the non-controlling interests even if this results in the non-controlling interests having a deficit balance.

When necessary, adjustments are made to the financial statements of subsidiaries to bring their accounting policies into line with the Group's accounting policies.

All intragroup assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

Non-controlling interests in subsidiaries are presented separately from the Group's equity therein, which represent present ownership interests entitling their holders to a proportionate share of net assets of the relevant subsidiaries upon liquidation.

Changes in the Group's interests in existing subsidiaries

Changes in the Group's interests in subsidiaries that do not result in the Group losing control over the subsidiaries are accounted for as equity transactions. The carrying amounts of the Group's relevant components of equity and the non-controlling interests are adjusted to reflect the changes in their relative interests in the subsidiaries, including re-attribution of relevant reserves between the Group and the non-controlling interests according to the Group's and the non-controlling interests' proportionate interests.

Any difference between the amount by which the non-controlling interests are adjusted, and the fair value of the consideration paid or received is recognised directly in equity and attributed to owners of the Company.

A subsidiary is an entity (including a structured entity), directly or indirectly, controlled by the Company. Control is achieved when the Group is exposed, or has rights, to variable returns from its involvement with the investee and has the ability to affect those returns through its power over the investee (i.e. existing rights that give the Group the current ability to direct the relevant activities of the investee).

When the Company has, directly or indirectly, less than a majority of the voting or similar rights of an investee, the Group considers all relevant facts and circumstances in assessing whether it has power over an investee, including:

- (a) the contractual arrangement with the other vote holders of the investee;
- (b) rights arising from other contractual arrangements; and
- (c) the Group's voting rights and potential voting rights.

The results of subsidiaries are included in the Company's statement of profit or loss to the extent of dividends received and receivable. The Company's investments in subsidiaries that are not classified as held for sale in accordance with HKFRS 5 *Non-current Assets Held for Sale and Discontinued Operations* are stated at cost less any impairment losses.

Interest in associates

An associate is an entity over which the Group has significant influence. Significant influence is the power to participate in the financial and operating policy decisions of the investee but is not control over those policies.

The results and assets and liabilities of associates are incorporated in these consolidated financial statements using the equity method of accounting. The financial statements of associates used for equity accounting purposes are prepared using uniform accounting policies as those of the Group for like transactions and events in similar circumstances. Under the equity method, an investment in associates is initially recognised in the consolidated statement of financial position at cost and adjusted thereafter to recognise the Group's share of the profit or loss and other comprehensive income of the associates. Changes in net assets of the associates other than profit or loss and other comprehensive income are not accounted for unless such changes resulted in changes in ownership interest held by the Group. When the Group's share of losses of associates exceeds the Group's interest in associates (which includes any long-term interests that, in substance, form part of the Group's net investment in the associates), the Group discontinues recognising its share of further losses. Additional losses are recognised only to the extent that the Group has incurred legal or constructive obligations or made payments on behalf of the associates.

An investment in associates is accounted for using the equity method from the date on which the investee becomes an associate. On acquisition of the investment in associates, any excess of the cost of the investment over the Group's share of the net fair value of the identifiable assets and liabilities of the investee is recognised as goodwill, which is included within the carrying amount of the investment. Any excess of the Group's share of the net fair value of the identifiable assets and liabilities over the cost of the investment, after reassessment, is recognised immediately in profit or loss in the period in which the investment is acquired.

Taxation

Income tax expense represents the sum of the tax currently payable and deferred tax.

The tax currently payable is based on taxable profit for the year. Taxable profit differs from profit/loss before tax because of income or expense that are taxable or deductible in other years and items that are never taxable or deductible. The Group's liability for current tax is calculated using tax rates that have been enacted or substantively enacted by the end of the reporting period.

Deferred tax is recognised on temporary differences between the carrying amounts of assets and liabilities in the consolidated financial statements and the corresponding tax bases used in the computation of taxable profit. Deferred tax liabilities are generally recognised for all taxable temporary differences. Deferred tax assets are generally recognised for all deductible temporary differences to the extent that it is probable that taxable profits will be available against which those deductible temporary differences can be utilised. Such deferred tax assets and liabilities are not recognised if the temporary difference arises from the initial recognition (other than in a business combination) of assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit. In addition, deferred tax liabilities are not recognised if the temporary difference arises from the initial recognition of goodwill.

Deferred tax liabilities are recognised for taxable temporary differences associated with investments in subsidiaries and associates, except where the Group is able to control the reversal of the temporary difference and it is probable that the temporary difference will not reverse in the foreseeable future. For the purposes of measuring deferred tax liabilities or deferred tax assets for investment properties that are measured using the fair value model, the carrying amounts of such properties are presumed to be recovered entirely through sale, unless the presumption is rebutted. The presumption is rebutted when the investment property is depreciable and is held within a business model whose objective is to consume substantially all of the economic benefits embodied in the investment property over time, rather than through sale.

Deferred tax assets and liabilities are offset when there is a legally enforceable right to set off current tax assets against current tax liabilities and when they relate to income taxes levied by the same taxable entity by the same taxation authority.

Current and deferred tax are recognised in profit or loss, except when they relate to items that are recognised in other comprehensive income or directly in equity, in which case, the current and deferred tax are also recognised in other comprehensive income or directly in equity respectively.

In assessing any uncertainty over income tax treatments, the Group considers whether it is probable that the relevant tax authority will accept the uncertain tax treatment used, or proposed to be used by individual group entities in their income tax filings. If it is probable, the current and deferred taxes are determined consistently with the tax treatment in the income tax filings. If it is not probable that the relevant authority will accept an uncertain tax treatment, the effect of each uncertainty is reflected by using either the most likely amount or the expected value.

Property, plant and equipment

Property, plant and equipment including hotel property held for use in the production or supply of goods or services, or for administrative purposes, are stated in the consolidated statement of financial position at cost or fair value less subsequent accumulated depreciation and subsequent accumulated impairment losses, if any.

Hotel property is interests in buildings and their integral fixed plant which are collectively used in the operations of the hotel, and are stated at cost less subsequent depreciation and impairment losses. The related repairs and maintenance attributable to hotel property are charged to the consolidated statement of profit or loss and other comprehensive income in the period which they are incurred. The costs of significant improvements are capitalised.

Depreciation of the hotel property is calculated on the straight-line basis to write off the cost of the hotel property over the remaining lease terms.

Depreciation of other property, plant and equipment is recognised so as to write off the cost of assets less their residual values over their useful lives and after taking into account of their estimated residual value, using the reducing balance method at a principal annual rate of 20%. The estimated useful lives, residual values and depreciation method are reviewed at the end of each reporting period, with the effect of any changes in estimate accounted for on a prospective basis.

物業、廠房及設備，包括酒店物業以用作生產或提供服務或管理目的，乃按成本值或於公允價值減其後的累積折舊及其後的累積減值虧損列賬於綜合財務狀況表內，如有。

酒店物業乃指於樓宇權益與經營酒店時運用之整體固定設施，按成本值扣除累計折舊及累計減值虧損列賬。酒店物業相關修葺及維修於其產生期間計入綜合損益及其他全面收益表。其主要修建成本已被撥作資本。

酒店物業乃以直線法計算折舊，並按酒店物業之成本除以剩餘租賃年期計算撇銷。

An item of property, plant and equipment is derecognised upon disposal or when no future economic benefits are expected to arise from the continued use of the asset. Any gain or loss arising on the disposal or retirement of an item of property, plant and equipment is determined as the difference between the sales proceeds and the carrying amount of the asset is recognised in profit or loss.

Investment properties

Investment properties are properties held to earn rentals and/or for capital appreciation.

Investment properties also include leased properties which are being recognised as right-of-use assets and subleased by the Group under operating leases.

Investment properties are initially measured at cost, including any directly attributable expenditure. Subsequent to initial recognition, investment properties are measured at their fair values, adjusted to exclude any prepaid or accrued operating lease income.

Gains or losses arising from changes in the fair value of investment properties are included in profit or loss for the period in which they arise.

An investment property is derecognised upon disposal or when the investment property is permanently withdrawn from use and no future economic benefits are expected from its disposals. A leased property which is recognised as a right-of-use asset is derecognised if the Group as intermediate lessor classifies the sublease as a finance lease. Any gain or loss arising on derecognition of the property (calculated as the difference between the net disposal proceeds and the carrying amount of the asset) is included in profit or loss in the period in which the property is derecognised.

投資物業

投資物業是為賺取租金收入和/或資本增值而持有的物業。

投資物業亦包括確認為使用權資產及轉租由本集團轉租並以經營租賃方式出租的租賃物業。

投資物業最初按成本計量，包括任何直接應佔支出。初始確認後，投資物業按公允價值計量，調整後不包括任何預付或應計經營租賃收入。

Impairment of tangible assets

At the end of the reporting period, the Group reviews the carrying amounts of its property, plant and equipment and right-of-use assets to determine whether there is any indication that the assets have suffered an impairment loss. If any such indication exists, the recoverable amount of the relevant asset is estimated in order to determine the extent of the impairment loss (if any).

The recoverable amount of property, plant and equipment and right-of-use assets are estimated individually. When it is not possible to estimate the recoverable amount individually, the Group estimates the recoverable amount of the cash-generating unit to which the assets belongs.

In testing a cash-generating unit for impairment, corporate assets are allocated to the relevant cash-generating unit when a reasonable and consistent basis of allocation can be established, or otherwise they are allocated to the smallest group of cash generating units for which a reasonable and consistent allocation basis can be established. The recoverable amount is determined for the cash-generating unit or group of cash-generating units to which the corporate asset belongs, and is compared with the carrying amount of the relevant cash-generating unit or group of cash-generating units.

Recoverable amount is the higher of fair value less costs of disposal and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset (or a cash-generating unit) for which the estimates of future cash flows have not been adjusted.

If the recoverable amount of an asset (or a cash-generating unit) is estimated to be less than its carrying amount, the carrying amount of the asset (or a cash-generating unit) is reduced to its recoverable amount. For corporate assets or portion of corporate assets which cannot be allocated on a reasonable and consistent basis to a cash-generating unit, the Group compares the carrying amount of a group of cash-generating units, including the carrying amounts of the corporate assets or portion of corporate assets allocated to that group of cash-generating units, with the recoverable amount of the group of cash-generating units. In allocating the impairment loss, the impairment loss is allocated first to reduce the carrying amount of any goodwill (if applicable) and then to the other assets on a pro-rata basis based on the carrying amount of each asset in the unit or the group of cash-generating units. The carrying amount of an asset is not reduced below the highest of its fair value less costs of disposal (if measurable), its value in use (if determinable) and zero. The amount of the impairment loss that would otherwise have been allocated to the asset is allocated pro rata to the other assets of the unit or the group of cash-generating units. An impairment loss is recognised immediately in profit or loss.

Inventories

Inventories are stated at the lower of cost and net realisable value. Costs of inventories are determined on a first-in-first-out basis. Net realisable value represents the estimated selling price for inventories less all estimated costs of completion and costs necessary to make the sale.

Provisions

Provisions are recognised when the Group has a present obligation (legal or constructive) as a result of a past event, it is probable that the Group will be required to settle the obligation, and a reliable estimate can be made of the amount of the obligation.

The amount recognised as a provision is the best estimate of the consideration required to settle the present obligation at the end of the reporting period, taking into account the risks and uncertainties surrounding the obligation. When a provision is measured using the cash flows estimated to settle the present obligation, its carrying amount is the present value of those cash flows (where the effect of the time value of money is material).

When some or all of the economic benefits required to settle a provision are expected to be recovered from a third party, a receivable is recognised as an asset if it is virtually certain that reimbursement will be received and the amount of the receivable can be measured reliably.

撥備

Financial instruments

Financial assets and financial liabilities are recognised when a group entity becomes a party to the contractual provisions of the instrument. All regular way purchases or sales are purchases or sales of financial assets that require delivery of assets within the time frame established by regulation or convention in the market place.

Financial assets and financial liabilities are initially measured at fair value except for trade receivable arising from contracts with customers which are initially measured in accordance with HKFRS 15. Transaction costs that are directly attributable to the acquisition or issue of financial assets and financial liabilities (other than financial assets or financial liabilities at fair value through profit or loss ("FVTPL")) are added to or deducted from the fair value of the financial assets or financial liabilities, as appropriate, on initial recognition.

The effective interest method is a method of calculating the amortised cost of a financial asset or financial liability and of allocating interest income and interest expense over the relevant period. The effective interest rate is the rate that exactly discounts estimated future cash receipts and payments (including all fees and points paid or received that form an integral part of the effective interest rate, transaction costs and other premiums or discounts) through the expected life of financial asset or financial liability, or, where appropriate, a shorter period, to the net carrying amount on initial recognition.

Interest income which are derived from the Group's ordinary course of business are presented as revenue.

The Group performs impairment assessment under expected credit loss (“ECL”) model on financial assets (including trade and other receivables, and cash and bank balances) which are subject to impairment under HKFRS 9. The amount of ECL is updated at each reporting date to reflect changes in credit risk since initial recognition.

Lifetime ECL represents the ECL that will result from all possible default events over the expected life of the relevant instrument. In contrast, 12-month ECL (“12m ECL”) represents the portion of lifetime ECL that is expected to result from default events that are possible within 12 months after the reporting date. Assessment are done based on the Group’s historical credit loss experience, adjusted for factors that are specific to the debtors, general economic conditions and an assessment of both the current conditions at the reporting date as well as the forecast of future conditions.

The Group applies the HKFRS 9 simplified approach to measure ECL when uses a lifetime ECL for all trade receivables. To measure the ECL, trade receivables have been grouped based on shared credit risk characteristics and the day past due.

For all other financial assets, the Group measures the loss allowance equal to 12m ECL, unless there has been a significant increase in credit risk since initial recognition, in which case the Group recognises lifetime ECL. The assessment of whether lifetime ECL should be recognised is based on significant increases in the likelihood or risk of a default occurring since initial recognition.

Significant increase in credit risk

In assessing whether the credit risk has increased significantly since initial recognition, the Group compares the risk of a default occurring on the financial instrument as at the reporting date with the risk of a default occurring on the financial instrument as at the date of initial recognition. In making this assessment, the Group considers both quantitative and qualitative information that is reasonable and supportable, including historical experience and forward-looking information that is available without undue cost or effort.

Irrespective of the outcome of the above assessment, the Group presumes that the credit risk has increased significantly since initial recognition when contractual payments are more than 30 days past due, unless the Group has reasonable and supportable information that demonstrates otherwise.

Despite the foregoing, the Group assumes that the credit risk on a debt instrument has not increased significantly since initial recognition if the debt instrument is determined to have low credit risk at the reporting date. A debt instrument is determined to have low credit risk if (i) it has a low risk of default, (ii) the borrower has a strong capacity to meet its contractual cash flow obligations in the near term and (iii) adverse changes in economic and business conditions in the longer term may, but will not necessarily, reduce the ability of the borrower to fulfil its contractual cash flow obligations. The Group considers a debt instrument to have low credit risk when it has an internal or external credit rating of "investment grade" as per globally understood definitions.

The Group regularly monitors the effectiveness of the criteria used to identify whether there has been a significant increase in credit risk and revises them as appropriate to ensure that the criteria are capable of identifying significant increase in credit risk before the amount becomes past due.

Definition of default

For internal credit risk management, the Group considers an event of default occurs when information developed internally or obtained from external sources indicates that the debtor is unlikely to pay its creditors, including the Group, in full (without taking into account any collaterals held by the Group).

Irrespective of the above, the Group considers that default has occurred when a financial asset is more than 90 days past due unless the Group has reasonable and supportable information to demonstrate that a more lagging default criterion is more appropriate.

Credit-impaired financial assets

A financial asset is credit-impaired when one or more events that have a detrimental impact the estimated future cash flows of that financial asset have occurred. Evidence that a financial asset is credit-impaired includes observable data about the following events:

- (a) significant financial difficulty of the issuer or the borrower;
- (b) a breach of contract, such as a default or past due event;
- (c) the lender(s) of the borrower, for economic or contractual reasons relating to the borrower's financial difficulty, having granted to the borrower a concession(s) that the lender(s) would not otherwise consider; or
- (d) it is becoming probable that the borrower will enter bankruptcy or other financial reorganisation.

Write-off policy

The Group writes off a financial asset when there is information indicating that the counterparty is in severe financial difficulty and there is no realistic prospect of recovery. Financial assets written off may still be subject to enforcement activities under the Group's recovery procedures, taking into account legal advice where appropriate. A write-off constitutes a derecognition event. Any subsequent recoveries are recognised in profit or loss.

Measurement and recognition of ECL

The measurement of ECL is a function of the probability of default, loss given default (i.e. the magnitude of the loss if there is a default) and the exposure at default. The assessment of the probability of default and loss given default is based on historical data adjusted by forward-looking information. Estimation of ECL reflects an unbiased and probability-weighted amount that is determined with the respective risks of default occurring as the weights. The Group uses a practical expedient in estimating ECL on trade receivables using a provision matrix taking into consideration historical credit loss experience, adjusted for forward looking information that is available without undue cost or effort.

Generally, the ECL is the difference between all contractual cash flows that are due to the Group in accordance with the contract and the cash flows that the Group expects to receive, discounted at the effective interest rate determined at initial recognition.

The estimates and associated assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an on-going basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

Key sources of estimation uncertainty

The following are the key assumptions concerning the future, and other key sources of estimation uncertainty at the end of the reporting period, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year.

Investment properties

Investment properties are stated at fair value based on the valuation performed by independent professional valuers. In determining the fair value, the valuers have based on a method of valuation which involves certain estimates. In relying on the valuation report, the directors of the Company have exercised their judgement and are satisfied that the method of valuation is reflective of the current market conditions and underlying assumptions adopted for capitalisation of the income derived from the existing tenancies with due provision for the reversionary income potential of the property interests.

The Group uses judgement in making these assumptions and selecting the inputs to the impairment calculation, based on the Group's past history, existing market conditions as well as forward looking estimates at the end of each reporting period.

The provision of ECL is sensitive to changes in estimates. The information about the ECL and the Group's trade receivables are disclosed in Note 31.

Estimated impairment of property, plant and equipment and right-of-use assets

Property, plant and equipment and right-of-use assets are stated at costs less accumulated depreciation and impairment, if any. In determining whether an asset is impaired, the Group has to exercise judgement and make estimation, particularly in assessing: (1) whether an event has occurred or any indicators that may affect the asset value; (2) whether the carrying value of an asset can be supported by the recoverable amount, in the case of value in use, the net present value of future cash flows which are estimated based upon the continued use of the asset; and (3) the appropriate key assumptions to be applied in estimated based upon the continued use of the asset; and (4) the appropriate key assumptions to be applied in estimating the recoverable amounts including cash flow projections and an appropriate discount rate. When it is not possible to estimate the recoverable amount of and individual asset (including right-of-use assets), the Group estimates the recoverable amount of the cash generating unit to which the assets belongs. Changing the assumptions and estimates, including the discount rates or the growth rate in the cash flow projections, could materially affect the net present value used in the impairment test.

The management estimates discount rate that reflects current market assessments of the time value of money and the risks specific to the CGU.

In determining the lease term and assessing the length of the non-cancellable period, the Group applies the definition of a contract and determines the period for which the contract is enforceable.

The Group entered into short-term leases for staff quarters and office premise. As at 31 December 2022, the portfolio of these outstanding short-term leases is similar to the portfolio during the year ended 31 December 2022 with the corresponding short-term lease expense disclosed above.

The lease agreements do not impose any covenants other than security interests in the leased assets that are held by the lessor. Leased assets may not be used as security for borrowing purposes.

Leases for office premise and staff quarters are agreed for terms ranging from one to three years, but may have termination options as described below. The lease for the leasehold land is agreed for a term of twenty years, with remaining of three years as of 31 December 2022.

As at 31 December 2022, the Group's right-of-use assets amounted to HK\$6,924,353 (2021: HK\$7,570,121) were located in Hong Kong and Mainland China.

As at 31 December 2022 and 2021, the Group did not enter into any leases that is not yet commenced.

Credit limits are reviewed on periodic basis, and the finance department is responsible for such monitoring procedures. In determining whether provision for impairment of receivables is required, the Group takes into consideration the credit risk characteristics of customers, ageing status and the likelihood of collection and adjusted for reasonable and supportable forward-looking information. In this regard, the directors are satisfied that the risks of impairment are monitored and adequate provision, if any, has been made in the consolidated financial statements. 34. RETIREMENT BENEFIT PLANS

The Group operates a Mandatory Provident Fund (“MPF”) Scheme under rules and regulations of MPF Schemes Ordinance for all qualifying employees in Hong Kong. The assets of the schemes are held separately from those of the Group, in funds under the control of trustees.
