- In the case of joint registered holders of any shares of the Company, one of such joint registered holders may vote at the Meeting, either in person or by proxy (whether physically or via the Tricor e-Meeting System), in respect of such shares as if he/she/it were solely entitled thereto; but if more than one of such joint registered holders are present at the Meeting, the vote of the senior who tenders a vote, whether in person or by proxy (whether physically or via the Tricor e-Meeting System), shall be accepted to the exclusion of the votes of the other joint holders, and for this purpose seniority shall be determined by the order in which the names stand in the register of members of the Company in respect of the joint holding.
- The completion and delivery of this form of proxy shall not preclude the shareholders from attending and voting in person physically or via online at the Meeting or any adjournment thereof (as the case may be) if they so wish.
