### PROPOSALS FOR GENERAL MANDATES TO ISSUE SHARES AND REPURCHASE SHARES; DECLARATION AND PAYMENT OF A FINAL DIVIDEND; RE-ELECTION OF RETIRING DIRECTORS; PROPOSED ADOPTION OF NEW ARTICLES OF ASSOCIATION; AND NOTICE OF ANNUAL GENERAL MEETING

#### **INTRODUCTION**

The purpose of this circular is to provide Shareholders with the notice of Annual General Meeting and the following proposals to be put forward at the Annual General Meeting: (i) the grant to the Directors of the General Mandate, the Repurchase Mandate and the Extension Mandate; (ii) the declaration and payment of a final dividend; (iii) the re-election of the retiring Directors; and (iv) the proposed amendments to the Articles of Association and the adoption of the New Articles of Association.

#### **GENERAL MANDATE TO ISSUE SHARES**

In order to ensure greater flexibility and give discretion to the Directors in the event that it becomes desirable for the Company to issue new Shares, approval is to be sought from the Shareholders, pursuant to the Listing Rules, for the General Mandate to issue Shares. An ordinary resolution no. 5(A) will be proposed at the Annual General Meeting to grant the General Mandate to the Directors to exercise the powers of the Company to allot, issue and deal with new shares in the share capital of the Company up to 20% of the number of issued Shares as at the date of the passing of the resolution in relation to the General Mandate. As at the Latest Practicable Date, there were 1,161,204,000 Shares in issue. Subject to the passing of the above ordinary resolution and on the basis that no further Shares are issued or repurchased after the Latest Practicable Date and up to the date of the Annual General Meeting, the Company will be allowed to issue a maximum of 232,240,800 Shares pursuant to the General Mandate.

In addition, subject to a separate approval of the ordinary resolution no. 5(C), the number of Shares purchased by the Company under ordinary resolution no. 5(B), if approved by the Shareholders at the Annual General Meeting, will also be added to extend the 20% limit of the General Mandate as mentioned in the ordinary resolution no. 5(A) provided that such additional number shall not exceed 10% of the issued Shares as at the date of the passing of the General Mandate and Repurchase Mandate.

### **REPURCHASE MANDATE TO REPURCHASE SHARES**

In addition, an ordinary resolution no. 5(B) will be proposed at the Annual General Meeting to grant the Repurchase Mandate to the Directors to exercise the powers of the Company to repurchase Shares representing up to 10% of the number of issued Shares as at the date of the passing of the resolution in relation to the Repurchase Mandate. As at the Latest Practicable Date, there were 1,161,204,000 Shares in issue. Subject to the passing of the above resolution and on the basis that no further Shares are issued or repurchased after the Latest Practicable Date and up to the date of the Annual General Meeting, the Company will be allowed to repurchase a maximum of 116,120,400 Shares pursuant to the Repurchase Mandate.

An explanatory statement required by the Listing Rules in connection with the Repurchase Mandate is set out in Appendix II to this circular. This explanatory statement contains all information reasonably necessary to enable the Shareholders to make an informed decision on whether to vote for or against the relevant resolution at the Annual General Meeting.

#### FINAL DIVIDEND

As stated in the announcement of the Company dated 30 March 2023 relating to the annual results of the Company for the year ended 31 December 2022, the Board recommended the payment of a final dividend of HK\$0.80 cents per ordinary Share (the "**Final Dividend**") to the Shareholders whose names appear on the register of members of the Company on Monday, 24 July 2023. The Final Dividend is subject to approval by the Shareholders at the Annual General Meeting

and a resolution will be proposed to the Shareholders for voting at the Annual General Meeting. Upon approval by the Shareholders at the Annual General Meeting, the Final Dividend will be paid on 31 July 2023.

#### **RE-ELECTION OF RETIRING DIRECTORS**

According to Article 84(1) of the Articles of Association, at each annual general meeting onethird of the Directors for the time being (or, if their number is not a multiple of three, the number nearest to but not less than one-third) shall retire from office by rotation provided that every Director shall be subject to retirement at an annual general meeting at least once every three years. Accordingly, Mr. Li Yunong, Mr. Li Yasheng and Mr. Guo Litian shall retire by rotation at the Annual General Meeting and, being eligible, have offered themselves for re-elation as Directors thereat.

To ensure a balance of skills, experience and diversity of perspectives appropriate to the requirements of the business of the Group among members of the Board, the nomination of Directors for appointment or re-appointment at the Annual General Meeting were made by the nomination committee of the Board in accordance with the nomination policy adopted by the Company and the selection criteria as set out in the board diversity policy of the Company (including but not limited to gender, age, cultural and educational background, professional experience, skills, knowledge and length of service).

The nomination committee of the Board had nominated the retiring Directors to the Board for the Board to make recommendation to the Shareholders for re-election at the Annual General Meeting, having reviewed the composition of the Board and having regard to the retiring Directors' professional experience, skills, knowledge and/or length of service, their commitment to their respective roles and functions, and their respective contributions brought and continued to be brought to the Group.

On the re-election of Mr. Guo Litian as an independent non-executive Director, the nomination committee of the Board considered, and the Board shared the same views, that at all times during the period of directorship with the Company, Mr. Guo has properly discharged his duties and responsibilities as an independent non-executive Director and has made positive contribution to the development to the Company through independent, constructive and informed comments and participation at the business and other affairs relating to the Group. In addition, the Company received confirmation of independence pursuant to Rule 3.13 of the Listing Rules from Mr. Guo. In this regard, the Board is satisfied that Mr. Guo is a person of integrity and stature and believes that his re-election and continued appointment will contribute to the Board's diversity with his years of experience and expertise in teaching management of public universities and allow the Board as well as the Company to continuously benefit from the sharing of his invaluable experience, contribution and participation. Therefore, the Board recommends the re-election of Mr. Guo as an independent non-executive Director at the Annual General Meeting.

Details of the above named Directors who are subject to re-election at the Annual General Meeting are set out in Appendix I to this circular in accordance with the relevant requirements of the Listing Rules.

#### PROPOSED ADOPTION OF NEW ARTICLES OF ASSOCIATION

Pursuant to the Consultation Conclusions on Listing Regime for Overseas Issuers published by the Stock Exchange in November 2021, the Listing Rules have been amended with effect from 1 January 2022 which requires, among others, listed issuers to adopt a uniform set of 14 "Core Standards" for shareholder protections for issuers.

Furthermore, the Company proposes to modernise and provide flexibility to the Company in relation to the conduct of general meetings. As such, the Board proposes the Amendments for the purposes of, among others, (i) bring the Articles of Association in line with amendments made to the Listing Rules and applicable laws of the Cayman Islands; (ii) provide flexibility to the Company in relation to the conduct of general meetings; and (iii) make certain housekeeping amendments to the Articles of Association for the purpose of clarifying existing practice and making consequential amendments in line with the Amendments, subject to the passing of the special resolutions, with effect from the conclusion of the Annual General Meeting. Details of the proposed Amendments are set out in Appendix III of this circular.

The Company has been advised by its legal adviser as to Hong Kong laws that the proposed Amendments conform to the requirements of the Listing Rules and by its legal adviser as to Cayman Islands laws that the proposed Amendments do not contravene the laws of the Cayman Islands. The Company also confirms that there is nothing unusual about the proposed Amendments to the Articles of Association for a company listed on the Stock Exchange.

The Board proposes to put forward to the Shareholders for approval at the Annual General Meeting special resolutions to approve the proposed Amendments and the adoption of the New Articles of Association. The proposed Amendments and the adoption of the New Articles of Association are subject to the passing of such special resolutions.

### **DIRECTOR CANDIDATES**

### **Executive Directors**

Mr. Li Yunong (李雨濃) (formerly known as Li Desong (李德頌)), aged 58, is one of the controlling shareholders and founders of the Group. Mr. Li was appointed as the chairman of the Board and an executive Director in January 2017 and has served as the chairman of Shijiazhuang Institute of Technology\* (石家莊理工職業學院) since May 2003, mainly responsible for the overall formulation of business strategies and development guidance of the Group. Mr. Li has more than 24 years of experience in the education industry.

Mr. Li served as a teacher in Hebei Institute of Physical Education\* (河北體育學院) from July 1985 to October 1990 and he was engaged as a scriptwriter in Shijiazhuang Institute of Art\* (石家 莊藝術研究所) from November 1990 to October 1994. Mr. Li has been serving as the art director in the Hebei Youth Television Culture and Art Center\* (河北青年電視藝術中心) from November 1994. Since January 2004, Mr. Li has been acting as the chairman of Lionful Investment Holding Co., Ltd. (新聯合投資控股有限公司).

Mr. Li graduated from Hebei University (河北大學) in Baoding City, Hebei Province, the PRC, with a bachelor's degree in economics in July 1985 and Tsinghua University (清華大學) in Beijing, the PRC, with a master's degree in business administration for senior management in January 2006. Mr. Li is the father of Mr. Li Yasheng (an executive Director).

### DETAILS OF RETIRING DIRECTORS PROPOSED FOR RE-ELECTION

Mr. Li has entered into a service contract with the Company for an initial fixed term of three years commencing from the Listing Date and will continue thereafter until terminated by not less than three months' notice in writing served by either party on the other. He is not entitled to receive any fee in relation to his position as an executive Director but is entitled to basic salaries, bonuses and benefits for his management positions in the Company.

As at the Latest Practicable Date, Mr. Li was deemed to be interested in an aggregate of 758,046,000 Shares, representing approximately 65.28% of the total number of issued Shares. Out of such 758,046,000 Shares, (i) 754,590,000 Shares were held by Sainange Holdings Company Limited, which was wholly-owned by Leonus Holdings Limited, and the entire issued Shares of which was controlled by HSBC International Trustee Limited, being the trustee of a trust founded by Mr. Li (the "**Family Trust**"). Mr. Li, as the founder of the Family Trust, is therefore deemed to be interested in such 754,590,000 Shares by virtue of the Securities and Futures Ordinance; (ii) 1,902,000 Shares represent the underlying shares of the outstanding share options granted to Mr. Li under the Share Award Plan; and (iv) 888,000 Shares represent the unvested award shares granted to Mr. Li under the Share Award Plan.

**Mr. Li Yasheng** (李亞晟), aged 27, was appointed as an executive Director in March 2021, is responsible for promoting the implementation of major events of the Group in line with its business strategy. Mr. Li joined the Group in 2017, and served as the investment director of the strategic investment department from December 2017 to December 2019 and an assistant to the president of the Company from January 2020 to November 2020.

Mr. Li graduated from New York University Leonard N. Stern School of Business with a bachelor's degree in finance and market management in 2017. He also graduated from the Cornell-Tsinghua Dual Degree Finance MBA program jointly offered by PBC School of Finance, Tsinghua University and S.C. Johnson Graduate School of Management, Cornell University, with an MBA degree in October 2022. Mr. Li is the son of Mr. Li Yunong (a controlling shareholder of the Company and an executive Director).

Mr. Li has entered into a service contract with the Company for a fixed term of three years commencing from 31 March 2021 and will continue thereafter until terminated by not less than three months' notice in writing served by either party on the other. He is entitled to receive an annual director's fee of RMB720,000, which is determined with reference to his roles and responsibilities, the performance of the Company and the prevailing market conditions.

As at the Latest Practicable Date, Mr. Li was deemed to be interested in an aggregate of 1,323,900 Shares, representing approximately 0.11% of the total number of issued Shares, out of which (i) 633,000 Shares represent the underlying shares of the outstanding share options granted to Mr. Li under the Share Option Scheme; (ii) 296,100 Shares represent the vested award shares granted to Mr. Li under the Share Award Plan; and (iii) 394,800 Shares represent the unvested award shares granted to Mr. Li under the Share Award Plan; and Plan.

#### **Independent non-executive Director**

**Mr. Guo Litian** (郭立田), aged 72, was appointed as an independent non-executive Director in January 2017 and is responsible for providing independent opinion and judgment to the Board.

Prior to joining the Group, Mr. Guo successively served in Hebei University of Economics and Business (河北經貿大學) as the dean of accounting college, the secretary of party committee and the dean of economics and management college, and the director of disciplinary construction and degree management office from June 1998 to May 2008. Mr. Guo served as a supervisor to postgraduate students in Hebei University of Economics and Business from May 2008 until he retired in March 2016.

Mr. Guo graduated from Hebei College of Finance and Trade\* (河北財貿學院) (currently known as Hebei University of Economics and Business (河北經貿大學)) in Shijiazhuang City, Hebei Province, the PRC, with a bachelor's degree in economics in July 1982. He obtained the title of professor (specialized in business administration) by the Title Reform Leading Group Office of Hebei Province\* (河北省職稱改革領導小組辦公室) in August 1997 and was awarded as a Brilliant Accounting Worker in Hebei Province (河北省優秀會計工作者) by the Finance Department of Hebei Province\* (河北省財政廳) in August 2005.

Mr. Guo has entered into a letter of appointment with the Company for an initial fixed term of one year commencing from the Listing Date and will continue thereafter until terminated by not less than three months' notice in writing by served by either party on the other. He is entitled to receive an annual director's fee of RMB72,000, which is determined with reference to his roles and responsibilities, the performance of the Company and the prevailing market conditions.

As at the Latest Practicable Date, Mr. Guo has no interests in the Shares which are required to be disclosed pursuant to Part XV of the Securities and Futures Ordinance.

The following is an explanatory statement required to be sent to the Shareholders under the Listing Rules in connection with the proposed Repurchase Mandate.

#### SHARE CAPITAL

As at the Latest Practicable Date, the total number of Shares in issue was 1,161,204,000 Shares. Subject to the passing of the resolution granting the Repurchase Mandate and on the basis that no further Shares are issued or repurchased after the Latest Practicable Date and up to the date of the Annual General Meeting, the Company will be allowed to repurchase a maximum of 116,120,400 Shares which represent 10% of the total number of issued Shares during the period ending on the earliest of (i) the conclusion of the next annual general meeting of the Company; or (ii) the expiration of the period within which the next annual general meeting of the Company is required to be held by Cayman Companies Act or the Articles of Association; or (iii) the date upon which such authority is revoked or varied by a resolution of the Shareholders in general meeting prior to the next annual general meeting of the Company.

#### **REASONS AND FUNDING OF REPURCHASES**

The Directors believe that it is in the best interests of the Company and the Shareholders as a whole to seek a general authority from the Shareholders to enable the Company to repurchase its Shares on the Stock Exchange. Such repurchases may, depending on market conditions and funding arrangements at the time, lead to an enhancement of the net asset value per Share and/or its earnings per Share and will only be made when the Directors believe that such a repurchase will benefit the Company and the Shareholders as a whole.

Repurchases of Shares will be financed out of funds legally available for the purpose and in accordance with the Articles of Association, the Cayman Companies Act and the Listing Rules. The Cayman Companies Act provides that the amount of capital repaid in connection with a share repurchase may be paid out of the profits of the Company or the proceeds of a fresh issue of Shares made for the purposes of the repurchase or out of capital subject to and in accordance with the Cayman Companies Act. The amount of premium payable on repurchase may only be paid out of either the profits of the Company or out of the share premium account before or at the time the Shares are repurchased in the manner provided for in the Cayman Companies Act.

#### **GENERAL INFORMATION**

To the best of their knowledge, having made all reasonable enquiries, none of the Directors nor any of their close associates, as defined in the Listing Rules, currently intend to sell any Shares to the Company or its subsidiaries, in the event that the Repurchase Mandate is approved by the Shareholders.

The Directors have undertaken to the Stock Exchange that, so far as the same may be applicable, they will exercise the Repurchase Mandate in accordance with the Listing Rules, the applicable laws of the Cayman Islands and the Articles of Association.

No core connected person of the Company has notified the Company that he or she has a present intention to sell any Shares to the Company, or has undertaken not to do so, if the Repurchase Mandate is exercised.

If as a result of a repurchase of Shares by the Company pursuant to the Repurchase Mandate, a Shareholder's proportionate interest in the voting rights of the Company increases, such increase will be treated as an acquisition for the purposes of Rule 32 of the Takeovers Code. Accordingly, a Shareholder, or a group of Shareholders acting in concert, depending on the level of increase of the Shareholder's interest, could obtain or consolidate control of the Company and become obliged to make a mandatory offer in accordance with Rule 26 of the Takeovers Code.

Among the 758,046,000 Shares, 754,590,000 Shares, representing approximately 64.98%, were held by Sainange Holdings Company Limited, which is wholly-owned by Leonus Holdings Limited. The issued shares of Leonus Holdings Limited are entirely controlled by a trust of which HSBC International Trustee Limited is the trustee and Mr. Li Yunong, an executive Director, is the founder. Assuming that no further Shares are issued between the Latest Practicable Date and the date of repurchase under the proposed Repurchased Mandate, and in the event that the Directors should exercise in full the Repurchase Mandate, the shareholding of Mr. Li and Sainange Holdings Company Limited in the Company will be increased to approximately 72.53% and 72.20% of the issued share capital of the Company. To the best knowledge and belief of the Directors, such increase would not give rise to any obligation to make a mandatory offer under the Takeovers Code. The Directors are not aware of any consequences which would arise under the Takeovers Code as a result of any repurchase of Shares pursuant to the Repurchase Mandate.

The Listing Rules prohibit a company from making repurchase on the Stock Exchange if the result of the repurchase would be that less than 25% (or such other prescribed minimum percentage as determined by the Stock Exchange) of the issued share capital would be in public hands. The Directors do not propose to repurchase Shares which would result in less than the prescribed minimum percentage of Shares in public hands.

### EXPLANATORY STATEMENT

The Directors consider there would not be any material adverse impact on the working capital or gearing position of the Company (as compared with the position disclosed in the audited financial statements contained in the 2022 annual report of the Company) in the event that the proposed purchases in the Repurchase Mandate were to be exercised in full at any time during the proposed purchase period. In addition, the Directors do not propose to exercise the Repurchase Mandate to such extent as would, in the circumstances, have a material adverse effect on the working capital requirements of the Group or on its gearing levels which in the opinion of the Directors are from time to time appropriate for the Group.

- (ii) the aggregate number of shares of the Company, which may be repurchased pursuant to the approval in paragraph (i) above shall not exceed 10% of the total number of issued shares of the Company as at the date of passing of this resolution, and the said approval shall be limited accordingly;
- (iii) subject to the passing of each of the paragraphs (i) and (ii) of this resolution, any prior approvals of the kind referred to in paragraphs (i) and (ii) of this resolution which had been granted to the Directors and which are still in effect be and are hereby revoked; and
- (iv) for the purpose of this resolution:

"**Relevant Period**" means the period from the passing of this resolution until whichever is the earliest of:
