According to HKFRS 16 "Leases", the Group, as the lessees, is required to recognise the leases as right-ofuse assets and lease liabilities in the consolidated balance sheet of the Group. As such, entering into the Renewed Property Lease Agreements and the transactions contemplated thereunder would be regarded as acquisitions of assets by the Group under the Listing Rules. The aggregate value of the right-of-use assets to be recognised by the Group under the Renewed Property Lease Agreements is estimated to be approximately RMB138,010,213, which is unaudited and may be subject to adjustment in the future.

REASONS AND BENEFITS FOR THE RENEWED PROPERTY LEASE AGREEMENTS

The Properties have been occupied and used by the Group as offices. Having taken into account the needs of the Group, the Group renewed the leasing of the Properties, each for a term of two years from 1 April 2023 to 31 March 2025 (both dates inclusive) with a view to continuing to lease and use the Properties as offices.

The rentals were negotiated on arm's length basis and on normal commercial terms by the contracting parties, and are determined with reference to market rental rates as recommended by independent professional valuers (in the cases of Property 1, Property 2, Property 3 and Property 5) and with reference to the prevailing market rental rate of Property 4 and rent payable by other tenants in the same building (in the case of Property 4). The rental payments will be satisfied by the internal resources of the Group.

The Board (including the independent non-executive Directors but excluding the interested Directors who were absent from the relevant Board meeting and accordingly did not vote, or who had abstained from voting on the resolutions to approve the Renewed Property Lease Agreements) considers that the terms of the Renewed Property Lease Agreements have been negotiated and arrived at on arm's length basis and on normal commercial terms, and that such terms are fair and reasonable and are in the interests of the Company and its Shareholders as a whole, and that the Renewed Property Lease Agreements were entered into in the ordinary and usual course of business of the Group.

Hunan Want is the Shanghai branch office of Hunan Want Want Foods Ltd. * (湖南旺旺食品有限公司), a limited liability company incorporated in the PRC and a subsidiary of the Company that is indirectly owned as to 99.99% by the Company. Its principal business activities are selling and distribution of food and beverages and various other products.

Shanghai Want Want Trading is a limited liability company incorporated in the PRC and a subsidiary of the Company that is indirectly owned as to 99.99% by the Company. It is principally engaged in the wholesale, retail, online retail, import and export, commission agents of food and packaged goods, merchandizing products, vending machines, disinfection products and other products and provision of related commission agency service and other relevant services.

I Lan Foods is a limited liability company incorporated in Taiwan region and a subsidiary of the Company that is indirectly owned as to 99.99% by the Company. Its principal business activities are manufacturing and distribution of food and beverages.

Landlord 1 is a limited liability company incorporated in the PRC and its principal business activities are investment and provision of services, and non-residential property leasing.

Landlord 2 is a limited liability company incorporated in the PRC and its principal business activities are provision of consulting services, parking lot management, property management and leasing services for

Property 2.

Landlord 3 is a limited liability company incorporated in the PRC and its principal business activities are provision of consulting services, conference services, parking lot management, property management and leasing services for properties located at Property 3.

Landlord 4 is a limited liability company incorporated in the PRC and is principally engaged in the development and sales of commercial housing and provision of related property leasing, real estate consulting, property management and parking lot management services, and construction of ancillary shopping mall facilities (excluding the operation of the shopping malls).

Mr. Tsai is the ultimate controlling shareholder of San Want Investments Co., Ltd. * (神旺投資股份有限公司).
