To be valid, this form of proxy and, if such proxy is signed by a person on behalf of the appointer pursuant to a power of attorney or other authority, a notarially certified copy of that power of attorney or other authority must be lodged to the Company's H share registrar, Computershare Hong Kong Investor Services Limited at 17M Floor, Hopewell Centre, 183 Queen's Road East, Wanchai, Hong Kong (for holders of H shares) no later than 24 hours before the time appointed for the AGM or any adjournment thereof, i.e. not later than 10:00 a.m. on Thursday, 8 June 2023.

In the case of joint registered holders of any shares of the Company, any one of such joint registered holders may vote at the AGM, either in person or by proxy, in respect of such shares as if he/she was solely entitled thereto; but should more than one of such joint registered holders be present at the AGM, either in person or by proxy, the vote of that one of the said persons so present whose name stands first on the register of members of the Company and who entitles to vote in respect of such H shares, either in person or by proxy, shall be accepted to the exclusion of the votes of the other joint registered holder(s) and for this purpose seniority will be determined by the order in which the names stand on the register of members of the Company in respect of such H shares.

You are reminded that completion and return of this form of proxy will not preclude you from attending and voting in person at the AGM or any adjournment thereof if you so wish.
