This is a voluntary announcement made by Trigiant Group Limited (“**Company**”, together with its subsidiaries, the “**Group**”).

The board of directors of the Group is pleased to announce that China Telecom released the bidding results notice (hereinafter referred to as the “**Notice**”) on the centralised procurement project in respect of Year 2023 Feeder Cable and Accessories Products on 4 May 2023, pursuant to which, 江蘇俊知技術有限公司 (Jiangsu Trigiant Technology Co., Ltd.*) (hereinafter referred to as “**Trigiant Technology**”), a wholly-owned subsidiary of the Group, is the relevant successful bidder. The details of the expected successful bid are as follows:

Centralised procurement project of China Telecom in respect of Year 2023 Feeder Cable Products: Trigiant Technology’s bidding price including tax is RMB1,517,178,381.33, and Trigiant Technology is one of the seven successful candidates.

Centralised procurement project of China Telecom in respect of Year 2023 Feeder Cable Accessories Products: Trigiant Technology’s bidding price including tax is RMB183,552,434.73, and Trigiant Technology is one of the six successful candidates.

China Telecom is a major client of the Group, and this centralised procurement plays an active role in pushing forward with the 5G infrastructure scale and deployment. The publicity period of the Notice, which is from 5 to 8 May 2023, has ended. Investors are advised to exercise caution in making decisions and take precautions against investment risks.
