(a) To approve and adopt the rules of the new share incentive scheme of the Company, a copy of which marked "IV" is produced to the meeting and for the purpose of identification signed by the Chairman thereof (the "2023 Share Incentive Scheme"), subject to and conditional upon the Listing Committee of The Stock Exchange of Hong Kong Limited (the "Stock Exchange") granting the listing of and permission to deal in the shares of the Company to be issued pursuant to the vesting or exercise of any Awards granted under the 2023 Share Incentive Scheme.		
	(b) To authorise the Board to grant Awards of Options or RSUs ("RSUs") pursuant to the 2023 Share Incentive Scheme and to allot and issue shares, direct and procure any professional trustee as may be appointed by the Company to assist with the administration, exercise and vesting of Options and RSUs to transfer shares and otherwise deal with shares underlying the Options and/or RSUs granted pursuant to the 2023 Share Incentive Scheme as and when they vest or are exercised (as the case may be).		
	(c) To approve the grant of a mandate authorising the Board to grant Awards of Options and/or RSUs pursuant to the 2023 Share Incentive Scheme in respect of a maximum number of the underlying 100,000,000 new shares equal to 8.60 per cent. of the shares in issue as at the date of adoption of the 2023 Share Incentive Scheme during the period from the date of adoption until the earlier of (a) conclusion of the Company's next Annual General Meeting, (b) the end of the period within which the Company is required by any applicable law or its bye-laws to hold its next Annual General Meeting and (c) the date on which the resolution granting such authorisation is varied or revoked by ordinary resolution of the Shareholders in general meeting (the "Applicable Period") and to allot, issue and deal with shares underlying the Options and/or RSUs granted pursuant to the 2023 Share Incentive Scheme during the Applicable Period as and when such Options and/or RSUs vest.		
	(d) To approve and adopt that the total number of options or RSUs which may be granted to any service provider of the Company under the 2023 Share Incentive Scheme shall not exceed 9,300,844 Shares, being no more than 0.8 per cent of the shares in issue during the Applicable Period (the "2023 Service Provider Sublimit").

If you do not indicate how you wish your proxy to vote, your proxy will be entitled to exercise his discretion. Unless you have indicated otherwise in this form of proxy, your proxy will also be entitled to vote at his discretion on any resolution properly put to the AGM other than those referred to in the notice convening the AGM.
- 5. This form of proxy must be signed by you or your attorney duly authorised attorney duly authorised attorney duly authorised attorney of the shareholder, the power of attorney authorising that attorney to sign or other authorisation document must be notarised.
- 6. In case of joint holders of any shares, any one of such joint holders may vote at the AGM, either personally or by proxy, in respect of such shares as if he is solely entitled thereto. However, if more than one of such joint holders are present at the AGM, personally or by proxy, the vote of the joint holder whose name stands first in the register of members of the Company and who tenders a vote, whether in person or by proxy, will be accepted to the exclusion of the votes of other joint holder(s).

In order to be valid, this form of proxy together with the power of attorney or other authorisation document (if any) must be deposited at the Company's share registrar in Hong Kong, Tricor Investor Services Limited at 17/F, Far East Finance Centre, 16 Harcourt Road, Hong Kong as soon as possible but in any event not less than 48 hours before the time appointed for the AGM or any adjournment thereof (as the case may be).
- 8. Completion and delivery of this form of proxy will not preclude you from attending and voting at the AGM if you so wish.
