POLL RESULTS OF THE ANNUAL GENERAL MEETING OF THE COMPANY HELD ON 31 MAY 2023

The Board is pleased to announce that all the ordinary resolutions set out in the Notice were duly passed by way of poll by the Shareholders at the AGM held on 31 May 2023.

Reference is made to the notice of the annual general meeting (the “**AGM**”) of Baguio Green Group Limited (the “**Company**”) dated 28 April 2023 (the “**Notice**”) and the circular of the Company dated 28 April 2023 (the “**Circular**”). Unless the context otherwise requires, capitalised terms used herein shall have the same meanings as those defined in the Circular.

POLL RESULTS OF THE AGM

The Board is pleased to announce that all the resolutions set out in the Notice were duly passed by way of poll by the Shareholders at the AGM held on 31 May 2023. The Company’s Hong Kong branch share registrar, Tricor Investor Services Limited, was appointed as the scrutineer for the vote-taking at the AGM.

As more than 50% of the votes were casted in favour of all the ordinary resolutions above, the above resolutions were duly passed as ordinary resolutions of the Company.

The executive Directors of the Company, Mr. Ng Wing Hong, Ms. Ng Yuk Kwan Phyllis and Ms. Leung Shuk Ping; and independent non-executive Directors of the Company, Mr. Sin Ho Chiu, Mr. Lau Chi Yin Thomas and Professor Cheng Edwin Tai Chiu attended the AGM.

As at the date of the AGM, the total number of issued Shares was 415,000,000 Shares, representing the total number of Shares entitling the holders thereof to attend and vote for or against all the ordinary resolutions at the AGM. No Shareholder was required under the Listing Rules to abstain from voting on any of the resolutions at the AGM. There was no Share entitling the Shareholders to attend and vote only against any resolution at the AGM and there were no restrictions on the Shareholders to cast votes on any proposed resolution at the AGM. The total Shares with voting rights represented by the Shareholders attending the AGM were 330,548,000 Shares, representing approximately 79.65% of the total issued Shares as at the date of the AGM.

In relation to resolution No. 2 above, the dividends will be payable to the Shareholders whose names appear on the register of members of the Company on 26 June 2023.
