As at the date of the Annual General Meeting, the total issued share capital of the Company was HK\$5,530,045 divided into 2,212,018,000 ordinary shares of HK\$0.0025 each (the “Shares”) in the capital of the Company. The total number of Shares entitling the Shareholders to attend and vote for or against any of the Resolutions at the Annual General Meeting was 2,212,018,000, representing 100% of the total issued share capital of the Company as at the date of the Annual General Meeting.

There was no restriction on any Shareholders to cast votes on any of the Resolutions at the Annual General Meeting and there was no Share entitling the Shareholders to attend and abstain from voting in favour of any of the Resolutions at the Annual General Meeting as set out in Rule 13.40 of the Listing Rules. No Shareholder was required under the Listing Rules to abstain from voting at the Annual General Meeting and no Shareholder has stated his/her/ its intention in the Circular to vote against or to abstain from voting on any of the Resolutions at the Annual General Meeting.

The Company's Hong Kong share registrar, Boardroom Share Registrars (HK) Limited, was appointed as the scrutineer at the Annual General Meeting for vote-taking.

As more than 50% of the votes were cast in favour of each of the resolutions numbered 1 to 9, all these resolutions were duly passed as ordinary resolutions of the Company.

The Annual General Meeting was chaired by Mr. Peng Zuncheng, an executive Director. Except for Cheung Chiu Tung, who did not attend the Annual General Meeting due to other business arrangements, the attendance record of the Directors at the Annual General Meeting was as follows:
