**CHANGE OF ENGLISH STOCK SHORT NAME OF HKD COUNTER
AND LAUNCH OF A RMB COUNTER**

Reference is made to the announcement of Great Wall Motor Company Limited (the “**Company**”) dated 5 May 2023. The board of directors (the “**Board**”) of the Company hereby announces that, the English stock short name of the Company’s Hong Kong Dollar (HKD) counter will be changed from “**GREATWALL MOTOR**” to “**GWMOTOR**”, and the Chinese stock short name of the HKD counter will remain unchanged. At the same time, a Renminbi (RMB) counter will be launched. The change of English stock short name of HKD counter and the launch of a new Renminbi (RMB) counter will be effective on 19 June 2023.

Shareholders of the Company (the “**Shareholders**”) and potential investors can distinguish between the HKD counter and the RMB counter of the Company by stock codes and stock short names as set out below.
