Announcement Trading Update Power Generation For May 2023

This announcement is made by CGN New Energy Holdings Co., Ltd. (the "Company") on a voluntary basis.

The board (the "Board") of directors (the "Directors") of the Company announces that, according to the preliminary statistics of the Company, the power generation of the Company and its subsidiaries (the "Group") on a consolidated basis amounted to 1,777.7GWh for the month of May 2023, representing an increase of 9.5% compared with the corresponding period of 2022. In particular, power generation of PRC wind projects increased by 14.4%, power generation of PRC solar projects decreased by 3.5%, power generation of PRC cogen and gas-fired projects decreased by 9.2%, power generation of PRC hydro projects decreased by 58.7% and power generation of Korea projects increased by 15.5%. For the five months ended 31 May 2023, the accumulated power generation of the Group of this year amounted to 8,567.9GWh, representing an increase of 9.4% compared with the corresponding period of 2022. In particular, power generation of PRC wind projects increased by 21.6%, power generation of PRC solar projects decreased by 0.3%, power generation of PRC cogen and gas-fired projects increased by 4.6%, power generation of PRC hydro projects decreased by 66.7% and power generation of Korea projects increased by 0.9%.
