**PLACING OF NEW SHARES UNDER NEW GENERAL MANDATE**

The Board announced that on 8 June 2023, after trading hours, the Company entered into the Placing Agreement with the Placing Agent pursuant to which the Company appointed the Placing Agent as its agent to procure not less than six Places to subscribe up to 200,000,000 Placing Shares at a price of HK\$0.490 per Placing Share on a best effort basis on the terms and subject to the condition of the Placing Agreement. The Placing Shares will be allotted and issued under the General Mandate.

The 200,000,000 Placing Shares represents (i) 5.96% of the existing issued share capital of the Company as at the date of this announcement; and (ii) approximately 5.63% of the issued share capital of the Company as enlarged by the allotment and issue of the Placing Shares.

Assuming that all the Placing Shares are fully placed, the maximum gross proceeds from the Placing will be approximately HK\$98.0 million. It is expected that the net proceeds from the Placing (after deducting the placing commission payable to the Placing Agent and other expenses incurred in the Placing) will amount to approximately HK\$96.8 million. The Company intends to apply the net proceeds from the Placing for general working capital of the Group.

The Placing is conditional upon (a) the passing by the Board of resolutions to approve the Placing Agreement and the transactions contemplated thereunder; and (b) the Listing Committee of the Stock Exchange granting or agreeing to grant approval the listing of, and permission to deal in, the Placing Shares.

## THE PLACING AGREEMENT

**Date:** 8 June 2023 (after trading hours)

**Parties:**

- (i) Issuer: The Company
- (ii) Placing Agent: China Sky Securities Limited

To the best of the Directors' knowledge, information and belief having made all reasonable enquiries, the Placing Agent and its ultimate beneficial owner(s) are independent of and not connected with the Company and its connected persons.

### Principal terms of the Placing Agreement

**Placing Shares:** The Company appointed the Placing Agent as its agent to procure not less than six Placees to subscribe up to 200,000,000 Placing Shares at a price of HK\$0.490 per Placing Share on a best effort basis. It is expected that none of the Placees will become a substantial shareholder (as defined in the Listing Rules) of the Company after Completion. The 200,000,000 Placing Shares represents (i) 5.96% of the existing issued share capital of the Company as at the date of this announcement; and (ii) approximately 5.63% of the issued share capital of the Company as enlarged by the allotment and issue of the Placing Shares. The maximum aggregate nominal value of the Placing Shares under the Placing will be HK\$20,000,000.

**Placing Price:** The price of HK\$0.490 per Placing Share was determined after arm's length negotiations between the Company and the Placing Agent with reference to the prevailing market price of the Shares on the Stock Exchange. The Placing Price represents:

- (a) a discount of approximately 16.95% to the closing price of HK\$0.590 per Share as quoted on the Stock Exchange on 8 June 2023, being the Last Trading Day; and
- (b) a discount of approximately 19.41% to the average closing price of HK\$0.608 per Share as quoted on the Stock Exchange for the last five consecutive trading days immediately prior to the Last Trading Day.

The Company will bear the costs and expenses of approximately HK\$1.2 million in connection with the Placing and the net proceeds from the Placing is estimated to be approximately HK\$96.8 million (assuming the Placing Shares are fully placed). As a result, the net price per Placing Share will be approximately HK\$0.484.

**Placing Commission:** The Placing Agent will receive a placing fee of 1% of the aggregate Placing Price of the Placing Shares actually placed by the Placing Agent with a cap of HK\$600,000. The placing fee was determined after arm's length negotiations between the Company and the Placing Agent.

**Ranking of the Placing Shares:** The Placing Shares, when issued, will rank *pari passu* in all respects with other Shares in issue at the date of allotment and issue of the Placing Shares and the Placing Shares, when issued and allotted, will be free from all liens, charges, encumbrances and the third party rights of whatever nature and together with all rights attaching to them as at the date of their allotment.

**Conditions precedent to Completion:** The Placing is conditional upon the following:

- (a) the passing by the Board of resolutions to approve the Placing Agreement and the transactions contemplated thereunder; and
- (b) the Listing Committee of the Stock Exchange granting or agreeing to grant approval the listing of, and permission to deal in, the Placing Shares.

Each of the Company and the Placing Agent shall use their respective best endeavours to procure the satisfaction of the conditions precedent by 29 June 2023 or such other date as all parties hereto may agree in writing (the "**Long Stop Date**"), but if the conditions precedent or any of them shall not be so satisfied by the Long Stop Date, all obligations of the Placing Agent and the Company shall cease and determine and none of the parties shall have any claim against the other (save in respect of any antecedent breach of any obligation under the Placing Agreement).

**Completion:** Completion is expected to take place on the third business day after the date on which all the conditions precedent are satisfied or such other date as Company and the Placing Agent may agree in writing.

**Termination:** The Placing Agent may, in its reasonable opinion, after consultation with the Company, terminate the Placing Agreement by notice in writing to the Company at any time up to 8:00 a.m. on the Completion Date if:

- (1) there is any change in national, international, financial, exchange control, political, economic conditions in Hong Kong which in the reasonable opinion of the Placing Agent would be materially adverse in the consummation of the Placing; or
- (2) there is any breach of the warranties, representations and undertakings given by the Company in the Placing Agreement and such breach is considered by the Placing Agent on reasonable grounds to be material in the context of the Placing; or
- (3) there is any material change (whether or not forming part of a series of changes) in market conditions which in the reasonable opinion of the Placing Agent would materially and prejudicially affect the Placing or makes it inadvisable or inexpedient for the Placing to proceed.

Upon termination of the Placing Agreement, all liabilities of the parties thereunder shall cease and terminate and no hereto shall have any claim against the other party in respect of any matter or thing arising out of or in connection with the Placing Agreement save in respect of any antecedent breach of any obligation under the Placing Agreement.

### **General Mandate**

The 200,000,000 Placing Shares will be allotted and issued under the General Mandate and therefore no Shareholders' Approval is required. Pursuant to the General Mandate, the total number of new Shares that the Directors are authorised to allot and issue is 670,607,473 new Shares (up to 20% of the issued share capital of the Company as at the date of the annual general meeting of the Company held on 19 May 2023). The total number of new Shares that can be allotted and issued under the General Mandate as at the date of this announcement is 670,607,473 new Shares. Upon Completion, 29.82% of the Shares of the General Mandate will be utilised by the Company.

### **REASONS FOR THE PLACING AND THE USE OF PROCEEDS**

The Group is engaged in shoes and clothes trading mainly in Asia as well as the design, manufacturing and sales of fabrics and elastic webbings in the PRC. The principal activity of the Company is investment holding.

The Directors consider that the Placing offers a good opportunity to raise further capital of the Company thereby increasing the liquidity of the Shares as well as to strengthen the financial position of the Group. The Directors consider that the terms of Placing Agreement are fair and reasonable and the Placing is in the interests of the Company and its Shareholders as a whole.

Assuming that all the Placing Shares are fully placed, the maximum gross proceeds from the Placing will be approximately HK\$98.0 million. It is expected that the net proceeds from the Placing (after deducting the placing commission payable to the Placing Agent and other expenses incurred in the Placing) will amount to approximately HK\$96.8 million. The Company intends to apply the net proceeds from the Placing for general working capital of the Group.
