### **POLL RESULTS OF THE ANNUAL GENERAL MEETING HELD ON 8 JUNE 2023**

The Board is pleased to announce that at the AGM, all the proposed resolutions were duly passed by the Shareholders by way of poll.

References are made to the circular (the “**Circular**”) of EEKA Fashion Holdings Limited (the “**Company**”) and the notice of the annual general meeting (“**AGM**”) both dated 28 April 2023. Unless the context otherwise requires, terms defined in this announcement shall have the same meanings as those defined in the Circular.

#### **POLL RESULTS OF THE AGM**

At the AGM held on 8 June 2023, the total number of issued Shares was 704,050,195, representing the number of Shares entitling the Shareholders to attend and vote for or against the ordinary resolutions at the AGM. No Shareholder is required under the Listing Rules to abstain from voting and no Shareholder is entitled to attend and abstain from voting in favour of any resolutions at the AGM as set out in Rule 13.40 of the Listing Rules.

The Board is pleased to announce that all the proposed resolutions were duly passed by the Shareholders by way of poll at the AGM. The Company’s branch share registrar in Hong Kong, Tricor Investor Services Limited, was appointed as the scrutineer at the AGM for the purpose of vote-taking. All Directors of the Company, namely, Mr. Jin Ming, Ms. He Hongmei, Mr. Jin Rui, Mr. Zhong Ming, Mr. Zhou Xiaoyu and Mr. Zhang Guodong, attended the AGM either in person or by way of electronic means.
