- (g) The Company’s branch share registrar, Tricor Investor Services Limited, acted as the scrutineer for the vote-taking at the AGM.
- (h) Mr. LI Xiaobing, Mr. WANG Quan, Mr. LEE Kwok Lun and Mr. FANG Cheng attended the AGM either in person or by electronics means. Mr. WANG Zhenfeng, Ms. QI Chunfeng and Mr. WEI Jian were unable to attend the AGM due to other business engagement.
