 To be valid, this form of proxy, together with the power of attorney or other authority (if any) under which it is signed or a certified copy thereof must be lodged with the Company's branch share registrar in Hong Kong, Computershare Hong Kong Investor Services Limited, at 17M Floor, Hopewell Centre, 183 Queen's Road East, Wan Chai, Hong Kong in any event not less than 48 hours before the time appointed for holding the Meeting (i.e. before 10:30 a.m. on Saturday, 15 July 2023 (Hong Kong time)) or any adjournment thereof. The proxy need not be a member of the Company but must attend the Meeting in person to represent you.

 Completion and delivery of this form of proxy will not preclude you from attending and voting at the Meeting if you so wish. In the event that you attend the Meeting after having lodged this form of proxy with the Company's Hong Kong branch share registrar, this form of proxy shall be deemed to have been revoked.

 The Chairman will demand a poll on each of the above resolutions at the Meeting.
