- Where there are joint registered holders of any Share(s), any one of such persons may vote at the Meeting, either personally or by proxy, in respect of such Share(s) as if he/she was solely entitled thereto, but if more than one of such joint holders are present at the Meeting, personally or by proxy, that one of the said persons so present whose name stands first on the register of members in respect of such Share(s) shall alone be entitled to vote in respect thereof.
- To be valid, this form of proxy, together with the power of attorney or other authority (if any) under which it is signed or a certified copy thereof must be lodged with the Company’s branch share registrar in Hong Kong, Computershare Hong Kong Investor Services Limited, at 17M Floor, Hopewell Centre, 183 Queen’s Road East, Wan Chai, Hong Kong in any event not less than 48 hours before the time appointed for holding the Meeting (i.e. before 10:30 a.m. on Saturday, 15 July 2023 (Hong Kong time)) or any adjournment thereof.
- The proxy need not be a member of the Company but must attend the Meeting in person to represent you.
- Completion and delivery of this form of proxy will not preclude you from attending and voting at the Meeting if you so wish. In the event that you attend the Meeting after having lodged this form of proxy with the Company’s Hong Kong branch share registrar, this form of proxy shall be deemed to have been revoked.
- Notice of the Meeting dated 15 June 2023 is set out in the circular of the Company dated 15 June 2023 sent to shareholders of the Company.
- The Chairman will demand a poll on each of the above resolutions at the Meeting. On a poll, every shareholder of the Company presents in person or by proxy or (being a corporation) is represented by proxy shall have one vote for every Share held by him/her. The results of the poll will be published on the websites of The Stock Exchange Hong Kong Limited and the Company following the Meeting.
