In May 2023, the main reasons for the year-on-year increase in gross power generation and total power output dispatch were that the power demand increased in certain areas where the thermal power generator units of the Company were located, the new power generator units brought the growth of power generation, and some power generator units were under maintenance leading to a relatively low base in the same period last year.

The major operational data above were calculated based on the internal statistics of the Company. Operational data may show major differences from month to month. The factors giving rise to such differences include, among others, changes in weather, equipment overhaul, seasonal factors and safety inspection.
