VOTING RESULTS OF THE RESOLUTIONS PROPOSED AT THE AGM

The Board is pleased to announce that all resolutions proposed at the AGM were duly passed by way of poll by the Shareholders at the AGM held on 16 June 2023.

VOTING RESULTS OF THE ANNUAL GENERAL MEETING

Reference is made to the circular of Xiwang Property Holdings Company Limited (the “**Company**”) dated 28 April 2023 (the “**AGM Circular**”) which contains the notice (the “**Notice of AGM**”) to convene the annual general meeting of the Company held on 16 June 2023 at 10:30 a.m. (the “**AGM**”). Terms used herein shall have the same meanings as defined in the AGM Circular unless the context requires otherwise. As at the date of the AGM, there were a total of 1,408,784,198 Shares in issue. None of the Shareholders was required under the Listing Rules to abstain from voting on the resolutions proposed at the AGM. The total number of Shares entitling the Shareholders to attend and vote for or against the resolutions at the AGM was 1,408,784,198, representing 100% of the total issued share capital in respect of the ordinary shares of the Company as at the date of the AGM. There was no Share entitling the Shareholders to attend and abstain from voting in favour of any of the resolutions proposed at the AGM as set out in Rule 13.40 of the Listing Rules. No party had stated its intention in the AGM Circular that it would vote against any resolution or that it would abstain from voting at the AGM. Pursuant to Rule 13.39(5) of the Listing Rules, the board (the “**Board**”) of directors of the Company is pleased to announce that all the ordinary resolutions proposed at the AGM were duly passed by the Shareholders by way of poll at the AGM and their respective voting results are set out below:
