# ISDN RECEIVES COMMERCIAL OPERATION APPROVAL AND COMMENCEMENT DATE FOR ANGGOCI AND SISIRA HYDROPOWER PLANTS

The Board of Directors (the "Board") of ISDN Holdings Limited, together with its subsidiaries (collectively "ISDN" or the "Group") wishes to announce that ISDN's two additional minihydropower plants, Anggoci and Sisira, have received their commercial operation date ("COD") as of 15 June 2023. The two plants have already demonstrated their readiness through precommercial operations, and they will transition to commercial operation immediately as of the COD.
