POLL RESULTS OF ANNUAL GENERAL MEETING HELD ON 16 JUNE 2023

Reference is made to the circular dated 23 May 2023 (the “**Circular**”) issued by i-CABLE Communications Limited (the “**Company**”). Unless otherwise defined herein, capitalised terms used in this announcement shall have the same meanings as defined in the Circular.

POLL RESULTS OF THE AGM

At the AGM held on 16 June 2023, a poll was demanded by the chairman of the AGM for voting on the proposed resolutions (the “**Resolutions**”) as set out in the notice of AGM dated 23 May 2023 (the “**Notice of AGM**”). All the Resolutions were duly passed by the Shareholders by way of poll at the AGM. Tricor Tengis Limited, the Registrar, was appointed as the scrutineer at the AGM for the purpose of vote-taking. As more than 50% of the votes were cast in favour of each of the above Resolutions, all the above Resolutions were duly passed as ordinary resolutions by the Shareholders by way of poll at the AGM.

The total number of Shares in issue as at the date of AGM was 7,134,623,520 Shares, which was the total number of Shares entitling the holders to attend and vote on the Resolutions at the AGM. There were no Shares entitling the holders to attend and abstain from voting in favour of any resolution pursuant to Rule 13.40 of the Listing Rules at the AGM. None of the Shareholders is required under the Listing Rules to abstain from voting at the AGM. There were no parties who had stated their intention in the Circular to vote against any resolution at the AGM or to abstain from voting the Resolutions at the AGM.

Apart from Dr. Cheng Kar-Shun, Henry, Ms. Ng Yuk Mui Jessica and Mr. Luk Koon Hoo, Roger who were unable to attend the AGM since each of them had other engagements at the time of such meeting, all the remaining Directors attended the AGM in person or by electronic means.
