CHAIRPERSON'S STATEMENT 主席報告

On behalf of the board ("Board") of directors ("Directors") of Winson Holdings Hong Kong Limited (the "Company" or "Winson"), I am pleased to present the annual results of the Company and its subsidiaries (collectively referred to as the "Group" or "Winson Group") for the year ended 31 March 2023 ("FY2023").

The prolonged outbreak of the novel coronavirus disease ("COVID-19") has subsided and disease control measures were gradually lifted in Hong Kong and China since the second half of the year 2022. Commercial activities in Hong Kong took a sharp rebound as businesses and consumers took to recoup losses suffered in the past two years. At the same time, government officials have rolled out a series of international business forums to put spotlight back onto Hong Kong as a financial and business hub, and launched campaigns to attract travelers to Hong Kong. Number of travelers to Hong Kong from January to March 2023 already accumulated to over 4.4 million¹, as compared to 0.6 million¹ for the whole year of 2022. With the surge in inbound travelers and local consumer demand, it is expected that transportation, food and beverage, retailing and hospitality operators are on the forefront to experience a flood of business activities, which in turn will drive up the needs for hygiene and cleaning services.

The Group remained committed to delivering environment hygiene services throughout the period of COVID-19 outbreak, and had taken strategic steps to strengthen organic growth and horizontal business development. For example, we offered disease-exposed venue deep cleaning and disinfecting service, general mist disinfection, and promoted the use of robotic/IT-assisted device to reduce personnel exposure to the elements and enhance efficiency. We also equipped ourselves to service the specialisd needs of certain targeted industries, which crystallised to encouraging results during the FY2023 when the Group secured environmental hygiene service contracts with new customers from a wide range of industries, including a public healthcare provider, a tertiary education institution, a governmental disciplinary force, an international brand five-star hotel in central business district, and a property management company associated with a prominent real estate developer.

本人代表永順控股香港有限公司(「本公司」或「永順」)董事(「董事」)會(「董事會」)欣然提呈本公司及其附屬公司(統稱「本集團」或「永順集團」)截至2023年3月31日止年度(「2023財年」)之年度業績。

自2022年下半年起,新型冠狀病毒病(「COVID-19」)的持續爆發已平息,香港及中國的疾病控制措施已逐漸解除。香港商業活動因企業及消費者採取行動彌補過去兩年蒙受的損失而顯著復甦。同時,政府官員已推出一系列國際商業論壇,使香港作為金融及商業樞紐重返舞台中心,並開展活動吸引旅客訪港。自2023年1月至3月訪港旅客數目已累計逾4.4百萬人次¹,而2022年全年為0.6百萬人次¹。藉由入境遊客及本地消費者需求激增,預期交通、餐飲、零售及酒店業營運商將率先感受到業務活動的潮湧,這繼而將拉動衛生及清潔服務需求。

本集團於整個COVID-19疫情期間一直致力於交付環境衛生服務,並已採取戰略措施鞏固內在增長及橫向業務發展。例如,我們提供病毒暴露場所的深度清潔及消毒服務、常規霧化消毒以及推廣使用機器人/IT輔助設備,以減少人員暴露於外部環境中,從而提高效率。於2023財年,我們亦武裝自己服務於若干目標行業的特定需求,當本集團與來自各行各業的新客戶(包括一家公共醫療供應商、一所高等教育機構、一個政府紀檢部門、一家位於核心商業區的國際品牌五星級酒店及一家與知名房地產開發商有關的物業管理公司)簽訂環境衛生服務合約時,該等服務即轉化為鼓舞人心的成果。

CHAIRPERSON'S STATEMENT 主席報告

We believe the Group's dedication to upholding quality service and foresight in broadening our service coverage during the period of turmoil in the past few years had strengthened trust and satisfaction with business partners and helped the Group to achieve a stable operating and financial performance for FY2023.

Looking forward, the Group expects a growth in demand for environmental hygiene and related services, particularly in the hospitality, food and beverage, and retailing segments to support the influx of travellers. At the same time, the Group will continue targeting public hygiene projects available in the governmental and other public service sector. Furthermore, the Lantau Tomorrow Vision and Northern Metropolis development plans promulgated by the Hong Kong SAR government will facilitate the blend in of Hong Kong into the Greater Bay Area as part of the PRC national development plan. We also look forward to resuming negotiations on potential horizontal business development opportunities, including the possible expansion in geographic coverage and in property related synergized services and the long-term outlook of the Group and the market in which we operate remains positive.

On behalf of the Board, I take this opportunity to express our heartfelt gratitude to our business partners, staff members and shareholders for their continuous support and we look forward to bringing you more promising news of the Group soon.

BUSINESS REVIEW

The Group's strategic steps to strengthen and diversify its customer base and service offerings demonstrated positive results during the year ended 31 March 2023 ("FY2023"), the Group achieved a relatively stable business performance for FY2023 as compared to the year ended 31 March 2022 ("FY2022" or "Comparative Year") and also successfully built up a strong and diverse network as foundation for future growth.

The Group's unwavering dedication to delivering environment hygiene services, including various forms of disinfection services for disease prevention, during the period of COVID-19 outbreak has strengthened trust and relationship with our portfolio of customers. The Group achieved a high contract renewal rate of 87.1% for the FY2023, as compared to 74.2% for FY2022. At the same time, the Group also committed strong effort to culture expansion by offering environmental hygiene services to a broader range of customers. During the FY2023, the Group secured environmental hygiene service contracts with new customers from a wide range of industries, including a tertiary education institution, an international brand five-star hotel in central business district, a service property management company associated with a prominent real estate developer, a governmental disciplinary force, and a public healthcare service provider. The Group's success rate of tenders for new contract for the FY2023 improved to 19.7%, as compared to 15.7% for the FY2022. With the encouraging results in tendering for new and renewal contracts, the Group's total number of contracts on hand as at 31 March 2023 rose to 117, as compared to 106 as at 31 March 2022.

On the other hand, total revenue of the Group's environmental hygiene and related services for the FY2023 recorded a minor decrease by 2.4%, which management believed was only temporary in nature and mainly attributable to drop in demand for special cleaning and disinfecting services in response to the gradual easing of the COVID-19 outbreak in Hong Kong. Despite a slight drop in revenue, the Group was able to achieve an improvement in gross profit to HK\$77.5 million for FY2023, as compared to HK\$76.3 million for FY2022, through effective use of resources and stringent cost control.

The Group's airline catering support services business has been temporarily suspended since March 2020 and remained so throughout the FY2023. But with the loosening up of disease control measure in Hong Kong and the PRC, passenger air traffic has resumed and consistently rose during FY2023. The Group has been communicating closely with customer on possible needs for our service to support the catering required associated with the expected surge in passenger air travel, which consequently led to the re-commencement, albeit not yet in full-scale, of our airline catering support service in April 2023.

Further analysis of the Group's financial results is set out in the section "Financial Review" below.

業務回顧

於截至2023年3月31日止年度（「2023財年」），本集團採取策略措施以鞏固及發展多樣化的客戶群及服務，且漸見佳績，相較於截至2022年3月31日止年度（「2022財年」或「比較年度」），本集團於2023財年的業務表現相對穩定，並已成功搭建強大且多元的網絡，為日後增長奠定基礎。

本集團於COVID-19疫情期間堅定不移地致力交付環境衛生服務（包括各種形式的疾病預防消毒服務）已增進與客戶組合的信任及關係。本集團於2023財年錄得87.1%的較高合約續約率，而2022財年則為74.2%。同時，本集團亦致力於透過將環境衛生服務推廣至更廣泛的客戶群大舉開展文化擴張。於2023財年，本集團與來自各行各業的新客戶（包括一所高等教育機構、一家位於核心商業區的國際品牌五星級酒店、一家與知名房地產開發商有關的物業管理公司、一個政府紀律部門及一家公共醫療服務商）簽訂環境衛生服務合約。本集團於2023財年的新合約中標率提升至19.7%，而2022財年則為15.7%。藉助新合約投標及續約取得鼓舞人心的成果，本集團於2023年3月31日的在手合約總數上升至117份，而於2022年3月31日則為106份。

另一方面，本集團於2023財年的環境衛生及相關服務總收益略微減少2.4%，管理層認為有關減少僅屬暫時性，且主要歸因於香港COVID-19疫情的逐漸緩和導致特別清潔及消毒服務需求下降。儘管收益略微減少，本集團透過資源的高效使用及嚴格的成本控制於2023財年將毛利提升至77.5百萬港元，而於2022財年則為76.3百萬港元。

本集團的航空餐飲支援服務業務自2020年3月起至今一直暫時停擺。但隨著香港及中國的疾病控制措施放寬，航空客運量已恢復並於2023財年持續上升。本集團一直就預計航空旅客激增相關的餐飲所需服務的支援與客戶進行密切溝通，此舉可令我們的航空餐飲支援服務於2023年4月重新開始（暫為非全面啟動）。

MANAGEMENT DISCUSSION AND ANALYSIS

管理層討論及分析

OUTLOOK

With the sharp rebound in local consumer and business activities and increasing inbound travellers into Hong Kong, it is expected that public transportation, food and beverage, retailing and hospitality operators will be amongst the first to take on a surge of business activities, which would in turn drive up demand for environmental hygiene services. We envisage that increasing number of business and public service operators will resort to external support on environmental hygiene solution in order to focus effort on developing internal manpower to serve core business needs. The Group has long-established and stable business relationship with a rail transport operator, shopping centres, international luxury brand retailers, restaurants and also recently secured contracts with various new customers including government departments, public health service provider, and real estate property conglomerate. Accordingly, the Group is in an advantageous position to capture business growth associated with a wide range of industries.

Nonetheless, the Group is exposed to labour shortage, adjustment on statutory minimum wage and rising material prices, all of which will cast potential downward pressure to profitability of its projects. Faced with aforesaid challenges, the Group is well-prepared to compete with other market players by providing technologically advanced environmental hygiene solutions to improve operational efficiency, and premium hygiene solution (such as environmental friendly cleaning products, waste up-cycling, etc.) for enhanced customer satisfaction.

FINANCIAL REVIEW

Revenue

For the FY2023, total revenue was approximately HK\$462.2 million, representing a slightly decrease of approximately 2.4% (FY2022: approximately HK\$473.7 million). The decrease in revenue mainly due to drop in demand for ad-hoc disinfection job in respond to the gradual easing of the COVID-19 outbreak during FY2023, which in most part contributed approximately HK\$11.5 million decrease in revenue as compare with the FY2022.

前景

隨著本地消費者及業務活動急劇回升及入境訪港遊客日益增多，預期公共交通、餐飲、零售及酒店業營運商將率先迎來業務活動激增，繼而拉動環境衛生服務需求。我們預計，越來越多的商業及公共服務營運商將在環境衛生解決方案方面尋求外部支援，以重點發展內部人力滿足核心業務需求。本集團與一家鐵路運輸營運商以及多家購物中心、國際奢侈品牌零售商及餐廳建立長期穩定的業務關係，近期亦與政府部門、公共衛生服務供應商及房地產物業集團等各類新客戶簽訂新合約。因此，本集團於把握與各行各業有關的業務增長機遇方面處於優勢地位。

儘管如此，本集團面臨勞動力短缺、法定最低工資調整及物料價格日益上漲的風險，全部該等風險將為其項目的盈利能力帶來潛在下行壓力。面對上述挑戰，本集團已作好充分準備，通過提供技術先進的環境衛生解決方案以提高營運效率及提供優質衛生解決方案（例如環保清潔產品、廢物回收再利用等）以提升客戶滿意度，與其他市場參與者展開有力競爭。

財務回顧

收益

於2023財年，總收益約為462.2百萬港元，略為減少約2.4%（2022財年：約473.7百萬港元）。收益減少乃主要由於隨著COVID-19疫情於2023財年逐漸緩解，臨時消毒工作的需求下降，導致收益在很大程度上較2022財年減少約11.5百萬港元。

For the FY2023, revenue from environmental hygiene and related services amounted to approximately HK\$462.2 million (FY2022: approximately HK\$473.7 million). The airline catering support services was still plagued with COVID-19 for FY2023, and there was no revenue from this segment as the same as FY2022.

於2023財年，環境衛生及相關服務收益約為462.2百萬港元（2022財年：約473.7百萬港元）。航空餐飲支援服務於2023財年繼續受COVID-19肆虐影響，故一如2022財年並無自此分部錄得收益。

Cost of Services

For the FY2023 and FY2022, the cost of services of the Group amounted to approximately HK\$384.7 million and HK\$397.3 million respectively, representing approximately 83.2% and 83.9% of the Group's revenue for the corresponding years. The cost of services of the Group comprised direct wages, consumables and sub-contracting fees.

服務成本

於2023財年及2022財年，本集團的服務成本分別約為384.7百萬港元及397.3百萬港元，佔本集團相應年度收益的約83.2%及83.9%。本集團服務成本包括直接工資、消耗品及分包費用。

Gross Profit and Gross Profit Margin

The gross profit slightly increased from approximately HK\$76.3 million for the FY2022 to approximately HK\$77.5 million for the FY2023. The overall gross profit margin increased from approximately 16.1% for the FY2022 to approximately 16.8% for the FY2023. The following table sets forth breakdown of gross profit and gross profit margin by segment.

MANAGEMENT DISCUSSION AND ANALYSIS

管理層討論及分析

The gross profit of environmental hygiene and related services slightly increased by approximately 1.5% from approximately HK\$76.3 million for the FY2022 to HK\$77.5 million for the FY2023. The gross profit margin increased from approximately 16.1% of the FY2022 to 16.8% for FY2023.

The increase of gross profit of environmental hygiene and related services was mainly due to few major contracts that were not successful in renewal in mid of last year and these contracts have a relatively lower gross profit margin. The airline catering support services was still suspended by customers because of COVID-19 for both FY2023 and FY2022, and there was no gross profit contribution from this segment.

General Operating Expenses

The general operating expenses increased by approximately 0.5% or approximately HK\$0.3 million, from approximately HK\$51.1 million for the FY2022 to approximately HK\$51.4 million for the FY2023. The increase of general operating expenses was mainly due to the increase of provision of long service payments as compare with the FY2022.

Finance Costs

The Group's finance costs for each of the FY2023 and FY2022 were approximately HK\$0.1 million.

Profit and Total Comprehensive Income for the Year Attributable to Owners of the Company

The Group's profit and total comprehensive income attributable to owners of the Company for the FY2023 and FY2022 were approximately HK\$24.7 million and HK\$22.1 million respectively, representing of approximately 5.4% and 4.7% of the respective year's total revenue.

Capital Expenditure

During the FY2023, the Group's capital expenditure which mainly included additions in machinery and equipment and motor vehicles amounted to approximately HK\$0.7 million respectively, (FY2022: HK\$5.9 million). These capital expenditures were mainly financed by fund generated from operating activities.

環境衛生及相關服務毛利自2022財年的約76.3百萬港元略為增加約1.5%至2023財年的77.5百萬港元。毛利率自2022財年的約16.1%增加至2023財年的16.8%。

環境衛生及相關服務的毛利上升，乃主要由於去年年中數份主要合約未能成功續約，且相關合約的毛利率相對較低。由於2023財年及2022財年均繼續因應COVID-19而客戶暫停航空餐飲支援服務，故此分部並無產生毛利。

一般經營開支

一般經營開支由2022財年約51.1百萬港元增加約0.5%或約0.3百萬港元至2023財年約51.4百萬港元。一般經營開支增加主要由於長期服務金撥備較2022財年增加所致。

融資成本

資本開支

於2023財年，本集團資本開支（主要包括購置機器及設備及汽車）約為0.7百萬港元（2022財年：5.9百萬港元）。該等資本開支乃主要由經營活動產生的資金撥付。

LIQUIDITY AND FINANCIAL RESOURCES AND CAPITAL STRUCTURE

As at 31 March 2023, the Group's total current assets and current liabilities were approximately HK\$239.4 million (31 March 2022: HK\$226.4 million) and HK\$51.8 million (31 March 2022: HK\$55.5 million) respectively, while the current ratio was approximately 4.6 times (31 March 2022: approximately 4.1 times).

As at 31 March 2023, the Group had total assets of approximately HK\$275.0 million which were financed by total liabilities and total equity of approximately HK\$63.7 million and HK\$211.3 million respectively. As at 31 March 2023, the Group had cash and bank balance of approximately HK\$154.0 million (31 March 2022: approximately HK\$117.2 million).

The Group gearing ratio was 0.01 times as at 31 March 2023 (31 March 2022: 0.02 times), which was calculated based on the total lease liabilities and bank borrowings over total equity of the Group.

There was no change to the Company's capital structure during the year ended 31 March 2023. As at 31 March 2023, the issued share capital of the Company was HK\$6,000,000 divided into 600,000,000 shares of HK\$0.01 each (the "Shares")

EMPLOYEES, TRAINING AND REMUNERATION POLICIES

As at 31 March 2023, the Group had 1,647 (31 March 2022: 1,886) employees. The Group enters into separate employment contracts with each of the Group's employees in accordance with the applicable employment laws in Hong Kong. The remuneration package includes basic salary, bonuses and other cash allowances or subsidies. The Group conducts annual review on salaries, bonuses and promotions based on the performance of each employee. The total staff costs and related expenses (including directors' remuneration) for the year ended 31 March 2023 were approximately HK\$283.6 million, representing a decrease of approximately 3.4% or approximately HK\$10.1 million as compared with approximately HK\$293.7 million for the year ended 31 March 2022.

Apart from basic remuneration, share options have been granted under the pre-IPO share option scheme to recognise the contribution to the Group by an executive Director and certain employees of the members of the Group. Further share options may be granted under share option scheme to attract and retain the best available personnel, provide additional incentive to employees (full-time and part-time), as well as promote the success of the business of the Group.

於2023年3月31日，本集團的資本負債比率為0.01倍（2022年3月31日：0.02倍），該資本負債比率乃根據本集團租賃負債及銀行借款總額除以權益總額計算。

截至2023年3月31日止年度，本公司的資本架構並無變動。於2023年3月31日，本公司的已發行股本為6,000,000港元，分為600,000,000股每股面值0.01港元的股份（「股份」）。

僱員、培訓及薪酬政策

於2023年3月31日，本集團有1,647名（2022年3月31日：1,886名）僱員。本集團根據香港適用僱傭法例與本集團每名僱員分別訂立僱傭合約。薪酬待遇包括基本薪資、花紅及其他現金津貼或補貼。本集團根據各僱員的表現對薪資、花紅和晉升進行年度檢討。截至2023年3月31日止年度的員工成本及相關開支總額（包括董事酬金）約為283.6百萬港元，較截至2022年3月31日止年度的約293.7百萬港元減少約3.4%或約10.1百萬港元。

除基本薪酬外，本集團已根據首次公開發售前購股權計劃授出購股權以表彰一名執行董事及本集團成員公司的若干僱員向本集團作出的貢獻，並可能根據購股權計劃授出更多購股權以吸引及挽留優秀可用人才，向僱員（全職及兼職）提供額外的激勵，並推動本集團業務達致成功。

In order to provide quality services to customers, the Group provides ongoing training regularly to relevant staff across different departments with topics including but not limited to information technology, environmental protection, ISO training, safety training as well as trainings for supervisory roles, etc. Such trainings are either provided internally or by external parties.

FOREIGN EXCHANGE EXPOSURE

Since the Group generated most of the revenue and incurred most of the costs in Hong Kong dollars for the year ended 31 March 2023, there was no significant exposure to foreign exchange fluctuation and the Group did not maintain any hedging policy against foreign exchange risk. The management will consider hedging significant currency exposure should the need arise.

CONTINGENT LIABILITIES

The Group did not have any material contingent liabilities as at 31 March 2023 and 31 March 2022.

CHARGE OVER GROUP'S ASSETS

The Group's leasehold land and buildings of carrying value of approximately HK\$24.2 million as at 31 March 2023 (31 March 2022: approximately HK\$25.2 million), were pledged to secure the bank loans.

CAPITAL COMMITMENTS

As at 31 March 2023, the Group had HK\$23.4 million capital commitments (31 March 2022: nil) in respect of contracted but not provided for purchase of property, plant and equipment.

MATERIAL ACQUISITIONS AND DISPOSALS

The Group did not have any material acquisitions and disposals of subsidiaries, associates and joint ventures during the year ended 31 March 2023.

SIGNIFICANT INVESTMENTS HELD

The Group did not have any significant investment held as at 31 March 2023.

USE OF PROCEEDS

Based on the offer price of HK\$0.42 per share, the net proceeds from the share offer, after deducting listing related expenses, amounted to approximately HK\$40.1 million. The Group will utilise such net proceeds from the share offer for the purposes set out in the section headed “Statement of Business Objectives and Use of Proceeds” in the Prospectus. As at 31 March 2023, the net proceeds had been utilised in full as intended.

EVENT AFTER REPORTING PERIOD

Save for the disclosure in note 35 to the financial statements, there are no other significant events after the reporting period and up to the date of this annual report.

The Directors recognise the importance of good corporate governance in management and internal procedures so as to achieve effective accountability. The Company has adopted the code provisions set out in the Corporate Governance Code (the “CG Code”) contained in Part 2 of Appendix 14 to the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “Stock Exchange”) (the “Listing Rules”) as its own code of corporate governance.

Save for the deviation of code provision C.2.1 of the CG Code as described below, the Board considers that, the Company has complied, to the extent applicable and permissible, with the code provisions as set out in the CG Code during the year ended 31 March 2023 and the Directors will use their best endeavours to procure the Company to comply with the CG Code and make disclosure of deviation from such code in accordance with the Listing Rules.

CODE OF CONDUCT REGARDING SECURITIES TRANSACTIONS BY DIRECTORS

The Company has adopted the Model Code for Securities Transactions by Directors of Listed Issuers set out in Appendix 10 to the Listing Rules (the “Model Code”) as its code of conduct for securities transactions by Directors. The Directors are reminded of their obligations under the required standard of dealings set out in the Model Code on a regular basis. The Company has made specific enquiry to all Directors, and all Directors have confirmed that they have complied with the required standard of dealings set out in the Model Code during the year ended 31 March 2023.

BOARD OF DIRECTORS

The Board is responsible for the overall leadership of the Group, gives direction and make decisions on the Group’s strategies, policies, business plan and financial budget and monitors business and performance. The Board has delegated the authority and responsibility for day-to-day management and operation of the Group to the senior management of the Group. In addition, to oversee particular aspects of the Company’s affairs, the Board has established three Board committees, namely the audit committee (the “Audit Committee”), the remuneration committee (the “Remuneration Committee”) and the nomination committee (the “Nomination Committee”). The Board has delegated to the Board committees responsibilities as set out in their respective terms of reference. Further details of the Board committees are set out in this annual report.

CHAIRPERSON AND CHIEF EXECUTIVE OFFICER

Code provision C.2.1 of the CG Code requires the responsibilities between the chairperson and chief executive officer should be separated and should not be performed by the same individual.

Up to the date of this annual report, the Company has not appointed a chief executive officer and the role and functions of chief executive officer have been performed by all the executive Directors, including Madam Ng Sing Mui, the chairperson of the Company (the “Chairperson”) and an executive Director, collectively. The Board considered that this has the advantages of allowing contributions from all executive Directors with different expertise and will review the current situation from time to time and shall make necessary arrangements when the Board considers appropriate.

BOARD DIVERSITY POLICY

The Board adopted on 13 March 2017 a board diversity policy (the “Board Diversity Policy”), a summary of which is set out as follows:

- The Company is committed to equality of opportunity in all aspects of its business;

The Board considers that the said mechanism has been operating effectively and will continue to monitor the implementation and effectiveness of such mechanism on an annual basis.

BOARD MEETINGS

The Board intends to hold Board meetings regularly at least four times a year at approximately quarterly intervals. Notices of not less than 14 days will be given for all regular Board meetings to provide all Directors with an opportunity to attend and propose matters to be discussed in the meeting agenda.

For other Board and Board committee meetings, reasonable notice will generally be given. The agenda and accompanying documents are dispatched to the Directors or Board committee members at least 3 days before the meetings to ensure that they have sufficient time to review the documents and be adequately prepared for the meetings.

When Directors or Board committee members are unable to attend a meeting, they will be advised of the matters to be discussed and given an opportunity to make their views known to the Chairperson prior to the meeting. Minutes of the Board meetings and Board committee meetings will be recorded in sufficient detail to include the matters considered by the Board and the Board committee and the decisions reached, including any concerns raised by the Directors. Draft minutes of each Board meeting and Board committee meeting will be sent to the Directors for comments within a reasonable time after the date on which the meeting is held.

During the year ended 31 March 2023, the Board held 4 Board meetings and passed resolutions by way of written resolutions. The attendance record of each Directors is set out in the table on page 25 of this annual report.

GENERAL MEETING

During the year ended 31 March 2023, 1 general meeting of the Company, being the 2022 annual general meeting held on 2 August 2022 (the "2022 AGM"), was held. The attendance record of each Director is set out in the table on page 25 of this annual report.

AUDIT COMMITTEE

The Company established the Audit Committee on 21 February 2017 with written terms of reference in compliance with the Listing Rules and the CG Code. Currently, the Audit Committee comprises three independent non-executive Directors, namely Mr. Chung Koon Yan, Mr. Yuen Ching Bor Stephen and Mr. Chan Chun Sing with Mr. Chung Koon Yan being the chairperson of the Audit Committee.

Amongst other things, the primary duties of the Audit Committee are to review, in draft form, the annual report, interim report and accounts, and to provide advice and comments to the Board. In this regard, members of the Audit Committee will liaise with the Board, the senior management and auditor. The Audit Committee will also consider any significant or unusual items that are, or may need to be, reflected in such reports and accounts and give consideration to any matters that have been raised by the Company's staff responsible for the accounting and financial reporting function, compliance officer (if any) or auditor. Members of the Audit Committee are also responsible for reviewing the Group's financial reporting process, internal control and risk management systems.

The corporate governance functions are also performed by the Audit Committee. - (e) scrutinising the Company's performance in achieving agreed corporate goals and objectives, and monitoring the reporting of performance;
- (f) ensuring the committees on which he or she serves to perform their powers and functions conferred on them by the Board; and
- (g) conforming to any requirement, direction and regulation that may from time to time be prescribed by the Board or contained in the constitutional documents of the Company or imposed by legislation or the Listing Rules, where appropriate.

If the candidate is proposed to be appointed as an independent non-executive Director, his or her independence shall be assessed in accordance with, among other things, the factors as set out in Rule 3.13 of the Listing Rules, subject to any amendments as may be made by the Stock Exchange from time to time. Where applicable, the totality of the candidate's education, qualifications and experience shall also be evaluated to consider whether he or she has the appropriate professional qualifications or accounting or related financial management expertise for filling the office of an independent non-executive Director with such qualifications or expertise as required under Rule 3.10(2) of the Listing Rules.

SHAREHOLDERS' COMMUNICATION POLICY 股東通訊政策

Corporate Communication will be provided to the Shareholders in plain language and in both English and Chinese versions to facilitate the Shareholders' understanding.

Board members, in particular, either the chairman of Board committees or their delegates, appropriate management executives and external auditors will attend annual general meetings to answer Shareholders' questions. Shareholders are encouraged to provide, amongst other things, in particular, their email addresses to the Company in order to facilitate timely and effective communications. The Company recognises the importance of Shareholders' privacy and will not disclose Shareholders' information without their consent, unless required by law to do so.

In view of the above, the Board considered that the Shareholders Communication Policy had been effectively implemented during the year ended 31 March 2023.

SHAREHOLDERS' RIGHTS

Convening of extraordinary general meeting on requisition by Shareholders

The general meetings of the Company provide an opportunity for communication between the Shareholders and the Board. An annual general meeting of the Company shall be held in each year and at the place as may be determined by the Board. Each general meeting, other than an annual general meeting, shall be called an extraordinary general meeting.

If within twenty-one days of such deposit the Board fails to proceed to convene such meeting, the requisitionist(s) themselves may do so in the same manner, and all reasonable expenses incurred by the requisitionist(s) as a result of the failure of the Board shall be reimbursed to the requisitionist(s) by the Company.

The written requisition must state the objects of the meeting, and must be signed by the relevant Shareholder(s) and deposited to the Board or the company secretary of the Company at the Company's principal place of business at Unit 01-02, 9/F., The Octagon, No. 6 Sha Tsui Road, Tsuen Wan, New Territories, Hong Kong.

Procedures for directing Shareholders' enquiries to the Board

Shareholder(s) may at any time send their enquiries and concerns to the Board in writing through the company secretary of the Company by post to Unit 01-02, 9/F., The Octagon, No. 6 Sha Tsui Road, Tsuen Wan, New Territories, Hong Kong, or via email at the contact information as provided on the website of the Company.

CONSTITUTIONAL DOCUMENTS

During the year ended 31 March 2023, the Company has made amendments to its memorandum of association and the articles of association to align with the latest legal and regulatory requirements, including the applicable laws of the Cayman Islands and the amendments made to Appendix 3 to the Listing Rules which took effect on 1 January 2022 by way of adoption of the amended and restated memorandum and articles of association by a special resolution passed by the Shareholders at the 2022 AGM. The amended and restated memorandum and articles of association of the Company is available on the websites of the Company and the Stock Exchange.

The Board's Responsibilities for the Risk Management and Internal Control Systems

The Board acknowledges that it is responsible for the risk management and internal control systems and oversees such systems on an ongoing basis, while ensuring a review of the effectiveness of these systems of the Group is conducted at least annually. The scope of such review covers all material controls, including financial, operational and compliance controls. The Group's risk management and internal control systems are designed to managing risks rather than eliminating the risk of failure to achieve business objectives, and can only provide reasonable and not absolute assurance against material misstatement or loss.

The Board has delegated its responsibilities (with relevant authorities) of risk management and internal control to the Audit Committee, and management has provided a confirmation to the Audit Committee and the Board on the effectiveness of these systems for the year ended 31 March 2023.

Main Features of the Risk Management System

The Company recognises that good risk management is essential for the long-term and sustainable growth of a business. The Group's risk management structure and the major responsibilities of each role of the structure are summarized below:

Process used to Review the Effectiveness of the Risk Management and Internal Control Systems and to Resolve Material Internal Control Defects

Risk assessment report and internal control review report are submitted to the Audit Committee and the Board annually. The Board, through the Audit Committee, had performed a review on the effectiveness of the Group's risk management and internal control systems, including, but not limited to, (i) the changes, in the nature and extent of significant risks and the Company's ability to respond to changes in its business and the external environment, (ii) the scope and quality of management's ongoing monitoring of risks and of the internal control systems, (iii) the extent and frequency of communication of monitoring results to the Audit Committee and the Board which enables them to assess control of the Company and the effectiveness of risk management, (iv) significant control failings or weaknesses that have been identified, and (v) the effectiveness of the Company's processes for financial reporting and Listing Rules compliance, and considered that the risk management and internal control systems were effective and adequate for the year ended 31 March 2023. No significant areas of concern that might affect the financial, operational, compliance controls, and risk management functions of the Group were identified. The scope of such review covers the adequacy of resources, qualification and experience of staff of the Group's accounting and financial reporting functions and their attitude against internal control of the Group. The Board will continue to work with the management to discuss and follow-up on the status of remediation of the internal control weaknesses and to monitor the risks of the Group in the coming years.

Procedures and Internal Controls for the Handling and Dissemination of Inside Information

In order to enhance the Group's system of handling inside information, and to ensure the truthfulness, accuracy, completeness and timeliness of its public disclosures, the Group also adopts and implements an inside information policy and procedures. Certain reasonable measures have been taken from time to time to ensure that proper safeguards exist to prevent a breach of a disclosure requirement in relation to the Group, which include:

- access of inside information is restricted to a limited number of employees on a need-to-know basis.
- transmission of inside information in electronic form should be password-protected.
- prohibit employees to discuss inside information in public area.
- code names are assigned to confidential projects so that any reference to them would not be linked to the projects themselves to minimize possibilities of unintentional leakage.
- trainings or briefings are provided to employees who will be in possession of inside information to ensure that they are fully conversant with their obligations to preserve confidentiality with reasonable care.
- confidentiality agreements are in place before the Group enters into significant negotiations.
- officers and employees other than the designated representative are prohibited to speak externally on behalf of the Company when communicating with external parties such as the media, analysts or investors.

INTERNAL AUDIT FUNCTION

The Company does not have an internal audit department. The Board has reviewed the need for an internal audit function and is of the view that in light of the size, nature and complexity of the business of the Group, as opposed to diverting resources to establish a separate internal audit department, it would be more cost effective to appoint external independent professionals to perform independent review of the adequacy and effectiveness of the risk management and internal control systems of the Group. Nevertheless, the Board will continue to review at least annually the need for an internal audit department.

COMPANY SECRETARY

The Company engaged an external professional company secretarial services provider, Uni-1 Corporate Services Limited (“Uni-1”), to provide compliance and full range of company secretarial services to the Group in order to assist the Group to cope with the changing regulatory environment and to suit difference commercial needs.

Mr. Tse Kam Fai (“Mr. Tse”), the representative of Uni-1, has been appointed as the company secretary with effect from 1 October 2022. His primary corporate contact person at the Company is Ms. Sze Tan Nei, an executive Director.

For the year ended 31 March 2023, Mr. Tse has undertaken not less than 15 hours of relevant professional training in accordance with Rule 3.29 of the Listing Rules.

DIRECTORS’ AND OFFICERS’ INSURANCE

The Company has arranged appropriate insurance cover in respect of potential legal actions against its Directors and officers.

Madam Ng Sing Mui (吳醒梅) (“Madam Ng”), aged 62, a co-founder of the Group, has been a Director since 31 May 2016. Madam Ng was re-designated as an executive Director on 21 February 2017 and is currently acting as the Chairperson. She is also the chairperson of the Nomination Committee and holds directorships in all subsidiaries of the Company. Madam Ng is primarily responsible for the strategic planning, operation planning and overall management of the Group.

Madam Ng has more than 30 years of experience in the environmental hygiene services industry in Hong Kong. Building the business from the ground up since December 1983, Madam Ng has held a leadership role in the overall management and business development of the Group.

Madam Ng has been a certified associate fellow of the Institute of Managers and Leaders Australia and New Zealand (formerly known as Australian Institute of Management) since September 1995 and has become a fellow member since June 2019. She was also awarded a Training Certificate on Fire Prevention (Commercial Sector) issued by the Occupational Safety & Health Council in August 2001.

Madam Ng is the mother of Ms. Sze Tan Nei and Mr. Sze Wai Lun, both are executive Directors. She is the sole director of Rich Cheer Development Limited and Sze’s Holdings Limited, both companies have disclosable interests in the Shares under the provisions in Divisions 2 and 3 of Part XV of the Securities and Futures Ordinance (Chapter 571, the Laws of Hong Kong) (the “SFO”). Madam Ng is also the sole shareholder of Rich Cheer Development Limited.

Ms. Sze is the daughter of Madam Ng Sing Mui, the Chairperson and an executive Director, and the sister of Mr. Sze Wai Lun, an executive Director.

Mr. Ang graduated from the University of Waterloo, Canada, with a Bachelor of Mathematics in October 1978, and Bachelor of Arts in October 1979. He also completed an executive program organised by the Business School of the University of Michigan in 1997. Mr. Ang was admitted as an associate member of the Hong Kong Management Association in 1986 and was appointed as an “Occupational Safety and Health Ambassador” by the Occupational Safety & Health Council in 2008.

Mr. Ang has over 30 years of experience in the environmental hygiene services industry in Hong Kong. Before joining the Group, Mr. Ang was employed by Reliance Services Company Limited (currently known as ISS Facility Services Limited), being a company engaging in the provision of environmental hygiene related services, as operations manager in May 1986. He was subsequently promoted to senior operations manager in October 1988. Mr. Ang left such company in February 2000 and his last position held was director in operation department. Mr. Ang subsequently joined Best Result Cleaning Services Ltd. (currently known as Best Result Environmental Services Limited), being a company engaging in the provision of cleaning services, as general manager in July 2000 and was appointed as director and general manager in 2004. The principal business of the Group is provision of environmental hygiene and related services and airline catering support services in Hong Kong.

主要業務

本集團之主要業務為在香港提供環境衛生及相關服務及航空餐飲支援服務。

業務回顧

PRINCIPAL RISKS AND UNCERTAINTIES

The Group's businesses, financial condition, results of operations and growth prospects may be affected by risks and uncertainties directly or indirectly pertaining to the Group's businesses. The risk factors set out below are those that could result in the Group's businesses, financial conditions, results of operations or growth prospects differing materially from expected or historical results. Such factors are by no means exhaustive or comprehensive, and there may be other risks in addition to those shown below which are not known to the Group or which may not be material now but could turn out to be material in the future.

Strategic Risks

An occurrence of a natural disaster, widespread health epidemic or other outbreaks could have a material adverse impact on the Group's business, financial condition and results of operations.

The Group is principally engaged in environmental hygiene and related services, and airline catering support services in Hong Kong which constitute one of the significant sources of revenue for the Group.

In late 2022, the airline operations started resuming to normal after the COVID-19 pandemic and the commercial flights increased; hence, the demand of airline catering support services has also been resumed gradually. Since certain labour force has switched to other industries during the time of pandemic, the Group may foresee encountering the problem of labour shortage, especially in the coming summer 2023. Eventually, the Group may suffer from the pressure of expensive labour cost. If the Group is unable to control the cost increment properly, it may pose a challenge to the Group's profitability.

To minimize the impact, the Group has implemented various measures, including recruiting more suitable workers to ensure an adequate manpower to perform its duties, providing training to new staff so as to meet the requirements of the client's operations, closely monitoring the labour expense and switching the increment of labour cost to clients.

Operational Risks

Tendering is the major way to engage a service provider in the cleaning service industry for both private and public sector. A majority of the Group's service contracts are under tendering which have fixed service terms that range from one to three years, contributing significant amount of the Group's revenue. Since the tendering process is very competitive, it is uncertain that whether the customer will award new contracts or renew the existing contracts with the Group. If some customers reduce the volume of service or terminates its business relationship with the Group, the financial results and profitability may be negatively impacted.

主要風險及不確定性

本集團的業務、財務狀況、經營業績及增長前景可能受到直接或間接與本集團業務有關的風險及不確定性的影響。下文所載風險因素可能導致本集團的業務、財務狀況、經營業績或增長前景與預期或過往結果出現重大差異。該等因素並非詳盡或全面，並可能為本集團並不知悉的下文所述因素以外的或目前不屬重大但於日後可能變得重大的其他風險。

戰略風險

發生自然災害、廣泛蔓延的疫病或其他疫情爆發均可能會對本集團的業務、財務狀況及經營業績造成重大不利影響。

本集團主要於香港從事環境衛生及相關服務及航空餐飲支援服務，提供航空餐飲支援服務構成本集團收益的重要來源之一。

於2022年底，航空業務在經歷COVID-19疫情後開始恢復正常，商業航班增加；因此，航空餐飲支援服務需求亦逐步恢復。由於部分勞動力已在疫情期間轉入其他行業，本集團預計會遭遇勞動力短缺的問題，尤其是在2023年夏天。最終，本集團或面臨昂貴人工成本的壓力。倘本集團無法妥善控制成本上漲，本集團的盈利能力或將面臨挑戰。

為將影響降至最低，本集團已落實各項措施，包括招募更多適合的工人，以確保有充足的人力履行其職責，為新員工提供培訓，以滿足客戶的營運需求，密切監控人工成本並將上漲的人工成本轉嫁予客戶。

經營風險

就私營及公共部門而言，招標是清潔服務行業委聘服務供應商的主要方式。本集團大部分的服務合約均在招標中，固定服務期限介乎一至三年，為本集團貢獻大量收益。由於招標過程競爭激烈，無法確定客戶是否會授予本集團新合約或重續與本集團的現有合約。倘部分客戶減少服務量或終止與本集團的業務關係，本集團的財務業績及盈利能力或受到不利影響。

Currently, most of the clients are large-scaled corporations which look for experienced service provider with good track record. The small service providers in the market may not be able to fulfill the strict requirement of those large-scaled clients. There was no major contract loss during the past year.

The management understands that the clients are not obligated in any way to award or renew the service contracts with the Group. To response to the risk, the Group has established a relatively broad customer base ranging from government department in Hong Kong, subsidiaries of multi-national companies to tenants of various premises. Besides, the Group has established strong reputation through maintaining consistent and quality service to its customers. A designated customer service team is responsible for enhancing client's communication and handling the feedback of clients.

Apart from maintaining good relationship with existing customers, the Group will continue explore new business opportunities including expansion in hotel-related synergised services to expand the source of revenue. Meanwhile, the Group will integrate opportunities with the existing business to create value for customers, such as extending the service package of customer from general cleaning services to other environmental hygiene and support services. Given the good reputation in the industry, the Group would be able to establish new business relationship with other customers.

On the other hand, the Group operates in labour-intensive industry which provides the hygiene services to client including garbage collection, disposal, and cleanliness of the workplace. Thus, manpower plays an essential role to the environmental hygiene service, which is highly dependent on both quantity and quality of labor.

However, owing to the condition of unpleasant working environment and keen demand of the labor market, the competitors may offer an incentive benefit to attract the skilled labor. Thus, some of the labor may switch the career field directly.

As a result, the shortage of capable labor can have far-reaching impacts on business operation. If the Group is unable to address the labor shortage and retain sufficient manpower, the quality of service and operation efficiency may be adversely influenced which may slow down the Group's growth.

In order to mitigate the aforementioned risk, the Group has taken the following measures:

- Performing the salary review by benchmarking the market rate and the scale of hourly rate;

目前，大部分的客戶為大型公司，尋求經驗豐富且往績記錄良好的服務供應商。市場上的小型服務供應商可能無法滿足該等大型客戶的嚴苛要求。過去的一年內並無主要合約丟失。

管理層理解客戶並無任何義務授予或與本集團重續服務合約。為應對該風險，本集團已建立相對廣泛的客戶群，覆蓋香港政府部門、跨國公司的附屬公司以及不同物業的租戶。此外，通過持續向客戶提供貫徹一致的優質服務，本集團已贏得良好的聲譽。專門的客戶服務團隊負責提升客戶溝通及處理客戶反饋。

除與現有客戶保持良好關係外，本集團將繼續探索新的商機，包括拓展酒店相關協同服務，以擴大收益來源。同時，本集團將整合現有業務的機會，為客戶創造價值，例如將客戶的服務套餐由一般保潔服務擴大至其他環境衛生及支援服務。鑒於行業內的良好聲譽，本集團將能夠與其他客戶建立新的業務關係。

另一方面，本集團從事為客戶提供衛生服務的勞動密集型行業，包括垃圾收集、處置及工作場所清潔。因此，人力在環境衛生服務中起著至關重要的作用，而環境衛生服務高度依賴勞工的數量及質素。

然而，由於不舒適的工作環境及勞工市場的熱切需求，競爭對手可能會提供激勵性福利以吸引熟練的勞工。因此，部分勞工可能會直接轉換職業領域。

因此，有能力的勞工的短缺會對業務營運產生深遠影響。倘本集團無法解決勞工短缺問題及留住足夠的人力，服務質素及經營效率可能會受到不利影響，從而拖累本集團的發展。

為減輕上述風險，本集團已採取以下措施：

- 通過參照市場費率基準及小時費率範圍進行薪資檢討；

- Offering competitive remuneration packages with fringe benefits which are comparable with other rivals in order to attract and retain competent employees;
 - Recruiting staff through a variety of channels, such as online advertisements, newspaper advertisements, social media advertisements, and employee referral, in order to enhance greater exposure to the potential candidates to recruit suitable employees timely;
 - Setting key performance indicator to monitor the staff performance and service quality. The staff with satisfactory performance will be offered with salary increment and promotion accordingly;
 - Analyzing the personnel data and ratio of deployment among full time staff, part time staff and subcontracting staff. Such valuable information can be utilized to suggest appropriate measures to resources allocation;
 - Organizing staff gatherings, festival celebration parties to enhance staff loyalty;
 - Conducting weekly meeting with middle management and supervisors to raise the awareness of recent regulatory changes and resolve the daily difficulties so as to maintain a positive workplace environment;
 - Reviewing leave arrangement which can provide more flexibility for staff; and
 - Providing extensive training for the employee in order to maintain a high quality service and make up for the shortage in skilled workers. Managers are responsible for coaching junior staff.
- 提供有競爭力的薪酬待遇，並享有與其他競爭對手相當的附加福利，以吸引及留住有能力的僱員；
 - 透過網上廣告、報章廣告、社交媒體廣告及僱員轉介等多種渠道招募員工，以增加潛在候選人的曝光率以及時招募合適的僱員；
 - 設定關鍵績效指標，以監察員工的表現及服務質素。表現令人滿意的員工將獲提供相應的加薪及晉升；
 - 分析全職員工、兼職員工及分包員工的人事數據及部署比例。該等寶貴的資料可用於建議資源分配的適當措施；
 - 組織員工聚會、節日慶典派對，提升員工忠誠度；
 - 每週與中層管理人員及主管舉行會議，以提高對近期監管變化的認識並解決日常困難，以維持積極的工作環境；
 - 檢討休假安排，為員工提供更大的靈活性；及
 - 為僱員提供廣泛的培訓，以維持高品質的服務並彌補熟練工人的短缺。經理負責指導初級員工。

Compliance Risks

The Group is exposed to litigation claims including employees' compensation claims and common law personal injury claims and insurance coverage of the Group may not adequately protect it against certain risks.

Through close monitoring of various legal and regulatory pronouncements from the government by its legal and compliance personnel, the Group is able to keep itself updated with various regulatory requirements and complies with local labour laws and regulations such as the Employment Ordinance and Employees' Compensation Ordinance. A comprehensive work safety management and supervision system is also established for enhancing safety performance. In addition, the management will review the insurance coverage on an ongoing basis.

RELATIONSHIPS WITH KEY STAKEHOLDERS

Employees

The Company treats human resources as the Group's valuable assets. Training and retaining good employees are always at top priorities.

Besides on-the-job trainings and funding for continuous learning, two committees are set up to ensure good physical and psychological health of our staffs. Workshops are held regularly to raise staff's awareness of occupational health and safety. The risk-free working environment is guaranteed by the certification of OHSAS 18001 Occupational Health and Safety Management System. In addition, the Company also organizes a range of recreational activities so as to foster team spirit.

Customers

Keeping strong relationship with the customers is critical to maintain the competitiveness of the Group.

For servicing industry with human as the main concern, it is vital to have an independent, comprehensive quality assurance mechanism in order to maintain high level of service, in which rule-of-man style and subjectivity in the old days can be eliminated. In view of this, the Company has established an evaluation mechanism with mutual assessment by internal and external teams of professionals audits. In order to achieve a set standard of service and customers' satisfaction, the work is monitored and reviewed in various aspects including provision of resources, training, infrastructure and working environment, with customers' expectation as the foundation. For services that are not up to high standard, remedial action will be advised and implemented with continuous improvement follow through. Also, preventive measure will be formulated as future guidelines.

Suppliers and Sub-contractors

The Group maintains a list of approved suppliers and sub-contractors which are selected with reference to, among other things, material/service quality, reliability and price. The Group performs annual evaluation on the Group's suppliers and sub-contractors with respect to raw materials/service quality, reliability and timely delivery.

就以人為本的服務業而言，建立一個獨立、全面的質量保證機制對保持高水平服務而言至關重要，舊時代的人治風格及主觀性亦可因而消除。有鑒於此，本公司已設立由內部及外部專業審核團隊共同評估的評估機制。為達致既定的服務標準及客戶滿意度，本公司以客戶的期望為基礎從多個方面監督及審查工作，包括提供資源、培訓、基礎設施及工作環境。對於不符合高標準的服務，建議採取補救措施並持續進行後續改善行動。此外，本公司將制定預防措施作為未來指引。

The Company does not have any predetermined dividend distribution proportion or distribution ratio. Any future declarations of dividends may or may not reflect the Company's historical declarations of dividends and will be at the absolute discretion of the Directors.

The Board will continually review the dividend policy and reserves the right in its sole and absolute discretion to update, amend, modify and/or cancel the dividend policy at any time, and the dividend policy shall in no way constitute a legally binding commitment by the Company that dividends will be paid in any particular amount and/or in no way obligate the Company to declare a dividend at any time or from time to time.

SHARE OPTION SCHEMES

Pre-IPO Share Option Scheme

Pursuant to a written resolution of the sole Shareholder passed on 21 February 2017, the principal terms of the pre-IPO share option scheme (the "Pre-IPO Share Option Scheme") were approved and adopted. The purpose of the Pre-IPO Share Option Scheme is to aid the Company in retaining key and senior employee of the Group. Principal terms of the Pre-IPO Share Option Scheme were set out in the Prospectus and note 26 to the financial statements. An aggregate of 192,000 share options at an exercise price of HK\$0.42 per Share, being the offer price under the Share Offer, were granted on 23 February 2017 to an executive Director and certain employees of the Group. No further options will be granted under the Pre-IPO Share Option Scheme.

Details of the share options granted under the Pre-IPO Share Option Scheme are as follows:

(b) Participant of the Share Option Scheme

The Board may, at its absolute discretion and on such terms as it may think fit, grant any employee (full-time or part-time), director, consultant, adviser, substantial shareholder, distributor, contractor, supplier, agent, customer, business partner or service provider of the Group, options to subscribe at a price calculated in accordance with paragraph (c) below for such number of Shares as it may determine in accordance with the terms of the Share Option Scheme.

(d) Grant of options and acceptance of offers

An offer for the grant of options must be accepted within seven days inclusive of the day on which such offer was made. The amount payable by the grantee of an option to the Company on acceptance of the offer for the grant of an option is HK\$1.

(e) Maximum number of Shares of the Company available for issue

The total number of Shares available for issue under the Share Option Scheme is 60,000,000 Shares, represent 10% of the Shares in issue as at the date of this annual report.

(f) Maximum entitlement of each participant

The total number of Shares issued and to be issued upon exercise of options granted to any participant (including both exercised and outstanding options) under the Share Option Scheme or any other share option schemes of the Company in any 12-month period up to the date of grant shall not exceed 1% of the Shares in issue.

(g) Time of exercise of option

An option may be exercised in accordance with the terms of the Share Option Scheme at any time during a period as the Board may determine which shall not exceed ten years from the date of grant subject to the provisions of early termination thereof.

(h) Vesting period of option

The Board may in its absolute discretion set a minimum period for which an option must be held before an option can be exercised.

(i) Remaining life of the Share Option Scheme

The Share Option Scheme will remain in force for a period of ten years commencing on 21 February 2017, subject to early termination provisions contained in the Share Option Scheme.

Key audit matters are those matters that, in our professional judgement, were of most significance in our audit of the consolidated financial statements of the current period. These matters were addressed in the context of our audit of the consolidated financial statements as a whole, and in forming our opinion thereon, and we do not provide a separate opinion on these matters.

Revenue recognition

Refer to summary of significant accounting policies in note 4.8 and note 7 to the consolidated financial statements.

Service income from provision of environmental hygiene and related services is recognised when the services are rendered. We have identified recognition of revenue as a key audit matter because revenue is one of the key performance indicators of the Group and there is an inherent risk over the recognition of revenue by the management to meet specific targets or expectations.

Our responses:

Our audit procedures to address the revenue recognition included the followings:

- evaluating the appropriateness of the recognition policy with reference to the relevant accounting standard;
- inspecting, on sample basis, customer contracts to identify terms and conditions relating to the provision of services;
- performing substantive analytical procedures to assess whether the recognised service revenue was in line with the expected level;
- inspecting service income recognised during the year, on sample basis, and comparing details of the service income being recognised with relevant the underlying documentation, including service contracts, service records and invoices; and
- assessing, on a sample basis, the service income recorded before and after the financial year end date with the relevant underlying documentation, including service contracts and service records, to verify whether the service income had been recognised in the appropriate financial period.

關鍵審計事項

關鍵審計事項是根據我們的專業判斷，認為對本期綜合財務報表的審計最為重要的事項。這些事項是在我們審計整體綜合財務報表及出具意見時進行處理的。我們不會對這些事項提供單獨的意見。

收益確認

請參閱綜合財務報表附註4.8之重大會計政策概要及附註7。

來自提供環境衛生及相關服務的服務收入乃於提供服務時確認。由於收益為貴集團其中一項關鍵績效指標，且存在管理層為了達到特定目標或期望而操縱收益確認的固有風險，因此我們識別收益確認為關鍵審計事項。

我們的應對：

我們就進行收益確認執行的審計程序包括以下各項：

- 參考相關會計準則評估確認政策是否適合；
- 抽樣檢查客戶合約，以識別與提供服務有關的條款及條件；
- 進行實質性分析程序，以評估已確認的服務收益是否符合預期水平；
- 抽樣檢查年內確認的服務收入，並將所確認的服務收入詳情與相關支持文件進行比較（包括服務合約、服務記錄及發票）；及
- 抽樣評估財政年度結算日前後記錄的服務收入及相關支持文件（包括服務合約及服務記錄），以核實服務收入是否已在適當的財政期間內確認。

Impairment assessment of trade receivables

Refer to summary of significant accounting policies in note 4.6, note 5.2, note 16 and note 31(b) to the consolidated financial statements.

As at 31 March 2023, the Group had trade receivables amounted to HK\$80,884,000 after loss allowance of expected credit losses ("ECL") of HK\$227,000.

The loss allowance are based on management's estimate of lifetime ECL of trade receivables by taking into account the credit loss experience, ageing of overdue receivables, debtors' creditworthiness and repayment history and an assessment of both the current and forecast general economic conditions at the reporting date. All of which involve a significant degree of management judgements.

Since the assessment of ECL of trade receivables is a subjective area which requires the management's judgement and uses of estimates, and in view of the significance of the amount to the consolidated financial statements as a whole, we considered this as a key audit matter.

Our responses:

Our audit procedures in relation to the impairment assessment of trade receivables included:

- evaluating the Group's policies for estimating the credit loss allowance with reference to the requirements of HKFRS 9 Financial Instruments;
- assessing, on a sample basis, whether items in the trade receivables' ageing report were classified within the appropriate ageing bracket by comparing individual items in the report with underlying documentation;
- assessing appropriateness of management's estimate of credit loss allowance by examining the information provided by the management to derive the key parameters and assumptions of the ECL model adopted by the management, including checking historical default data, assessing management's estimated loss rates and assessing how reasonably management has incorporated forward-looking information in the ECL allowance; and
- reperforming the calculation of the loss allowance as at 31 March 2023 based on the Group's credit loss allowance policies.

貿易應收款項的減值評估

茲提述綜合財務報表附註4.6、附註5.2、附註16及附註31(b)中的重大會計政策概要。

於2023年3月31日，扣除預期信貸虧損（「預期信貸虧損」）虧損撥備227,000港元後，貴集團的貿易應收款項為80,884,000港元。

虧損撥備以於報告日期管理層經考慮信貸虧損經驗、逾期應收款項的賬齡、債務人的信用等級及還款記錄以及對現時及預測整體經濟狀況的評估而對貿易應收款項的全期預期信貸虧損估計為基準，上述各項均涉及管理層的重要判斷。

由於貿易應收款項預期信貸虧損的評估主觀範疇，其需要管理層判斷及運用估計，及鑑於相關金額對整體綜合財務報表而言屬重大，我們認為貿易應收款項預期信貸虧損為關鍵審計事項。

我們的應對：

我們關於貿易應收款項減值評估的審計程序包括：

- 參照香港財務報告準則第9號金融工具的要求評估 貴集團有關估計信貸虧損撥備的政策；
- 透過比較報告中個別項目與相關文件，抽樣評估貿易應收款項賬齡報告中的項目是否已歸類至適當的賬齡範圍內；
- 透過審查管理層提供的資料，評估管理層對信貸虧損撥備的估計是否恰當，以得出管理層採納的預期信貸虧損模式的關鍵參數及假設，包括查閱過往違約數據，評估管理層估計的虧損率及評估管理層在信貸虧損撥備中納入前瞻性資料的合理性；及
- 根據 貴集團的信貸虧損撥備政策，重新計算於2023年3月31日的虧損撥備。

1. CORPORATE INFORMATION

Winson Holdings Hong Kong Limited (the “Company”) was incorporated in the Cayman Islands as an exempted company with limited liability on 31 May 2016. The Company’s shares are listed on the Main Board of The Stock Exchange of Hong Kong Limited (the “Stock Exchange”).

The address of the Company’s registered office is Cricket Square, Hutchins Drive, P.O. Box 2681, Grand Cayman, KY1-1111, Cayman Islands. The address of its principal place of business is Unit 01-02, 9/F., The Octagon, No. 6 Sha Tsui Road, Tsuen Wan, New Territories, Hong Kong.

The Company is an investment holding company. The principal activities of its subsidiaries (together with the Company, collectively referred to as the “Group”) are set out in note 34.

The Company’s immediate holding company is Sze’s Holdings Limited (“Sze’s Holdings”), a company incorporated in the British Virgin Islands (the “BVI”) and the entire issued share capital of Sze’s Holdings is held by Rich Cheer Development Limited, a company incorporated in Hong Kong, as the trustee of a family trust (the “Sze Family Trust”). The Sze Family Trust is a discretionary trust established by Madam Ng Sing Mui. The beneficiaries of the Sze Family Trust included, inter alia, Mr. Sze Wai Lun and Ms. Sze Tan Nei. Rich Cheer Development Limited is deemed or taken to be interested in all the shares beneficially owned by Sze’s Holdings.

3. BASIS OF PREPARATION

(a) Statement of compliance

The consolidated financial statements have been prepared in accordance with all applicable HKFRSs, Hong Kong Accounting Standards (“HKASs”) and Interpretations (hereinafter collectively referred to as the “HKFRSs”) and the disclosure requirements of the Hong Kong Companies Ordinance which concern the preparation of financial statements. In addition, the consolidated financial statements include applicable disclosures required by the Rules Governing the Listing of Securities on the Stock Exchange.

(b) Basis of measurement

The consolidated financial statements have been prepared under the historical cost basis.

(c) Functional and presentation currency

The consolidated financial statements are presented in Hong Kong Dollars (“HK\$”), which is also the functional currency of the Company and all values are rounded to the nearest thousand (“HK\$’000”) except otherwise indicated.

4. SIGNIFICANT ACCOUNTING POLICIES

4.1 Business combination and basis of consolidation

The consolidated financial statements comprise the financial statements of the Company and its subsidiaries. Inter-company transactions and balances between group companies together with unrealised profits are eliminated in full in preparing the consolidated financial statements. Unrealised losses are also eliminated unless the transaction provides evidence of impairment on the asset transferred, in which case the loss is recognised in profit or loss.

3. 編製基準

(a) 合規聲明

4.2 Subsidiaries

A subsidiary is an investee over which the Company is able to exercise control. The Company controls an investee if all three of the following elements are present: (i) power over the investee, (ii) exposure, or rights, to variable returns from the investee, and (iii) the ability to use its power to affect those variable returns. Control is reassessed whenever facts and circumstances indicate that there may be a change in any of these elements of control.

In the Company's statement of financial position, interests in subsidiaries are stated at cost less impairment loss, if any. The results of subsidiaries are accounted for by the Company on the basis of dividend received and receivable.

4.3 Property, plant and equipment

Property, plant and equipment are stated at cost less accumulated depreciation and accumulated impairment losses.

The cost of property, plant and equipment includes its purchase price and the costs directly attributable to the acquisition of the items.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Group and the cost of the item can be measured reliably. The carrying amount of the replaced part is derecognised. All other repairs and maintenance are recognised as an expense in profit or loss during the financial period in which they are incurred.

4.2 附屬公司

附屬公司為本公司可行使控制權的投資對象。以下三個因素全部滿足時，本公司控制該投資對象：(i)對投資對象的權力、(ii)來自投資對象可變回報的風險或權利及(iii)利用其權力影響該等可變回報的能力。當有事實或情況顯示任何該等控制因素可能出現變動時，會重新評估控制權。

於本公司財務狀況表中，於附屬公司的權益按成本減減值虧損（如有）列賬。本公司將附屬公司業績按已收及應收股息基準入賬。

4.3 物業、廠房及設備

物業、廠房及設備按成本減累計折舊及累計減值虧損列賬。

物業、廠房及設備的成本包括其購買價以及購買有關項目直接應佔的成本。

其後成本僅在與該項目有關的未來經濟利益有可能流入本集團，而該項目的成本能可靠計量時，方計入資產的賬面值或確認為獨立資產（如適用）。替代部分的賬面值不予確認。所有其他維修及保養在產生的財政期間於損益確認為開支。

4.4 Leases

Accounting as a lessee

All leases are required to be capitalised in the consolidated statement of financial position as right-of-use assets and lease liabilities, but accounting policy choices exist for an entity to choose not to capitalise leases which are short-term leases. The Group has elected not to recognise right-of-use assets and lease liabilities for leases for which at the commencement date have a lease term of 12 months or less and do not contain purchase option. The lease payments associated with those leases have been expensed on straight-line basis over the lease term.

Right-of-use asset

The right-of-use asset should be recognised at cost and would comprise: (i) the amount of the initial measurement of the lease liability (see below for the accounting policy to account for lease liability); (ii) any lease payments made at or before the commencement date, less any lease incentives received; (iii) any initial direct costs incurred by the lessee; and (iv) an estimate of costs to be incurred by the lessee in dismantling and removing the underlying asset to the condition required by the terms and conditions of the lease, unless those costs are incurred to produce inventories.

The Group measures the right-of-use assets applying a cost model. Under the cost model, the Group measures the right-to-use at cost, less any accumulated depreciation and any impairment losses, and adjusted for any remeasurement of lease liability.

Other than the above right-of-use assets, the Group has leased a number of properties under tenancy agreements which the Group exercises its judgement and determines that it is a separate class of asset apart from the leasehold land which is held for own use. As a result, the right-of-use asset arising from the properties under tenancy agreements are carried at depreciated cost.

4.4 租賃

作為承租人的會計處理

所有租賃須於綜合財務狀況表內資本化為使用權資產及租賃負債，惟會計政策為實體提供選擇，可選擇不將屬短期租賃的租賃進行資本化。本集團已選擇不就於開始日期租賃期為12個月或少於12個月且不包括購買選擇權的租賃確認使用權資產及租賃負債。與該等租賃相關的租賃付款已於租賃期內按直線法支銷。

使用權資產

使用權資產應按成本確認並將包括：(i)租賃負債之初始計量金額（見下文有關租賃負債入賬的會計政策）；(ii)於開始日期或之前作出之任何租賃付款減已收取之任何租賃優惠；(iii)承租人產生之任何初始直接成本；及(iv)承租人將於分解及移除相關資產至租賃條款及條件規定之狀況時產生之估計成本，惟該等成本乃為生產存貨而產生則除外。

本集團應用成本模式計量使用權資產。根據成本模式，本集團按成本減任何累計折舊及任何減值虧損計量使用權資產，並就租賃負債之任何重新計量作出調整。

除以上使用權資產外，本集團已根據租賃協議租賃多項物業，而本集團行使其判斷並釐定其為持作自用的租賃土地以外的獨立類別資產。因此，租賃協議項下物業產生的使用權資產按折舊成本列賬。

Lease liability

The lease liability is recognised at the present value of the lease payments that are not paid at the date of commencement of the lease. The lease payments are discounted using the interest rate implicit in the lease, if that rate can be readily determined. If that rate cannot be readily determined, the Group uses the Group's incremental borrowing rate.

The following payments for the right-to-use the underlying asset during the lease term that are not paid at the commencement date of the lease are considered to be lease payments: (i) fixed payments less any lease incentives receivable; (ii) variable lease payments that depend on an index or a rate, initially measured using the index or rate as at commencement date; (iii) amounts expected to be payable by the lessee under residual value guarantees; (iv) the exercise price of a purchase option if the lessee is reasonably certain to exercise that option; and (v) payments of penalties for terminating the lease, if the lease term reflects the lessee exercising an option to terminate the lease.

Subsequent to the commencement date, the Group measures the lease liability by: (i) increasing the carrying amount to reflect interest on the lease liability; (ii) reducing the carrying amount to reflect the lease payments made; and (iii) remeasuring the carrying amount to reflect any reassessment or lease modifications, or to reflect revised in-substance fixed lease payments.

租賃負債乃按於租賃開始日期尚未支付之租賃付款之現值確認。倘該利率可輕易釐定，則租賃付款須使用租賃隱含之利率貼現。倘該利率無法輕易釐定，則本集團使用本集團之增量借款利率。

When the Group revises its estimate of the term of any lease (because, for example, it re-assesses the probability of a lessee extension or termination option being exercised), it adjusts the carrying amount of the lease liability to reflect the payments to make over the revised term, which are discounted using a revised discount rate. The carrying value of lease liabilities is similarly revised when the variable element of future lease payments dependent on a rate or index is revised, except the discount rate remains unchanged. In both cases, an equivalent adjustment is made to the carrying value of the right-of-use asset, with the revised carrying amount being amortised over the remaining (revised) lease term. If the carrying amount of the right-of-use asset is adjusted to zero, any further reduction is recognised in profit or loss.

When the Group renegotiates the contractual terms of a lease with the lessor, if the renegotiation results in one or more additional assets being leased for an amount commensurate with the standalone price for the additional rights-of-use obtained, the modification is accounted for as a separate lease, in all other cases, where the renegotiated increases the scope of the lease (whether that is an extension to the lease term, or one or more additional assets being leased), the lease liability is remeasured using the discount rate applicable on the modification date, with the right-of-use asset being adjusted by the same amount. If the renegotiation results in a decrease in the scope of the lease, both the carrying amount of the lease liability and right-of-use asset are reduced by the same proportion to reflect the partial or full termination of the lease with any difference recognised in profit or loss. The lease liability is then further adjusted to ensure its carrying amount reflects the amount of the renegotiated payments over the renegotiated term, with the modified lease payments discounted at the rate applicable on the modification date and the right-of-use asset is adjusted by the same amount.

當本集團修訂其對任何租賃期的估計時 (例如, 由於其重新評估承租人延期或終止選擇權獲行使的可能性), 則會調整租賃負債的賬面值, 以反映於經修訂期限內作出的付款, 並使用經修訂貼現率貼現。當取決於利率或指數的未來租賃付款的可變部分獲修訂時, 租賃負債的賬面值亦作類似修訂, 惟貼現率維持不變。於兩種情況下, 對使用權資產的賬面值作出相等調整, 經修訂賬面值於餘下 (經修訂) 租賃期內攤銷。倘使用權資產的賬面值調整至零, 則於損益確認任何進一步削減。

Accounting as a lessor

Leases are classified as finance leases whenever the terms of the lease transfer substantially all the risks and rewards of ownership of the leased assets to the lessee. All other leases are classified as operating leases.

Rental income from operating leases is recognised in profit or loss on a straight-line basis over the term of the relevant lease. Initial direct costs incurred in negotiating and arranging an operating lease are added to the carrying amount of the leased asset and recognised as an expense on the straight-line basis over the lease term.

Any changes in the scope of the consideration for a lease that was not part of the original terms and conditions of the lease are accounted for as lease modifications. The Group accounts for a modification to an operating lease as a new lease from the effective date of the modification, recognising the remaining lease payments as income on either a straight-line basis or another systematic basis over the remaining lease term.

4.5 Inventories

Inventories are initially recognised at cost, and subsequently at the lower of cost and net realisable value. Cost comprises all costs of purchase, costs of conversion and other costs incurred in bringing the inventories to their present location and condition. Cost is calculated using the weighted average method. Net realisable value represents the estimated selling price in the ordinary course of business less the estimated costs necessary to make the sale.

凡租賃條款規定所租賃資產擁有權之全部風險及回報轉移至承租人之租賃均分類為融資租賃。所有其他租賃均分類為經營租賃。

經營租賃之租金收入於有關租期以直線法於損益內確認。磋商及安排經營租賃所產生初步直接成本會計入租賃資產之賬面值，並於租期內以直線法確認為開支。

倘租賃代價範圍內出現任何不屬於原租賃條款及條件部份的任何變動，將作為租賃修訂入賬。本集團自修訂生效日期起將經營租賃修訂作為新租賃入賬，租賃付款餘額於餘下租賃期內按直線法或另一系統基準確認為收入。

4.5 存貨

存貨初始按成本確認，其後按成本與可變現淨值兩者中的較低者確認。成本包括所有採購成本、轉換成本及將存貨送至彼等現有地點及達致現有狀況所產生的其他成本。成本按加權平均法計算。可變現淨值指日常業務過程中的估計售價減進行銷售必要的估計成本。

(i) Financial assets

A financial asset (unless it is a trade receivable without a significant financing component) is initially measured at fair value plus, for an item not at fair value through profit or loss, transaction costs that are directly attributable to its acquisition or issue. A trade receivable without a significant financing component is initially measured at the transaction price.

All regular way purchases and sales of financial assets are recognised on the trade date, that is, the date that the Group commits to purchase or sell the asset. Regular way purchases or sales are purchases or sales of financial assets that require delivery of assets within the period generally established by regulation or convention in the market place.

Financial assets with embedded derivatives are considered in their entirety when determining whether their cash flows are solely payment of principal and interest.

Debt instruments

Subsequent measurement of debt instruments depends on the Group's business model for managing the asset and the cash flow characteristics of the asset. The following is the measurement category into which the Group classifies its debt instruments:

Amortised cost: Assets that are held for collection of contractual cash flows where those cash flows represent solely payments of principal and interest are measured at amortised cost. Financial assets at amortised cost are subsequently measured using the effective interest method. Interest income, foreign exchange gains and losses and impairment are recognised in profit or loss. Any gain or loss on derecognition is recognised in profit or loss.

所有常規買賣之金融資產於交易日(即本集團承諾購買或出售該資產之日期)確認。常規買賣是指於規定或市場慣例通常設定之期間內交付資產之金融資產買賣。

釐定具有嵌入衍生工具的金融資產的現金流量是否僅為支付本金和利息時,應予以整體考慮。

債務工具

債務工具其後計量視乎本集團管理該資產之業務模式及該資產之現金流量特徵而定。本集團將其債務工具分類為下列計量類別:

The Group recognises loss allowances for expected credit loss (“ECL”) on financial assets measured at amortised cost. The ECL are measured on either of the following bases: (1) 12 months ECL: these are the ECL that result from possible default events within the 12 months after the reporting date; and (2) lifetime ECL: these are ECL that result from all possible default events over the expected life of a financial instrument. The maximum period considered when estimating ECL is the maximum contractual period over which the Group is exposed to credit risk.

ECL are a probability-weighted estimate of credit losses. Credit losses are measured as the difference between all contractual cash flows that are due to the Group in accordance with the contract and all the cash flows that the Group expects to receive. The shortfall is then discounted at an approximation to the assets’ original effective interest rate.

The Group measured loss allowances for trade receivables using HKFRS 9 simplified approach and has calculated ECL based on lifetime ECL. The Group has established a provision matrix that is based on the Group’s historical credit loss experience, adjusted for forward-looking factors specific to the debtors and the economic environment.

本集團使用香港財務報告準則第9號簡化法計量貿易應收款項的虧損撥備，並根據全期預期信貸虧損計算預期信貸虧損。本集團已設立根據本集團過往信貸虧損經驗計算之撥備矩陣，並按債務人特定之前瞻性因素及經濟環境作出調整。

For other financial assets at amortised cost, ECL are based on lifetime ECL except when there has not been a significant increase in credit risk since initial recognition, in which case the allowance will be based on the 12 months ECL.

When determining whether the credit risk of a financial asset has increased significantly since initial recognition and when estimating ECL, the Group considers reasonable and supportable information that is relevant and available without undue cost or effort. This includes both quantitative and qualitative information analysis, based on the Group's historical experience and informed credit assessment and including forward-looking information.

The Group assumes that the credit risk on a financial asset has increased significantly if it is more than 30 days past due.

The Group considers a financial asset to be in default when: (1) the borrower is unlikely to pay its credit obligations to the Group in full, without recourse by the Group to actions such as realising security (if any is held); or (2) the financial asset is more than 90 days past due unless the Group has reasonable and supportable information to demonstrate that a more lagging default criterion is more appropriate.

對於按攤銷成本計量的其他金融資產而言，預期信貸虧損乃基於全期預期信貸虧損。惟倘信貸風險自初始確認以來大幅增加，在此情況下撥備將以12個月預期信貸虧損為基礎。

當釐定金融資產之信貸風險是否自初始確認後大幅增加，並於估計預期信貸虧損時，本集團考慮到相關及毋須付出過多成本或努力後即可獲得之合理及可靠資料。此包括根據本集團之過往經驗及已知信貸評估得出定量及定性之資料及分析，包括前瞻性資料。

倘金融資產逾期30日以上，本集團假設金融資產的信貸風險顯著增加。

在下列情況下，本集團認為金融資產屬違約：(1) 借款人不大可能在本集團無追索權採取變現抵押(如持有)等行動的情況下向本集團悉數支付其信貸債務；或(2) 金融資產逾期90日以上，惟本集團擁有合理及可靠資料顯示一項更滯後的違約標準更為合適，則另作別論。

Depending on the nature of the financial instruments, the assessment of a significant increase in credit risk is performed on either an individual or a collective basis. When the assessment is performed on a collective basis, the financial instruments are grouped based on shared credit risk characteristics, such as past due status and credit risk ratings.

The Group considers a financial asset to be credit-impaired when:

- significant financial difficulty of the debtor;
- a breach of contract, such as a default or past due event;
- the restructuring of a loan or advance by the Group on terms that the Group would not consider otherwise;
- it is probable that the debtor will enter bankruptcy or other financial reorganisation; or
- the disappearance of an active market for a security because of financial difficulties.

The Group recognises an impairment gain or loss in profit or loss for all financial instruments with a corresponding adjustment to their carrying amount through a loss allowance account.

The Group writes off a financial asset when there is information indicating that the debtor is in severe financial difficulty and there is no realistic prospect of recovery, e.g. when the debtor has been placed under liquidation or has entered into bankruptcy proceedings, or in the case of trade receivables, when the amounts are past due for a number of years. Financial assets written off may still be subject to enforcement activities under the Group's recovery procedures, taking into account legal advice where appropriate. Any recoveries made are recognised in profit or loss.

在下列情況下，本集團認為金融資產存在信貸減值：

- 債務人遭遇重大財務困難；
- 違約，如拖欠或逾期還款事件；
- 本集團按本集團在其他情況下不會考慮的條款重組貸款或墊款；
- 債務人可能破產或進行其他財務重組；或
- 由於財務困難導致失去證券活躍市場。

本集團就所有金融工具於損益確認減值收益或虧損，並通過虧損撥備賬對其賬面值作出相應調整。

當有資料顯示債務人處於嚴重財務困難時，及並無合理預期收回時（包括債務人已被清盤或已進入破產程序，或就貿易應收款項而言，金額逾期多年），本集團將撇銷其金融資產。已撇銷的金融資產可能需根據本集團的收回程序進行法律行動，當中於適當情況下將考慮法律意見。收回的任何資產於損益內確認。

Interest income on credit-impaired financial assets is calculated based on the amortised cost (i.e. the gross carrying amount less loss allowance) of the financial asset. For non credit-impaired financial assets, interest income is calculated based on the gross carrying amount.

(iii) Financial liabilities

The Group classifies its financial liabilities, depending on the purpose for which the liabilities were incurred. Financial liabilities at amortised costs are initially measured at fair value, net of directly attributable costs incurred.

Financial liabilities at amortised cost

Financial liabilities at amortised cost including trade payables, accruals, deposits and other payables and bank borrowings are subsequently measured at amortised cost, using the effective interest method. The related interest expense is recognised in profit or loss.

Gains or losses are recognised in profit or loss when the liabilities are derecognised as well as through the amortisation process.

(iv) Effective interest method

The effective interest method is a method of calculating the amortised cost of a financial asset or financial liability and of allocating interest income or interest expense over the relevant period. The effective interest rate is the rate that exactly discounts estimated future cash receipts or payments through the expected life of the financial asset or liability, or where appropriate, a shorter period.

(vi) Derecognition

The Group derecognises a financial asset when the contractual rights to the future cash flows in relation to the financial asset expire or when the financial asset has been transferred and the transfer meets the criteria for derecognition in accordance with HKFRS 9.

Financial liabilities are derecognised when the obligation specified in the relevant contract is discharged, cancelled or expired.

4.7 Cash and cash equivalents

In the consolidated statement of cash flows, cash and cash equivalents represented cash and bank balances.

4.8 Revenue recognition

Revenue from contracts with customers is recognised when control of goods or services is transferred to the customers at an amount that reflects the consideration to which the Group expects to be entitled in exchange for those goods or services, excluding those amounts collected on behalf of third parties. Revenue is after deduction of any trade discounts.

Depending on the terms of the contract and the laws that apply to the contract, control of the goods or service may be transferred over time or at a point in time. Control of the goods or service is transferred over time if the Group's performance:

- provides all of the benefits received and consumed simultaneously by the customer;
- creates or enhances an asset that the customer controls as the Group performs; or
- does not create an asset with an alternative use to the Group and the Group has an enforceable right to payment for performance completed to date.

If control of the goods or services transfers over time, revenue is recognised over the period of the contract by reference to the progress towards complete satisfaction of that performance obligation. Otherwise, revenue is recognised at a point in time when the customer obtains control of the goods or service.

When the contract contains a financing component which provides the customer a significant benefit of financing the transfer of goods or services to the customer for more than one year, revenue is measured at the present value of the amounts receivable, discounted using the discount rate that would be reflected in a separate financing transaction between the Group and the customer at contract inception. Where the contract contains a financing component which provides a significant financing benefit to the Group, revenue recognised under that contract includes the interest expense accreted on the contract liability under the effective interest method. For contracts where the period between the payment and the transfer of the promised goods or services is one year or less, the transaction price is not adjusted for the effects of a significant financing component, using the practical expedient in HKFRS 15.

倘貨品或服務之控制權在一段時間轉讓，則收益於合約期間經參考完成履行該履約責任之進度確認。否則，收益於客戶獲得貨品或服務控制權之某一時間點確認。

倘合約包含融資部分，就為轉讓貨品或服務予客戶融資向客戶提供重大利益超過一年，則收益按應收款項金額使用本集團與客戶在合約訂立時於個別融資交易內反映之貼現率貼現之現值計量。倘合約載有為本集團提供重大融資利益之融資部分，則收益根據有關合約確認，包括根據實際利息法合約負債附有之利息開支。就付款與轉讓承諾貨品或服務之間的期間為一年或以下之合約而言，本集團使用香港財務報告準則第15號之實際權宜之策，即交易價格不會就重大融資部分之影響作出調整。

Further details of the Group's revenue and other income recognition policies are as follows:

- (i) Service income is recognised in the accounting period in which the services are rendered.
- (ii) Income from sales of goods is recognised at point in time when the goods are delivered to customers and title has passed.
- (iii) Interest income is calculated by applying the effective interest rate to the gross carrying amount of a financial asset except for financial asset that subsequently become credit-impaired. For credit-impaired financial asset, the effective interest rate is applied to the net carrying amount of the financial asset (after deduction of the loss allowance).
- (iv) Rental income under operating leases is recognised on a straight-line basis over the lease terms.

Contract assets and liabilities

A contract asset represents the Group's right to consideration in exchange for services that the Group has transferred to a customer that is not yet unconditional. In contrast, a receivable represents the Group's unconditional right to consideration, i.e. only the passage of time is required before payment of that consideration is due.

A contract liability represents the Group's obligation to transfer services to a customer for which the Group has received consideration (or an amount of consideration is due) from the customer.

Contract asset is recognised when the customers retain retention money to secure the due performance of the contracts. Any amount previously recognised as a contract asset is reclassified to trade receivables at the point at which it is invoiced to the customer. If the considerations (including advances received from customers) exceeds the revenue recognised to date under the output method then the Group recognises a contract liability for the difference.

合約資產指本集團就向客戶換取本集團已轉讓的服務收取代價的權利(尚未成為無條件)。相反，應收款項指本集團收取代價的無條件權利，即代價到期付款前僅需時間推移。

合約負債指本集團因已自客戶收取代價(或代價金額到期)，而須轉讓服務予客戶之義務。

當客戶保留質保金以確保妥善履約時，則確認合約資產。先前確認為合約資產的任何金額在向客戶開具發票時重新分類為貿易應收款項。倘代價(包括已收客戶墊款)迄今超過根據產出法確認的收益，則本集團就差額確認合約負債。

4.9 Income taxes

Income taxes for the year comprise current tax and deferred tax.

Current tax is based on the profit or loss from ordinary activities adjusted for items that are non-assessable or disallowable for income tax purposes and is calculated using tax rates that have been enacted or substantively enacted at the end of reporting period. The amount of current tax payable or receivable is the best estimate of the tax amount expected to be paid or received that reflects any uncertainty related to income tax.

Deferred tax is recognised in respect of temporary differences between the carrying amounts of assets and liabilities for financial reporting purposes and the corresponding amounts used for tax purposes. Except for initial recognition of assets and liabilities that are not part of the business combination which affect neither accounting nor taxable profits, taxable temporary differences arising on investments in subsidiaries where the Group is able to control the reversal of the temporary difference and it is probable that the temporary difference will not reverse in the foreseeable future, deferred tax liabilities are recognised for all taxable temporary differences. Deferred tax assets are recognised to the extent that it is probable that taxable profits will be available against which deductible temporary differences can be utilised, provided that the deductible temporary differences are not arises from initial recognition of assets and liabilities in a transaction other than in a business combination that affects neither taxable profit nor the accounting profit. Deferred tax is measured at the tax rates appropriate to the expected manner in which the carrying amount of the asset or liability is realised or settled and that have been enacted or substantively enacted at the end of reporting period, and reflects any uncertainty related to income taxes.

Deferred tax assets and liabilities are offset when there is a legally enforceable right to set off current tax assets against current tax liabilities and when they relate to income tax levied by the same taxation authority and the Group intends to settle its current tax assets and liabilities on a net basis.

4.9 所得稅

年內所得稅包括即期稅項及遞延稅項。

即期稅項基於毋須就利得稅課稅或不可扣減利得稅之項目作出調整之日常業務溢利或虧損，按報告期末已頒佈或實際頒佈之稅率計算。即期應付或應收稅項金額為預期將支付或收取的稅項金額之最佳估計，反映與所得稅有關的任何不確定性。

遞延稅項按作財務報告之資產與負債賬面值，與就稅務所用相應數值之暫時差額確認。除初步確認並非業務合併一部分（不會影響會計或應課稅溢利）之資產及負債外，倘於附屬公司的投資產生之應課稅暫時差額，而本集團可控制暫時差額之撥回，且暫時差額於可見將來可能不會撥回，則就所有應課稅暫時差額確認遞延稅項負債。遞延稅項資產於存在可動用可扣稅暫時差額抵銷的應課稅溢利之情況下確認，惟可抵扣暫時差額並非因初步確認交易（業務合併除外）的資產及負債而產生，且不會影響應課稅溢利或會計溢利。遞延稅項乃按適用於資產或負債之賬面值獲變現或結算的預期方式，根據於報告期末已頒佈或大致上頒佈之稅率計量，並反映與所得稅有關之任何不確定性。

當有合法可強制執行權利將即期稅項資產抵銷即期稅項負債，且與同一稅務機關徵收之所得稅有關。而本集團擬按淨額基準結算其即期稅項資產及負債時，則遞延稅項資產及負債可互相對銷。

The carrying amount of deferred tax assets is reviewed at each reporting date and reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow all or part of the assets to be recovered.

Income taxes are recognised in profit or loss except when they relate to items recognised in other comprehensive income in which case the taxes are also recognised in other comprehensive income or when they relate to items recognised directly in equity in which case the taxes are also recognised directly in equity.

4.10 Employee benefits

(i) Short term employee benefits

Short term employee benefits are employee benefits (other than termination benefits) that are expected to be settled wholly before twelve months after the end of the annual reporting period in which the employees render the related service. Short term employee benefits are recognised in the year when the employees render the related service.

(ii) Defined contribution retirement plan

Contributions to defined contribution retirement plans are recognised as an expense in profit or loss when the services are rendered by the employees.

(iii) Termination benefits

Termination benefits are recognised on the earlier of when the Group can no longer withdraw the offer of those benefits and when the Group recognises restructuring costs involving the payment of termination benefits.

(iv) Long service payments

The Group's net obligation in respect of long service amounts payable on cessation of employment in certain circumstances under the Hong Kong Employment Ordinance is the amount of future benefit that employees have earned in return for their service in the current and prior periods. Liabilities recognised in respect of long service payment are measured at the present value of the estimated future cash outflows expected to be made by the Group in respect of services provided by employees up to the reporting date. The cost of providing the long service payment liabilities is charged to the consolidated statement of comprehensive income. The long service payment liabilities are determined by the recent remuneration of the eligible employees based on the requirement of Hong Kong Employment Ordinance, and is reduced by entitlements accrued under the Group's retirement plans that are attributable to contributions made by the Group.

4.11 Impairment loss of non-financial assets

At the end of each reporting period, the Group reviews the carrying amounts of the following assets to determine whether there is any indication that those assets have suffered an impairment loss or an impairment loss previously recognised no longer exists or may have decreased:

- property, plant and equipment; and
- interests in subsidiaries

If the recoverable amount (i.e. the greater of the fair value less costs to sell and value in use) of an asset is estimated to be less than its carrying amount, the carrying amount of the asset is reduced to its recoverable amount. An impairment loss is recognised as an expense immediately.

Where an impairment loss subsequently reverses, the carrying amount of the asset is increased to the revised estimate of its recoverable amount, to the extent that the increased carrying amount does not exceed the carrying amount that would have been determined had no impairment loss been recognised for the asset in prior years. A reversal of an impairment loss is recognised as income immediately.

4.12 Borrowing costs

Borrowing costs attributable directly to the acquisition, construction or production of qualifying assets which require a substantial period of time to be ready for their intended use or sale, are capitalised as part of the cost of those assets. Income earned on temporary investments of specific borrowings pending their expenditure on those assets is deducted from borrowing costs capitalised. All other borrowing costs are recognised in profit or loss in the period in which they are incurred.

4.13 Government grants

Government grants are not recognised until there is reasonable assurance that the Group will comply with the conditions attaching to them and that the grants will be received.

Government grants are recognised in profit or loss on a systematic basis over the periods in which the Group recognises as expenses the related costs for which the grants are intended to compensate.

Government grants that are receivable as compensation for expenses or losses already incurred or for the purpose of giving immediate financial support to the Group with no future related costs are recognised in profit or loss in the period in which they become receivable and are recognised as other income and gains, rather than reducing the related expense.

4.14 Provisions and contingent liabilities

Provisions are recognised for liabilities of uncertain timing or amount when the Group has a legal or constructive as a result of a past event, which will probably result in an outflow of economic benefits that can be reliably estimated.

Where it is not probable that an outflow of economic benefits will be required, or the amount cannot be estimated reliably, the obligation is disclosed as a contingent liability, unless the probability of outflow of economic benefits is remote. Possible obligations, the existence of which will only be confirmed by the occurrence or non-occurrence of one or more uncertain future events, are also disclosed as contingent liabilities unless the probability of outflow of economic benefits is remote.

4.15 Equity-settled share-based payment transactions

The fair value of services received is determined by reference to the fair value of share options granted at the date of grant and is expensed on a straight-line basis over the vesting period, with a corresponding increase in equity under the heading of share option reserve.

At the end of the reporting period, the Group revises its estimates of the number of options that are expected to ultimately vest. The impact of the revision of the original estimates during the vesting period, if any, is recognised in profit or loss such that the cumulative expense reflects the revised estimate, with a corresponding adjustment to the share option reserve.

When share options are exercised, the amount previously recognised in share option reserve will be transferred to share premium. When the share options are forfeited after the vesting date or are still not exercised at the expiry date, the amount previously recognised in the share option reserve will be transferred to retained profits.

所收到之服務之公平值乃參考所授出購股權於授出日期之公平值釐定，並按歸屬期以直線法予以支銷，並於權益內購股權儲備項下作相應增加。

本集團於報告期末修訂預期最終歸屬之購股權數目之估計。於歸屬期內，原有估計修訂之影響(如有)於損益內確認，以致累計開支反映經修訂估計，並對購股權儲備作相應調整。

當購股權獲行使時，先前於購股權儲備內確認之金額將轉撥至股份溢價。當購股權於歸屬日期後被沒收或於到期日仍未行使時，先前於購股權儲備內確認之金額將轉撥至保留溢利。

4.17 Segment reporting

The Group identifies operating segments and prepares segment information based on the regular internal financial information reported to the executive directors for their decisions about resources allocation to the Group's business components and for their review of the performance of those components. The business components in the internal financial information reported to the executive directors are determined following the Group's major operations.

The measurement policies the Group uses for reporting segment results under HKFRS 8 "Operating Segments" ("HKFRS 8") are the same as those used in its consolidated financial statements prepared under HKFRSs.

5. CRITICAL ACCOUNTING ESTIMATES AND ASSUMPTIONS

In the application of the Group's accounting policies, the directors of the Company are required to make judgements, estimates and assumptions about the carrying amounts of assets and liabilities that are not readily apparent from other sources. The estimates and associated assumptions are based on historical experience and other factors that are considered to be relevant. Actual results differ from these estimates.

The key assumptions concerning the future, and other key sources of estimation uncertainty at the end of the reporting period, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year is set out below.

5.1 Estimated useful lives of property, plant and equipment

The Group determines the estimated useful lives and related depreciation charges for the Group's property, plant and equipment based on the historical experience of the actual useful lives of property, plant and equipment of similar nature and functions. The Group will revise the depreciation charge where useful lives are different to those previously estimated, or it will write-off or write-down technically obsolete or non-strategic assets that have been abandoned or sold.

The Group depreciates the property, plant and equipment in accordance with the accounting policies stated in note 4.3. The estimated useful lives reflect the directors' estimates of the periods that the Group intends to derive future economic benefits from the use of these assets.

本集團根據香港財務報告準則第8號「經營分部」(「香港財務報告準則第8號」)用作呈報分部業績所採用計量政策與根據香港財務報告準則編製綜合財務報表所採用者一致。

應用本集團會計政策時，本公司董事需就目前無法從其他來源得出之資產與負債之賬面值作出判斷、估計及假設。該等估計及有關假設根據過往經驗及視為相關之其他因素作出。實際結果或會有別於該等估計。

可導致資產與負債賬面值於下一個財政年度出現大幅調整之重大風險之有關未來的主要假設及於報告期末存在之估計不明朗因素之其他主要來源如下。

5.1 物業、廠房及設備估計使用年期

本集團根據對性質與功能類似之物業、廠房及設備實際使用年期的過往經驗釐定本集團物業、廠房及設備的估計使用年期與相關折舊費。倘使用年期有別於先前估計者，本集團會修訂折舊費或撇銷或撇減已棄置或出售之技術陳舊或非戰略資產。

本集團根據附註4.3所載會計政策折舊物業、廠房及設備。估計使用年期反映董事對本集團擬從使用該等資產獲得未來經濟利益期間的估計。

5.2 Impairment of trade receivables

The measurement of impairment losses under HKFRS 9 for the financial assets measured at amortised cost requires judgement when determining impairment losses.

The Group's loss allowances are based on management's estimate of the lifetime ECL, which is estimated by taking into account the credit loss experience, ageing of overdue receivables, debtors' creditworthiness and repayment history and an assessment of both the current and forecast general economic conditions at the reporting date. Changes in these estimates could have a significant impact on the loss allowance to be recognised or reversed in future years.

5.3 Provision for long service payments

The Group's provision for long service payments is based on the best estimation of the probable future payments that have been earned by the employees from their services to the Group at the end of each reporting period, calculated in accordance with the relevant laws. The Group's net obligation are dependent on future events and recent payment experience may not be indicative of future payments. Any increase or decrease in the provision would affect profit or loss in future years.

5.4 Income taxes

The Group is subject to income taxes in Hong Kong. Significant judgement is required in determining the provision for income taxes. There are many transactions and calculations for which ultimate tax determination is uncertain during the ordinary course of business. The Group recognised liabilities for anticipated tax issues based on estimates of whether additional taxes will be due. Where the final tax outcome of these matters is different from the amounts that were initially recorded, such differences will affect the income tax and deferred tax provision in the period in which such determination is made.

5.2 貿易應收款項減值

根據香港財務報告準則第9號對按攤銷成本計量的金融資產釐定減值虧損計量須作出判斷。

本集團的虧損撥備以於報告日期管理層經考慮信貸虧損經驗、逾期應收款項的賬齡、債務人的信譽及還款記錄以及對現時及預測整體經濟狀況的評估而對應收款項的存續期預期信貸虧損估計為基準。相關估計的變動可能對未來年度確認或轉回的虧損撥備有重大影響。

5.3 長期服務金撥備

本集團長期服務金撥備乃根據有關法例根據各報告期末僱員因向本集團提供服務而可能賺取之未來付款之最佳估計。本集團負債淨額乃取決於未來事件及可能並不代表未來付款情況之近期付款記錄。撥備之任何增加或減少均會影響未來數年之損益。

5.4 所得稅

本集團須繳納香港所得稅。釐定所得稅撥備時需運用重大判斷。日常業務過程中諸多交易及其最終稅項釐定的計算尚不明朗。本集團基於對額外稅項會否到期的估計確認預計稅務負債。倘該等事項的最終稅務結果有別於初始入賬金額，則有關差額將影響作出釐定期間的所得稅與遞延稅項撥備。

On 23 February 2017, the Company has authorised to grant to 6 eligible participants to subscribe for an aggregate of 192,000 shares under the Pre-IPO Share Option Scheme. On the same date, the Company has granted share options to 6 eligible participants to subscribe for an aggregate of 192,000 shares.

The subscription price of a share in respect of any particular share option offered under the Pre-IPO Share Option Scheme shall be equal to the offer price of HK\$0.42 per share.

Options previously granted under the Share Option Scheme and any other share option schemes of the Company (including those outstanding, cancelled or lapsed in accordance with the terms of the Share Option Scheme and any other share option schemes of the Company) will not be counted for the purpose of calculating the refreshed 10% limit.

Notwithstanding the foregoing, the shares which may be issued upon exercise of all outstanding share options granted and yet to be exercised under the Share Option Scheme and any other share option schemes of the Group at any time shall not exceed 30% of the issued shares of the Company from time to time. No share options shall be granted under any schemes of the Company (including the Share Option Scheme) if this will result in the 30% limit being exceeded.

27. EMPLOYEE RETIREMENT BENEFITS

The Group operates a defined contribution retirement benefits scheme which is registered under the Occupational Retirement Scheme Ordinance (the "ORSO Scheme") for certain employees, the assets of which are held separately from those of the Group in trustee-administered funds independently. The Group contributes 5% on the employee's monthly salary to the ORSO Scheme.

The Group also operates a Mandatory Provident Fund Scheme (the "MPF Scheme") under the Hong Kong Mandatory Provident Fund Schemes Ordinance for employees employed in Hong Kong. The MPF Scheme is a defined contribution retirement plan administered by independent trustees. Under the MPF Scheme, the employers and its employees are each required to make contributions to the plan at 5% of the employees' relevant income, subject to a cap of monthly relevant income of HK\$30,000. Contributions to the plan vest immediately.

The retirement scheme cost recognised in profit or loss represents contributions paid or payable to the ORSO Scheme and the MPF Scheme by the Group at rates specified in the rule of the respective schemes.

As at 31 March 2023 and 2022, the Group had no significant obligation apart from the contributions as stated above and there is no forfeited contribution arose upon employees leaving the retirement benefit schemes and which were available to reduce contributions payable.

On 9 June 2022, the third reading of a bill for cancelling the Mandatory Provident Fund ("MPF") offsetting mechanism was passed in the Legislative Council of the Hong Kong Special Administrative Region. After the bill takes effect, the Group can no longer offset employees' long-service payments against the MPF derived from the employers' mandatory contributions for the employment period starting from that day. In April 2023, the government further announced the abolition of the MPF offsetting mechanism will take effect on 1 May 2025. Apart from MPF Scheme, the abolition of the offsetting arrangement will also be applicable to ORSO Scheme.

27. 僱員退休福利

本集團為若干僱員推行根據職業退休保障計劃條例（「職業退休保障計劃」）註冊之定額供款退休福利計劃，該計劃之資產與本集團的資產分開，由受託人管理之基金獨立持有。本集團按僱員月薪5%向職業退休保障計劃供款。

本集團亦根據香港強制性公積金計劃條例，為在香港受僱的僱員推行強制性公積金計劃（「強積金計劃」）。強積金計劃為由獨立受託人管理的定額供款退休福利計劃。根據強積金計劃，僱主及其僱員須各自按僱員相關收入5%向該計劃供款，每月相關收入的上限為30,000港元。該計劃的供款立即歸屬。

在損益中確認的退休計劃成本指本集團按各計劃規則規定的費率向職業退休保障計劃及強積金計劃支付或應付的供款。

於2023年及2022年3月31日，除上述供款外，本集團並無重大責任，亦並無因僱員退出退休福利計劃而產生的沒收供款，可用於減少應付供款。

於2022年6月9日，香港特別行政區立法會三讀通過取消強制性公積金（「強積金」）對沖機制法案。在相關法案生效後，本集團不能再將僱員自受聘首日起計期間的長期服務金與僱主的強制性供款所產生的強積金進行抵銷。於2023年4月，政府進一步宣佈廢除強積金對沖機制將於2025年5月1日生效。除強積金計劃外，廢除對沖安排亦將適用於職業退休計劃條例。

31. FINANCIAL RISK MANAGEMENT

The Group is exposed to a variety of financial risks through its use of financial instruments in its ordinary course of operations and in its investment activities. The financial risks include credit risk, liquidity risk, interest rate risk and fair value risk.

Financial risk management is coordinated at the Group's headquarter, in close co-operation with the directors. The overall objectives in managing financial risks focus on securing the Group's short to medium term cash flows by minimising its exposure to financial markets.

It is not the Group's policy to actively engage in the trading of financial instruments for speculative purposes. It identifies ways to access financial markets and monitors the Group's financial risk exposure. Regular reports are provided to the directors of the Company.

(b) Credit risk

The Group's credit risk is primarily attributed to its trade and other receivables and cash and bank balances. Management has a credit policy in place and the exposures to these credit risks are monitored on an ongoing basis and follow-up action is taken to recover overdue debts.

The Group has concentration of credit risk with two customers with trade receivables of HK\$45,236,000 (2022: two customers of HK\$52,639,000) as at 31 March 2023.

For trade receivables, the Group reassesses the lifetime expected credit losses at the end of the reporting period to ensure the adequate impairment losses are made for significant increases in the likelihood or risk of default occurring since initial recognition.

The Group applies collective basis to measure the expected credit losses. As at 31 March 2023 and 2022, the expected loss rates applied in the provision matrix are determined with reference to the debtors' shared credit risk characteristics, including background of the customers and their historical payment behaviour, historical credit loss on the trade receivables and information pertaining to the economic environment in which the debtors operate.

(c) Liquidity risk

Liquidity risk relates to the risk that the Group will not be able to meet its obligations associated with its financial liabilities. The Group is exposed to liquidity risk in respect of settlement of trade and other payables and its financing obligations, and also in respect of its cash flow management.

The Group's policy is to regularly monitor its liquidity requirements and its compliance with bank covenants, to ensure the Group maintains sufficient reserves of cash and adequate committed lines of funding from major banks and financial institutions to meet its liquidity requirements in the short and longer term.

(d) Interest rate risk

The Group's interest rate risk arises from variable rate bank balances and bank borrowings. Exposure to interest rate risk exists on those balances subject to floating interest rate when there are unexpected adverse interest rate movements. The Group's policy is to manage its interest rate risk, working within an agreed framework, to ensure that there are no unduly exposures to significant interest rate movements and rates are approximately fixed when necessary.

Sensitivity analysis

The sensitivity analysis below has been determined based on the exposure to interest rates for bank borrowings at the end of the year. The analysis is prepared assuming amounts of these financial instruments outstanding at the end of the year were outstanding for the whole year. A 50 basis points increase or decrease in the prevailing rates of relevant banks is used when reporting interest rate risk internally to key management personnel and represents management's assessment of the reasonably possible change in interest rates.

If the interest rates had been 50 basis points higher/lower for variables rate bank borrowings, with all other variables were held constant, the Group's post-tax profit for the year would decrease/increase by approximately HK\$10,000 (2022: HK\$17,000).

No sensitivity analysis of bank balances of the Group is presented as the interest income from bank balances is negligible.

(e) Fair value risk

The directors of the Company consider that the carrying amounts of financial assets and financial liabilities recorded at amortised cost in the Group's financial statements approximate to their fair values.

倘銀行借款的浮動利率上浮／下降50個基點而其他所有變量保持不變，則本集團年內的除稅後溢利將減少／增加約10,000港元（2022年：17,000港元）。

由於銀行結餘利息收入可忽略不計，故並無呈列本集團銀行結餘的敏感度分析。
