PROPOSED GRANTING OF GENERAL MANDATES TO REPURCHASE AND ISSUE NEW SHARES AND PROPOSED RE-ELECTION OF DIRECTORS AND NOTICE OF AGM

INTRODUCTION

The purpose of this circular is to provide you with notice of the AGM, and information regarding the resolutions to be proposed at the AGM.

The resolutions to be proposed at the AGM include, amongst others, (i) the Repurchase Mandate; (ii) the Issuance Mandate; and (iii) the re-election of Directors.

GENERAL MANDATES TO REPURCHASE SHARES AND ISSUE NEW SHARES

At the AGM, an ordinary resolution will be proposed to grant to the Directors a general and unconditional mandate to exercise all powers of the Company to repurchase issued Shares in the share capital of the Company. In particular, Shareholders should note that the maximum number of Shares that may be repurchased pursuant to the Repurchase Mandate will be such number which represents 10% of the aggregate number of issued Shares of the Company as at the date of passing of the resolution.

In addition, an ordinary resolution will be proposed at the AGM to grant to the Directors a general and unconditional mandate to allot, issue and deal with further Shares representing up to 20% of the aggregate number of issued Shares of the Company as at the date of passing of the resolution.

Subject to the passing of the ordinary resolutions in respect of the Repurchase Mandate and the Issuance Mandate, a separate ordinary resolution will also be proposed to authorise the Directors to issue new Shares in the share capital of the Company in an amount not exceeding the aggregate number of issued Shares of the Company purchased pursuant to the Repurchase Mandate.

The Repurchase Mandate and the Issuance Mandate will end on the earliest of the date of the next AGM, the date by which the next AGM of the Company is required to be held by law or the Bye-laws, or the date upon which such authority is revoked or varied by ordinary resolution of the Company in general meeting.

In accordance with the Listing Rules, the Company is required to send to the Shareholders an explanatory statement containing all the information reasonably necessary to enable them to make an informed decision on whether to vote for or against the grant of the Repurchase Mandate, which is set out in Appendix I to this circular.

RE-ELECTION OF DIRECTORS

Pursuant to Bye-law 87, at each annual general meeting, one-third of the Directors for the time being (or, if their number is not a multiple of three (3), the number nearest to but not less than one third) shall retire from office by rotation. Every Director, including those appointed for a specific term, shall be subject to retirement by rotation at least once every three years. Accordingly, Mr. Tam Lup Wai, Franky, Mr. Liu Liyang, Mr. Qiu Qing, Mr. Lim Kim Chai, J.P. and Mr. Leung Chi Hung will retire from office by rotation at the AGM and being eligible, have offered themselves for re-election at the AGM.

Details of the Directors who are proposed to be re-elected, pursuant to Rule 13.51(2) of the Listing Rules, are set out in Appendix II to this circular.

LENGTH OF TENURE OF INDEPENDENT NON-EXECUTIVE DIRECTORS ("INEDs")

Pursuant to code provision B.2.4 of the Corporate Governance Code contained in Appendix 14 to the Listing Rules, Where all the INEDs of an issuer have served more than nine years on the board, the issuer should: disclose the length of tenure of each existing independent non-executive director on a named basis in the circular to shareholders accompanying the notice of the annual general meeting. All of the INEDs of the Company, namely Mr. Leung Chi Hung, Mr. Li Hon Kuen, and Mr. Hau Chi Kit have been serving for more than nine years. Mr. Leung Chi Hung has been serving as an independent non-executive Director since his appointment in July 2013; and Mr. Hau Chi Kit has been serving as an independent non-executive Director since his appointment in March 2014.

AGM

The AGM will be convened and held at Unit 1005, 10/F, Bank of East Asia Harbour View Centre, No. 56 Gloucester Road, Wanchai, Hong Kong on Thursday, 20 July 2023 at 11:30 a.m. At the AGM, ordinary resolutions will be proposed to approve the Repurchase Mandate, the Issuance Mandate and the re-election of Directors.

The notice of the AGM is set out in Appendix III of this circular. A form of proxy for use at the AGM is enclosed. Pursuant to Rule 13.39(4) of the Listing Rules, any votes of the Shareholders at a general meeting must be taken by poll except where the chairman, in good faith, decides to allow a resolution which relates purely to a procedural or administrative matter to be voted on by a show of hands. Therefore, the chairman of the AGM will demand a poll for each and every resolution put forward at the AGM pursuant to Bye-law 66(1) of the Bye-laws of the Company. The Company will appoint scrutineers to handle vote-taking procedures at the AGM. APPENDIX I EXPLANATORY STATEMENT FOR THE REPURCHASE MANDATE

This is an explanatory statement given to all Shareholders relating to a resolution to be proposed at the AGM in relation to the Repurchase Mandate. This explanatory statement contains all the information required pursuant to Rule 10.06(1)(b) and other relevant provisions of the Listing Rules which is set out as follows:

1. SHARE CAPITAL

As at the Latest Practicable Date, the issued and fully-paid share capital of the Company was 10,721,666,832 Shares of HK\$0.00004 each. Subject to the passing of the ordinary resolution granting the Repurchase Mandate and on the basis that no further Shares are issued or repurchased prior to the AGM, the Company would be allowed under the Repurchase Mandate to repurchase a maximum of 1,072,166,683 Shares, being 10% of the aggregate number of issued Shares of the Company at the time of passing the resolutions.

2. REASONS FOR REPURCHASES

The Directors believe that the Repurchase Mandate is in the best interests of the Company and its Shareholders. Whilst it is not possible to anticipate in advance any specific circumstance in which the Directors might think it appropriate to repurchase Shares, they believe that an ability to do so would give the Company additional flexibility that would be beneficial to the Company and its Shareholders as such repurchases may, depending on market conditions and funding arrangements at that time, lead to an enhancement of the net asset value per Share and/or earnings per Share. The Directors would only make such purchases in circumstances where they consider them to be in the best interests of the Company.

3. FUNDING OF REPURCHASES

Repurchases must be funded out of funds legally available for such purpose in accordance with the Bye-laws and the laws of Bermuda. The laws of Bermuda provide that the amount of capital repaid in connection with a share repurchase may only be paid out of either, the capital paid up on the relevant shares, or the funds of the Company that would otherwise be available for, dividend or distribution or the proceeds of a fresh issue of shares made for the purpose of the repurchase. The amount of premium payable on repurchase may only be paid out of either the funds of the Company that would otherwise be available for, dividend or distribution or out of the Company's share premium account before the Shares are repurchased. In accordance with the laws of Bermuda, the shares so repurchased would be treated as cancelled but the aggregate amount of authorised share capital would not be reduced.

On the basis of the consolidated financial position of the Company as at 30 June 2022 (being the date to which the latest published audited financial statements of the Company have been made up) and in particular the working capital position of the Company at that time and the number of Shares now in issue, the Directors consider, that there might be a material adverse impact on the working capital position and the gearing position of the Company in the event that purchases of all the Shares subject to the Repurchase Mandate were to be carried out in full. No purchase would be made in circumstances that would have a material adverse impact on the working capital position or the gearing position of the Company (as compared with the position disclosed in the latest published audited financial statements as at 30 June 2022).

APPENDIX I EXPLANATORY STATEMENT FOR THE REPURCHASE MANDATE

5. UNDERTAKING

The Directors have undertaken to the Stock Exchange that, so far as the same may be applicable, they will exercise the power of the Company to make repurchases pursuant to the Repurchase Mandate in accordance with the Listing Rules and the laws of Bermuda.

None of the Directors nor, to the best of their knowledge having made all reasonable enquiries, their associates, has any present intention to sell any Shares to the Company in the event that the Repurchase Mandate is approved by the Shareholders.

No connected persons of the Company have notified the Company that they have a present intention to sell Shares to the Company, or have undertaken not to do so, in the event that the Repurchase Mandate is granted by the Shareholders.

6. HONG KONG CODES ON TAKEOVERS AND MERGERS

Upon the exercise of the power by the Directors to repurchase the securities pursuant to the Repurchase Mandate, a Shareholder's proportionate interest in the voting rights of the Company increases, such increase will be treated as an acquisition of the voting rights for the purpose of Rule 32 of the Takeovers Code and Rule 6 of the Repurchase Code. Accordingly, a Shareholder, or group of Shareholders acting in concert, depending on the level of increase of the Shareholders' interest, could obtain or consolidate control of the Company and depending on the level of increase of Shareholders' interests, may become obliged to make a general offer in accordance with Rule 26 and 32 of the Takeovers Code.

Mr. Tam Lup Wai, Franky ("Mr. Tam")

(Deputy Chairman and Executive Director)

Mr. Tam, aged 75, was appointed as executive Director of the Company on 17 December 2001 and the Chairman of the board of Directors of the Company on 21 July 2011. He was also appointed as a member of the remuneration committee of the Company on 3 July 2007 and the chairman of the nomination committee on 29 March 2012. Mr. Tam was re-designated as the deputy chairman of the Board and ceased to be the chairman of the Nomination Committee with effect from 18 January 2018. He is also a director of the following subsidiaries of the Company, namely, Big Advanced Holdings Limited, Dongguan Weihang Electrical Product Co. Limited, eForce Management Limited, Fairform Holdings Limited, Fairform Manufacturing Co. Limited, New Hong Kong Industrial Co. Limited, Qesco International (HK) Limited, and Smart Guard Limited. Mr. Tam holds a Bachelor of Arts degree in Applied Mathematics from the University of California at Berkeley, USA. He has diversified management experiences in the fields of property, retail and technology. He also specializes in formulating and executing business strategies for companies and has experience in the investment of technology start-up. He was previously an administration director of a conglomerate with four listed companies in Hong Kong and directly oversaw the administration of such conglomerate, responsible for managing operation of several subsidiaries, including properties acquisition, strategic investments and hotel start-up project. Before joining the Company in 2001, Mr. Tam served as an executive director of a Hong Kong publicly listed fashion retail chain store with over 200 outlets in Hong Kong and China and during his employment then, he was instrumental in setting up a franchise operation in the PRC.

Save as disclosed above, Mr. Tam (i) does not hold any positions with the Company and its Group; and (ii) did not hold any other directorships in any listed public companies in Hong Kong or overseas for the last three years.

There is no service contract between the Company and Mr. Tam and he is not appointed for a specific term but shall be subject to retirement and re-election at annual general meeting of the Company in accordance with the Bye-laws. Mr. Tam's remuneration is determined with reference to his experiences, duties and responsibilities with the Company and the market benchmark.

Mr. Tam does not have any relationships with any directors, senior management or substantial or controlling shareholders of the Company.

As at the Latest Practicable Date, Mr. Tam does not have any interests in the shares within the meaning of Part XV of the Securities and Futures Ordinances ("SFO").

Save as disclosed above, Mr. Tam has confirmed that there is no other information relating to him which is required to be disclosed to the Shareholders pursuant to Rule 13.51 (2) (a) to (x) of the Listing Rules.

Mr. Liu Liyang ("Mr. Liu")

(Executive Director)

Mr. Liu, aged 62, Mr. Liu, aged 61, was appointed as executive Director, Deputy Chairman of the Board and the Chief Executive Officer ("CEO") and a member of the remuneration committee of the Company on 19 August 2010. He was further appointed as a member of the nomination committee of the Company on 29 March 2012. He ceased to be the deputy chairman of Board with effect on 18 January 2018. And he ceased to be CEO and a member of each of the remuneration committee and the nomination committee of the Company with effect from 16 July 2020. He is also the director of Yixin Holdings Limited and Pacific Memory Sdn Bhd, members of the Group. Mr. Liu has 17 years of experience in the investment banking industry. Before joining the Company, he was the co-head of the China Investment Banking of Nomura International (HK) Limited. He had also worked in the Merrill Lynch (Asia Pacific) Limited, China International Capital Corporation Limited and Morgan Stanley & Co. Inc. Mr. Liu holds an MBA degree from Columbia University. Mr. Liu was an independent non-executive director of Beautiful China Holdings Company Limited (stock code: 706), a company listed on the Main Board of the Stock Exchange, before February 2022.

Save as disclosed above, Mr. Liu (i) does not hold any positions with the Group; and (ii) has not been a director of any other listed companies in Hong Kong or overseas in the past three years preceding the Latest Practicable Date.

Mr. Qiu Qing ("Mr. Qiu")

(CEO and Executive Director)

Mr. Oiu, aged 57, was appointed as Executive Director and a member of the remuneration committee and the nomination committee of the Company on 17 April 2020. He was further appointed as the Chief Executive Officer ("CEO") of the Company on 16 July 2020. He is also director of the following members of the Group, namely, Guangdong Zhongzheng City Development Management Co., Ltd. (廣東中證城市發展管理有限公司), Shenzhen Xinzheng Zhiyuan Venture Capital Co., Ltd. (深圳市 信證致遠創業投資有限公司), Shenzhen Qianhai Zhongzheng Huateng Industrial Co., Ltd (深圳市前海中 證華騰實業有限公司), Chengde Zhongzheng Jinvu Investment Development Co., Ltd. (承德中證金域投 資開發有限公司), and Chengde Zhongzheng Urban and Rural Development Co., Ltd. (承德中證城鄉開 發有限公司). He was the director of Shenzhen Zhongzheng Ruifeng Management Limited (深圳市中證 瑞豐管理有限公司), a subsidiary of the Company, from May 2020 to November 2022. He has over 19 years of experience in real estate investment and development business. From October 2000 to October 2006, he served at CITIC South China (Group) Co., Ltd.* (中信華南(集團)有限公司), with his last position as the director of office of the company. From December 2004 to October 2007, he served as a deputy general manager of CITIC South China (Group) Dongguan Co., Ltd.* (中信華南(集團)東莞有限 公司) and from October 2006 to October 2009, as a member of the party committee, secretary of the disciplinary committee, and deputy secretary of the party committee of CITIC Real Estate Co., Ltd.* (中 信房地產股份有限公司) ("CITIC Real Estate"). Mr. Oiu was the general manager of Hainan Boao Investment Holdings Co., Ltd.* (海南博鼇投資控股有限公司) from October 2007 to October 2009.
