UNAUDITED OPERATING FIGURES FOR MAY 2023

The board of directors (the “**Board**”) of Sanxun Holdings Group Limited (the “**Company**”) wishes to provide the shareholders of the Company and potential investors with a sales update containing certain operating data of the Group for the five months ended 31 May 2023. For the five months ended 31 May 2023, the aggregate contracted sales of the Company, its subsidiaries and associated companies (the “**Group**”) was approximately RMB488 million, the aggregate contracted gross floor area was 67,708 sq.m. and the average selling price was approximately RMB7,213 per sq.m..

The above-mentioned operating figures are unaudited and are based on preliminary internal information of the Group, which may differ from the figures to be disclosed in the audited or unaudited consolidated financial statements to be published by the Group on an annual or half-yearly basis due to various uncertainties during the process of collecting such information.
