The term of office of Mr. Wang as the Chairman shall commence from the date of obtaining the approval of his qualification as the Chairman from National Administration of Financial Regulation until the expiry of the term of the fourth session of the Board of the Company, and he is eligible for re-election upon the expiry of the term.

Mr. Wang, as an executive director of the Company, does not receive any director's fee from the Company other than the corresponding emoluments (including salary, performance bonus and benefits) received pursuant to his specific management position in the Company.
