Announcement Trading Update Power Generation For June 2023

This announcement is made by CGN New Energy Holdings Co., Ltd. (the "Company") on a voluntary basis.

The board (the "Board") of directors (the "Directors") of the Company announces that, according to the preliminary statistics of the Company, the power generation of the Company and its subsidiaries (the "Group") on a consolidated basis amounted to 1,572.7GWh for the month of June 2023, representing a decrease of 6.6% compared with the corresponding period of 2022. In particular, power generation of PRC wind projects decreased by 6.8%, power generation of PRC solar projects increased by 5.8%, power generation of PRC cogen and gas-fired projects decreased by 0.6%, power generation of PRC hydro projects decreased by 67.8% and power generation of Korea projects decreased by 3.9%. For the six months ended 30 June 2023, the accumulated power generation of the Group of this year amounted to 10,140.6GWh, representing an increase of 6.6% compared with the corresponding period of 2022. In particular, power generation of PRC wind projects increased by 16.7%, power generation of PRC solar projects increased by 0.7%, power generation of PRC cogen and gas-fired projects increased by 3.5%, power generation of PRC hydro projects decreased by 66.9% and power generation of Korea projects increased by 0.1%.

Details of the power generation of the Group for June 2023 (with corresponding period of 2022) are set out as follows:
