**VOLUNTARY ANNOUNCEMENT  
FURTHER INCREASE IN SHAREHOLDING IN THE COMPANY  
BY THE CHAIRMAN,  
CHIEF EXECUTIVE OFFICER AND EXECUTIVE DIRECTOR**

This is a voluntary announcement made by the board of directors (the “**Board**”) of Perfect Medical Health Management Limited (the “**Company**”) in relation to the further increase in the holding of shares in the Company (“**Shares**”) by Dr. Au-Yeung Kong (“**Dr. Au-Yeung**”), the chairman, chief executive officer and executive director of the Company.

The Board was informed that Dr. Au-Yeung had further purchased a total of 560,000 Shares in the open market on 7 July 2023 at an average price of HK\$4.40 (“**Dr. Au-Yeung’s Further Increase in Shareholding**”), in addition to his individual increase in shareholding of 4,832,000 Shares from 4 July 2023 to 5 July 2023. The aggregate consideration in respect of the said increases in shareholdings by Dr. Au-Yeung from 4 July 2023 to 7 July 2023 was HK\$20,882,000.

Immediately before Dr. Au-Yeung’s Further Increase in Shareholding, Dr. Au-Yeung was interested in an aggregate of 941,443,768 Shares, representing approximately 74.92% of the issued share capital of the Company.

Immediately after Dr. Au-Yeung’s Further Increase in Shareholding, Dr. Au-Yeung is interested in an aggregate of 942,003,768 Shares, representing approximately 74.96% of the issued share capital of the Company.

Dr. Au-Yeung is confident about the future prospects of the Company and may consider further increasing his shareholding in the Company when appropriate in the future, subject to compliance with applicable legal and regulatory requirements.

Based on the information available to the Company and to the knowledge of the Board as at the date of this announcement, the Company has maintained sufficient public float of the issued shares of the Company following the abovesaid further increase in shareholding by Dr. Au-Yeung.
